The Closing Time will be adjusted, as the case may be, in accordance with (a) or (b) below if a Typhoon Warning Signal No. 8 or above is hoisted, a Black Rainstorm Warning is in force in Hong Kong or "extreme conditions" resulting from a typhoon or a rainstorm are announced by the Government of the Hong Kong Special Administrative Region of the People's Republic of China:
(a) at any local time before 12:00 noon on Monday, 11 October 2021. In such a case, the Closing Time will be extended to 5:00 p.m. on the same business day; or
(b) at any local time between 12:00 noon and 4:30 p.m. on Monday, 11 October 2021. In such a case, the Closing Time will be extended to 4:30 p.m. on the next business day which does not have any of the above warnings in force at any time between 6:00 a.m. and 4:30 p.m.
