# Arrangements on Electronic Dissemination of Corporate Communications

In line with the new Rule 2.07A of the Rules (the "Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") effective from 31 December 2023, Legend Upstar Holdings Limited (the "Company") has adopted new arrangements to disseminate all future corporate communications (the "Corporate Communications") electronically to its non-registered shareholders.
