

As we reflect on our journey, we are filled with immense pride and gratitude for the trust and support of our shareholders, the dedication of our exceptional team, and the enduring partnerships we have cultivated across Hong Kong, Macau, and Chinese Mainland.

The financial year 2025 has been a period of celebration, strategic evolution, and resilient growth. Against a backdrop of shifting economic landscapes and increasing public focus on healthcare resilience, our performance demonstrates the strength and adaptability of our integrated healthcare services model – one that is increasingly prioritizing preventive medicine.

### Celebrating a Legacy of Trust, Innovation, and Purpose

From our humble beginnings in 1990, UMP was founded on a simple yet powerful vision: to enhance the quality and accessibility of healthcare services. Over the past 35 years, we have grown from a small clinical medical center into a leading integrated healthcare services provider. - Diagnostic & Imaging Services, the foundation of our heritage, continue to set the standard for accuracy and efficiency. Strategic investments in advanced imaging technologies ensure we remain at the forefront of diagnostic medicine.

This ecosystem creates a virtuous cycle: corporate clients drive volume to our centers and diagnostics, while our clinical excellence enhances the value of our corporate offerings – the unique UMP advantage.

We will also continue to look for suitable medical partners and investment opportunities in other provinces and cities in Chinese Mainland to promote the Group's expansion strategy.
- **Digital Transformation:** Our investment in smart clinic systems, telemedicine, Al-assisted diagnostics, and digital health platforms positions us to deliver scalable, personalized care. These tools enhance operational efficiency and support early detection and proactive health management.

### Joint Statement of the Co-Chief Executive Officers

Dear Shareholders,

This milestone year – marking 35 years since the founding of UMP Healthcare Holdings Limited and a decade since our listing on the Hong Kong Stock Exchange Main Board– powerfully demonstrates our enduring mission, strategic evolution, and unwavering commitment to redefining healthcare. As Co-Chief Executive Officers, we are honored to lead UMP into its next chapter, building upon a legacy of clinical excellence, operational resilience, and purpose-driven innovation.

### **Performance Highlights**

UMP Healthcare demonstrated resilience and strategic discipline during the financial year ended June 30, 2025, navigating a challenging macroeconomic environment to deliver solid results. While total revenue declined by 2.9% year-on-year to HK\$726.9 million, our corporate healthcare solutions continued to grow, now serving over 1.3 million end users across more than 1,000 service points in Hong Kong, Macau, and Chinese Mainland. Profits attributable to shareholders fell to HK\$31.44 million, reflecting deliberate investments in people, infrastructure, and technology that will drive long-term value and elevate care quality.

Despite revenue pressure, we preserved our gross profit margin through rigorous cost control, achieving notable savings in rental and staffing expenses. The slight dip in operating profit was due to a one-off HK\$18 million gain in FY2024; excluding this, our core operating performance remained stable, underscoring effective execution amid market normalization. The solid results for the 2025 financial year are a direct outcome of this collaborative leadership model and the dedication of our entire UMP team. We are pleased to present this review of our key achievements and strategic priorities.

### 聯席行政總裁聯合報告

各位股東:

今年是一個深具里程碑意義的年份一標誌著聯合醫務集團有限公司成立35週年以及本公司在香港聯合交易所主板上市十週年,其強而有力地展示了我們恆久不變的使命、策略革新以及對重新定義醫療保健的堅定承諾。作為聯席行政總裁,我們很榮幸帶領聯合醫務邁入新篇章,承傳卓越臨床水平、營運韌性及以目標驅動創新。

### 表現摘要

聯合醫務於截至2025年6月30日止財政年度 展現韌性及嚴謹的策略執行力,在充滿挑戰 的宏觀經濟環境中取得穩健業績。儘管總收 入按年下跌2.9%至726.9百萬港元,我們的企 業醫療保健解決方案業務持續增長,現時在 香港、澳門及中國內地超過1,000個服務點為 超過130萬名終端用戶提供服務。股東應佔利 潤下跌至31.44百萬港元,這是由於我們刻意 投資於人才、基礎設施及技術,以推動長遠 價值及提升醫療質素。

儘管收入面臨壓力,我們透過嚴謹的成本控制維持毛利率,並在租金及員工開支方面實現顯著節省。經營利潤輕微下跌,此乃由於2024財政年度錄得一次性收益1,800萬港元;撇除該項收益,我們的核心經營表現保持穩定,突顯我們在市場正常化進程中維持有效的執行力。2025財政年度穩健的業績乃直接得益於共同協作的領導模式及整個聯合醫務團隊的全心投入。我們欣然在此回顧我們的主要成就及策略重點。

In FY2025, although the Hong Kong economy remained in a state of uncertainty, our corporate healthcare solutions business in Hong Kong and Macau leveraged its defensive and offensive capabilities to mitigate economic instability. Citizens, patients, and customer channels increased their use of healthcare plans offered by insurance companies and corporations. This increased usage of certain solutions, driving revenue and profit from related solutions and stimulating revenue from related clinical medical services. Although the economic impact of the environment has impacted the number of employees in corporations, which has affected the performance of certain corporate healthcare solutions products, the complementary characteristics of different corporate solutions have resulted in continued growth in revenue and profit from related corporate healthcare solutions in this fiscal year.

UMP continues to provide and support insurance companies and corporations with personalized and accurate healthcare solutions, ultimately achieving low costs and high efficiency healthcare solutions. During the FY2025, we continued to strengthen our third-party administration (TPA) services, expanding beyond our other strategic business partners, hopes to provide a more comprehensive and integrated healthcare service, thereby establishing a more one-stop and operationally quality efficient medical eco-system.

We communicated with our customers closely to understand their needs and build a strong and stable customer base. This also enables the sustainable development of our corporate healthcare plan field while ensuring that our customers can receive high-quality services.

### **OUR BUSINESS**

UMP's business scope consists of the following business lines:

### 1. Hong Kong & Macau Corporate Healthcare Solution Services

Our Hong Kong and Macau corporate healthcare solution services refer to the business of designing and administrating healthcare benefits plans and solutions tailored for contract clients in the region. The extension of third party administration ("TPA") service (including hotline and pre-approval services) to our insurance company clients is an important offering among UMP's corporate healthcare solutions. UMP aims to provide convenient, reliable, coordinated, comprehensive and affordable healthcare services through the well-established and multi-specialties UMP Network. As at 30 June 2025, the UMP Network comprises over 1,000 points of services located across Hong Kong, Macau and Chinese Mainland.

The Group's Contract Customers comprise (i) insurance companies, which enter into contracts with the Group for healthcare services for their policyholders or employees of their policyholders and (ii) corporations, which enter into contracts with the Group for healthcare services for their employees and/or their dependants. When designing healthcare benefits plans, the Group collaborates closely with the Contract Customers and designs and refines corporate healthcare benefits plans, with each plan tailored to each customer's needs based on factors such as industry or occupational health-related concerns, scope of healthcare benefits desired, employee demographic as well as their budget.

### 我們的業務

### 2. Hong Kong & Macau Clinical Healthcare Services

UMP provides medical and dental services, medical imaging and laboratory services and other auxiliary medical services to Self-paid Patients. For medical services, UMP provides (i) general practice services, which serves as the first point of contact for the patients and (ii) specialist services covering more than 20 different specialties. For dental services, UMP provides both primary dental care and secondary dental care such as dental implants.

Medical imaging and laboratory services are an integral part of medical and healthcare. UMP, through its ProCare medical group, provides one-stop and comprehensive imaging and laboratory services. Equipped with many advanced imaging equipment and testing facilities including PET-CT, MRI, CT Scan, ultrasound, mammography and X-ray, we provide extensive and reliable medical diagnosis and laboratory services. UMP can provide a wide range of imaging and laboratory services at our self-owned centre. The reorganisation and consolidation of certain medical imaging and laboratory centres initiated in FY2023/24 have begun to yield positive results in FY2024/25, contributing notable growth in both revenue and profit to the Group during the year under review. As at 30 June 2025, the Group owned and operated 6 core medical integrated and advanced imaging centres and 1 central medical laboratory centre.

During FY2025, UMP provides other auxiliary medical services such as physiotherapy, traditional chinese medicine and vision care.

### 3. Chinese Mainland Clinical Healthcare Services

Our Chinese Mainland Clinical Healthcare Services currently consists of (i) health check-up business and (ii) selected outpatient services such as family medicine within the clinics we own and operate.

### 2. 香港及澳門臨床醫療保健服務

聯合醫務向自費患者提供醫療及牙科服務、醫學影像及化驗服務以及其他輔助醫療服務。醫療服務方面,聯合醫務提供(i)全科醫療服務,為患者的首個接觸點;及(ii)專科服務,覆蓋超過20個不同專科。牙科服務方面,聯合醫務提供基本牙科護理及第二層牙科護理(例如植牙)。

醫學影像及化驗服務是旗下業務的不 可或缺組成部分。聯合醫務通過其普康 醫療集團,提供一站式及全面的影像及 化驗服務。我們備有多種先進的影像設 備及測試設施,包括正電子電腦斷層掃 描、磁力共振成像、電腦斷層掃描、超 聲波、乳房造影及X光,提供廣泛而可 靠的醫療診斷及化驗服務。聯合醫務可 以在旗下中心提供一系列影像及化驗 服務。於2023/2024財政年度就若干醫 療影像及化驗中心所所開展的重組及 整合已於2024/2025財政年度開始呈現 成果,並於回顧年度內為本集團貢獻顯 著的收入及利潤增長。於2025年6月30 日,本集團擁有及經營6間核心醫療綜 合及先進影像中心及1間中央醫療化驗 中心。

於2025財政年度,聯合醫務提供其他輔助醫療服務如物理治療、中醫以及眼科護理等。

### 3. 中國內地臨床醫療保健服務

我們的中國內地臨床醫療保健服務目前 包括(i)體檢業務:及(ii)在我們擁有及經 營的診所內提供選定門診服務(如家庭 醫學服務)。

### **BUSINESS REVIEW**

The financial year 2025 was a period of significant transition and strategic resilience for the Group. Operating within a complex and uncertain macroeconomic landscape, our corporate healthcare solution services business successfully navigated headwinds by capitalizing on core defensive strengths and executing targeted growth initiatives. The heightened demand for value-driven employee benefits, coupled with our ability to deliver integrated, cost-effective healthcare plans management, resulted in satisfactory year-on-year growth in both revenue and profitability.

While we navigated a normalizing demand for immigration medical services and a softer macroeconomic climate impacting our clinical services, our focused execution on cost control and operational efficiency yielded a robust improvement in our core operating profitability.

We are particularly encouraged by the successful ramp-up of our newly established medical imaging centres from the previous financial year, which are now contributing positively and represent a key growth vector for the future. Our performance this year underscores the strength of our diversified business model and our management's ability to adapt to evolving market conditions.

## Hong Kong & Macau Corporate Healthcare Solution Services ("UMP Healthcare Solutions")

In 2025, our UMP Healthcare Solutions and Macau achieved a commendable revenue increase of 4.2% and an increase in operating profit of 13.7%, despite a 5.5% decrease in user volume, demonstrating efficient and effective cost control in operation.

### (i) Challenging Macroeconomic Environment

The Hong Kong economy in FY2025 was characterized by significant volatility, influencing corporate decision-making and operational priorities. Key environmental factors included:

 Corporate Cost Sensitivity: Widespread economic uncertainty led corporations to scrutinize all operational expenditures intensely.

### 業務回顧

2025財政年度對本集團而言是一個重要的轉型與策略韌性構築時期。在複雜且不確定的宏觀經濟環境下,我們的企業醫療保健解決方案業務憑藉其核心防禦優勢並通過執行針對性的增長策略,成功抵禦逆境。隨著對價值導向僱員福利的需求日益提升,結合我們提供全面及具成本效益的醫療保健計劃管理的能力,集團在收入及盈利能力方面均錄得理想的按年增長。

儘管移民體檢服務需求逐步正常化以及臨床 服務受宏觀經濟環境漸趨疲軟影響,我們通 過專注於落實成本控制及營運效率措施,顯 著改善核心營運盈利能力。

我們於去年財政年度新開設的醫學影像中心 已於今年逐步全面正常營運,該等中心已開 始帶來正面貢獻,並成為未來增長的關鍵支 柱。本年度的表現突顯了我們多元化商業模 式的優勢,以及管理層適應動態市場環境的 能力。

### 香港及澳門企業醫療保健解決方案服務 (「聯合醫務醫療保健解決方案」)

於2025年,我們的聯合醫務醫療保健解決方案在用戶數量下跌5.5%的情況下,仍然實現4.2%的收入可觀增長及13.7%的經營利潤增長,顯示具效益及效率的營運成本控制。

### (i) 充滿挑戰的宏觀經濟環境

香港經濟於2025財政年度呈現顯著波動,影響企業決策及營運重心。主要的環境因素包括:

 企業成本敏感度:廣泛的經濟不確 定性促使企業嚴格審視所有營運 支出。

- Talent Retention Challenges: Despite economic pressures, the competition for top talent remained fierce.
   Companies identified comprehensive benefits packages as a critical differentiator to attract and retain capable employees without solely relying on salary increases.
- Shift in Healthcare Consumption: We observed a marked increase in the utilization of insured healthcare plans by members. This behavioral shift, a flight to quality and security during uncertain times, drove volume into our network and related clinical services.

These factors created a dual challenge: the need for cost containment on one hand, and the necessity of investing in human capital on the other. Our business model is uniquely positioned at this intersection.

The UMP Healthcare Solutions delivered encouraging financial results, exceeding initial projections.

- Revenue Growth: We achieved high-single-digit revenue growth, primarily driven by increased utilization of our comprehensive healthcare plans and a surge in demand for related clinical medical services within our network.
- Profitability Expansion: Through operational efficiencies and the scalable nature of our TPA platform, profit margins expanded. The complementary nature of our diverse product portfolio ensured that weakness in any single segment was offset by strength in others, showcasing the strategic value of our integrated model.

### (ii) Strategic & Operational Achievements

• **Product Portfolio Optimization:** We successfully launched enhanced and modular plan options designed for various industries and company sizes. This "tailor-made" approach allowed clients to enrich employee benefits (e.g. adding mental health support, telehealth) while maintaining strict control over their benefits budget.

- 人才挽留挑戰:儘管經濟壓力存在,惟對頂尖人才的競爭依然激烈。企業視全面的福利計劃(而非僅依賴薪資增長)為吸引及挽留優秀員工的關鍵差異化因素。
- **醫療保健消費轉變**:我們觀察到醫療保險計劃的會員對服務的使用顯著增加。這種行為轉變反映大眾在不確定時期對優質及安全醫療服務的追求,推動我們網絡及相關臨床服務的用量增加。

上述因素形成雙重挑戰:既需控制成本,又需投資於人力資本。我們的商業模式在這關鍵節點展現獨特優勢。

聯合醫務醫療保健解決方案的財務業績 令人鼓舞,超出初步預期。

- **收入增長**:我們錄得高單位數收入 增長,主要歸因於我們的全面醫療 保健計劃的用量增加,以及網絡相 關臨床醫療服務需求的顯著上升。
- **盈利能力提升**:透過提升營運效率 及利用我們第三方管理平台的規 模效應,我們成功擴大利潤率。我 們的多元化產品組合所具備的互 補性確保單一分部的弱點可由其 他分部的優勢彌補,體現我們綜合 模式的戰略價值。

### (ii) 策略與營運成就

• **產品組合優化**: 我們成功推出針對 不同行業及企業規模的更強大模 組化計劃方案。此「量身定制」方 式使客戶能夠加強僱員福利(例如 增加心理健康支持、提供遠程醫 療),同時嚴格控制福利預算。

- Ecosystem Development: Our strategy is to build a
  one-stop healthcare ecosystem advanced significantly.
  We expanded our roster of strategic business partners
  beyond core insurance providers to include wellness tech
  firms, specialist outpatient centres and pharmaceutical
  providers.
- Third-Party Administration (TPA) Strengthening: Investments in our TPA platform yielded greater operational efficiency, faster claims processing and enhanced data analytics capabilities. This not only improved the member experience but also provided our corporate and insurance partners with valuable insights into healthcare trends and cost drivers.

### (iii) Core Growth Strategies & Value Proposition

Our success was underpinned by a clear value proposition: delivering personalized, efficient, and high-quality healthcare solutions that reduce long-term cost while improving health outcomes.

- Deep Client Engagement & Solution Customization: We moved beyond a transactional relationship model. Through dedicated client management teams, we engaged in proactive consultations to understand the unique demographics and needs of each client's workforce. This allowed us to co-create bespoke plans that maximized the perceived value of benefits for employees while optimizing the cost structure for the employer.
- Building an Integrated Healthcare Ecosystem: Our vision is to become the central hub for corporate healthcare in the region. In FY2025, we focused on creating a seamless user journey by integrating services across the continuum of care— from prevention and wellness (e.g., health screenings, vaccinations) to treatment (clinical services) and recovery. This ecosystem approach enhances member loyalty, improves health outcomes, and creates multiple and synergistic revenue streams for our business.

- 生態系統拓展:打造一站式醫療生態系統的策略取得顯著進展。我們擴大了與核心保險供應商以外的策略業務夥伴合作名單,新增健康科技公司、專科門診中心及製藥供應商。
- 第三方管理強化: 通過投資第三方管理平台,我們提升了營運效率、加快理賠處理速度,並增強數據分析能力。此舉不僅改善會員體驗,亦為企業及保險公司合作夥伴提供有關醫療保健趨勢及成本驅動因素的寶貴洞察。

### (iii) 核心增長策略與價值主張

我們的成功建基於明確的價值主張: 提供個性化、高效及優質的醫療保健解 決方案,以降低長期成本並改善健康成 果。

- 深層客戶關係與定制化解決方案: 我們放棄交易型關係模式,通過專 屬客戶管理團隊,主動查詢並了解 每名客戶的獨特勞動力特徵及需 求。這使我們能夠共同創建定制化 計劃,為僱員爭取最大的福利感知 價值,同時為僱主優化成本結構。
- 構建綜合醫療保健生態系統:我們的願景是成為區內企業醫療保健的中心樞紐。於2025財政年度,我們專注於提供一系列從預防及養生(例如健康篩查、疫苗接種)到治療(臨床服務)及康復的綜合性醫療服務,創造無縫用戶體驗。此生態系統增強會員忠誠度,改善健康成果,並為我們的業務創造多重協同收入來源。

### (iv) Challenges & Risk Mitigation

The primary challenge encountered was a reduction in corporate headcounts within certain sectors, which temporarily affected enrolment-based products. Our mitigation strategy involved:

- *Upselling and Cross-Selling:* Engaging existing clients to enhance their plans for remaining employees, thereby maintaining per-member revenue.
- Focus on SME Market: Increasing our focus on the small and medium enterprise sector, which showed resilient growth and a strong appetite for structured benefits packages.

### (v) Provision of Cross-Border Medical Services for Insurance Scheme Members

The full reopening of borders between Hong Kong and Chinese Mainland in late 2024 and throughout 2025 unleashed pent-up demand from Mainland residents seeking high-quality, specialized medical services in Hong Kong.

- Pent-Up Demand: Many insurance scheme members deferred elective procedures and specialist consultations during border closures. FY2025 saw a significant catch-up effect.
- Preferred Provider Network: UMP's extensive and curated network of premium healthcare providers in Hong Kong (including leading specialists, hospitals, and diagnostic centres) was a critical competitive advantage. Insurers and corporate clients leveraged this network to offer value-added services to their high-net-worth employees and clients.
- Seamless Service Integration: UMP's role as a Third-Party
  Administrator (TPA) allowed it to offer an integrated
  solution encompassing provider search, appointment
  booking, guarantee of payment and claims settlement,
  making the process hassle-free for Mainland patients.

### (iv) 挑戰與風險緩解

我們面對的首要挑戰是若干行業企業員 工人數減少,導致對入院類產品造成暫 時性影響。我們的緩解策略包括:

- 追加銷售與交叉銷售:鼓勵現有客戶為其餘下僱員增強計劃,藉此維持每會員收入。
- 聚焦中小企業市場:中小企業市場 展現穩健增長及對結構化福利計 劃的強烈需求,故我們加大對中小 企業市場的關注。

### (v) 為保險計劃會員提供跨境醫療服務

隨著2024年底至2025年香港與內地邊境全面重開,內地居民對香港優質及專業醫療服務的積壓需求得以釋放。

- 積壓需求:邊境關閉期間,許多保險計劃會員推遲非急需手術及專科診症。2025財政年度呈現明顯的追趕效應。
- **優選醫療網絡**:聯合醫務擁有一大 關鍵競爭優勢一在香港擁有廣泛及 精心挑選的優質醫療保健提供者 網絡(包括頂尖的專科醫生、醫院 及診斷中心)。保險公司及企業客 戶利用該網絡為其高淨值僱員及 客戶提供增值服務。
- 無縫服務整合:聯合醫務發揮其第 三方管理人的角色,提供包括服 務提供者檢索、預約診症、付款保 證及理賠索償在內的綜合解決方 案,為內地患者提供無憂體驗。

### (vi) Partnership Development of TPA Service in Chinese Mainland

- B2B2C Model Expansion: UMP successfully partnered
  with several major Mainland insurers to white-label or
  integrate its TPA services into their health insurance
  products. This provides the insurers with a sophisticated
  healthcare management solution, enhancing their product
  attractiveness.
- Greater Bay Area ("GBA") Integration: The Company made significant progress in aligning its service protocols with the evolving policies for integrating healthcare within the GBA. This includes facilitating easier access for Hong Kong-based employees of Mainland firms to healthcare in Chinese Mainland through designated networks.
- Technology Deployment: Continued investment in digital platforms to streamline the authorization and claims process for these cross-border partnerships, improving efficiency and user experience.

## (vii) Speed Up Digitalisation & Launch of E-Pre-approval Platform

A key strategic initiative was the acceleration of our digital transformation. A major milestone was the **development and launch of a new e-pre-approval platform**. This digital solution significantly streamlines the claims process for members, reduces administrative overhead for corporate clients, and improves operational efficiency on our end. It represents a critical step towards a fully digitized, seamless user experience.

## (viii) Leverage Low Manpower Cost in Greater Bay Area as Backend Support Base

To enhance our competitive advantage and operational efficiency, we have begun strategically **utilizing the GBA** as a backend supporting base. This initiative allows us to leverage the region's cost-effective, high-quality talent pool for functions such as data processing, claims administration, and customer service support. This not only reduces operational costs but also improves our service scalability.

### (vi) 在中國內地合作發展第三方管理服 務

- 企業對企業再對消費者(B2B2C)模式擴展:聯合醫務成功與多間內地主要保險公司合作,將其第三方管理服務以白標方式外包或整合至該等保險業者的健康保險產品。這為保險公司提供先進的醫療保健管理解決方案,並增強其產品吸引力。
- **粵港澳大灣區(「大灣區」)整合**: 本公司在推動其服務配合大灣區 醫療保健整合政策方面取得顯著 進展。此包括促進內地企業的香港 僱員通過指定網絡更輕鬆地獲得 中國內地醫療服務。
- **技術部署**:持續投資於數碼平台, 簡化跨境合作的授權及理賠程序, 提升效率及用戶體驗。

### (vii) 加快數碼化與電子預先批核平台的 推出

加速數碼轉型是我們的關鍵策略舉措。 本年度的重大里程碑是**開發並推出新的電子預先批核平台**。該數碼解決方案顯著簡化會員理賠程序,降低企業客戶的行政開支,並提升我們的營運效率。此舉標誌著邁向全面數碼化及無縫用戶體驗的關鍵一步。

## (viii) 利用大灣區低人力成本作為後台支持

為增強競爭優勢及營運效率,我們已開始策略性地**利用大灣區作為後台支持**。 這項策略使我們能夠依託該區的高成本效益及優質人才庫,支持數據處理、理 賠管理及客戶服務等功能。此舉不僅降 低營運成本,亦提升我們服務的可擴展 性。

### Hong Kong & Macau Clinical Healthcare Services

In the past year, our Clinical Healthcare Services in Hong Kong and Macau reported a revenue decrease of 4.3%, while operating profit saw an increase of 16.4%. This stark contrast can be attributed to lower costs for staffing, medical supplies, rental charges and facility maintenance.

Our clinical medical services arm worked in synergy with our corporate solutions business. The strategic focus for FY2025 was on operational excellence, cost optimization, and aligning with government healthcare initiatives to ensure sustainable profitability. This delivered stable and profitable growth in FY2025. The performance was bolstered by a combination of organic growth from existing centres and contributions from newly acquired or opened facilities.

- Same-Clinic Sales Growth: Existing multi-specialty medical centres reported strong patient volumes, driven by both corporate client referrals and direct private pay patients. Specialized services like orthopedics, diagnostics, and preventive health screenings were in high demand.
- Strategic Acquisitions & Openings: The Company continued its "buy-and-build" strategy, selectively acquiring high-quality clinics and opening new centres in strategic locations. This expanded its physical footprint and deepened its service offerings.
- **Synergy Realization:** The clinical arm benefited strongly from referrals from the Corporate Solutions segment, creating a virtuous cycle. Patients from corporate schemes and cross-border services often utilize UMP's own clinics, ensuring revenue is captured internally.

## (i) Revisit Workflow for Operational Efficiency & Cost Saving

We conducted a comprehensive review of operational workflows across our medical and imaging centres. By re-engineering processes, we identified significant opportunities to save operating costs. This includes optimizing staff rostering to reduce manpower costs, implementing stricter inventory controls to reduce consumable waste, and introducing more effective drug management systems to minimize expiry and overstocking.

### 香港及澳門臨床醫療保健服務

過去一年,集團旗下香港及澳門的臨床醫療保健服務錄得4.3%的收入減少,但經營利潤上升16.4%。如此強烈的對比,主要受員工、醫療用品、租金費用及設施保養的成本下跌所致。

我們的臨床醫療服務部門與企業解決方案業務協同運作。2025財政年度的策略重點聚焦於卓越營運、成本優化及與政府醫療保健計劃對接,以確保可持續的盈利能力。此部門於2025財政年度實現穩定且具盈利性的增長。業務表現得益於現有中心的自然增長以及新收購或新開設設施的貢獻。

- *同店銷售增長*:在企業客戶轉介及直接 私人付費患者的帶動下,現有跨專科醫 療中心錄得強勁的患者流量。骨科、診 斷及預防性健康篩查等專科服務的需求 尤為殷切。
- 策略性收購與開設:本公司繼續實施 「買入並建設」策略,選擇性收購優質診 所,並在策略性位置開設新中心。此舉 擴大公司的實體覆蓋範圍,並深化其服 務範疇。
- 協同效應實現:臨床部門從企業解決方案分部的轉介中顯著受益,形成良性循環。來自企業計劃及跨境服務的患者經常使用聯合醫務的自家診所,確保捕獲內在收入。

### (i) 重新審視工作流程,以提升營運效 率及節省成本

我們全面審視了醫療及影像中心的營運流程。通過流程再造,我們發現可顯著節省營運成本的辦法。此包括優化員工排班,以降低人力成本;實施更嚴格的庫存控制,以減少耗材浪費;及引入更有效的藥品管理系統,以減少過期及過量庫存。

### MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

### (ii) Medical Examination Services (Immigration)

As anticipated, revenue from this segment normalized following the peak cycles of past years. The business has stabilized at a sustainable baseline level, with operational focus placed on maintaining service quality and efficiency.

### (iii) Clinical Healthcare Services

Revenue in this segment experienced softness due to the weak economic environment, which led to deferred discretionary healthcare spending by consumers. We have responded by enhancing our service packages and promoting essential care to maintain patient engagement.

### (iv) Consolidation of Medical and Imaging Centres

This segment emerged as a standout performer. The newly established centres are now fully operational and have gained strong market traction. Their growing contribution is a validation of our expansion strategy and investment in advanced diagnostic technology. To address the high-cost environment, we executed a strategy to consolidate several medical and imaging centres. This involved merging adjacent services into larger, more efficient hubs. This consolidation has led to a direct reduction in rental charges and allowed for a more efficient allocation of staff, reducing overall staff costs while maintaining service accessibility.

### (v) Replacement of New Clinical Medical System

We initiated a project to replace our legacy clinical medical system with a new, integrated platform. This new system is designed to significantly improve customer service through a more intuitive booking system, enhance drug management and inventory tracking, and facilitate better patient record management. This investment is crucial for improving long-term efficiency and service quality.

### (vi) Participation in Government Tenders

We actively increased our participation in government tender exercises for providing outsourced medical and diagnostic services. This strategy diversifies our revenue sources, ensures higher utilization of our advanced equipment, and strengthens our brand reputation as a trusted public service partner.

### (ii) 體檢服務(移民體檢)

誠如預期,本分部的收入於過去數年達 到高峰後回復正常。業務已穩定在可持 續的基線水平,其營運重點放在維持服 務質素及效率。

### (iii) 臨床醫療服務

由於經濟環境疲弱,消費者推遲非必要 醫療支出,導致本分部收入略顯疲軟。 為此,我們通過優化服務方案及推廣基 礎醫療護理,以維持患者關係。

### (iv) 醫療及影像中心整合

本分部表現亮眼。新設立的中心已全面 投入營運,並獲得市場高度認可。其穩 步增長的貢獻足證我們的擴張策略及對 先進診斷技術的投資奏效。為應對醫院 本環境,我們執行了一項整合多間醫 及影像中心的策略,將相鄰服務合併成 更大、更高效的綜合中心。此舉直接 低租金成本,並容許更有效率的員下 配,在維持服務可及性的同時降低整體 員工成本。

### (v) 更換為新的臨床醫療系統

我們啟動了將舊有臨床醫療系統更換為全新整合平台的計劃。新系統旨在通過更直觀的預約界面,更強大的藥品管理及庫存追蹤功能,以及更優化的患者記錄管理,以顯著提升客戶服務體驗。此項投資對提升長期效率及服務質素相當關鍵。

### (vi) 參與政府招標

我們積極參與政府外包醫療及診斷服 務的招標。此策略有助分散我們的收入 來源,確保我們的先進設備有更高使用 率,並增強我們作為公共服務可靠合作 夥伴的品牌聲譽。

### (vii) Benefit from Government Fiscal Policy

We positioned our services to benefit from the government's fiscal policy of increasing public hospital service charges. As public hospital fees rise, our services become a more competitively priced and efficient alternative for both private patients and corporate clients, making our offerings more attractive and driving volume to our centres.

## (viii) Align with Government Healthcare Management Blueprint

In line with the government's blueprint to promote domestic healthcare management, we developed and launched community-based health programs. These initiatives focus on promoting local district healthcare management, including health screenings, vaccination drives, and chronic disease education. This aligns our business with public policy goals, enhances our corporate social responsibility profile, and drives patient volume into our ecosystem.

Financial performance, as affected by the overall downturn and uncertain business environment, reflects both the challenges and opportunities within our service offerings. In particular:

- In our medical sector, general practice (GP) services experienced a slight decrease of 7.2% in revenue. For Immigration Medical Examinations (IME), revenue adjusted downward, resulting in a significant drop in its contribution to the overall revenue reflecting the adjustment to more normalized service demand level. On a positive note, no significant drop in specialist practice (SP) revenue was noted, indicating strong demand and the fact that UMP remains the chosen provider in this area.
- The dental sector has a mild drop of 1.8% in revenue with a slightly decrease of about 8% in number of visits. It has been obvious to the local dental care market faced challenges due to shifts in living patterns and changing demand for complex dental care services. As more patients seek dental treatments in Shenzhen, we must carefully navigate this evolving landscape. We are actively adjusting our operational efficiency to ensure we maintain our profit contributions amid these changes. Maintaining a strong relationship with our patient base is crucial, and we are committed to providing quality care that meets their needs, even in a competitive environment.

### (vii) 從政府財政政策中受益

我們調整我們的服務定位,以從政府上調公立醫院服務收費的財政政策中受益。隨著公立醫院費用上調,我們的服務對私人患者及企業客戶更具價格競爭力,成為更具吸引力的替代選擇,吸引更多患者選擇我們的中心就診。

### (viii)與政府醫療管理藍圖對接

為配合政府促進本地醫療管理的藍圖, 我們制定並推出以社區為本的健康計 劃。該等計劃聚焦於推動本地醫療管 理,包括健康篩查、疫苗接種及慢性病 教育。該等計劃與公共政策目標一致, 提升我們的企業社會責任形象,並帶動 患者流量進入我們的生態系統。

財務表現受整體下行及營商環境不確定性的 影響,反映我們的服務同時面臨著挑戰與機 遇。特別是在以下分部:

- 在門診分部中,普通科服務的收入輕微減少7.2%。移民體檢帶來的收入下調, 導致其對整體收入的貢獻顯著減少,反映服務需求水平調整至更正常水平。從正面的角度來看,專科醫療的收入並無顯著下滑,顯示需求強勁,而且聯合醫務仍是此一領域的首選服務提供者。
- 牙科分部的收入輕微下降1.8%,而就診 人次則下跌約8%。由於生活模式的轉 變和對牙科進階治療服務需求的變化, 本港牙科醫療市場顯然正面對挑戰。隨 著越來越多患者到深圳尋求牙科治療, 我們必須小心應對不斷變化的形勢。我 們正積極調整經營效率,以確保在這些 變化中保持利潤貢獻。與患者維持良好 關係至關重要,即使在競爭激烈的環境 中,我們仍致力提供滿足患者需求的優 質醫療服務。

- Our imaging centres have ramped up operations significantly, resulting in increased revenue of 4.5%. This growth is especially important given the competitive market, where margin pressures are prevalent. Our investment in advanced technology in previous years has enhanced our diagnostic capabilities and improved patient throughput. While the depreciation of capital expenditures poses a challenge, we are confident that our strategic investments will yield positive contributions in the long run. By continuously optimizing our processes and expanding our service offerings, we aim to solidify our position in the imaging sector, ensuring that we meet the growing demand for high-quality diagnostic services.
- 影像中心業務營運迅速提升,使收入增加4.5%。考慮到因為市場競爭激烈使利潤普遍受壓,使這種增長十分重要。我們過去幾年在先進技術上的投資,增強了我們的診斷能力,並提高了患者周轉量。雖然資本開支的折舊帶來挑戰,但我們相信策略性投資將帶來長遠正面的貢獻。透過持續改善流程和擴大服務範圍,我們期望可以鞏固在影像市場的地位,確保滿足對高品質診斷服務不斷增長的需求。

### (ix) One-off Profit guarantee gain in FY2024

In July 2024, we announced that we have concluded a settlement deed for a profit guarantee shortfall receivable amounted to HK\$18 million related to our dermatology specialty business, SkinCentral. This receivable was part of our strategic initiative to enhance our dermatological service delivery and operational performance. Since carrying value of such profit guarantee financial assets have been confirmed and valued as at 30 June 2024, the Group has recognised a gain of profit guarantee in FY2024. There was no such gain in FY2025.

### **Chinese Mainland Clinical Healthcare Services**

The year 2025 presented a complex operating environment for UMP's clinical healthcare services in Chinese Mainland. The dual impact of an economic downturn and escalating geopolitical tensions significantly affected the immigration landscape. As a result, the demand for Immigration Medical Examination (IME) services experienced a marked decline across the regions.

Despite these headwinds, UMP remained agile and proactive in navigating the shifting market dynamics.

### (i) Strategic Adjustments & Operational Enhancements

In response to the economy downturn, UMP undertook a comprehensive review of its operational workflows and service delivery models. Key initiatives included:

 Workflow Optimization: Streamlined internal processes to enhance service efficiency and reduce turnaround times.

### (ix) 2024財政年度一次性的保證溢利收

於2024年7月,我們公告已就有關皮膚專科業務「SkinCentral」的應收保證溢利短欠付款,簽訂1,800萬港元的結算契據。此項應收款項乃增強皮膚科服務及經營表現的策略性舉措之一。該保證溢利金融資產的賬面值已於2024年6月30日予以確認及估值,故此本集團於2024財政年度已確認溢利保證收入。於2025財政年度並沒有此收入。

### 中國內地臨床醫療保健服務

2025年對聯合醫務在中國內地的臨床醫療保健服務而言是營商環境複雜的一年。經濟下行與日益升級的地緣政治緊張局勢的雙重效應顯著影響了移民格局。因此,移民體檢服務的需求在多個地區均顯著下降。

儘管面臨這些困難,聯合醫務保持靈活及主 動性,以積極應對瞬息萬變的市場動態。

### (i) 策略調整與營運提升

為應對經濟下行,聯合醫務對其營運流 程及服務交付模式進行全面審視。主要 舉措包括:

流程優化:簡化內部程序以提升服務效率並縮短處理時間。

• **Strategic Partnerships:** Engaged with reputable medical partners for example, a reputable hospital, to strengthen service capacity and broaden referral networks.

• **建立策略合作關係**:與知名醫療機 構夥伴(例如某知名醫院)合作, 以加強服務能力及擴大轉介網絡。

### (ii) Expansion & Regional Diversification

While maintaining strong operations in Shanghai and Beijing, UMP strategically expanded its footprint to GBA, e.g. Guangzhou in 2025. This new cooperative business arrangement was specifically designed to support the IME segment, offering:

- Enhanced regional coverage for immigration-related medical services
- Greater accessibility for clients in Southern China
- Diversification of revenue streams and risk mitigation

The Guangzhou initiative has already shown promising signs of growth and complements UMP's broader strategy of regional resilience.

### (iii) Strategic Response to Policy Shifts

In alignment with evolving government healthcare policies emphasizing community-based care, early intervention, and chronic disease management, UMP proactively explored new avenues in primary healthcare and preventive medicine. Recognizing the strategic importance of GBA as a high-growth region with increasing demand for accessible and quality healthcare, UMP initiated a bold expansion plan.

### (iv) Establishment of New Medical Centre in GBA

In 2025, UMP officially commenced the development of a new primary healthcare medical centre in the GBA. This facility is designed to serve as a regional hub for integrated care, offering:

- Comprehensive Primary Care Services: Family medicine, chronic disease management, and health screenings
- Preventive Health Programs: Vaccination, lifestyle counseling, and wellness initiatives

### (ii) 擴張與區域多元化

在維持上海及北京強勁營運的同時,聯合醫務策略性地將業務版圖擴展至大灣區,例如於2025年進軍廣州。新的合作業務安排乃專為支持移民體檢分部而設,其提供:

- 更大的移民相關醫療服務地域覆蓋
- 更高的華南地區客戶可及性
- 多元化收入來源及風險緩解

廣州業務已顯示出令人鼓舞的增長跡 象,補充了聯合醫務在提高區域韌性方 面的更廣泛策略。

### (iii) 對政策變化的策略應對

為配合政府強調社區醫療、早期療育及 慢性病管理的醫療政策演變,聯合醫務 積極探索基層醫療及預防疾病的新路 徑。意識到大灣區這個高增長地區對可 及和優質的醫療保健需求的增加,聯合 醫務展開了一項大膽的擴張計劃。

### (iv) 在大灣區設立新醫療中心

於2025年,聯合醫務正式展開在大灣區 建設新的基層醫療中心。該設施旨在成 為提供整全護理的區域中心,提供:

- **全面基層醫療服務**:家庭醫學、慢性病管理及健康篩查
- 預防疾病健康計劃:疫苗接種、生活型態輔導及康健活動

• **Digital Health Integration:** Telemedicine, electronic health records, and mobile health platforms

This expansion marks a significant milestone in UMP's commitment to population health management and long-term sustainability.

### **OUTLOOK**

FY2025 was a year of exceptional performance and strategic consolidation for the Corporate Healthcare Solutions division. By understanding the market's evolving needs and responding with innovative, efficient and high-value solutions, we have strengthened our market leadership position. We are confident that our proven business model and clear strategic roadmap will enable us to continue delivering sustainable growth and value to all stakeholders in FY2026 and beyond.

The Group is confident in the long-term strategic development in the Chinese Mainland healthcare market. While it may not be a major profit contributor in FY2025, its successful development is crucial for future diversification and growth. The expertise gained here also directly enhances and supports the cross-border TPA business. While the revenue contribution from this nascent segment may still be building, the partnerships secured in FY2025 lay a critical foundation for future, high-margin revenue streams as these insurance products gain traction. The strategy of building a comprehensive owned-clinic network is expected to continue, enhancing control over service quality, patient journey and profitability.

Looking ahead to FY2026, we remain cautiously optimistic. The economic environment continues to present challenges, but the fundamental demand for quality healthcare in Hong Kong remains strong. Our priorities are:

### (i) Cost-Efficient Operating Model

To continue leveraging our cost-efficient operating model to protect profitability. To explore selective organic growth opportunities that align with our core competencies and promise sustainable returns. To remain agile and ready to capitalize on any market recovery or new demand catalysts, including potential shifts in immigration policy.

數碼健康整合:遠程醫療、電子健康記錄及流動健康平台

這一擴張標誌著聯合醫務在人口健康管理及長遠可持續發展方面的重大里程 碑。

### 展望

2025財政年度是企業醫療保健解決方案分部取得優異成績與策略整合的一年。通過理解市場不斷變化的需求並以創新、高效及高價值的解決方案回應,我們鞏固了我們的市場領導地位。我們有信心,我們行之有效的商業模式及清晰的策略路線圖將帶領我們於2026財政年度及往後繼續為所有持份者創造可持續增長及價值。

本公司對中國內地醫療保健市場的長遠戰略發展充滿信心。儘管其於2025財政年度未必能成為主要利潤貢獻者,惟其成功發展對門門的未來多元化佈局與增長至關重要。支持第三方管理業務的發展。雖然該新興年度,但於2025財政年度,也於2025財政年度之立的合作夥伴關係已為未來奠定關鍵收,預計會於一個,隨著這些保險產品獲得市場認可,以加強財政治的,以加強對服務質素、患者體驗及盈利能力的控制。

展望2026財政年度,我們保持謹慎樂觀。經濟環境繼續帶來挑戰,但香港對優質醫療保健的基本需求依然強勁。我們的優先任務包括:

### (i) 具成本效益的營運模式

繼續利用具成本效益的營運模式以保護盈利能力,探索與我們的核心優勢一致及可帶來可持續回報的優質自然增長機遇,保持靈活性並時刻準備把握任何市場復甦或新需求風口,包括潛在的移民政策變化。

### (ii) Digital Transformation

Launch a comprehensive member mobile app to facilitate easier access to services, telemedicine consultations and personalized health tracking. Further leverage our data analytics to provide clients with predictive insights on healthcare trends, helping them make more informed decisions about their benefits strategies.

### (iii) Geographic & Service Expansion

Explore selected opportunities to expand our service model to other key markets in the Asia-Pacific region and introduce new service lines, such as advanced mental health and chronic disease management programs. Continue to advocate for and design plans that promote preventive care, which is the most sustainable method of controlling long-term healthcare costs for our clients and the system at large.

The Board wishes to thank our dedicated staff, loyal customers, and shareholders for their continued support during this transformative year.

Looking ahead, UMP remains committed to delivering high-quality clinical healthcare services while adapting to evolving market conditions. Continued investment in partnerships, technology, and regional expansion will be key pillars of growth and sustainability.

#### Revenue

During FY2025, we primarily generated revenue from (i) the provision of corporate healthcare solutions to Contract Customers in Hong Kong and Macau, (ii) the provision of clinical healthcare services to Self-paid Patients in Hong Kong and Macau and (iii) the provision of clinical healthcare services in Chinese Mainland.

During the period under review, the Group reported a total revenue of approximately HK\$726.9 million, represented a decrease of 2.9% as compared to that of FY2024. Such decrease was mainly attributable to the increase in revenue from corporate healthcare solutions business but offset by the significant drop in volume of Immigration Medical Examinations (IME) and the decrease in revenue from clinical medical service.

### **Professional Services Expenses**

Professional services expenses is one of the key operating expense which primarily comprise fees paid to Doctors, Dentists and Auxiliary Services Providers for Medical Services, Dental Services, medical imaging and laboratory services and Auxiliary Services rendered within the UMP Network, as well as fees paid to third party laboratories and medical imaging centres for services rendered to the Group.

Professional services expenses in FY2025 decreased by approximately HK\$13.9 million, representing an decrease of 5.1% as compared to that in FY2024. Professional services expenses maintained at 35.4% to the total revenue (FY2024: 36.1%). The decrease in professional services expenses was due to decrease in the cost of services rendered by doctors, dentists and other professionals as a result of increase in operation efficiency.

### 財務回顧

2025財政年度與2024財政年度比較

#### 收入

於2025財政年度,我們的收入主要來自(i)於香港及澳門向合約客戶提供企業醫療保健解決方案:(ii)於香港及澳門向自費患者提供臨床醫療保健服務及(iii)於中國內地提供臨床醫療保健服務。

於回顧期間,本集團錄得總收入約726.9百萬港元,較2024財政年度減少2.9%。該減少主要由於企業醫療保健解決方案業務收入雖然增加,但被移民體檢的用量大幅下降及臨床醫療服務收入減少所抵銷。

#### 專業服務費用

專業服務費用乃主要經營開支之一,主要包括就醫生、牙醫及輔助服務提供者於UMP網絡內提供的醫療服務、牙科服務、醫學影像及化驗服務以及輔助服務而向其支付的費用,以及就第三方化驗及醫學影像中心向本集團提供的服務而向其支付的費用。

2025財政年度專業服務開支減少約13.9百萬港元,較2024財政年度減少5.1%。專業服務開支維持於佔總收入的35.4%(2024財政年度:36.1%)。專業服務開支減少乃由於營運效率上升以致相對醫生、牙醫及其他專業人員提供服務的成本減少。

### **Employee Benefit Expense**

Employee benefit expense primarily comprise salaries and related costs, equity-settled share-based payment expense, as well as pension scheme contributions for nurses and administrative personnel, and also include those of the Directors and key management personnel.

Employee benefit expenses in FY2025 recorded an amount of approximately HK\$180.0 million, representing a decrease of approximately HK\$17.0 million and 8.6% as compared to that in FY2024. Employee benefit expenses principally included staff costs for clinical medical service frontline staff and the corporate staff expenses. Employee benefit expenses represented at about 24.8% to the total revenue (FY2024: 26.3%). The decrease in employee benefit expenses was attributable to the workforce optimization and the percentage of employee benefit expenses to the total revenue was maintained at a reasonable range.

## Earning before Interest, Tax, Depreciation and Amortisation ("EBITDA")

During the year ended 30 June 2025, the Group reported an EBITDA of approximately HK\$87.0 million, represented an increase of 2.7% as compared to approximately HK\$84.8 million in FY2024. Excluding impairment of goodwill and investments as well as one-off gain, the Group core business reported an EBITDA ("Adjusted EBITDA") of approximately HK\$94.9 million (FY2024: HK\$78.4 million), which represented an increase of 21.1% from FY2024. Such increase in EBITDA was mainly attributable to improvement in operation efficiency and the decrease in various operating costs.

### 僱員福利開支

僱員福利開支主要包括護士及行政人員以及 董事及主要管理人員的薪金及相關成本、以 權益結算的股份支付開支以及退休金計劃供 款。

2025財政年度僱員福利開支錄得約180.0百萬港元,較2024財政年度減少約17.0百萬港元及8.6%。僱員福利開支主要包括臨床醫療服務前線員工的員工成本以及企業員工開支。僱員福利開支佔總收入約24.8%(2024財政年度:26.3%)。僱員福利開支減少乃由於人員編制優化,而僱員福利開支佔總收入百分比維持在合理範圍內。

### 未計利息、税項、折舊及攤銷前的利潤 (「EBITDA」)

於截至2025年6月30日止年度,本集團錄得EBITDA約87.0百萬港元,較2024財政年度約84.8百萬港元增加2.7%。撇除商譽及投資項目減值以及一筆過收益,本集團核心業務錄得EBITDA(「經調整EBITDA」)約94.9百萬港元(2024財政年度:78.4百萬港元),較2024財政年度增加21.1%。EBITDA出現此增幅乃主要由於營運效率的改善及各類經營成本減少所致。

### **Depreciation and Amortisation**

Depreciation and amortisation, which comprises of depreciation of the right-of-use assets and depreciation and amortisation of other non-current assets.

### (i) Right-of-use assets

Depreciation of Right-of-use assets decreased by 13.6% from HK\$71.0 million for FY2024 to HK\$61.4 million for FY2025, which was mainly relating to the completion of lease contracts and reduction of lease contracts as a result of centres consolidation.

### (ii) Property, plant and equipment and intangible assets

Depreciation of property, plant and equipment and intangible assets increased by 6.5% from HK\$41.7 million for FY2024 to HK\$44.4 million for FY2025, which was in line with business development.

### **Other Expenses**

Other expenses primarily comprise provision of impairment loss and general overhead expenses such as utilities, operating and other administrative expenses such as professional fees, repair and maintenance expenses incurred with respect to the Group's offices and medical equipment, printing expenses and bank charges.

Other expenses in FY2025 recorded an amount of approximately HK\$77.9 million, representing an decrease of approximately HK\$3.7 million and 4.5% as compared to that in FY2024. The decrease was mainly attributable to a non-cash one-off write-off of other intangible assets last year. Other expenses represented at about 10.7% to the total revenue (FY2024: 10.9%). The percentage of other expenses to total revenue was maintained at a stable and reasonable range.

### **Net Profit**

During the year ended 30 June 2025, the profit for the year 2025 reported approximately HK\$31.9 million (FY2024: HK\$35.2 million) represented a drop of approximately HK\$3.3 million, 9.4%. The drop in profit for the year was mainly attributable to the drop in revenue and nil recognition of one-off profit from financial assets of profit guarantee offset by the drop in operating costs.

### 折舊及攤銷

折舊及攤銷包括使用權資產折舊以及其他非 流動資產之折舊及攤銷。

### (i) 使用權資產

使用權資產折舊由2024財政年度的71.0 百萬港元減少13.6%至2025財政年度的 61.4百萬港元,這主要與租賃合約完結 以及因整合醫療中心而使租賃合約減少 有關。

### (ii) 物業、廠房及設備及無形資產

物業、廠房及設備及無形資產折舊由 2024財政年度的41.7百萬港元增加 6.5%至2025財政年度的44.4百萬港 元,這與業務發展一致。

### 其他開支

其他開支主要包括減值虧損撥備及日常開銷,例如水電、經營及其他行政開支(例如專業費用、與本集團辦公室及醫療設備相關的維修及保養開支、印刷費及銀行收費)。

2025財政年度的其他開支錄得約77.9百萬港元,較2024財政年度下跌約3.7百萬港元及4.5%。該下跌主要由於去年的非現金一筆過撤銷其他無形資產所致。其他開支佔總收入約10.7%(2024財政年度:10.9%)。其他開支佔總收入百分比維持在穩定合理的範圍內。

#### 淨利潤

於截至2025年6月30日止年度,2025年錄得 利潤約31.9百萬港元(2024財政年度:35.2百 萬港元),下跌約3.3百萬港元、9.4%。年內 利潤下跌乃主要由於收入下跌及並無就保證 溢利金融資產確認一筆過利潤所致,但此獲 經營成本下跌抵銷。

## **KEY FINANCIAL POSITION ITEMS**Right-of-use assets

Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. The recognised right-of-use assets are depreciated on a straight-line basis over the shorter of the estimated useful life and the lease term.

As at 30 June 2025, the right-of-use assets recorded at approximately HK\$96.5 million (FY2024: HK\$107.2 million), the change in FY2025 was result from the additions of new lease amounted to approximately HK\$53.6 million net off to the depreciation charge of approximately HK\$61.4 million. As at 30 June 2025, the right-of-asset represented about 8.8% of the Group's total assets (FY2024: 9.7%).

### Goodwill

Goodwill primarily represents the excess of the aggregate of the consideration over the fair value of the identifiable assets acquired and liabilities assumed. After initial recognition, goodwill is measured at cost less any accumulated impairment losses.

As at 30 June 2025, the goodwill recorded at approximately HK\$156.6 million (FY2024: HK\$164.2 million), the change in FY2025 was result from write-off goodwill. As at 30 June 2025, the goodwill represented about 14.7% of the Group's total assets (FY2024: 14.8%).

# Investments at fair value through other comprehensive income, financial assets at fair value through profit or loss and financial assets at amortised cost

Investments at fair value through other comprehensive income, financial assets at fair value through profit or loss and financial assets at amortised cost primarily represent unlisted equity investments at fair value, listed equity and debt investments at fair value and investment funds. Certain equity investments are designated at fair value through other comprehensive income as the Group considers these investments to be strategic in nature.

## 主要財務狀況項目 使用權資產

使用權資產按成本減去任何累計折舊和任何減值虧損後的金額計量,並就租賃負債的任何重新計量進行調整。使用權資產的成本包括已確認的租賃負債金額、已產生的初始直接成本以及在開始日期或之前已作出的租賃付款減已收到的任何租賃優惠。已確認的使用權資產以直線法按估計可使用年期和租期之較短者計提折舊。

於2025年6月30日,錄得使用權資產約96.5 百萬港元(2024財政年度:107.2百萬港元), 2025財政年度的變動乃由於增訂新租賃約 53.6百萬港元扣除折舊支出約61.4百萬港元 所致。於2025年6月30日,使用權資產佔本 集團總資產約8.8%(2024財政年度:9.7%)。

### 商譽

商譽主要指總代價超出所收購可識別資產及 所承擔負債公允價值的部分。初始確認後, 商譽按照成本減任何累計減值虧損計量。

於2025年6月30日,錄得商譽約156.6百萬港元(2024財政年度:164.2百萬港元), 2025財政年度的變動乃由於撇銷商譽所致。 於2025年6月30日,商譽佔本集團總資產約 14.7%(2024財政年度:14.8%)。

### 按公允價值計入其他全面收入的投資、 按公允價值計入損益的金融資產及按攤 銷成本計量的金融資產

按公允價值計入其他全面收入的投資、按公允價值計入損益的金融資產及按攤銷成本計量的金融資產主要代表按公允價值計量的非上市股本投資、按公允價值計量的上市股本及債務投資及投資基金。若干股本投資已指定為按公允價值計入其他全面收入,原因為本集團認為有關投資屬策略性質。

### (i) Investments at fair value through other comprehensive income

As at 30 June 2025, the investments at fair value through other comprehensive income amounted to approximately HK\$40.3 million (FY2024: HK\$30.5 million), the change in FY2025 was resulted in fair value change of the investment.

### (ii) Financial assets at fair value through profit or loss

As at 30 June 2025, the financial assets at fair value through profit or loss amounted to approximately HK\$38.9 million (FY2024: HK\$41.1 million), the change in FY2025 was resulted in decrease in investment and the fair value change during the year.

As at 30 June 2025, the total value of the investments at fair value through other comprehensive income and the financial assets at fair value through profit or loss represented about 7.2% of the Group's total assets (FY2024: 6.5%).

The Group has historically funded its operations primarily by cash generated from operating activities. Upon the listing of the shares of the Company on the Stock Exchange, the Group intended to satisfy its liquidity requirements using a combination of cash generated from operating activities, net proceeds from the Global Offering and the net considerations received from the series of transactions. As of 30 June 2025, the Group had free cash and bank deposits of approximately HK\$301.1 million (30 June 2024: HK\$253.3 million).

As of the date of this report, the Group did not have any bank borrowings or outstanding bank loans and did not enter into any bank loan facilities.

#### **GEARING RATIO**

The gearing ratio expressed as a percentage of loans from non-controlling shareholders of subsidiaries divided by consolidated total equity of the Group as at 30 June 2025 as about 7.1% (30 June 2024: 7.0%).

#### CAPITAL STRUCTURE

There has been no change in the capital structure of the Company during the year ended 30 June 2025. The capital of the Company comprises ordinary shares and other reserves.

#### SIGNIFICANT INVESTMENTS HELD

Save for the Investments at fair value through other comprehensive income, financial assets at fair value through profit or loss and financial assets at amortised cost held by the Group, as elaborated in further details in the section headed "FINANCIAL REVIEW" of this report, the Group did not hold any significant investment as at 30 June 2025.

### MATERIAL ACQUISITION OR DISPOSAL OF SUBSIDIARIES AND ASSOCIATES

Save as disclosed in this report, there was no material acquisition or disposal of subsidiaries undertaken by the Group during FY2025.

Save as disclosed in this report, the Group did not have any specific future plan for material investments or capital assets as of 30 June 2025.

#### **CAPITAL EXPENDITURE**

The capital expenditure during the year was primarily related to deposits paid for and expenditures on additions of property, plant and equipment for the Group's Medical, Dental, and Auxiliary Services centres. For FY2025, the Group incurred capital expenditure in an aggregate amount of approximately HK\$12.3 million (FY2024: HK\$57.2 million).

#### **INDEBTEDNESS**

#### **Contingent Liabilities**

As at 30 June 2025, the Group did not have any material contingent liabilities.

#### **Capital Commitment**

As at 30 June 2025, the Group has material capital commitments of approximately HK\$6.1 million in relation to the acquisition of property, plant and equipment (FY2024: HK\$3.9 million).

#### TREASURY MANAGEMENT

The Group employs a conservative approach to cash management and risk control. To achieve better risk control and efficient fund management, the Group's treasury activities are centralised.

During FY2025, the Group's receipts were mainly denominated in Hong Kong dollars and Renminbi. Payments were mainly made in Hong Kong dollars and Renminbi. Cash was generally placed in short-term deposits denominated in Hong Kong dollars.

The objective of the Group's treasury policies is to minimise risks and exposures due to the fluctuations in foreign currency exchange rates and interest rates. The Group does not have any significant interest rate risk at present as the Group did not have any bank borrowings or outstanding bank loans and did not enter into any bank loan facilities.

#### 資本開支

年內資本開支主要涉及為本集團的醫療、牙科及輔助服務中心添置物業、廠房及設備所支付的保證金及開支。於2025財政年度,本集團產生資本開支合共約12.3百萬港元(2024財政年度:57.2百萬港元)。

#### 債務

#### 或有負債

於2025年6月30日,本集團並無任何重大或 有負債。

#### 資本承擔

於2025年6月30日,本集團有關於購置物業、廠房及設備的重大資本承擔約6.1百萬港元(2024財政年度:3.9百萬港元)。

#### 庫務管理

本集團在現金管理及風險控制方面以審慎穩 健為先。為了實現更佳的風險控制及有效的 資金管理,本集團集中進行庫務活動。

在2025財政年度,本集團的收款主要以港元及人民幣計值。付款主要以港元及人民幣作出。現金一般存作港元計值的短期存款。

本集團財務政策的目標是盡量減少因外幣匯率及利率波動而帶來的風險及敞口。由於本集團並無任何銀行借款或未償還銀行貸款,亦無訂立任何銀行貸款融資,本集團目前並無任何重大的利率風險。

#### RISK MANAGEMENT Foreign Currency Risk

During the reporting period, the Group undertook certain transactions in foreign currencies, which exposed the Group to foreign currency risk, primarily relating to the Renminbi against Hong Kong dollars.

The Group did not use any derivative contracts to hedge against its exposure to currency risk. The management manages the currency risk by closely monitoring the movement of the foreign currency rates and will consider hedging against significant foreign exchange exposure when the need arises.

#### **Credit Risk**

The credit risk of the Group's financial assets arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and concentrations of credit risk are managed by customer/counterparty.

#### **PLEDGE OF ASSETS**

As at 30 June 2025, the Group has pledged certain deposits with an aggregate carrying amount of HK\$1.8 million (30 June 2024: HK\$2.8 million) in connection with a surety bond issued by a bank in favour of respective independent third parties for potential disruption of Medical and Dental Services.

#### **EMPLOYEE AND REMUNERATION POLICY**

As at 30 June 2025, the Group had a total of 452 full-time employees (30 June 2024: 486 full-time employees). For FY2025, the staff cost (including Directors' remuneration in the form of salaries and other benefits) was approximately HK\$179.0 million (FY2024: HK\$197.0 million).

#### 風險管理 外匯風險

於報告期內,本集團進行了若干外幣交易, 令本集團承擔外匯風險,主要與人民幣兑港 元有關。

本集團並無使用任何衍生工具合約來對沖其 貨幣風險。管理層通過密切留意外幣匯率的 走向管理貨幣風險,並在需要時會考慮對沖 重大外匯風險。

#### 信貸風險

本集團金融資產的信貸風險源自交易對手違 約,最大風險相等於有關工具的賬面值。

本集團僅與認可及信譽可靠的第三方進行 買賣。本集團之政策為所有有意按信貸條款 進行買賣之客戶均須接受信貸審核程序。此 外,本集團持續監控應收款項結餘,集中信 貸風險由客戶/交易方管理。

#### 資產抵押

於2025年6月30日,本集團已抵押若干賬面 總值合共1.8百萬港元(2024年6月30日:2.8 百萬港元)的存款,乃涉及由一間銀行就潛在 醫療及牙科服務干擾而向有關獨立第三方發 出的履約保證。

#### 僱員及薪酬政策

於2025年6月30日,本集團共有452名全職僱員(2024年6月30日:486名全職僱員)。於2025財政年度,員工成本(包括以薪金及其他福利形式發放的董事薪酬)約為179.0百萬港元(2024財政年度:197.0百萬港元)。

The Group ensures that the pay levels of its employees are competitive and employees are rewarded on a performance-related basis, together with reference to the profitability of the Group, prevailing remuneration benchmarks in the industry, and market conditions within the general framework of the Group's remuneration system.

本集團確保其僱員的薪金水平具競爭力,僱 員按工作表現基準獲得獎勵,且經參考本集 團的盈利能力、行業內現行的薪酬基準以及 本集團薪酬體系整體框架內的市場狀況。

In addition, the Company also adopted the 2023 Share Option Scheme on 24 November 2023, where eligible persons are entitled to subscribe for the Shares for their contribution to the Group. The Company has not granted any share options under the 2023 Share Option Scheme since its adoption. The Post-IPO Share Option Scheme was terminated on 24 November 2023. As at 30 June 2025, there were 11,200,000 share options under the Post-IPO Share Option Scheme remained outstanding. Under the Post-IPO Share Option Scheme, 1,500,000 share options were lapsed or forfeited and no share options were granted or exercised during FY2025.

The Company has also adopted the Share Award Scheme to provide an incentive and reward to selected participants for their contribution or potential contribution to the Group. During FY2025, 3,900,000 awarded shares were granted and 4,400,000 awarded shares were vested under the Share Award Scheme, with 200,000 awarded shares were forfeited.

#### **FINAL DIVIDEND**

The directors proposed the payment of a final dividend of HK1.90 cents per Share for FY2025 (FY2024: HK2.00 cents), subject to the approval of the Shareholders at the 2025 AGM. Such proposed dividend is expected to be distributed on Friday, 9 January 2026 to the Shareholders whose names appear on the register of members of the Company on Friday, 12 December 2025.

#### **Report Overview**

Environmental data only covers our operations in Hong Kong as the relevant figures for our operations in Chinese Mainland and Macau are considered relatively insignificant to the Group.



#### **Talent Attraction and Retention**

We put great emphasis on attracting and retaining talent. We recruit the best talent via multiple hiring channels and offer competitive remuneration with a wide range of benefits. Employee performance and remuneration are periodically reviewed based on an individual's overall contributions and market conditions, to ensure we can motivate colleagues in a way that is authentic to our culture and values. Our aim is to offer just and favorable conditions of work including the right to reasonable working hours, fair working conditions and pay. In addition, we encourage internal promotion to offer extra opportunities for employees to develop their full potential. Our approach will help colleagues have clarity on performance expectations, awareness of development opportunities and access to resources. In FY2025, our employee turnover was 27.09%.

#### **Fair Employment**

Our Employment Policy provides guidance on respecting and promoting equal opportunity. The Policy states our commitment to offer equal opportunities to job candidates, equal remuneration for men and women for work of equal value, and mandates the need for a harassment and discrimination-free environment. We have established objective performance indicators for annual performance evaluation. The supervisor will engage with the employee on a two-way communication to discuss his/her performance for advancement. Employees regularly receive feedback on their work performance and capabilities to make progress and enhance team competitiveness.

We only allow reasonable and substantiated terminations of employment. Dismissals, when required, are based on reasonable and lawful grounds supported by policies and are conducted in accordance with applicable laws and regulations. Prior verbal or written warnings will be issued to provide a fair opportunity to employees for improvement.

#### **Prevention of Child Labour and Forced Labour**

We adhere to relevant statutory requirements and strictly prohibit all forms of forced labour and child labour. During the recruitment process, the Human Resources Department will verify the applicant's identity documents and ensure that they have reached the minimum age for employment. The Group stipulates the working days and rest time for employees in the employment contract to eliminate forced labour, and carefully monitor the employee working hours and schedules to ensure they work voluntarily and freely. When overtime is required, employees are properly compensated as required by law.

Managers are responsible for ensuring compliance with the Group's policies to eliminate human trafficking and modern slavery by raising concerns on abnormal work conditions or behaviours. If any child labour or forced labour is found, the Group will immediately stop all work of the identified child labour or forced labour. Follow-up investigations will be conducted to find out the reasons and modify the employment management measures to rectify the loopholes.

During the Reporting Period, the Group was not aware of any material non-compliance with any relevant laws and regulations in relation to compensation and dismissal, recruitment, and promotion, working hours, rest periods, equal opportunity, diversity, anti-discrimination, and other benefits and welfare, that would have a significant impact on the Group.

#### 公平就業

我們的僱傭政策就尊重及促進平等機會提供 指引。我們於該政策中承諾為求職者提供平 等機會,實現男女同工同酬,並規定必須創 造一個無騷擾及歧視的環境。我們為年度績 效評估制定客觀績效指標。主管與下屬會進 行雙向溝通,討論僱員績效以助其進步。僱 員定期聽取有關其工作表現及能力的反饋, 以取得進步並加強團隊的競爭力。

我們只會容許在合理及有充分理據的情況下 作出解僱。倘若有必要作出解僱,其必須是 基於合理、合法及獲政策支持的理據,並根 據適用的法律及法規作出。我們會事先向僱 員發出口頭或書面警告,讓彼等有公平的機 會進行改善。

#### 防止童工及強制勞工

我們遵守相關的法定要求,嚴格禁止任何形式的強制勞工及童工。在招聘過程中,人力資源部會核實應徵者的身份證明文件,並確保彼等已達到最低就業年齡。本集團在僱傭合約中訂明僱員的工作日及休息時間,以杜絕強制勞工,並仔細監督僱員的工作時間及安排,確保彼等乃自願及自由地工作。需要加班時,僱員可依法獲得適當補償。

經理有責任提出對異常工作條件或行為的疑慮,以杜絕人口販運及現代奴役,從而確保本集團的政策獲得遵守。倘若發現任何童工或強制勞工的情況,本集團會立即停止所有已查明屬實的童工或強制勞工。後續將會進行調查,以找出原因及修改僱傭管理措施,糾正漏洞。

於報告期間,本集團並不知悉任何違反有關薪酬及解僱、招聘及晉升、工作時數、假期、平等機會、多元化、反歧視以及其他待遇及福利等對本集團有重大影響的相關法律及規例的情況。

#### **Other Employee Benefits**

To motivate employees to support our goals, we offer competitive remuneration and merit bonuses, including share options and share awards schemes. Staff benefits include comprehensive medical insurance, employment compensation insurance, directors' and officers' liability insurance and mandatory provident fund for employees. Employees are also entitled to annual leave, maternity leave, paternity leave, marriage leave and examination leave.

To encourage work-life balance and ensure well-being among employees, the Group has clear policies outlining overtime working arrangements. We are devoted to creating career development opportunities and fostering unified spirit amongst employees across the Group.

#### **Investing in People**

We aim to build a dynamic environment where our colleagues can develop skills and undertake experiences that help them fulfil their potential. Our human capital management strategy places priority on equipping our people with continuing education and personal development opportunities. New employees receive orientation training to familiarise themselves with our values, strategy, purpose and corporate culture. For existing employees, a number of training programmes, including in-house seminars, training workshops and talks, are provided to facilitate continuous improvement in their technical capabilities and personal development.

As the way we work and the way we learn has changed, driven by the adoption of hybrid work styles and digital capabilities, we use a range of resources to help colleagues take ownership of their development and career, including knowledge sharing of online resources. In FY2025, 28% of our employees received training, with an average internal training hour of 0.5 hour.

#### 人才投資

在混合工作模式及數碼技術的驅動下,我們 的工作及學習模式已有改變,因此,我們借 助一系列資源幫助同事掌握自己的發展路 向及職涯發展,包括共享線上學習資源。於 2025財政年度,我們有28%僱員接受培訓, 平均內部培訓時數為0.5小時。

Other than clinic-related matters, employees are required to be familiarised with protocols for maintaining a clean, orderly, and safe work area that is hazard-free, and performing work in a safe manner so as not to jeopardise oneself or others. They are also familiar with the use of protective equipment and harmless materials and have adequate knowledge of the Emergency Plan, Evacuation Procedures, Procedures for Life Safety Threats, and other general safety issues in the event of an emergency to ensure safety.

Furthermore, we encourage employees to expand their work contacts within the Group and to take advantage of career development opportunities. Employees will have the chance to pursue development in other parts of the Group, and the policy also allows us to maximise the company's utility by transferring capable employees to the most suitable service areas.

#### **Developing a Culture of Safety**

Our continued success depends on the well-being of our people. To create a safe and healthy work environment, we have implemented a comprehensive occupational health and safety management system that safeguards our employees and workers.

Infection control is a priority in every clinic. Our clinics are equipped with personal protection and preventive equipment, including hand-washing facilities, adequate masks, and sharps disposal containers. All clinic staff have been educated on health and safety procedures and are encouraged to proactively raise awareness of infection control and report potential risks to the person in charge of the clinic.

We require all employees to practise safe medical procedures. Special medical equipment such as irradiation apparatus can only be operated by certified staff. Clinic staff are regularly trained to use medical equipment properly and to keep updated with the changes. All employees are also required to follow the workplace safety rules.

During FY2025, the Group strictly complied with all relevant laws and regulations on occupational health and safety, including but not limited to the Occupational Safety and Health Ordinance and the Occupational Safety Law on prevention and control of occupational diseases.

#### 6. MAINTAINING TRUST OF OUR PATIENTS

We operate in a way that upholds high standards of corporate governance. We strive to maintain the unwavering trust that society has on us, including being transparent in our approach to fulfilling different obligations. We also seek to ensure we respect stringent standards of the healthcare industry in our workplace and our supply chains, and continually work to improve our compliance management capabilities.

#### **Upholding the Highest Standards of Business Ethics**

#### **Anti-corruption**

The Group is committed to acting with integrity and have a risk management framework and policies that are designed to govern, monitor and report unlawful behaviour. We have a zero-tolerance approach towards all forms of corruption and observes high standards of business ethics. Our Anti-corruption Policy sets out the minimum standard of conduct which applies to all directors, officers, and employees of the Group. Compliance with this policy is obligatory, and any violation thereof may result in disciplinary action, including potential employment termination and the imposition of civil or criminal sanctions. As part of our efforts to strengthen anti-corruption practices and promote employee awareness, we have invited Independent Commission Against Corruption to deliver annual anti-corruption training sessions to directors and all employees this year.

#### Whistle-blowing Mechanism

Our whistle-blowing channel encourages our colleagues and other stakeholders to raise concerns confidentially and, anonymously if preferred, subject to laws and regulations. We offer an email address providing colleagues and stakeholders the confidence to speak up when they observe unlawful or unethical behaviour. Their concerns are delivered through the most effective route. We always listen to the concerns of individuals and have a zero tolerance for acts of retaliation.

Concerns are investigated proportionately and independently, with actions taken where appropriate. These can include disciplinary actions, dismissals, and adjustments to variable pay and performance ratings. We ensure that whistle-blowers are protected from unfair dismissal, victimisation, or unwarranted disciplinary action. There were no concluded legal cases regarding corrupt practices brought against the Group or its employees during FY2025.

#### 6. 維護病人信任

#### 堅持最高標準的商業道德

#### 反貪污

#### 舉報機制

我們鼓勵同事及其他持份者在遵守法律及法 規的前提下,利用我們的舉報渠道以保密及 匿名的方式提出疑慮。我們提供電子郵件地 址,讓同事及持份者在發現不合法或不道德 的行為時能暢所欲言。彼等的疑慮會透過最 有效的途徑送達。我們必然聆聽每個人的疑 慮,並對報復行為採取零容忍態度。

我們會對疑慮進行相稱且獨立的調查,並在適當情況下採取行動。該等行動可包括紀律處分、解僱、以及調整薪資及績效評分。我們確保舉報者受到保護,不會遭受不公平的解僱、傷害或不必要的紀律處分。於2025財政年度,本集團或其僱員未曾因貪污行為而被起訴。

#### **Achieving Mutual Growth with Suppliers**

The Group has established a robust supply chain management system to ensure that our suppliers adhere to relevant environmental and social laws and regulations, as well as our internal supplier selection policy.

We evaluate supplier performance based on several criteria, including product quality, delivery time, brand reputation, and environmental and social considerations. Suppliers with higher performance ratings are prioritised when sourcing specific goods or services.

Additionally, the preferred supplier list is reviewed annually to ensure that supplier performance continuously aligns with UMP's procurement standards. Additionally, UMP utilises a centralised procurement system to streamline the ordering and distribution of medical supplies to each UMP Medical Centre. We source medicines and medical equipment from qualified pharmaceutical companies and suppliers of medical consumables, ensuring compliance with all applicable laws and regulations. Each centre is accountable for managing its own inventory of drugs and medical consumables. This approach effectively controls procurement quality and costs, while also minimising the risk of corruption and bribery.

To support our local economy and minimise transportation-induced carbon emissions, we preferred local suppliers. During the Reporting Period, we had over 621 suppliers, 431 and 190 of which were located in Hong Kong and Chinese Mainland respectively.

#### 與供應商共同成長

本集團已建立健全的供應鏈管理系統,以確保供應商遵守相關的環境及社會法律及法規,以及我們的內部供應商遴選政策。

我們根據多項標準評估供應商的表現,包括 產品質量、交付時間、品牌聲譽、以及環境 及社會因素。在採購特定貨品或服務時,我 們優先考慮表現評分較高的供應商。

此外,我們每年檢討我們的優先供應商名單,以確保供應商的表現持續符合聯合醫務的採購標準。此外,聯合醫務採用中央採購系統,以簡化訂購醫療用品及將其分發藥至司及醫療消耗品供應商採購藥物及醫療消耗品供應商採購藥物及醫療領耗。以確保符合所有適用法律及法規。每個醫務中心負責管理自身的藥物及醫療消耗品庫存。此方式能有效控制採購的質量及成本,同時亦能將貪污受賄的風險降至最低。

為支持當地經濟,並將運輸引起的碳排放量 降至最低,我們傾向選用當地供應商。於報 告期間,我們有超過621個供應商,其中431 及190個分別位於香港及中國內地。



#### **Building Patient Confidence**

We consider patient experience as the core of our operations, and we constantly engage with our patients to identify and understand their needs. Our conduct approach guides us to deliver the best quality, and it is embedded in the way we provide our professional services and the way we care for our patients.

#### **Quality Assurance**

Our Quality Assurance and Safety ("QAS") Committee, comprising of medical practitioners and senior management, is responsible for monitoring the performance of our clinics and providing suggestions on clinical governance, clinical risk, and continuous development of clinical and professional services. The QAS Committee also formulates policies and procedures regarding the healthcare and medical services offered by the Group.

In addition, we have implemented a service quality management approach in our day-to-day business operations. This approach strictly monitors operations from patient registration to clinical consultation procedures and efficiency management. It also stipulates our internal guidelines and procedures which are regularly reviewed to ensure they remain up to date.

#### Clinic Hygiene and Infection Control

To ensure a healthy and comfortable clinical environment, we prioritise environmental hygiene in our medical centres. Other than efficient ventilation and lighting systems, our clinics are equipped with a special suction apparatus to reduce aerosols in the air. Personal protective equipment ("PPE") is used and is always kept in sufficient stock at our clinics. Patient triage and placement procedures are in place to prevent the transmission of disease within clinics. Reusable medical equipment is sterilised, and sufficient sanitary and hand-washing facilities are available to all patients and staff. Hand hygiene tips and cough etiquette posters are also displayed at our clinics as a reminder for all. We provide clinic infection control training to clinic staff to prevent epidemic diseases and further reduce the risk of communicable diseases. Surgical masks and other necessary protective equipment are also provided to frontline staff to safeguard their health. Any waste generated at the clinics are properly disposed as an important clinical infection control.

#### 建立患者信心

我們將患者求診體驗視為營運的核心,並持續與患者溝通,以找出並了解彼等的需要。 我們的行為方針引導我們提供最佳質量,並 將其融入我們的專業服務及照顧患者的實踐 之中。

#### 質量保證

我們的質量保證及安全(「質量保證及安全」) 委員會由醫生及高級管理人員組成,負責監 控我們診所的表現,並就臨床管治、臨床風 險、以及臨床及專業服務的持續發展提供建 議。質量保證及安全委員會亦針對本集團所 提供的醫療保健及醫療服務,制定相關政策 及程序。

此外,我們已在日常業務營運中實施服務質量管理方針。此方針嚴格監控從患者登記到臨床診症程序的運作及效率管理。其亦訂明了內部指引及程序,而我們會對此定期檢討,確保與時並進。

#### 診所衛生及感染控制

為確保健康及舒適的診症環境,我們首要目 標是要維持我們醫療中心的環境衛生。除 了高效的通風及照明系統外,我們的診所亦 配備特殊抽吸器,以減少空氣中的氣溶膠。 我們的診所備有充足的個人防護裝備以供 使用。我們已制定患者分流及安置程序,以 防止疾病於診所內傳播。可重複使用的醫療 設備均經過消毒,而所有患者及職員均獲提 供足夠的衛生及洗手設施。我們的診所亦張 貼了潔手告示及咳嗽禮儀海報,提醒大家留 神注意。我們為診所職員提供診所感染控制 培訓,以預防流行性疾病傳播及進一步降低 傳染病的風險。我們亦為前線職員提供外科 口罩及其他必要的防護裝備,以保障彼等的 健康。任何於診所產生的廢棄物均會妥善處 理,此亦是臨床感染控制的重要一環。

#### **Professional Practitioners**

All of our medical practitioners possess valid certifications and qualifications to provide relevant medical treatments and handle drug and pharmacy matters. Doctors, dentists, and certain auxiliary service providers are required to comply with applicable codes of professional conduct or discipline.

To ensure that all practitioners are competent in providing quality healthcare services, we have a process in place that involves more than one senior executive from UMP to identify qualified and suitable practitioners. The recruitment process begins with a review of the candidate's background by the Human Resources Department, followed by a video or face-to-face meeting with the respective unit. The Co-Chief Executive Officers are also involved in the hiring decision-making process. Professional qualifications and certificates are collected and kept on record.

Our practitioners are provided with the necessary resources to enhance their skills and knowledge. Our dedicated team conducts regular clinical visits to engage with our affiliated practitioners and ensure consistency of quality. We periodically review our policies on practitioner selection, remuneration, and training with the senior management team to ensure that we deliver clinical care in accordance with industry standards and promote sustainable business operations.

#### **Patient Engagement**

We listen to patient's feedback so that we know where we can take proactive measures to improve. We have established various communication platforms to engage with patients and provide them with enhanced services. Through our websites, social media pages, and mobile app," UMP Service Point," service users can access the latest information on doctor availability, types of healthcare services offered, and the location and operating hours of our medical centres.

#### 專業的醫療從業人員

我們所有醫療從業人員均具備有效的執業證 書及資格,可提供相關醫療服務以及處理藥 物及配藥事宜。醫生、牙醫及若干輔助服務 提供者必須遵守適用的專業操守或紀律守則。

為確保所有醫療從業人員均勝任提供優質的醫療保健服務,我們已制定一套程序,由多於一名聯合醫務的高級管理人員參與物色合資格且適當的醫療從業人員。招聘過程首先從人力資源部審查應徵者背景開始,然後由相關部門進行視像或面對面會談。聯席行內收組裁亦會參與招聘的決策過程。過程中所收繳裁亦會參與招聘的決策過程。過程中所收取的專業資格及證書副本將予保存,以作記錄。

我們為醫療從業人員提供必要資源提升彼等的技能及知識。我們的專責團隊定期到訪診所與我們的聯屬醫療從業人員交流,確保質量保持一致。我們定期與高級管理團隊一同檢視醫療從業人員的甄選、薪酬及培訓政策,以確保我們所提供的臨床護理符合行業標準,並促進可持續的業務營運。

#### 患者溝通

我們聆聽患者的意見,以了解我們自身可於哪些方面採取積極的改善措施。我們已建立不同的溝通平台,以便與患者溝通,為彼等提供更優質的服務。透過我們的網站、社交媒體網頁及流動應用程式「UMP服務點」,用戶可獲取有關醫生應診時間、所提供醫療保健服務類型、以及醫療中心位置及營業時間等的最新資訊。

#### **Complaint Handling Procedures**

When faced with complaints, we remain open and acknowledge our flaws, and we will resolve conflicts promptly and fairly. We aim to be consistent in how we track, record and manage complaints. Following our Complaints and Incident Reporting guidelines, all first-hand complaints about the clinics are to be directed to the respective clinic-in-charge. Feedback or suggestions can be submitted via the UMP hotline or website. Any complaints that relate to medical practice are handled by Clinic Chain Operation Department and will be investigated thoroughly and impartially.

Given the nature of our business, we did not receive any product recalls related to safety or health during the Reporting Period.

#### **Advertising and Labelling**

We are committed to providing transparent and accurate information to assist customers in making informed purchasing decisions. We strictly adhere to all relevant regulations and industry guidelines. To promote responsible marketing practices, we have implemented a strict internal review system for our promotional materials and labelling. We use marketing and promotional materials that support customer understanding and provide information on products and services that is clear, fair and not misleading. We are proud to report that there were no significant cases of non-compliance during the Reporting Period with respect to our products and services.

#### 投訴處理程序

遇到投訴時,我們會保持開放態度,承認自身的過失,並迅速及公平地解決問題。我們的目標是在追蹤、記錄及管理投訴上保持一致。根據我們的投訴及意外報告指引,所有與診所有關的第一手投訴均應直接提交可關診所負責人處理。任何意見或建議亦可透關聯合醫務熱線或網站提出。任何與醫療有調的投訴均由醫務中心營業部處理,所有調查均會獲得徹底及公正對待。

鑑於我們的業務性質,我們於報告期間並無 收到任何與安全或健康相關的產品回收。

#### 廣告及標籤

我們致力提供透明及準確的資訊,以協助客戶作出明智的採購決定。我們嚴格遵守所有相關法規及行業指引。為推廣負責任的營銷手法,我們對宣傳資料及標籤實施嚴格的內部審核制度。我們使用能幫助客戶了解有關產品及服務的營銷及宣傳材料,當中提供清晰、不偏不倚及無誤導成分的資訊。我們對於自身產品及服務於報告期間並無嚴重不合規情況感到驕傲。

#### **Protecting Data Privacy and Intellectual Properties**

At UMP, we are dedicated to upholding customer rights, including intellectual property rights, and safeguard patients' data privacy. We maintain strict confidentiality regarding patients' medical status. Transparency is key in how we handle personal data for our customers and stakeholders. Our practices align with the Personal Data (Privacy) Ordinance ("PDPO"), directing how we collect, handle, and disclose personal and medical information.

To prevent unauthorised disclosure of confidential data, we oversee our data storage systems diligently. Access to sensitive information is restricted solely to essential personnel as outlined in our Employee Handbook. Regular employee training sessions reinforce data privacy and security protocols, while privacy personnel report directly to top management on related risks.

In case of any reportable incidents, we have procedures in place for timely actions, including notifying regulators and data subjects as required by privacy laws. Regular reviews and risk assessments enhance our privacy controls. We adapt to evolving data privacy laws by monitoring the regulatory landscape closely to ensure compliant responses to changes.

#### **Intellectual Property Rights**

We think highly of the intellectual property rights of the company and respect third party intellectual property rights. Over the years, the Group had registered a myriad of trademarks for its services offered in Hong Kong and Chinese Mainland, covering diverse domains such as family doctor services, payment application, internal training courses and branches of different professional centre. The Group maintains a Trademark Register which keeps records of the registration number, mark image, class number, owner's name and expiry date. The Group will take legal action and consult with legal experts if there are any violations of the intellectual property rights that the company owns. We will continue to strengthen intellectual property application and protection.

During the Reporting Period, the Group was not aware of any incidents of non-compliance with related laws and regulations concerning health and safety, advertising, labelling, and privacy matters relating to products and services provided and methods of redress that would have a significant impact on the Group.

#### 保護資料私隱及知識產權

在聯合醫務,我們致力維護包括知識產權在內的客戶權利,並保障患者的資料私隱。我們對患者的醫療狀況嚴格保密。透明度是我們處理客戶及持份者個人資料的關鍵。我們的做法符合《個人資料(私隱)條例》(「私隱條例」)有關如何收集、處理及披露個人及醫療資料的規定。

為防止機密資料在未經授權的情況下外洩, 我們嚴格監管我們的資料儲存系統。我們的 員工手冊已訂明,只有「必要人員」才可存取 敏感資料。資料私隱及安全規範乃透過定期 的僱員培訓課程獲得加強,而相關風險則由 私隱保障人員直接向最高管理層匯報。

倘若發生任何須予匯報的事件,我們會依程 序及時採取行動,包括按照私隱法規定通知 監管機構及資料當事人。我們在私隱權方面 的控制乃透過定期檢討及風險評估予以加 強。我們密切注視監管環境,適應不斷演變 的資料私隱法律,以確保能合規地應對變化。

#### 知識產權

於報告期間,本集團並不知悉任何違反有關 所提供產品和服務的健康與安全、廣告、標 籤及私隱事宜以及補救方法等對本集團有重 大影響的相關法律及規例的情況。

#### 7. SAFEGUARDING THE PLANET

Our plan of carbon reduction illustrates our commitment and strategies to achieve the global ambition of net-zero by 2050. We also collaborate proactively with our business partners and customers to identify green energy alternatives, and innovative solutions to reduce carbon emissions and promote sustainability throughout the industry. We will continue to monitor the corresponding changes within the regulatory landscape and actively support the government's decarbonisation plans and initiatives.

#### **Our Environmental Targets**

We have established targets that direct our business practices and measure our ESG performance. These targets are designed to help us achieve our environment goals. We acknowledge this is a journey that requires regular reassessment to take into account for climate scenarios, improved data and changes in reporting standards, as well as to reflect real world developments and trends.

Below outlines our metrics to assess our progress in reducing intensity by 2030, using 2023 as the base year:

#### 7. 保護地球

#### **Emissions and Waste Management**

#### Greenhouse Gas ("GHG") Emissions

GHG emissions are widely regarded as a significant contribution to climate change and global warming. As their consequential impact on the environment and all lives on earth intensifies, the Group is committed to lowering its emissions and exploring its options on cleaner energy sources.

Electricity is the largest contributor to our GHG emissions. Healthcare facilities require significant energy: medical equipment as well as air-filtration and air-conditioning units run continuously at many clinics. Improved operational efficiency will result from the introduction of various new energy-efficient and renewable technologies. To further manage GHG emissions, we have taken different measures on the efficient use of energy with further information documented in the section "Optimising Resources".

As the number of visiting patients increased last year, the increase in electricity consumption has led to an increase in GHG emissions. The Group will closely monitor GHG emissions and implement relevant measures to reduce our carbon footprint.

#### 排放及廢棄物管理

#### 溫室氣體排放

溫室氣體排放被廣泛認為是導致氣候變化及 全球變暖的重要因素。由於溫室氣體排放對 環境及地球上所有生命造成日益嚴重的影 響,故本集團致力降低其排放量並探討其他 更潔淨的能源。

電力是我們最大的溫室氣體排放來源。醫療保健設施需要大量能源:許多診所的醫療設備及空氣過濾和空調機組均持續運轉。透過引入各種新興節能及可再生技術,將有助提高運轉效率。為進一步管理溫室氣體排放,我們已採取不同措施以有效善用能源,更多資訊載於「善用資源」一節。

由於去年就診患者數量增加,用電量增加導致溫室氣體排放量增加。本集團將密切監測 溫室氣體排放,並採取相關措施減少碳足跡。

#### Hazardous Waste

We recognise the importance of safe and effective waste management. We follow established local protocols and guidelines to minimise the risk of accidents or exposure to hazardous materials. In terms of disposing of clinical waste, the Group strictly abide by environmental policies and regulations including the Code of Practice on Clinical Waste Management in Hong Kong. UMP is experienced in handling clinical waste in a safe, legal, and professional manner to avoid potential risks to the environment and human health caused by improper disposal.

Prior to collection, clinical waste is segregated and placed in appropriately labelled garbage bins and bags, while chemical waste is categorised and disposed of in labelled containers that are specifically designed to be leakproof and puncture resistant. The Code for the Disposal of Medical Waste specifies the categories of medical waste, including syringes, contaminated pads, cotton balls, human tissue samples from examinations, dental amalgam, and expired medicines, and provides staff with specific procedures to properly manage and dispose of medical waste.

Records of Medical Waste should be sealed, labelled, and stored in designated locations in our medical centres for collection by licensed waste collector for further processing. We keep detailed medical waste records with tracking information, such as delivery date and address, quantity, and name of licensed collector. All clinic staff are required to receive training to ensure proper implementation of these procedures. We regularly monitor the disposal of both clinical and chemical waste to ensure that they are handled correctly and safely.

#### 有害廢棄物

我們深明實施安全有效的廢棄物管理的重要性。我們遵循本地程序及指引,以盡量減少事故發生或有害物質暴露的風險。在處置醫療廢棄物方面,本集團嚴格遵守各項環境政策及法規,包括香港《醫療廢物管理工作守則》。聯合醫務在安全、合法及專業處理醫療廢棄物方面擁有豐富經驗,避免因處置不當而對環境及人類健康造成潛在風險。

在收集之前,醫療廢棄物會被分類並放置於 貼有適當標籤的垃圾箱及袋子中,化學廢棄 物則會在分類後放置於經過專門設計、並具 有防漏及防刺穿功能的標籤容器中。《處理醫 療廢棄物守則》訂明各項醫療廢棄物的類別, 包括注射器、受污染的墊片、棉花球、檢驗 產生的人體組織樣本、牙用銀汞合金及過期 藥物,並為職員提供正確管理及處置醫療廢 棄物的具體程序。

醫療廢棄物紀錄應予密封、貼上標籤、並存放於我們醫務中心的指定地點,以便持牌廢棄物收集商收集作進一步處理。我們備存詳細的醫療廢棄物紀錄,並標記追蹤資料,如交付日期及地址、數量、及持牌收集商的確保不可有關程序獲妥善執行。我們定期監察醫療廢棄物及化學廢棄物的處置,以確保其得到正確及安全處理。

Our non-hazardous waste includes paper and general waste. Most of the wastes are temporarily stored in a specified location and then recycled by licensed contractors. To reduce the amount of non-hazardous waste, the Group has adopted the following measures:

#### **Optimising Resources**

We share finite resources with our community and planet. We recognise the need to pursue a more circular approach to the operation of our cities. While the transition to a circular environment and economy will take time and require collaboration with all stakeholders in the community, we are developing a resource management plan with specific improvement measures and initiatives to help prepare us for net zero and beyond.

#### **Energy Management**

Electricity consumed in the office and clinics are the major type of energy use in our business. A significant portion of UMP's electricity consumption is attributed to the general lighting and the use of medical equipment, such as high-temperature disinfection and X-ray imaging apparatus. To reduce our energy consumption, we are continuously exploring energy-saving measures in our daily operations, such as installing LED lighting systems in some medical centres and prioritising energy efficiency medical equipment to improve energy efficiency.

In order to optimise the management of energy consumption, we have launched a Smart Energy Monitoring Solution at our ProCare Integrated Medical Imaging and Laboratory Centre (Tsim Sha Tsui) this year which enables real-time monitoring of energy usage and provides intricate analysis of energy consumption patterns. By leveraging this technology, we can identify areas of superfluous energy usage and implement targeted strategies to enhance energy efficiency.

Furthermore, the Group is actively promoting centralised information management and digitising operations by utilising IT systems to reduce paper consumption. Clinical management and administrative work, including the Group's eClaims system, have been digitalised to further minimise our paper consumption.

#### 善用資源

我們與社區及地球共享著有限的資源。我們 意識到有必要在營運所在城市中採用更循環 的方式經營業務。儘管過渡至循環環境及經 濟的過程需時,並且需要與所有社區持份者 合作,惟我們正制定資源管理計劃,其中包 含具體改善措施及倡議,以幫助我們為淨零 甚至更低排放做好準備。

#### 能源管理

我們業務中主要使用的能源類型為辦公室及診所電力。聯合醫務的耗電量有很大部分來自一般照明及醫療設備使用,例如高溫消毒及X光影像儀。為減少能源消耗,我們在日常營運中不斷探索節能措施,例如在部分醫務中心安裝LED照明系統以及優先選用具能源效益的醫療設備,以提高能源效率。

為了優化能源消耗的管理,我們於今年在普康綜合醫學影像及化驗中心(尖沙咀)推出智能能源監控解決方案,實時監控能源的使用情況,並提供精細的能源消耗模式分析。利用此項技術,我們能夠確定能源使用過剩的區域,並實施針對性策略,以提高能源效率。

另外,本集團正積極推行中央資料管理,利 用IT系統進行數碼化營運,以減少紙張消耗。 臨床管理及行政工作(包括本集團的「康橋」 電子理賠系統)現已實現數碼化,以進一步減 少紙張消耗。

The reduction in electricity consumption directly reflects our ongoing sustainability initiatives, including the installation of energy-efficient lighting and the implementation of smart building systems to optimise energy use.

用電量的下降反映出我們在節能減碳上的努力已逐漸展現成效,這些措施包括安裝節能 照明設備及導入智慧建築系統,以提升能源 使用效率。

#### Water Management

The Group prioritises water saving initiatives that have greater reduction potential. We look for pragmatic methods to improve water efficiency and reduce wastage from the source and promote circularity. We explored the potential application of highly efficient water restrictors. Matching with existing water facilities, water restrictors can help improve water efficiency. The implementation of water restrictors is simple and easy, without the need to replace current water facilities. We also implemented the following water conservation measures that enabled water savings:

#### 水資源管理

本集團優先採取節水潛力較大的節水措施。 我們尋求以務實的方法來提高用水效率, 從源頭減少浪費,並促進循環再用。我們研 究了高效節水器的應用潛力。配合現有的用 水設施,節水器可有助提高用水效率。節水 器的實行簡單方便,不需更換現有的用水設 施。我們亦實施了以下節水措施,有助實現 節約用水:

Inspect and maintain water pipes regularly 定期檢查及維護水管 Arouse awareness on water consumption 提高用水意識

Study the possibility of wastewater reuse or recycling 研究廢水再利用或回收的 可能性

Notably, UMP has not been documenting water consumption data for the past few years, as the management fees encompassed this service. 特此註明,聯合醫務於過去幾年一直並無記 錄用水量數據,原因是此服務已包含於管理 費中。

#### Use of Packaging Materials

Ensuring medication safety and quality requires appropriate packaging with clear labelling for identification. At UMP, we use various packaging types, including medicinal bottles, pill pouches, ointment jars, dropper bottles, and plastic bags for medicines and topical ointments. Report folders and bags are used for imaging services, while specimen containers serve laboratory needs.

To reduce plastic waste and support environmental preservation, we are exploring a digital storage system to replace wet film, aiming for a 5% reduction in X-ray bag use next year. We encourage referral doctors to use MEDEX WED, USB, or CD instead of printing wet films.

During the Reporting Period, X-ray bag usage decreased due to the wider use of digital storage in place of wet films.

藥物需要適當的包裝,才能確保安全及質量; 其應附有清晰可見的標籤以利識別。在聯合 醫務,我們使用各式各樣的包裝,包括藥物 瓶、藥丸袋、藥膏罐、滴管瓶及適合裝載藥 物及外用藥膏的塑膠袋。報告文件夾及文件 袋適用於影像服務,而標本容器則滿足化驗 室的需求。

為減少塑膠廢棄物及支持環境保護,我們正探討採用數位儲存系統取代X光顯影片,目標是於明年將X光袋的使用量減少百分之五。 我們鼓勵轉介醫生使用MEDEX WED、USB或CD來取代列印X光顯影片。

於報告期間,由於使用數位儲存取代X光顯影片的情況愈加普遍,X光袋的使用量有所減少。

#### **Environmental and Natural Resources**

Since the Group's business is mainly engaged in the healthcare market and has relatively little impact on the environment and natural resources, we have formulated relevant policies to reduce greenhouse gas emissions, waste generation and energy reduction and other corresponding measures to protect natural resources and the environment.

We closely enhances our environmental monitoring and early warning system so that we can effectively address environmental emergencies.

#### 環境及天然資源

由於本集團業務主要從事醫療保健市場,對環境及天然資源影響較小,因此我們制定了相關政策,減少溫室氣體排放、廢棄物產生及節能減排等相應措施,以保護自然資源與環境。

我們加強環境監測預警體系建設,有效因應 及處置突發環境事件。

#### **Climate Crisis**

UMP acknowledges the pressing necessity of tackling climate change and is dedicated to contributing to a sustainable future. Through our journey towards net zero emissions, we strive to diminish our carbon footprint, showcase environmental stewardship, and play a pivotal role in fostering a cleaner and more eco-friendly world for future generations.

#### **Identification of Climate Risks and Opportunities**

To enhance our understanding and effectively address the various potential impacts of climate change on UMP's operations, we have carefully identified climate-related risks and opportunities. Our analysis examines how these factors influence UMP's business model and operational processes, considering both financial and non-financial implications. The following tables outline the climate-related risks and opportunities that may affect UMP's operations. He is a Clinical Associate Professor (honorary) in Faculty of Medicine, Jockey Club School of Public Health and Primary Care, The Chinese University of Hong Kong and an Honorary Clinical Assistant Professor in Department of Family Medicine and Primary Care, The University of Hong Kong. Dr. Sun is one of the pioneer Hong Kong doctors to participate in the healthcare development and training of medical professionals in the PRC.

Dr. Sun is the father of Dr. Michael Sun, the Vice Chairman, executive Director and Co-Chief Executive Officer and the father-in-law of Mr. Patrick Tsang, an executive Director. He is the sole shareholder and one of the directors of East Majestic Group Limited. He is also the sole shareholder and director of EM Team Limited.

He is a Council Member of the Hong Kong University of Science and Technology and the President of Greater Bay Area International Information Technology Industry Association and the Founding Chairman of the Institute of Big Data Governance. In addition, Mr. Yeung serves as an independent non-executive director of companies which are listed on the Stock Exchange, including Yau Lee Holdings Limited (stock code: 406) and Chinasoft International Limited (stock code: 354). He also serves as an independent non-executive director of POA Bank Limited, which is a wholly-owned subsidiary of Lufax Holding Ltd (listed on the New York Stock Exchange (NYSE: LU) and The Stock Exchange of Hong Kong Limited (stock code: 6623)) and a member of Ping An Insurance (Group) Company of China, Ltd. (listed on The Stock Exchange of Hong Kong Limited (stock code: 2318) and on the Shanghai Stock Exchange (SSE: 601318)). From October 2018 to December 2023, Mr. Yeung was an independent non-executive director of Lansen Pharmaceutical Holdings Limited (delisted from the Stock Exchange).

The Board currently comprises nine Directors, consisting of five executive Directors, one non-executive Director and three independent non-executive Directors, namely Dr. Sun Yiu Kwong as Chairman, Dr. Sun Man Kin, Michael as Vice Chairman, Co-Chief Executive Officer, Ms. Kwok Cheuk Kwan, Jacquen, as Co-Chief Executive Officer, Mr. Tsang On Yip, Patrick *BBs* and Dr. Lee Pak Cheung, Patrick as executive Directors; Dr. Lee Kar Chung, Felix as non-executive Director; and Mr. Lee Luen Wai, John *BBS JP*, Dr. Li Kwok Tung, Donald *GBS JP*, and Mr. Yeung Tak Bun *BBS JP* as independent non-executive Directors.

The Board has conducted a review and considered that the Board Independence Evaluation Mechanism has been properly implemented for FY2025 and is effective.

#### **Board Diversity Policy**

The Company considered diversity of Board members can be achieved through consideration of a number of aspects, including but not limited to the gender, age, cultural, educational background and professional experience of the Board members. The appointment of Directors will be based on the Group's own business model and specific needs, having due regard to the benefits of diversity of the Board.

The Company believes that the current Board composition is well-balanced and of a diverse mix appropriate for the business of the Company. The Board currently has one female Director and in compliance with Board gender diversity requirement under Rule 13.92 of the Listing Rules. We will continue to strive to enhance female representation and achieve an appropriate balance of gender diversity. The Board has reviewed the Board Diversity Policy for FY2025 and is of the view that the Board Diversity Policy has been properly implemented and is effective.

As at 30 June 2025, the gender ratio in the workforce (including senior management) of the Group was approximately 78% female and approximately 22% male. The Group treats every employee equally and equal opportunities for different genders. In particular, the recruitment process of the Group shall not involve any discrimination on the grounds of race, disability, gender, sexual orientation, family responsibilities, marital status, age or other discriminatory factors. It is relatively more challenging for the Group to achieve equal gender ratio across all business units of the Group due to the characteristics and work types of different business units. The Group will continue to enhance diversity in different levels of workforce.

#### Independent Non-executive Directors

During FY2025, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing one third of the Board with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise. The Company has received written annual confirmation from each of the independent non-executive Directors in respect of his independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors are independent.

#### Roles of the Board and Management

The Board oversees the management, business, strategic directions and performance of the Group. It is collectively responsible for the management and operation of the Company. The Board is the ultimate decision making body of the Company except for matters requiring the approval of the Shareholders in accordance with the Articles, the Listing Rules or other applicable laws and regulations.

The Board delegates day-to-day operations of the Group to the management of the Company. The Board and the management have clearly defined authorities and responsibilities under various internal control and check and balance mechanisms.

#### 獨立非執行董事

#### **Corporate Governance Functions**

The Board plays a major role in the supervision of corporate governance to ensure that the Company maintains a sound governance framework and the long-term sustainable Shareholders' value by way of, among others:

- (a) to develop and review the Company's policies and practices on corporate governance;
- (b) to review and monitor the training and continuous professional development of the Directors and senior management;
- (c) to review and monitor the Company's policies and practices in compliance with legal and regulatory requirements;
- (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and the Directors; and
- (e) to review the Company's compliance with Appendix C1 of the Listing Rules (Corporate Governance Code and Corporate Governance Report).

During the year, the Board has reviewed the Company's policies and practices on corporate governance, and reviewed and monitored the training and continuous professional development of directors and senior management. The Board has also reviewed and ensured compliance of the relevant legal and regulatory requirements, the code of conducts, the code and the disclosure in the Corporate Governance Report.

Meeting agenda and accompanying meeting papers are sent to all relevant Directors at least 3 days in advance of every regular Board meeting or committee meeting.

The Company Secretary assists the Chairman of the Board and the chairmen of Board committees in preparing meeting agendas and ensures that the Corporate Governance Code as well as all applicable laws and regulations are duly complied with. Minutes of Board meetings and Board committee meetings are recorded in sufficient details of the matters considered and decisions reached at the relevant meetings. Draft and final versions of the minutes in respect of Board meetings and Board committee meetings are sent to all Directors or Board committee members respectively for comment and records within a reasonable time after the relevant meetings. All minutes are properly kept by the Company Secretary and are available for the Directors' and Board committee members' inspection.

All Directors are entitled to have access to timely information in relation to the Company's business and make further enquiries or retain independent professional advisors where necessary. The management provides all relevant explanation and information to the Board so as to give the Board the information it needs to discharge its responsibilities. During FY2025, the management has provided all members of the Board with adequate information giving a balanced and understandable assessment of the Company's performance, position and prospects.

#### Directors' Appointment, Re-election and Removal

Each of the executive Directors has entered into a service contract with the Company for a term of three years subject to the provision of retirement and rotation of Directors under the Articles and the provision under the service contract.

The non-executive Director has entered into a letter of appointment with the Company for a fixed term of one year subject to retirement by rotation in accordance with the Articles.

Each of the independent non-executive Directors (other than Mr. Yeung Tak Bun) has entered into a letter of appointment with the Company for a term of three years commencing on the date of his appointment. Thereafter, the appointment is renewable automatically for successive terms of one year. Mr. Yeung Tak Bun has entered into a letter of appointment with the Company as an independent non-executive Director for a term of one year commencing from the date on of his appointment, which term shall be automatically renewable for successive terms of one year. All independent non-executive Directors are subject to the provision of retirement and rotation of Directors under the Articles and the provision under their letters of appointment.

The Articles provide that each Director is subject to retirement from office by rotation and re-election once every three years and that one-third (or the number nearest to but not less than one-third) of the Directors shall retire from office every year at the annual general meeting. Any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting after his appointment and be subject to re-election at such meeting while any Director appointed by the Board as additional Director shall be subject to re-election at the next following annual general meeting.

The Directors are encouraged to attend seminars and conferences to enrich their knowledge in discharging their duties as a director. The Remuneration Committee is responsible for making recommendations to the Board on the Company's policy and structure for all Directors' and senior management's remuneration and on the establishment of a formal and transparent procedure for developing such remuneration policies. In arriving at its recommendations to the Board, the Remuneration Committee will consider salaries paid by comparable companies, time commitment and responsibilities and employment conditions elsewhere in the Group. The Committee either determines or makes recommendations to the Board on the remuneration package of individual executive Directors and senior management, and it also makes recommendations to the Board on the remuneration of non-executive Directors. The Board is responsible for the preparation of the financial statements which should give a true and fair view of the state of affairs of the Group and of the financial performance and cash flows for such reporting period. In preparing the financial statements, the Board has adopted generally accepted accounting standards in Hong Kong and suitable accounting policies and applied them consistently, made judgments and estimates that are prudent, fair and reasonable, and prepared the financial statements on a going concern basis. The Board is responsible for ensuring that the Group keeps proper accounting records which disclose with reasonable accuracy at any time the financial position of the Group.

The Board is not aware of any material uncertainties relating to events or conditions which may cast significant doubt over the Group's ability to continue as a going concern. Accordingly, the Board has continued to adopt the going concern basis in preparing the financial statements.

The auditor is responsible for auditing and reporting its opinion on the financial statements of the Group and the independent auditor's report for FY2025 is set out in the section headed "Independent Auditor's Report" of this annual report.

Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Company has developed and adopted various risk management procedures and guidelines with defined authority for implementation by key business processes and office functions, including clinic chain operations, business development, financial reporting, human resources, information technology and handling and dissemination of inside information.

All departments conducted internal control assessment regularly to identify risks that potentially impact the business of the Group and various aspects including key operational and financial processes, regulatory compliance and information security.

The management, in coordination with department heads, assessed the likelihood of risk occurrence, provide treatment plans, and monitor the risk management progress, and reported to the Audit Committee and the Board on all findings and the effectiveness of the systems.

The internal audit team is responsible for providing the internal audit function and performing independent review of the adequacy and effectiveness of the risk management and internal control systems.

#### SHAREHOLDERS' RIGHTS

#### Convening an extraordinary General Meeting

Article 58 of the Articles of the Company provides that any one or more members of the Company holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Company Secretary, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within 2 months after the deposit of such requisition. If within 21 days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

A Shareholder may lodge a notice of his intention to propose any person (other than himself/herself) for election as a Director together with a notice signed by the person to be proposed of his/her willingness to be elected to the head office of the Company or at the registration office where the branch register of members of the Company is kept provided that the minimum length of the period, during which such notice(s) are given shall be at least 7 days and that (if the notices are submitted after the despatch of the notice of the general meeting appointed for such election) the period for lodgment of such notice(s) shall commence on the day after the despatch of the notice of the general meeting appointed for such election and end no later than 7 days prior to the date of such general meeting.

Other than the above concerning a proposal of a person for election as a Director, there are no provisions in the Articles of Association or the Companies Law of the Cayman Islands for putting forward proposals of new resolutions by Shareholders at general meetings. Shareholders may follow the procedures set out above to convene an extraordinary general meeting for any business specified in such written requisition.

Besides, the potential risks and uncertainties faced by the Group, key relationship between the Group and its employees, customers and suppliers, the environmental policies of the Group and compliance with the relevant laws and regulations which have significant impact are set out below.

#### **KEY RISKS AND UNCERTAINTIES**

The Groups' results and operations are subject to various factors with the key risks summarised below:

#### **Strategy Risk**

The current macroeconomic uncertainty and sluggish economy may cause episodic disruptions to the medical industry. Our Company must effectively and efficiently allocate resources in order to minimize the risk brought on by the uncertain economic environment. We must also continue to find new strategic angles to improve our operations and business. The sluggish economy may continue to impact global business in the near future. The Group must be prepared to continue being agile in our operations and ready to switch gears to curb any unexpected operational headwinds that might cause significant interruptions to our business. As consumer discretionary spending decreases, we need to be thoughtful about pricing and promotional strategies. At the same time, we should look for opportunities to diversify our revenue streams and create new partnerships to weather the economic downturn.

#### **Compliance Risk**

The Group's business operations, Doctors, Dentists and Auxiliary Services Providers in the Group's network working in Hong Kong, Macau and Chinese Mainland are subject to extensive laws, regulations and licensing requirements, any failure to comply with such laws, regulations or licensing requirement could harm the Group's business, results of operations, financial condition, brand and reputation.

#### KEY RELATIONSHIPS BETWEEN THE GROUP AND ITS EMPLOYEES, CUSTOMERS AND SUPPLIERS

The Group fully understands that employees, customers and suppliers are the key to our sustainable and stable development. We are committed to establishing a close relationship with our employees, enhancing cooperation with our suppliers and providing high-quality services to our customers so as to ensure the Group's sustainable development.

#### **ENVIRONMENTAL POLICIES**

As a responsible corporation, the Group recognises the importance of good environmental stewardship. In this connection, the Group strictly adopted and implemented policies and procedures to ensure environmental protection. To the best knowledge of the Directors, the Group has complied with all the relevant laws and regulations that have a significant impact on the Group in relation to its business including health and safety, workplace conditions, employment and the environment. During FY2025, no environmental claims, lawsuits, penalties or administrative sanctions were reported to our management.

The Board proposed the payment of a final dividend of HK1.90 cents per Share for FY2025 (FY2024: HK2.00 cents), subject to the approval of the Shareholders at the 2025 AGM. Such proposed dividend is expected to be distributed on Friday, 9 January 2026 to the Shareholders whose names appear on the register of members of the Company on Friday, 12 December 2025.

Together with the interim dividend of HK1.4 cent per Share paid in April 2025, the total distribution of dividend by the Company for FY2025 will be HK3.30 cents per Share (FY2024: HK3.30 cents per Share).

#### **DIVIDENDS POLICY**

The Board has approved and adopted a dividend policy (the "Dividend Policy"). The Company is endeavor to maintain sufficient operating capital to develop and operate the Group's business, and to provide stable and sustainable returns to the Shareholders.

The Company adopted the Post-IPO Share Option Scheme on 13 November 2015.

The Board resolved to terminate the Post-IPO Share Option Scheme with effect from 24 November 2023 and no option was available for grant as at 1 July 2024 and 30 June 2025.

#### (b) Participants

The Board (including any committee or delegate of the Board appointed by the Board to perform any of its functions pursuant to the rules of the Post-IPO Share Option Scheme) may, at its absolute discretion, offer to grant an option to subscribe for such number of Shares as the Board may determine to an employee (whether full-time or part-time) or a director of a member of the Group or associated companies of the Company (the "Eligible Persons").

#### (c) Total number of securities available for issue

The total number of Shares which may be issued upon exercise of all options to be granted under the Post-IPO Share Option Scheme and any other share option schemes (including but not limited to the Pre-IPO Share Option Scheme) of the Company must not in aggregate exceed 10% of the total number of Shares in issue as at the Listing Date which is 73,600,000 Shares, representing approximately 9.08% issued shares of the Company as at the date of this annual report.

#### (d) Maximum entitlement of each participant

No options shall be granted to any Eligible Person under the Post-IPO Share Option Scheme and any other Share option schemes of the Company which, if exercised, would result in such Eligible Person becoming entitled to subscribe for such number of Shares as, when aggregated with the total number of Shares already issued or to be issued to him under all options granted to him (including exercised, cancelled and outstanding options) in the 12-month period up to and including the date of offer of such options, exceeds 1% of the Shares in issue at such date.

### (g) Time of acceptance and the amount payable on acceptance of the option

An offer of options shall be open for acceptance in writing or by telex or facsimile transmission or (if the Board agree) by electronic communication received by the Chairman (or a person designated by him with the approval of the Board) for such period (not exceeding 30 days inclusive of, and from, the date of offer) as the Board may determine and notify to the Eligible Person concerned provided that no such offer shall be open for acceptance after the expiry of the duration of the Post-IPO Share Option Scheme. An offer of options not accepted within this period shall lapse.

An amount of HK\$1.00 is payable upon acceptance of the grant of an option and such payment shall not be refundable and shall not be deemed to be a part payment of the exercise price.

#### (h) Basis of determining the exercise price

The exercise price shall be such price as determined by the Board and notified to an option-holder and which shall not be less than the higher of: (i) the closing price of the Shares as stated in the Stock Exchange's daily quotation sheets on the date of offer of the option; (ii) the average of the closing price of the Shares as stated in the Stock Exchange's daily quotation sheets for the five trading days immediately preceding the date of offer of the option; and (iii) the nominal value of the Shares.

The purpose of the Share Award Scheme is to recognise the contributions by certain Eligible Persons and to provide them with incentives in order to retain them for the continual operation and development of the Group; and to attract suitable personnel for further development of the Group.

The Board resolved to amend the following key terms of the Share Award Scheme which was effected from 24 November 2023 (the "Amendment Date"):

#### (a) Duration of the Share Award Scheme

The Share Award Scheme shall be valid and effective for a further term of 10 years commencing on the Amendment Date.

#### (b) Eligible Persons for the Share Award Scheme

The following classes of persons (other than excluded person) are eligible for being selected for participation in the Share Award Scheme (the "Eligible Person(s)"):

- (i) director(s) and employee(s) of the Company or any of its Subsidiaries;
- (ii) director(s) and employee(s) of any member of the related entity; and
- (iii) service provider(s).

#### (c) Scheme Limit

The Board shall not make any further award of awarded Shares which will result in the aggregate number of the Shares awarded by the Board under the Share Award Scheme exceeding ten per cent (10%) of the Shares of the Company in issue as at the Amendment Date which is 81,095,524 Shares, representing approximately 10% of the issued Shares as at the date of this annual report.

A selected participant under the Share Award Scheme shall be entitled to receive the awarded Shares vested in him/her in accordance with the vesting schedule (if any) and subject to the selected participant having satisfied all vesting conditions (if any) as specified in the Share Award Scheme or the grant notice.

Upon receipt of the grant notice, the selected participant shall confirm acceptance of the awarded Shares being granted to him by signing and returning to the Board the acceptance form attached to the grant notice within 5 business days after the date of the grant notice.

No consideration is required to be paid upon acceptance of the award by a selected participant.

#### (d) 投票權

CTFE is a substantial shareholder of the Company and, accordingly, a connected person of the Company under Chapter 14A of the Listing Rules. The transactions contemplated under the 2024 Medical Services Framework Renewal Agreement constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

The annual cap for the aggregate fees to be received by the Company from CTFE for FY2025 was HK\$20,000,000 and the actual amount received or receivable by the Company was HK\$15,896,000.

#### D. Medical Services Agreement

On 1 October 2022, UMP Professional Management Limited ("UMP Professional"), an indirect wholly-owned subsidiary of the Company, entered into a Medical Services Agreement with Chow Tai Fook Life Insurance Company Limited (Formerly known as: FTLife Insurance Company Limited) ("CTFLife") in respect of provision and administration of the Medical Services by UMP Professional (or procure its applicable affiliates) to the insured and/or policyholders of CTFLife ("CTFLife Members") and/or respective family members of policyholders of FTLife including spouse and children ("Family Members").

UMP Professional agreed (or procure its applicable affiliates) to provide and administer medical services to CTFLife Members and/or Family Members, including (a) various administrative services including, among others, 24/7 hotline services, third-party administrative services and other ancillary digital support for CTFLife Members and/or Family Members ("Administrative Services"); and (b) medical services including, among others, day procedures, diagnostic imaging services, in-patient surgical procedures, medical advice and other relevant services ("Clinical Services") (collectively, the "Medical Services").

CTFLife is an indirect wholly-owned subsidiary of CTF Services Limited which in turn is a subsidiary of CTFE, whereas CTFE is a substantial shareholder of the Company. Hence, CTFLife is a connected person of the Company and the transactions contemplated under the Medical Services Agreement constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

#### D. 醫療服務協議

於2022年10月1日,本公司間接全資附屬公司聯合醫務專業管理有限公司(「聯合醫務專業」)與周大福人壽保險有限公司(前稱富通保險有限公司)(「周大福人壽」))訂立醫療服務協議,內容有關出聯屬公司)向周大福人壽之受保人及/或保單持有人(「周大福人壽成員」)及/或周大福人壽保單持有人各自之家庭成員(包括配偶及子女)(「家庭成員」)提供及管理醫療服務。

聯合醫務專業同意(或促使其適用之聯屬公司)向周大福人壽成員及/或家庭成員提供及管理醫療服務,包括(a)對象為周大福人壽成員及/或家庭成員的不同行政管理服務,包括(除其他服務外)24/7全天候熱線服務、第三方行政管理服務及其他配套數碼支援(「行政管理服務」);及(b)醫療服務,包括(除其他服務外)日間手術、診斷影像服務、(「臨床服務」)(統稱「醫療服務」)。

周大福人壽為周大福創建有限公司之間接全資附屬公司,而周大福創建有限公司為周大福企業(本公司之主要股東)之附屬公司。因此,周大福人壽為本公司之關連人士,而根據上市規則第十四A章,醫療服務協議項下擬進行之交易構成本公司之持續關連交易。

The term of the Medical Services Agreement shall be for three (3) years commencing from the 1 October 2022, unless terminated in accordance with the terms of the Medical Services Agreement.

The actual demand for the Medical Services under the Medical Services Agreement has exceeded the original expectations which has resulted in a corresponding increase in the total amount of service fees payable by CTFLife to UMP Professional under such agreement. As such, the aggregate amount of service fees payable by CTFLife to UMP Professional under the Medical Services Agreement are expected to be higher than the level envisaged at the time when the parties entered into the Medical Services Agreement. On 11 May 2023, an extraordinary general meeting approved the annual caps (revised) and the transactions contemplated thereunder.

The annual cap for FY2025 received by UMP Professional from CTFLife was HK\$80,000,000 and the actual amount received or receivable by UMP Professional was HK\$50,200,000.

- (c) the transactions have been entered into in accordance with the relevant agreement governing them on terms that are fair and reasonable and in the interests of the Shareholders as a whole.

KPMG, the Company's auditors, were engaged to report on the Group's continuing connected transactions in accordance with Hong Kong Standard on Assurance Engagements 3000 Assurance Engagements Other Than Audits or Reviews of Historical Financial Information and with reference to Practice Note 740 (Revised) Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules issued by the Hong Kong Institute of Certified Public Accountants. KPMG have issued their unqualified letter containing their findings and conclusions in respect of the continuing connected transactions disclosed above by the Group in accordance with Rule 14A.56 of the Listing Rules.

The Company's auditors have reported to the Directors that (i) nothing has come to their attention that causes them to believe that the disclosed continuing connected transactions have not been approved by the Board; (ii) for transactions including the provision of goods or services by the Group, nothing has come to their attention that causes them to believe that the transactions were not, in all material respects, in accordance with the pricing policies of the Group; (iii) nothing has come to their attention that causes them to believe that the disclosed continuing connected transactions were not entered into, in all material respects, in accordance with the relevant agreements governing such transactions; and (iv) with respect to the aggregate amount of each of the above continuing connected transactions, nothing has come to their attention that causes them to believe that the disclosed continuing connected transactions have exceeded the annual cap as set by the Company.

There are no provision for pre-emptive rights under the Articles of Association or the relevant laws of the Cayman Islands where the Company is incorporated which would oblige the Company to offer new shares on a pro-rata basis to existing Shareholders.

#### SUFFICIENCY OF THE PUBLIC FLOAT

Based on the information publicly available to the Company, and to the best knowledge, information and belief of the Directors, the Directors confirm that the Company had maintained a sufficient public float as required under the Listing Rules during FY2025.

## 2.1 BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with HKFRS Accounting Standards (which include all Hong Kong Financial Reporting Standards ("HKFRSs"), Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for equity investments and certain other assets which have been measured at fair value. These consolidated financial statements are presented in Hong Kong dollars and all values are rounded to the nearest thousand except when otherwise indicated.

## **Basis of consolidation**

Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

The consolidated financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. # Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

# **Business combinations and goodwill**

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 30 June. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash- generating units ("CGUs"), or groups of CGUs, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the CGU (group of CGUs) to which the goodwill relates. Where the recoverable amount of the CGU (group of CGUs) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a CGU (or group of CGUs) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the CGU retained.

#### Fair value measurement

The Group measures its equity investments and certain debt investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

- Level 1 based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the consolidated financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

# Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or CGU's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the CGU to which the asset belongs.

In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the consolidated statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the consolidated statement of profit or loss in the period in which it arises.

### Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the CGU level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

#### Brand names

Brand names with indefinite useful lives are stated at cost less any impairment losses, and are not amortised.

### **Customer relationships**

Customer relationships are stated at cost less any impairment losses and are amortised on the straight-line basis over their estimated useful economic lives of 5 years.

## Software

The development cost is stated at cost less any impairment losses and is amortised on the straight-line basis over its estimated useful economic life of 1 year.

#### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

# The Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets. At inception or on reassessment of a contract that contains a lease component and non-lease components, the Group adopts the practical expedient not to separate non-lease components and to account for the lease component and the associated non-lease components (e.g., property management services for leases of properties) as a single lease component.

In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

The Group's lease liabilities are presented separately in the consolidated statement of financial position.

### (c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

### The Group as a lessor

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

When the Group is an intermediate lessor, the sub-leases are classified as a finance lease or as an operating lease with reference to the right-of-use asset arising from the head lease. If the head lease is a short-term lease to which the Group applies the exemption, then the Group classifies the sub-lease as an operating lease.

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15, Revenue from contracts with customers, in accordance with the policies set out for "Revenue recognition" below.

Except for investment in equity securities, in order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

#### Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

# Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the consolidated statement of profit or loss when the asset is derecognised, modified or impaired.

# Financial assets at fair value through other comprehensive income (debt instruments)

For debt investments at fair value through other comprehensive income, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in the consolidated statement of profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to the consolidated statement of profit or loss.

# Financial assets designated at fair value through other comprehensive income (equity investments)

Upon initial recognition, the Group can elect to classify irrevocably its equity investments as equity investments designated at fair value through other comprehensive income when they meet the definition of equity under HKAS 32, *Financial Instruments: Presentation*, and are not held for trading. The classification is determined on an instrument-by-instrument basis.

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

# Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

For debt investments at fair value through other comprehensive income, the Group applies the low credit risk simplification. At each reporting date, the Group evaluates whether the debt investments are considered to have low credit risk using all reasonable and supportable information that is available without undue cost or effort. In making that evaluation, the Group reassesses the external credit ratings of the debt investments. In addition, the Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

The Group considers a financial asset in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

## Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

#### **Financial liabilities**

### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

# Subsequent measurement of financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the consolidated statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is recognised in the consolidated statement of profit or loss.

#### **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the consolidated statement of profit or loss.

## Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the consolidated statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

### **Derivative financial instruments**

Derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently remeasured at fair value. Derivatives are carried as assets when the fair value is positive and as liabilities when the fair value is negative. Any gains or losses arising from changes in fair value of derivatives are taken directly to the consolidated statement of profit or loss.

### Shares held under the share award scheme

Where shares are acquired by the share award scheme from the market or by electing for scrip in lieu of cash dividends, the total consideration of shares acquired from the market (including any directly attributable incremental costs) or under the scrip dividend scheme is presented as shares held for the share award scheme and deducted from total equity.

Upon vesting, the related costs of the vested awarded shares purchased from the market and shares acquired under the scrip dividend scheme (dividend shares) are credited to shares held for the share award scheme, with a corresponding decrease in the share-based payment reserve for awarded shares and a decrease in retained profits for dividend shares.

### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to disposal.

## Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short-term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

#### **Provisions**

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is recognised in the consolidated statement of profit or loss.

A provision for reinstatement costs is recognised when a contractual obligation under the terms of an operating lease has arisen to reinstate a leased property at the end of the lease. Reinstatement costs are provided at the value of the expected costs to settle the obligation at the end of the reporting period using estimated cash flows and an equivalent asset is recognised and depreciated over the term of the operating lease. The estimated future costs of reinstatement are reviewed, and adjusted if appropriate, at least at each financial year end. Changes in the estimated future costs are added to or deducted from the cost of the corresponding asset.

#### **Onerous contracts**

An onerous contract exists when the Company has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract. Provisions for onerous contracts are measured at the present value of the lower of the expected cost of terminating the contract and the net cost of fulfilling the contract. The cost of fulfilling the contract includes both the incremental costs of fulfilling that contract and an allocation of other costs that relate directly to fulfilling that contract.

#### **Income tax**

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries/jurisdictions in which the Group operates.

# **Revenue recognition**

### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

Further details are explained in the accounting policy for "fixed-fee service contracts" below;
- (b) Revenue from the below services are recognised as services are rendered:
  - medical and dental services;
  - healthcare management services; and
  - administrative support services
- dividend income, when the shareholders' right to receive payment has been established;
- (d) interest income, on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset; and
- (e) rental income under operating leases is recognised on the straight-line basis over the terms of the relevant leases.

#### **Fixed-fee service contracts**

The Group has certain medical, dental and other service contracts, in which the Group agrees to provide specific services over the terms of the contracts for a fixed fee in which the level of services depends on uncertain future events (the "Fixed-fee Service Contracts"). The Fixed-fee Service Contracts are in general of one to two years and the Group receives the related service fees upfront. The Contract Customers cannot recover the service fee upon the expiration of the respective fixed-fee service contract periods irrespective of whether the plan members utilised any services under the Fixed-fee Service Contracts.

At the end of each reporting period, tests are performed to ensure the adequacy of the contract liabilities under the Fixed-fee Service Contracts. In performing these tests, the current best estimates of future contractual cash flows under the Fixed-fee Service Contracts are used. Any deficiency is immediately charged to the consolidated statement of profit or loss by establishing a provision for losses.

Fees received or receivable under the Fixed-fee Service Contracts are recognised on a time proportion basis (i.e., straight-line basis) over the terms of the Fixed-fee Service Contracts. At the time of revenue recognition, plan members may not utilise any services under the Fixed-fee Service Contracts and hence, no direct cost will be incurred by the Group in association with the professional services rendered by the doctors, dentists and auxiliary service providers. Accordingly, expenses incurred in connection with the Fixed-fee Service Contracts are charged to the consolidated statement of profit or loss as incurred.

For certain contracts, the Group accepts significant insurance risk by agreeing to compensate the customer if a specified uncertain future event adversely affects the customer. The Group also mitigates the risk by using other contracts to transfer part of the risk to insurance companies. As the coverage period of each of the Group's insurance and reinsurance contracts would be one year or less, they are expected to meet the eligibility criteria and be measured using the premium allocation approach. Those insurance and reinsurance contracts are considered to be insignificant to the Group's consolidated financial statements

#### **Contract liabilities**

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

### **Share-based payments**

The Company operates share option schemes, a share award scheme and warrants scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors), consultants and a business partner of the Group receive remuneration in the form of share-based payments, whereby employees, consultants and a business partner render services as consideration for equity instruments ("equity-settled transactions").

In situations where the share-based payment transactions are with employees of the Group, the cost of equity-settled transactions is measured by reference to the fair value of the equity instruments at the date at which they are granted, taking into account the terms and conditions upon which these equity instruments are granted. In situations where the share-based payment transactions are with non-employees of the Group, the cost of equity-settled transactions is measured by reference to the fair value of goods or services received, unless that fair value cannot be estimated reliably. If the Group cannot estimate reliably the fair value of the goods or services received, indirectly, by reference to the fair value of the equity instruments granted.

The fair value of the share options granted is determined by an external valuer using a binomial model, further details of which are given in note 36 to the consolidated financial statements.

The cost of equity-settled transactions is recognised either in employee benefit expense or other expenses, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the consolidated statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

The Group shall revise the estimates of the amount for the goods or services received if subsequent information indicates that the number of equity instruments expected to vest differs from previous estimates. For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of the modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

## Other employee benefits

#### **Pension schemes**

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the consolidated statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Chinese Mainland are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute certain percentages of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

The employees of the Group's subsidiaries which operate in Macau are required to participate in a social security fund operated by the government of the Macao Special Administrative Region. These subsidiaries are required to contribute certain fixed amounts of their payroll costs to the social security fund. The contributions are charged to the consolidated statement of profit or loss as they become payable in accordance with the rules of the social security fund.

#### **Dividends**

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the consolidated financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

#### **Foreign currencies**

These consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the consolidated statement of profit or loss. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions.

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain subsidiaries outside Hong Kong, associates and a joint venture are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the consolidated statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of subsidiaries outside Hong Kong are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

# 3. ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's consolidated financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### **Estimation uncertainty**

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

### Impairment of goodwill and indefinite-lived intangible assets

The Group determines whether goodwill and indefinite-lived intangible assets are impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill and indefinite-lived intangible assets are allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill and the indefinite-lived intangible assets at 30 June 2025 was HK\$156,604,000 (2024: HK\$164,157,000) and HK\$37,892,000 (2024: HK\$37,892,000), respectively. Further details of impairment testing are set out in note 18 to the consolidated financial statements.

#### 4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and services and has three reportable operating segments as follows:

- (a) Hong Kong & Macau Corporate Healthcare Solution Services segment engages in the provision of corporate healthcare solutions to Contract Customers in Hong Kong and Macau;
- (b) Hong Kong & Macau Clinical Healthcare Services segment engages in the provision of medical and dental services, medical imaging and laboratory services, health check-up, and other auxiliary services in Hong Kong and Macau; and
- (c) Chinese Mainland Clinical Healthcare Services segment engages in the provision of health check-up service and selected outpatient services in Chinese Mainland.

Management monitors the results of the Group's operating segments separately for the purpose of facilitating decision-making process of resources allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/ loss, which is a measure of adjusted profit/loss before tax. The adjusted profit/loss before tax is measured consistently with the Group's profit before tax excluding interest income, other income and gains, and share of profits and losses of joint ventures and associates as well as head office and corporate expenses.

Segment assets exclude goodwill, investments in joint ventures and associates, financial assets at fair value through profit or loss, financial assets at amortised cost, investments at fair value through other comprehensive income, other assets and other unallocated head office and corporate assets as these assets are managed on a group basis.

Segment liabilities exclude derivative financial instrument, and other unallocated head office and corporate liabilities as these liabilities are managed on a group basis.

Inter-segment sales and transfers are transacted with reference to the selling prices used for sales made to third parties at the then prevailing market prices.

Each contract customer has a maximum credit limit. The Group seeks to maintain strict control over its outstanding receivables and has a designated policy to monitor and minimise credit risk. Overdue balances are reviewed regularly by senior management. The Group does not hold any collateral or other credit enhancements over its trade receivable balances. Trade receivables are non-interest bearing.

Withholding tax rate may be applied if there is a tax treaty between Chinese Mainland and the jurisdiction of the foreign investors. For the Group, the applicable rate is 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Chinese Mainland in respect of earnings generated from 1 January 2008.

At 30 June 2025, no deferred tax has been recognised for withholding taxes that would be payable on the unremitted earnings that are subject to withholding taxes of the Group's subsidiaries established in Chinese Mainland. In the opinion of the directors, it is not probable that these subsidiaries will distribute such earnings in the foreseeable future. The aggregate amount of temporary differences associated with investments in subsidiaries in Chinese Mainland for which deferred tax liabilities have not been recognised totalled approximately HK\$59,501,000 at 30 June 2025 (2024: HK\$24,007,000).

There are no income tax consequences attaching to the payment of dividends by the Company to its shareholders.

## **36. SHARE OPTION SCHEMES**Share option schemes

The Company adopted a share option scheme (the Scheme") for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations.

Eligible participants of the Schemes include the Company's directors, including independent non-executive directors, other employees of the Group, consultants of the Group, suppliers of goods or services to the Group, customers of the Group, the Company's shareholders, and any non-controlling shareholder in the Company's subsidiaries. The Scheme became effective on 27 November 2015 and, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

The maximum number of unexercised share options currently permitted to be granted under the Schemes is an amount equivalent, upon their exercise, to 10% of the shares of the Company in issue at any time. The maximum number of shares issuable under share options to each eligible participant in the Schemes within any 12-month period is limited to 1% of the shares of the Company in issue at any time. Any further grant of share options in excess of this limit is subject to shareholders' approval in a general meeting.

Share options granted to a director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the closing price of the Company's shares at the date of grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

Eligible participants of the Share Award Scheme include the Company's directors, senior management and other employees of the Group, and service provider(s) of the Group. The Share Award Scheme shall be valid and effective for a further term of 10 years commencing on the Amendment Date.

The maximum number of shares currently permitted to be granted under the Share Award Scheme is limited to 10% of the issued share capital of the Company as at the Amendment Date. The maximum number of shares which may be awarded to each eligible participant in the Share Award Scheme is limited to 1% of the issued share capital of the Company in each year.

The eligible participant for participation in the Share Award Scheme (the "Selected Participant") is selected and the number of shares to be awarded under the Share Award Scheme is determined by the board of directors. The shares to be awarded under the Share Award Scheme will be purchased by a trustee (the "Trustee") from the open market out of cash contributed by the Group and be held on trust for the Selected Participant until such shares are vested with the Selected Participant in accordance with the provisions of the Share Award Scheme.

The Trustee shall not exercise the voting rights in respect of any shares held on trust for the Group or the Selected Participant.

During the year, the Group purchased 440,000 (2024: 802,000) of its own shares through the Trustee from the open market. The total amount paid to acquire the shares was approximately HK\$180,000 (2024: HK\$463,399) and has been deducted from equity. As at 30 June 2025, such shares were classified as treasury shares of the Company as they were not yet vested.

The Group's principal financial instruments comprise cash and cash equivalents and short term deposits. The main purpose of these financial instruments is to finance the Group's operations. The Group has various other financial assets and liabilities such as trade receivables and trade payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

### Credit risk

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

With respect to listed equity and debt investments, the Group purchases and holds them only through various creditworthy financial institutions.

### Maximum exposure and year-end staging

The tables below show the credit quality and the maximum exposure to credit risk based on the Group's credit policy, which is mainly based on past due information unless other information is available without undue cost or effort, and year-end staging classification as at 30 June. For listed debt investments, the Group also monitors them by using external credit ratings and ensures that investments are only made in debts meeting a certain credit rating to minimise credit risk. The amounts presented are gross carrying amounts for financial assets.
