#### 管理層討論與分析

#### **BUSINESS REVIEW**

For the year ended 31st March, 2021, UBA Investments Limited and its subsidiaries (the "Group") recorded a loss attributable to owners of approximately HK\$8.7 million (2020: HK\$44.5 million) of which unrealised loss of HK\$0.85 million (2020: unrealised loss HK\$37.8 million) in relation to the listed securities and realised and unrealised loss of HK\$5.3 million and HK\$2.1 million respectively (2020: unrealised loss HK\$4.1 million) in relation to the unlisted equity investment. The loss per share was HK\$0.0068 (2020: HK\$0.035). Gross proceeds from disposal of trading securities significantly decreased 85% from HK\$17.6 million to HK\$2.6 million as the Group reduced the investment proportion on trading listed securities under the uncertainty of economic environment affected by COVID-19 pandemic during the period. In order to minimize the potential loss generated in the highly volatile stock markets under the COVID-19, the Group needs to be prudent and kept those high yield and blue chip listed securities in order to generate dividend for operations and sufficient fund for the coming investment opportunities. Therefore, it was not in line with the increasing transaction volume of approximately 67% in Hang Seng Index ("HSI") compared with last year. As at 31st March, 2021, the net assets of the Group were approximately HK\$104.7million (2020: HK\$113.4 million). The net assets decreased by 7.7% when compared with last year, which is not in line with the increase of 20% in HSI during this year mainly due to the realised loss on disposal of unlisted equity investment amount HK\$ 5.3 million and unrealised loss on unlisted equity investment amount HK2.1 million. In addition, it was because the increase of share price of those high yield listed securities kept by the Group underperformed HSI.

During the corresponding period, the global and local equity markets had experienced intense volatility. The Group's proactive investment strategy was to maximize profit for shareholders during the period, through investment in listed securities with relatively high yield and more stable, especially the bank and telecommunication sectors which contributed 86% in dividend income in which all dividend income were generated from listed securities investment during the year.

As at 31st March, 2021, the Group's investment portfolio was well diversified and comprised of different sectors including bank, telecommunications, transportation, retail businesses, properties, manufacturing, construction etc, in which investment in listed securities amounted HK\$99.9 million (2020: HK\$91.2 million) and unlisted investment with fair value at amount HK\$1.5 million (2020: HK\$12.6 million) which match with the strategy of the Group. The significant decrease of the unlisted investment was mainly due to one of the unlisted investment was disposed during the year.

#### 業務回顧

開明投資有限公司及其附屬公司(「本集團」)截 至二零二一年三月三十一日年度止,本集團股 東應佔虧損約為8,700,000港元(二零二零年:約 為 44,500,000港元),其中關於按上市證券的未 變現虧損約為850,000港元(二零二零年:未變 現虧損約為37,800,000港元),而關於非上市股 本投資的變現及未變現虧損分別約為5.300.000 港元及2,100,000港元(二零二零年:未變現虧損 4,100,000港元)。每股虧損為0.0068港元(二零 二零年: 虧損為0.035港元)。出售交易證券所得 款項總額由去年同期約17,600,000港元急降85% 至約2,600,000港元,成因是本集團受2019冠狀 病毒病疫情爆發的不確定性經濟環境期間下減 少對上市證券交易的投資意願所致。而且為了 最大程度地減少受2019冠狀病毒病疫情下高波 動性股票市場產生的潛在損失,本集團須謹慎 行事, 並保留更多的高息和藍籌上市證券, 以便 產生足夠的股息收入作為營運用途並為未來的 投資機會提供足夠的資金。因此,與恆生指數同 期上升約67%的交易量不同。本集團於二零二一 年三月三十一日之資產淨值約為104,700,000 港元(二零二零年:約為113,400,000港元)。淨 資產較去年減少約7.7%,與本年度恆指的20% 增幅並不相符,主要是由於出售非上市投資約 5.300,000港元的虧損及非上市投資的未變現虧 損約2,100,000港元。再加上本集團持有的高息 上市證券股價升幅表現遜於恆指所致。

在相應期間,全球及本地股票市場經歷了劇烈的波動。本集團期間的積極投資策略為使股東利潤最大化,並主要投資於收益率及穩定性相對較高的證券,尤其是銀行及電訊板塊,共佔本集團本年度約86%的股息收入,而本期間全部股息收入均來自上市股本證券。

於二零二一年三月三十一日,本集團之投資組合頗多元化,其中包括銀行、電訊服務、交通運輸、零售、地產、製造業及建造業等不同業務,當中上市股本證券約為99,900,000港元(二零二零年三月三十一日:約91,200,000港元)及按公平值之非上市投資約為1,500,000港元(二零二年三月三十一日:約12,600,000港元),此亦符合本隻團之投資方針。非上市投資大幅減少的主要原因是本年度變賣了一項非上市投資。

The strategy of the Group in short term is to trade listed securities depending on the market sentiment and to maintain sufficient dividend level for the Group operation. For the long term strategy, it is to balance the listed and unlisted investment so as to bring better returns for our shareholders and to maintain sufficient liquidity for the future actions when fluctuation in stock markets and investing in unlisted investment may have higher potentials. In addition, the Group would conduct further review on acquisition of the unlisted equity investment from time to time in the future.

本集團短期投資策略為買賣上市證券以維持足夠的股息水平以運作集團業務。而長期策略是平衡上市及非上市投資,目的為股東帶來更佳回報,並在維持充足流動資金以便可以在股票市場波動時及可能出現具有高潛力之非上市投資時作出投資。此外,本集團未來將不時對收購非上市投資進行進一步審查。

During the corresponding year, the trend of the stock markets were similar between United States ("U.S."), China and Hong Kong. All these equity markets had experienced an uptrend. It was mainly due to the effect of the fiscal stimulus in U.S. and China and the release of the COVID-19 vaccines around the world bringing economies back from the brink and led the economic recovery and bull market in stocks was born.

在相應期間,美國、中國及香港股票市場走勢相約。全部股票市場正經歷上升趨勢。上升趨勢主要是由於受美國及中國的財政刺激政策以及2019冠狀病毒病疫苗發佈的影響,使經濟從瀕臨崩潰的邊緣重回正軌,經濟復甦和誕生股票牛市。

The negative impact of elevated uncertainty surrounding the COVID-19 pandemic was carrying over from last period along with surging COVID infections in the world, which led to a depressing economy in U.S. and European countries in the beginning of second quarter of 2020. However, the U.S. Federal Reserve (the "Fed") indicated that interest rates would remain nearly 0% throughout 2022. In addition, the Fed initiated Quantitative Easing (the "QE") and the State purchased unlimited amount of Treasury securities and agency mortgage-backedsecurities together with the US\$ 1.9 trillion American Rescue Plan announced by the New U.S. President Joe Biden, which include at least 400 billion US dollars to solve the COVID crisis by expanding the scope of testing and COVID vaccination, etc, which stimulated the equity markets. Together with the good economic data, such as reduction in unemployment rate and improvement in PMI, and most important is the release of COVID-19 vaccines during the year brought positive market sentiment to the investors and drove the U.S. economy and stimulated the U.S. stock markets during the year. The Dow Jones Index increased sharply by approximately 50% from 21,917 at the end of March 2020 to 32,981 at the end of March 2021.

受上季度2019冠狀病毒病疫情爆發的不確定性 上升及全球感染激增而引致的負面影響,二零二 零年第二季度初美國經濟處於低迷狀態。但是, 美國聯邦儲備局(「聯儲局」)指出直至二零二二 年前,利率將保持在接近0%的水平。此外,聯 儲局啟動了量化寬鬆政策(「量化寬鬆」),美國將 購買無上限數量的美國國債和機構抵押貸款支持 證券,以及美國新總統喬.拜登宣布的1.9萬億美 元疫情紓困方案,其中包括至少4,000億美元用 作擴大2019冠狀病毒測試範圍和疫苗接種來解 決2019冠狀病毒危機,從而刺激了股市。再加上 良好的經濟數據,例如失業率的下降和PMI的改 善,及最重要於本年度內2019冠狀病毒疫苗的發 佈,推動了美國經濟並刺激了美國股市。道瓊斯 指數從二零二零年三月底的21,917升至二零二一 年三月底的32.981,增長了約50%。

Meanwhile, the China stock markets sentiment had experienced an uptrend which was similar to U.S. and Europe during the year as the epidemic of COVID-19 started to ease in China, especially after the release of the COVID-19 vaccines during the year. In addition, the Chinese Government announced a series of stabilized policies to stimulate economy, especially after the announcement of the Fourteenth Five-Year Plan for National Economic and Social Development in which the Chinese Government will focus on the new generation of information technology, biotechnology, new energy, new materials, high-end equipment, etc ("new economy business") which lead to increase in the prospects and confidence in new economy business companies. Together with the good economic data just like the uptrend of the Caixin China Manufacturing Purchasing Managers Index ("PMI") from April 2020 at 49.4 to 50.6 at the end of March 2021 and the increase in the valuation of the RMB against USD by approximately 8% during the year. In addition, the GDP had significant improvement as the first quarter 2021 increased 18.3% comparing with last corresponding period. The Shanghai Composite Index increased approximately 25% from 2,750 at the end of March 2020 to 3,441 at the end of March 2021.

Back to the Hong Kong Stock Markets, which were highly sensitive to the news of the global economy, especially the negative impact from COVID-19 pandemic and U.S. executive order to abolish the preferential tariff rates for exports to United States from Hong Kong in June 2020. However, the positive impact from QE of U.S., Chinese economic stimulate policy and the release of COVID-19 vaccines during the year outweighed the negative impact. As a result, the HSI also increase significantly approximately 20% from 23,603 at the end of March 2020 to 28,378 at the end of March 2021.

#### **PROSPECTS**

Notwithstanding positive impacts the year, we expect global economy will be full of challenges in the coming few months even though benefiting from the rebound economics in U.S., Europe and PRC, low interest rate environment worldwide and the release of the COVID -19 vaccines, which may enhance the investment desire and confidence of investors around the world and keep the global stock markets flourishing. On the flip side, we also remain cautious of the impact of the COVID-19 pandemic outbreak seriously in other backward countries which may bring negative effect toward the global economics.

Due to these reasons, the Group remains cautiously optimistic about the outlook of the global as well as Hong Kong equity markets. We may consider investing in more relatively high yield listed securities and maintain sufficient liquidity for future investment opportunities to enrich our investment portfolios. We will also continue to adopt and maintain a cautious and pragmatic investment approach in order to bring better returns for our shareholders.

另一邊廂,隨著2019冠狀病毒病疫情在中國受 控,尤其在2019冠狀病毒疫苗發佈後,使中國股 市投資氣氛旺盛亦與歐美相似。此外,中國政府 宣布了一系列刺激經濟的穩定政策,特別是在宣 布《國民經濟和社會發展第十四個五年計劃》之 後,中國政府將把重點放在新一代信息技術、生 物技術、新能源、新材料及高端設備等之上(「新 經濟業務」),從而增加了對新經濟業務公司的前 景和信心。加上良好的經濟數據,如中國製造業 採購經理人指數(「PMI」)的趨勢從二零二零年四 月的49.4上升至二零二一年三月底的50.6,人民 幣對美元的估值上升了約8%。此外,中國國內 生產總值亦有了顯著改善,二零二一年第一季度 與去年同期相比增長了約18.3%。上海綜合指數 從二零二零年三月底的2.750增長到二零二一年 三月底的3,441,增長了約25%。

至於香港股票市場,對周遭環球經濟形勢十分敏感,尤其是來自2019冠狀病毒病疫情及於二零二零年六月美國總統指示行政命令廢除美國對香港的特惠關稅待遇的負面影響。然而,美國的量化寬鬆和中國經濟刺激政策以及2019冠狀病毒疫苗發佈後的利好消息,抵消了上述負面影響。最終恆指由二零二零年三月底的23,603大幅上升約20%至二零二一年三月底的28,378。

#### 前景

儘管本年度面對很多正面影響,對受益於美國、歐洲和中國的經濟反彈,全球低息環境以及2019 冠狀病毒疫苗的發佈,可能會增強全球投資者的投資慾及信心,使全球股市蓬勃發展。但我們預期未來數月仍充滿挑戰。因我們也對在其他落後國家嚴重爆發2019冠狀病毒病疫情的影響保持謹慎,這可能給全球經濟帶來負面影響。

因此,本集團對全球及香港股票市場的前景仍保持審慎樂觀的態度。我們會考慮投資於股息相對較高的上市證券,並為未來的投資機會保持充足的流動性,以豐富我們的投資組合。我們將繼續採取及保持謹慎和務實的投資方針,期望為我們的股東帶來更好的回報。

A brief description of the business, financial performance and prospect of the Listed securities investment is as follows:

#### 1. CK Hutchison Holdings Limited ("CKH Holdings")

CKH Holdings is incorporated in Cayman Islands and is principally engaged in ports and related services, retail, infrastructure, energy and telecommunication industries.

Pursuant to the annual report for the year ended 31<sup>st</sup> December, 2020, CKH Holdings recorded revenue of approximately HK\$266,396 million, total comprehensive income of approximately HK\$54,715 million and net assets of approximately HK\$630,063 million.

On a Pre-IFRS 16 basis, EBITDA and EBIT decreased 13% and 24% respectively against last year, primarily reflecting the adverse full year performances due to the pandemic. Comparing against the first half of the year, excluding the one-time transactional gains, as well as the share of Husky's impairment and other charges, all operations have seen some recovery in the second half, with the overall underlying EBITDA and EBIT increasing 38% and 65% respectively against the first six months of 2020. Profit attributable to ordinary shareholders for 2020 of HK\$29,000 million, a decrease of 27% compared to 2019. On a Post-IFRS 16 basis, profit attributable to ordinary shareholders of HK\$29,143 million decreased by 27% from 2019. Earnings per share were HK\$7.56 for the year ended 31st December, 2020, a decrease of 27%.

The Group concurs with that CKH Holdings believes that, in 2021, CKH Holdings will continue to react nimbly to changing business conditions, which will likely be similar to the second half of 2020, while continuing to prioritise health and safety for employees and customers and preserving strong balance sheet and liquidity. CKH Holdings' year end net debt to net total capital ratio of 22.2% is expected to be further reduced following the various transactions completing in 2021. CKH Holdings is in a strong financial position and expects solid performance in 2021. Therefore, the Group holds 50,000 shares in CKH Holdings, representing 0.001% interest in the issued share capital of CKH Holdings based on the annual report at 31st December, 2020, and derived a dividend income of HK\$122,000 for the year ended 31st March, 2021.

上市證券投資的業務,財務表現及前景簡述如 下:

1. 長江和記實業有限公司(「長江和記」) 長江和記於開曼群島註冊成立,主要經 營物業為港口及相關服務、零售、基建、 能源以及電訊行業。

根據截至二零二零年十二月三十一日止年報,長江和記錄得收益約266,396,000,000港元,綜合收益總額約54,715,000,000港元及淨資產約630,063,000,000港元。

按IFRS 16前基準,EBITDA及EBIT較去年分別減少13%及24%,主要反映疫情導致全年表現逆轉。與上半年相比,撇除一次性之交易收益,以及集團於上半年所佔赫斯基之減值及其他支出份額,不有業務於下半年均重拾增長,整體基本EBITDA及EBIT較二零二零年首六之普通股股東應佔溢利為29,000,000,000港元,較二零一九年減少27%。按IFRS 16後基準,普通股股東應佔溢利為港幣29,143,000,000港元,較二零一九年減少27%。截至二零二零年十二月三十一日止年度之每股盈利為港幣7.56元,減少27%。

### 2. PCCW Limited ("PCCW")

PCCW is incorporated in Hong Kong and is principally engaged in telecommunications, media, IT solutions, property development and investment, and other business.

Pursuant to the report for the year ended 31st December, 2020, PCCW recorded revenue of approximately HK\$38,046 million, total comprehensive income of approximately HK\$674 million and net assets of approximately HK\$13,554 million. PCCW recorded a steady performance for the year ended 31st December, 2020, even as the COVID-19 pandemic persisted throughout the year and severely disrupted normal economic activity and life around the world.

The Group believes that, the economic outlook in 2021 for Hong Kong and the world is clouded by the pandemic and external factors including persistent tensions between China and the US. But with PCCW established local leadership and strong regional presence, PCCW are determined to continue deploying technology, creativity and innovation to support customer needs under the new normal and in the post-pandemic recovery. Therefore, the Group holds 5,800,265 shares in PCCW, representing 0.075% interest in the issued share capital of PCCW based on the annual report at 31st December, 2020 and derived a dividend income of HK\$1,855,000 for the year ended 31st March, 2021.

#### 3. MTR Corporation Limited ("MTR")

MTR is incorporated in Hong Kong and is principally engaged in provision in the following businesses – railway design, construction, operation, maintenance and investment in Hong Kong, the Mainland of China and a number of major overseas cities.

Pursuant to the annual report for the year ended 31st December, 2020, MTR recorded total revenue of approximately HK\$42,541 million, net loss of approximately HK\$4,809 million and net assets of approximately HK\$176,981 million. The financial results were affected by the significant impact of the COVID-19 pandemic. Loss arising from recurrent businesses for the year was HK\$1,126 million. Property development profit for the year decreased by 1.3% to HK\$5,507 million. As a result, profit arising from underlying businesses decreased by 58.5% to HK\$4,381 million.

#### 2. 電訊盈科有限公司(「電盈」)

電盈於香港註冊成立,主要業務為提供 電訊、媒體、資訊科技服務方案、物業發 展及投資以及其他業務。

根據截至二零二零年十二月三十一日止年報,電盈錄得收益約38,046,000,000港元,綜合收益總額約674,000,000港元及淨資產約13,554,000,000港元。雖然年內2019冠狀病毒疫情徘徊不退,嚴重打擊世界各地的日常經濟活動及市民生活,但電訊盈科於截至二零二零年十二月三十一日止年度仍錄得穩定的業績。

本集團相信在疫情持續及中美關係緊張等外在因素的影響下,香港以至全電工零二一年的經濟前景並不明朗。電盈在本地穩佔領先地位,在區內市場業為亦有穩固基礎,電盈繼續運用科技後,電型,為20,265股電盈股份,根據電盈於二零年十二月三十一日之年報佔電盈已發行股本之0.075%及於截至二零二一年股下,2000港元股息。

#### 3. 香港鐵路有限公司(「港鐵」)

港鐵於香港註冊成立,主要經營之業務 為於香港、澳門、中國內地和數個海外城 市參與鐵路設計、建造、營運、維修及投 資。

根據截至二零二零年十二月三十一日止年報,港鐵全面收益總約42,541,000,000港元,虧損約4,809,000,000港元及淨資產的176,981,000,000港元。港鐵財務表現因新冠病毒疫情而受嚴重影響。二零二零年,來自經常性業務的虧損為1,126,000,000港元。年內的物業發展利潤減少1.3%至5,507,000,000港元。因此,來自基本業務的利潤減少58.5%至4,381,000,000港元。

The Group believes that while in the near terms economic outlook remains challenging, MTR has reasons to be optimistic about their medium to long-term future. Despite the fact that businesses suffered to varying degrees in 2020, MTR is in a solid financial position, and they continue to drive a number of projects and developments that offer strong potential. Therefore, the Group holds 183,775 shares in MTR, representing 0.003% interest in the issued share capital of MTR based on the annual report at 31st December, 2020. No dividend was received during the year.

#### 4. i-Control Holdings Limited ("i-Control")

i-Control is incorporated in Cayman Islands and is principally engaged in provision of video conferencing and multimedia audiovisual solution ("VCMA") and related system integration services in Hong Kong.

Pursuant to the interim report for the six months ended 30<sup>th</sup> September, 2020, i-Control recorded revenue of approximately HK\$75 million, total comprehensive income of approximately HK\$9 million and net assets of approximately HK\$142 million. Profit for the period increased from approximately HK\$1,130,000 for the six months ended 30<sup>th</sup> September, 2019 to approximately HK\$9,495,000 for the six months ended 30<sup>th</sup> September, 2020, which was mainly due to the decreased in gross operating profit net off with the effect of (i) no non-recurring transfer listing expenses incurred in relation to the transfer of listing during the period; (ii) decrease in income tax expenses; and (iii) subsidy from employment Support Scheme of approximately HK\$2,312,000. Excluding the subsidy from Employment Support Scheme, i-Control's adjusted profit for the period would be approximately HK\$7,183,000.

The Group concurs with i-Control will continue to closely monitor the development of COVID-19 and new precautionary measures and evaluate the policies of the i-Control to minimize the epidemic's impact on the business of i-Control. Meanwhile, i-Control will seize business opportunities with gradual relaxation in anti-epidemic measures and continue to seek and explore new opportunities to expand the i-Control's business in order to support long-term development of i-Control. Therefore, the Group holds 6,000,000 shares in i-Control, representing 0.6% interest in the issued share capital of i-Control based on interim report ended at 30th September, 2020 and derived a dividend income of approximately HK\$26,000 for the year ended 31st March, 2021.

#### 4. 超智能控股有限公司(「超智能」)

超智能於開曼群島註冊成立,主要經營香港的視像會議及多媒體影音(「視像會議及多媒體影音(」)解決方案。

根據超智能截至二零二零年九月三十日止之中期報告,超智能錄得收益約75,000,000港元,綜合收益總額約9,000,000港元及淨資產約142,000,000港元。年度溢利由截至二零一九年九月三十日止六個月約1,130,000港元增加至截至二零二零年九月三十日止六個月的第至二零二零年九月三十日止六個月數等五十十日,該期間支:(ii) 所得稅開支減少:及(iii) 僱員支持計劃補助約2,312,000港元。扣除僱員支持計劃補助約2,312,000港元。扣除僱員支持計劃補助後,超智能期內經調整溢利為約7,183,000港元。

#### 5. JBB Builders International Limited ("JBBI")

JBBI is incorporated in Cayman Islands. It is an investment holding company and its subsidiaries are principally engaged in the provision of marine construction services and building and infrastructure services.

Pursuant to the interim report ended 31st December, 2020, JBBI recorded revenue of approximately RM34.6 million, total comprehensive loss of approximately RM8 million and net assets of approximately RM128 million. Revenue decreased by approximately RM56.7 million or 62.1% from approximately RM91.3 million for the six months ended 31st December, 2019 to approximately RM34.6 million for the six months ended 31st December, 2020. The substantial decline in revenue is mainly attributable to (i) the reduction in volume of work for marine construction services and building and infrastructure services following the completion of certain key contracts which contributed to a substantial portion of the revenue for the six months ended 31st December, 2019; and (ii) the suspension of the JBBI's ongoing contracts, postponement of the scheduled construction works and further delay in the commencement of new contracts secured in earlier periods due to the long lasting COVID-19 Outbreak and the enforcement of the conditional Restriction of Movement Order by Malaysia government.

The Group concurs with JBBI continue to leverage the advantageous financial position of JBBI and to explore new business opportunities in Malaysia, Singapore and Hong Kong and at the same time strengthen JBBI presence and market position in marine construction and building and infrastructure services industry. Therefore, the Group holds 4,644,000 shares in JBBI, representing 0.93% interest in the issued share capital of JBBI based on the interim report ended 31st December, 2020. No dividend was received during the year.

## 5. JBB Builders International Limited (「JBBI |)

JBBI於開曼群島註冊成立,為投資控股公司,其附屬公司主要經營提供海上建築服務及樓宇及基礎設施服務。

根據JBBI截至二零二零年十二月 三十一日止之中期報告,JBBI錄得 收益約34,600,000林吉特,綜合虧損 總額約8,000,000林吉特及淨資產約 128,000,000林吉特。收益由截至二零 一九年十二月三十一日止六個月的約 91,300,000林吉特減少約 56,700,000 林吉特或62.1%至截至二零二零年十二 月三十一日止六個月的約34,600,000林 吉特。收益大幅下降主要由於(i) 於若干 主要合約(其佔截至二零一九年十二月 三十一日止六個月收益之大部分) 完成 後,海上建築服務以及樓宇及基礎設施 服務工作量減少;及(ii) 2019新冠病毒疫 情持續及馬來西亞政府實施有條件限制 令導致該集團進行中的合約被暫停、計 劃中的工程被延遲以及過往期間取得的 新合約進一步延遲動工。

本集團相信,JBBI將繼續利用集團有利的財務狀況,發掘馬來西亞、新加坡及香港的新商機,同時加強JBBI於海上建築以及樓宇及基礎設施服務行業的業務及市場地位。因此,本集團持有4,644,000股JBBI股份,根據JBBI於二零二零年十二月三十一日止之中期報告佔JBBI已發行股本之0.93%。本年度並無收取股息。

#### 6. Bank of Communications Co., Ltd. ("Bank Com.")

Bank Com. is incorporated in the PRC and is principally engaged in provision of banking and related financial services.

Pursuant to the annual report for the year ended 31st December, 2020, Bank Com. recorded profit of approximately RMB79,570 million, total comprehensive income of approximately RMB 71,021 million and net assets of approximately RMB878,628 million. During the period, Bank Com. realised a profit attributable to shareholders of Bank Com. of approximately RMB78,274 million, an increase of approximately 1.28% compared with prior year. Return on average total assets ("ROA") was 0.77% and return on average equity ("ROE") was 11.35%.

The Group concurs with Bank Com. believes that, looking forward into 2021, the international economic situation will remain complex and challenging, and the global economy recovery is still going to be tottering, but the fundamentals of China's long-term economic development remain positive. The pandemic prevention and control results will continue to consolidate, and the macro policies will remain their continuity, stability and sustainability. The implementation of policy would be more targeted and effective. Overall, during 2021 and the period of the "14th Five-Year Plan", the banking industry will switch from rapid growth to a new phase of high-quality development, with opportunities going together with challenges. Therefore, the Group holds 1,200,000 shares in Bank Com., representing 0.002% interest in the issued share capital of Bank Com. based on the annual report at 31st December, 2020 and derived a dividend income of HK\$381,000 for the year ended 31st March, 2021.

6. 交通銀行股份有限公司(「交通銀行」) 交通銀行於中華人民共和國註冊成立, 主要提供銀行和其相關財務服務。

根據交通銀行截至二零二零年十二月三十一日止之年報,交通銀行錄得利潤約人民幣79,570,000,000,綜合收益總額約人民幣71,021,000,000及淨資產約人民幣878,628,000,000。年內,交通銀行之股東應佔溢利約人民幣78,274,000,000元,較去年同期上升1.28%。平均總資產回報率(ROA)為0.77%,平均股本回報率(ROE)為11.35%。

#### 7. Bank of China Limited ("BOC")

BOC is incorporated in the PRC and is principally engaged in provision a full range of corporate banking, personal banking, treasury operations, investment banking, insurance and other services to its customers in the Chinese mainland, Hong Kong, Macau, Taiwan and other major international financial centres.

Pursuant to the annual report for the year ended 31st December, 2020, BOC recorded profit of approximately RMB205,096 million, total comprehensive income of approximately RMB182,234 million and net assets of RMB2,162,837 million. BOC realised a profit attributable to equity Holders of RMB192,870 million, a year-on-year increase of 2.92%. Return on average total assets ("ROA") was 0.87%, and return on average equity ("ROE") was 10.61%.

The Group concurs with BOC believes that, in 2021, the banking industry will face a complicated operating environment. From an international perspective, the world economic situation remains complication and grim. The global economic recovery is expected to be unstable and uneven, and the potential risks caused by COVID-19 pandemic should not be ignored. From a domestic perspective, China's economy is in good condition from a long-term perspective, with the new development pattern being built at an accelerating pace and endogenous capacity gradually improving. Therefore, the Group holds 4,600,000 shares in BOC, representing 0.002% interest in the issued share capital of BOC based on the annual report at 31st December, 2020 and derived a dividend income of HK\$861,000 for the year ended 31st March, 2021.

#### 7. 中國銀行股份有限公司(「中國銀行」)

中國銀行於中華人民共和國註冊成立, 主要在中國內地、香港、澳門、台灣以及 國際主要金融中心地區為其客戶從事全 面的公司金融業務、個人金融業務、資金 業務、投資銀行業務、保險業務和其他業 務。

根據中國銀行截至二零二零年十二月三十一日止之年報,中國銀行錄得利潤約人民幣205,096,000,000,綜合收益總額約人民幣182,234,000,000及淨資產約人民幣2,162,837,000,000。年內,中國銀行之股東應佔溢利約人民幣192,870,000,000,較去年同期上升2.92%。平均總資產回報率(ROA)為0.87%,平均股本回報率(ROE)為10.61%。

本集團認同中國銀行對二零二一年,銀行業仍將面臨較為複雜的經營環境。從國際來看,世界經濟形勢仍然複雜嚴峻,復甦不穩定不平衡,疫情衝擊導致的各類潛在風險不容忽視。從國內來看,中國經濟長期向好,新發展格局加快構建,內部產生動能逐步增強。因此,本集團持有4,600,000股中國銀行之股份,根據中國銀行於二零二零年十二月三十一日止之年報佔中國銀行已發行股本之0.002%及於截至二零二一年三月三十一日共收取約861,000港元股息。

#### 8. Gemilang International Limited ("Gemilang")

Gemilang is incorporated in Cayman Islands and is principally engaged in design and manufacture bus bodies and assemble buses and have over 25 years of track record in the industry.

Pursuant to the annual report for the year ended 31st October, 2020, Gemilang recorded revenue of approximately US\$31 million, total comprehensive income of approximately US\$0.3 million and net assets of approximately US\$20 million. Gemilang recorded a revenue of approximately US\$31 million, representing a significant decrease of approximately US\$31 million, representing a significant decrease of approximately 50.68% from approximately US\$63 million in the financial year ended 31st October, 2019. The decrease in revenue was primarily due to the decrease in the delivery of bus bodies to Singapore and the United Arab Emirates during the year as compared to the year ended 31st October, 2019.

The Group believes that Gemilang objective is to become one of the leading bus manufacturing solution providers in Asia. Gemilang believes the Asia market has a lot of growth potential as countries continue to urbanise with a growth population and bus is a convenient and cost efficient form of public transportation that can be implemented in many areas. Gemilang believes they are well positioned and equipped with the technological capability to capture this opportunity. Therefore, the Group holds 4,791,250 shares in Gemilang, representing 1.906% interest in the issued share capital of Gemilang based on the annual report at 31st October, 2020. No dividend was received during the year.

#### 9. Kwong Man Kee Group Limited ("KMK")

KMK is incorporated in Cayman Islands and is principally engaged in provision of engineering services in flooring, screeding, anti-skid surfacing and concrete repairing.

Pursuant to the interim report ended 30th September, 2020, KMK recorded revenue of approximately HK\$64 million, and total comprehensive income of approximately HK\$11 million and net assets of approximately HK\$96 million. During the period, the increase of revenue was mainly driven by the increase in the number of projects undertaken by KMK during the six months ended 30th September, 2020.

#### 8. 彭順國際有限公司(「彭順」)

彭順為於開曼群島註冊成立之經營實體, 主要從事設計及製造車身及裝配巴士並 擁有超過25年的相關行業經驗。

根據彭順截至二零二零年十月三十一日 止之年報,彭順錄得收益約31,000,000 美元,綜合收益總額約300,000美元及淨 資產約20,000,000美元。集團錄得收益 約31,000,000美元,較截至二零一九年 十月三十一日止財政年度約63,000,000 美元顯著減少約50.68%。收益減少主要 由於本年度交付至新加坡及阿拉伯聯合 酋長國之巴士車身數目較截至二零一九 年十月三十一日止年度減少。

本集團認為彭順的目標是成為亞洲領先的巴士製造解決方案供應商。彭順認為,隨著國家持續城市化及人口的不斷增長,巴士為許多地區可配備的便捷且具成或應的公共交通形式。因此亞洲市場且長潛力巨大。彭順相信已準備就緒且具備技術實力把握該商機。因此,本集團持有4,791,250股彭順之股份,根據彭順已發行股本之1.906%。本年度並無收取股息。

#### 9. 鄺文記集團有限公司(「鄺文記」)

鄺文記為於開曼群島註冊成立,主要從 事地板工程、塗刷、防滑表面及混凝土維 修服務。

根據鄺文記截至二零二零年九月三十日止之中期報告,鄺文記錄得收入約64,000,000港元,綜合收益總額約11,000,000港元及淨資產約96,000,000港元。收益增加主要由於截至二零二零年九月三十日止六個月,鄺文記所承造的工程數目有所增加。

The Group concurs with KMK believes that, in light of the prevailing market and economic uncertainty (in particular, the impact of COVID-19 pandemic) and the keen competition in car park flooring market, KMK will continue to strengthen its market position and income stream by focusing on the following business strategies: (i) explore any new opportunities to diversify its business; (ii) keep track of any new construction projects and refurbishment projects in car park flooring markets in Hong Kong and Macau; (iii) expand the business in ancillary service, i.e. specialized texture painting and waterproofing works; and (iv) take measures to control the operating cost, such as the labour and material costs, as well as general administrative expenses. Therefore, the Group holds 30,003,000 shares in KMK, representing 5% interest in the issued share capital of KMK based on the interim report at 30th September, 2020. No dividend was received during the year.

#### 10. Shen You Holdings Limited ("Shen You")

Shen You is incorporated in Cayman Islands and is principally engaged in the manufacture and trading of sewing threads and broad categories of garment accessories.

Pursuant to the annual report for the year ended 31st December, 2020, Shen You recorded revenue of approximately HK\$45 million, total comprehensive loss of approximately HK\$12 million and net assets of approximately HK\$46 million. Shen You's net loss decreased to approximately HK\$15.6 million for the year ended 31st December, 2020 from approximately HK\$19.2 million for the year ended 31st December, 2019, representing a decrease of approximately 18.9%. Such decrease in net loss was mainly due to the decrease in impairment losses on financial assets of approximately HK\$3.0 million and decreased in the finance cost of approximately HK\$0.9 million during the year ended 31st December, 2020.

The Group believes that Shen You would continue to review the existing businesses from time to time with a view to improving the business operation and financial position of Shen You. Shen You is in the course of feasibility study to invest in new business related to quality thoroughbred, acquire the horse racing and breeding operations.

#### 10. 申酉控股有限公司(「申酉」)

申酉為於開曼群島註冊成立,主要從事 生產及銷售縫紉線和各類服裝輔料。

根據申酉截至二零二零年十二月三十一日 止之年報,申酉錄得收益約45,000,000 港元,全面虧損總額約12,000,000港元 及淨資產約46,000,000港元。截至二零 二零年十二月三十一日止年度申酉的虧 損淨額由截至二零一九年十二月三十一 日止年度約 19,200,000港元下跌至約 15,600,000港元,相當於大幅下跌約 18.9%。有關虧損淨額下降乃主要由於與 截至二零一九年十二月三十一日止年度相 比,截至二零二零年十二月三十一日止年 度的金融資產減值虧損增加約3,000,000 港元及財務成本減少約900,000港元所 致。

本集團同意申酉將持續不時檢討其現有 業務,以改進申酉業務營運及財務狀況。 申酉正就有關優質純種馬、購買賽馬及 育種的新業務投資進行可行性研究。

Therefore, the Group entered into and completed a sales and purchase agreement with Shen You to sell one of the Group unlisted investment Diamond Motto for an aggregate of 16,852,711 of Shen You shares as consideration during the year. The Group holds 16,852,711 shares in Shen You, representing 4.74% interest in the issued share capital of Shen You after the completion of the above transaction on 9th February, 2021. No dividend was received during the year.

A brief description of the business, financial performance and prospect of the unlisted securities investment is as follows:

## 1. Guangdong Jingyeng Aquaculture Company Limited ("Jingyeng Aquaculture")

Jingyeng Aquaculture is incorporated in The People's Republic of China and is principally engaged in business of aquaculture and feed production during the year.

Pursuant to the annual report for the year ended 31st December, 2020, Jingyeng Aquaculture recorded net profit was approximately RMB3.4 million and net assets of approximately RMB218 million. Jingyeng Aquaculture's net profit margin for the year was about 1.94%.

## **1.** 廣州市金洋水產養殖有限公司 (「金洋水產」)

金洋水產於中華人民共和國註冊 成立,年內主要經營水產業及生 產飼料業務。

The Group believes that there will be steady growth in aquaculture and feed production business in China and it is beneficial to Jingyeng Aquaculture. Therefore, the Group holds 1.6% interest in the issued share capital of Jingyeng Aquaculture. No dividend was derived during the year. The net assets attributable to the Group was approximately HK\$4,130,000 (2020: HK\$\$3,748,000).

#### 2. Diamond Motto Limited ("Diamond Motto")

On 18th August, 2020, the Group entered into a sales and purchase agreement with Shen You, a company listed on the Stock Exchange of Hong Kong Limited with stock code 8377. Pursuant to the agreement, the Group together with three other Vendors sold the entire interests in the issued share capital of and loans due from Diamond Motto for an aggregate stated consideration of HK\$14,500,000, by way of an aggregate of 67,441,860 consolidated shares, representing HK\$0.215 per share. The Group agreed to sell its entire shares, representing approximately 16.67% of the entire issued share capital of Diamond Motto, and the amount due from Diamond Motto for a stated consideration of HK\$3,623,333, which was satisfied by Shen You by way of allotting and issuing an aggregate of 16,852,711 consolidated shares of HK\$0.05 each in the issued share capital of Shen You. On 2<sup>nd</sup> February, 2021, an Extraordinary General Meeting ("EGM") of Shen You was held and the shareholders of Shen You approved the sales and purchase transaction and the allotment and issuance of its shares as consideration, and completion of the transaction took place on 9th February, 2021. Being the date of completion on 9th February, 2021, the market value of Shen You's shares was approximately HK\$6,404,000. The total of the carrying amount of Diamond Motto (HK\$9,105,000) and the gross carrying amount of the amount due from Diamond Motto (HK\$2,590,000) were approximately HK\$11,695,000. Therefore, the Group recognized a loss on disposal amount approximately HK\$5,291,000 during the year.

#### Investment objectives and policies

The Company is an investment company incorporated in the Cayman Islands with the primary objective of achieving medium term capital appreciation by investing in listed and unlisted companies in Hong Kong and the PRC. The Company also intends to invest in unlisted companies with the potential to seek a listing on the Stock Exchange or any overseas stock exchanges.

The Company has adopted the following investment policies:

• Investment will normally be made in the form of equity or equityrelated securities and debt instruments in listed and unlisted

- Where possible, the Board and the investment manager would seek to identify investment where there is a certain degree of synergy with other investee companies and where co-operation between such companies would be of mutual benefit to each other; and
- The Company's investment are intended to be held for medium term capital growth. There is no present intention to realize any of such investment in any specific period or by any specific date. Nevertheless, the directors of the Company (the "Director") will from time to time realize investment where they believe the realization would be in the best interests of the Company or where the terms on which such realization can be achieved are believed by the Directors to be particularly favourable to the Company.

#### Investment restrictions

Under the Articles and the Listing Rules relating to the listing of investment companies, certain restrictions on investment are imposed on the Company. In part to meet such restrictions, the Board has resolved that the Company may not:

- either itself or through its wholly-owned subsidiaries or in conjunction with any connected person take legal, or effective, management control of underlying investment and in no event, will the Company itself or through its wholly-owned subsidiaries own or control more than 30%, (or such lower percentage as may from time to time be specified in the Takeover Code as being the level for triggering a mandatory general offer) of the voting rights in any one company or body;
- 2. invest in any company or entity other than wholly-owned subsidiaries of the Company if such investment will result in more than 20% of the net asset value being invested in such company or entity as at the date the investment is made;

The Company has to comply with investment restrictions 1 and 2 above at all times while it remains listed as an investment company under Chapter 21 of the Listing Rules.

Investment restrictions 3 and 4 cannot be changed for at least 3 years from the date of the prospectus without the approval of the shareholders of the Company by way of an ordinary resolution. The Board has no present intention to change any of the above-mentioned investment restrictions.

Sound corporate governance practices are crucial to the smooth, effective and transparent operation of a company and its ability to attract investment, protect rights of shareholders and stakeholders, and enhance shareholder value. The Company is committed to high standards of corporate governance with a view to being transparent, open and accountable to our shareholders.

This report describes the Company's corporate governance practices and structures that were in place during the financial year ended 31st March, 2021, with specific reference to the principles and guidelines of the Corporate Governance Code (the "CG Code") as set out in Appendix 14 of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") issued by The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). In developing and reviewing its corporate governance policies and practices, the Company has sought to adopt a balanced approach.

#### **COMPLIANCE WITH CORPORATE GOVERNANCE CODE**

The Company complied with the code provisions as set out in the Code contained in Appendix 14 to the Listing Rules throughout year ended 31st March, 2021, except for the following.

#### Code Provision A.4.1

Under the code provision A.4.1, non-executive directors should be appointed for a specific term and subject to re-election. None of the independent non-executive directors of the Company were appointed for a specific term. None of the non-executive directors has entered or proposed to enter into any service contracts with the Company or its subsidiaries. But all directors of the Company are subject to the retirement by rotation according to the provisions under article 157 of the Articles of Association of the Company. As such, the Board considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the CG Code.

#### Code Provision A.6.7

Under the code provision A.6.7, independent non-executive directors and other non-executive directors should attend general meetings and develop a balanced understanding of the views of shareholders. The independent non-executive director, Mr. TANG Hon Bui, Ronald was unable to attend the annual general meeting ("AGM") on 14<sup>th</sup> August, 2020 due to his other business engagements. This constitutes a deviation from code provision A.6.7 of the CG Code. Moreover, non attendance of this Independent Non-executive Director may also constitute deviation from code provision E.1.2 of the CG Code. Despite of that independent non-executive director, all the other directors of the Company were present in the AGM.

根據守則條文第A.4.1條,非執行董事應按指定任期獲委任及重選。然而,本公司現時之獨立非執行董事並無特定任期。本公司或其附屬公司並無與非執行董事訂立或擬訂立任何服務合約。惟本公司全體董事須遵守本公司組織章程細則第157條之輪席退任規定。因此,本公司認為已採取足夠措施,以確保本公司之企業管治常規不遜於企業管治守則。

#### 守則條文A.6.7條

根據守則條文A.6.7條,獨立非執行董事及其他非執行董事應出席股東大會並均衡了解股東意見。獨立非執行董事鄧漢標先生因彼之其他事務而末能出席本公司於二零二零年八月十四日舉行之股東週年大會(「股東週年大會」)。這構成與企業管治守則內條文A.6.7條有偏離。此外,該位獨立非執行董事的缺席也有可能構成與企業管治守則內條文E.1.2條有偏離。除該位獨立非執行董事外,其他董事均有出席股東週年大會。

#### CORPORATE GOVERNANCE PRACTICE

With the assistance of the Compliance Department, the Board has designed a proper corporate governance structure. Currently, there are three board committees, including Audit Committee, Remuneration Committee and Nomination Committee. Audit Committee, Remuneration Committee and Nomination Committee perform their distinct roles in accordance with their respective terms of reference.

#### **BOARD OF DIRECTORS**

#### Composition

As at 31st March, 2021, the Board of Directors of the Company comprises six members. Dr. WONG Yun Kuen, acts as Chairman of the Board, whereas Mr. CHENG Wai Lun, Andrew acts as Managing Director of the Company. The Company has four independent non-executive directors, they are Mr. CHAN Chung Yee, Alan, Dr. FUNG Lewis Hung, Mr. TANG Hon Bui, Ronald and Mr. KWOK Ming Fai. Mr. CHAN Chung Yee, Alan and Mr. KWOK Ming Fai has appropriate professional accounting experience and expertise.

All directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. The biographical details of each director are disclosed in page 24 to page 26 of this Annual Report.

Each independent non-executive director has pursuant to the Rule 3.13 of the Listing Rules, confirmed that he is independent of the Company and the Company also considers that they are independent.

The Company has adopted the Model Code set out in Appendix 10 of the Listing Rules as the code of conduct regarding securities transaction by the directors (the "Model Code"). Having made specific enquiry of all directors, the Company confirmed that all directors have complied with the required standards as set out in the Model Code during the year.

There is no relationship (including financial, business, family or other material relationship) among members of the Board.

Pursuant to the Articles of Association of the Company, the directors shall hold office subject to retirement by rotation at the annual general meeting of the Company at least once every three years and eligible for re-election.

#### **Function**

The Board of Directors, headed by the Chairman, is responsible for formulation and approval of the Group's development and business strategies and policies, approval of annual budgets and business plans, recommendation of dividend, and supervision of management in accordance with the rules governing the meeting of the Board of Directors, the Managing Director's working guides, articles of association and rules governing the meeting of shareholders.

The executive directors are responsible for day-to-day management of the Company's operations. These executive directors conduct regular meetings with the senior management of the Company and its subsidiaries and associated companies, at which operational issues and financial performance are evaluated.

The Company considers well-developed and timely reporting systems and internal controls are essential, and the Board of Directors plays a key role in the implementation and monitoring of internal financial controls.

The Board of Directors has established procedure to enable directors, upon reasonable request, to seek independent professional advice in appropriate circumstances, at the Company's expenses.

The Articles of Association of the Company contain description of responsibilities and operation procedures of the Board of Directors. The Board of Directors holds regular meeting and listens to the operating reports of the Company and makes policies. Significant operating policies of the Company have to be discussed and passed by the Board of Directors. Board meetings include regular meetings and irregular meetings. The Board of Directors meets formally at least 4 times a year.

Besides regular and irregular meetings, the Board of Directors obtains adequate information through working meetings, presided by the Chairman in a timely manner, to monitor objectives and strategies of the management, financial conditions and operating results of the Company and provisions of significant agreements.

#### 職能

#### **Chairman and Managing Director**

The roles of the Chairman and the Managing Director are segregated and assumed by two separate individuals who have no relationship with each other to strike a balance of power and authority so that the job responsibilities are not concentrated on any one individual.

The Chairman of the Board is responsible for the leadership and effective running of the Board. The Chairman is also responsible for deciding the agenda of each Board meeting, taking into account, where appropriate, matters proposed by other directors for inclusion in the agenda.

The Managing Director is delegated with the authorities to manage the Group's business in all aspects effectively, implement major strategies, make day-to-day decision and coordinate overall business operation.

The number of independent non-executive directors is more than half of the Board membership. The Board membership is covered by professionally qualified and widely experienced personnel so as to bring in valuable contribution and different professional advices and consultancy for the development of the Company.

- Monitoring the quality, timeliness, relevance and reliability of internal and external reporting.
- Reviewing of the compliance with the CG Code.

These committees have been formed with specific written terms of reference which is available on the Company's website set out details of the Committee's duties, powers and functions.

#### **Board Diversity Policy**

The Company adopted a Board Diversity Policy (the "Diversity Policy") which became effective in September 2013. To ensure Directors' contribution to the Board remains informed and relevant, the Company encourages Directors to participate in continuous professional development to develop and refresh their knowledge and skills and understanding of the business and markets in which the Group operates. Directors are also provided with monthly performance and position updates of the Group, and information such as performance and key operational highlights to enable the Board as a whole as well as each Director to discharge their duties. #### INTERNAL CONTROL AND RISK MANAGEMENT

It is the responsibility of the Board to ensure that the Company maintains sound and effective risk management and internal control systems to safeguard the Shareholders' investment and the Group's assets at all times. The Audit Committee assists the Board in fulfilling its corporate governance roles in the Group's financial, operational, compliance, risk management and internal controls, and the resourcing of the finance and internal audit functions.

The Board has established an on-going process for identifying, evaluating and managing the significant risks faced by the Group and this process includes updating the system of internal controls when there are changes to business environment or regulatory guidelines.

The Board is of the view that the system of internal controls in place for the year under review and up to the date of issuance of the annual report and consolidated financial statements is sound and is sufficient to safeguard the interests of shareholders and employees, and the Group's assets.

The investment manager assists the Board in the implementation of the board's policies and procedures on risk and control by identifying and assessing the risks faced, and involving in the design, operation and monitoring of suitable internal controls to mitigate and control these risks.

The key processes that have been established in reviewing the adequacy and integrity of the system of internal controls include the following:

- The Executive Board is responsible to ensure the effectiveness of the daily operations and that the operations are in accordance with the corporate objectives and strategies.
- The Audit Committee of the Company reviews internal control issues identified by external auditors, regulatory authorities and management, and evaluates the adequacy and effectiveness of the Group's risk management and internal control systems.

Policies and procedures have been designed for safeguarding assets against unauthorised use or disposition; maintenance of proper accounting records for the use of reliable information within the business or external publication, and compliance of relevant regulations, rules and legislations. The policies and procedures are designed for providing reasonable but not absolute assurance to avoid fraud, material misstatements or errors.

#### **COMPANY SECRETARY**

Mr. LEUNG Man Lai was appointed as the Company Secretary of the Company on 30<sup>th</sup> July, 2012. The Company Secretary reports to the Directors of the Company and is responsible for advising the Board on governance matters. According to the Rule 3.29 of the Listing Rules, the Company Secretary has taken not less than 15 hours of relevant professional training during the year.

#### **DISSEMINATION OF INSIDE INFORMATION**

The Board ensures the inside information is kept strictly confidential until the relevant announcement is made. The Directors are not aware of any significant areas which need to be brought to the attention of the Shareholders.

#### **Dividend Policy**

The Company may declare and distribute dividends to the shareholders, provided that the Group records a profit after tax and that the declaration and distribution of dividends does not affect the normal operations of the Group.

In deciding whether to propose a dividend and in determining the dividend amount the Board shall take into account, inter alia:

- (i) the general financial condition of the Group;
- (ii) capital and debt level of the Group;
- (iii) future cash requirements and availability for business operations, business strategies and future development needs;
- (iv) the general market conditions; and
- (v) any restrictions on payment of dividends that may be imposed by the Group's lenders; and any other factors that the Board deems appropriate.

The payment of the dividend by the Company is also subject to any restrictions under the Company Law of the Cayman Islands and Articles of Association of the Company.

The Company's assets were used in an appropriate manner, the expenditures in each of the operating units of the Group were under a strict control, expenditures exceeding certain predetermined amounts needed management's authorisation. Accounting records were properly maintained. The allocation of resources and manpower in performing accounting and financial reporting function are adequate to comply with the requirement of Listing Rules.

#### Operation

A hierarchical system with proper work flow and reporting procedures was duly established in each of the operating units. Every employee was assigned with a specific area of duty and responsibility.

Regular meetings with the attendance of senior management and representatives from each of the operating units were held during the year so as to improve communication and identify potential issues within the Group.

#### LISTING RULES COMPLIANCE

During the year, the continuing connected transactions undertaken by the Group are included in the transactions set out in note 27 on the consolidated financial statements. The Group has fully complied with the Listing Rules requirements. Financial Reports, announcements and circulars have been prepared and published in accordance with the requirements of the Listing Rules. The prevailing internal control system are compliant with all the requirements of the Listing Rules.

#### **GOING CONCERN**

The Directors, having made appropriate enquiries, consider that the Company has adequate resources to continue in operational existence for the foreseeable future and that, for this reason, it is appropriate to adopt the going concern basis in preparing the financial statements.

#### SHAREHOLDERS AND INVESTORS COMMUNICATION

The objective of shareholder communication is to provide our shareholders with detailed information about the Company so that they can exercise their rights as shareholders in an informed manner.

The Company uses a range of communication tools to ensure its shareholders are kept well informed of key business imperatives. 

The Group understands that the increasing trend of demand for the ESG investing for the investors. As an ongoing commitment to good corporation, the Group recognize the responsibility in minimizing the negative environmental and social impact of our business operations and our investment portfolio, in order to bring long-term sustainable value to our investors and shareholders. ESG analysis is an integral part of the Group's investment process. The Group will consider all environmental and social criteria when making investment decisions and will invest in investment which have an adequate level of governance quality and mitigate environmental and will not investing in any investment which may violate environmental law. The Group also concur investment in those ESG compliance investment may improve Group reputation and bring long-term sustainable value to our investors and shareholders.

# Emissions, Use of Resources, Environment and Natural Resources and Climate Change

The Group operates in the investment field and it's operation is mainly office-based and the Group is committed to minimising the impact of businesses on the environment through adopting eco-friendly measures at the office. In addition, there is no actual business facing climate change directly. However, climate change is seriously all over the world, and the extreme weather is affecting the Global in recent years. The Company believes that climate change will affect worldwide and we should put effort to reduce waste at sources and to promote energy efficiency.

The Group encourages employees to implement the following environmental initiatives to prevent the adverse climate change:

- to reduce paper consumption by using duplex printing, reusing papers printed on one side and place for paper waste recycling;
- using electronic storage and communication wherever possible;
- setting air-conditioning temperature at 25 degree in summer whenever possible to energy saving;
- to switch off lights and air-conditioning in the meeting room and the computer at the workstation when not in use; and
- Conference calls instead of face-to-face meetings are arranged where possible.

Furthermore, climate-related issues such as risk of extreme weather is increasing which may affect significantly of the operation of the Company and may danger to the safety of the employee. Also the change of regulatory regarding to the climate related issue may also lead to devaluation of the company investment which include energy related investment. Therefore, the Company will consider climate related issue before making our investment decision in order to mitigate potential impacts to the Company and shareholders.

#### A. 環境

排放物、資源使用,環境及自然資源及氣 候變化

本集團於投資領域經營並以辦公室運作 為主。因此,本集團致力通過辦公室更內 的環保措施,盡量減少公司對環境的影響。此外,本公司實際並無直接面臨氣候 變化的業務。然而,近年來氣候變化風險 不斷增加,極端氣候正在影響全球。本公 司認為氣候變化將影響全球,我們應努 力從源頭減少廢物並提高能源效率。

本集團鼓勵員工實施以下環保措施以防 止氣候變化惡化:

- 減少用紙、多採用雙面列印、重用已經單面打印的紙張及設置地方回收廢紙;
- 在可行的情況下均以電子方式儲存資料及進行通訊;
- 於夏季期間將空調溫度設置為25 度以節省能源;
- 提醒員工在不使用會議室時關閉電源及空調,不使用電腦時關閉電腦;及
- 盡可能安排電話會議而非面對面 之會議。

此外,極端天氣風險等氣候相關問題日益增多,可能對公司的經營產生重大影響,並可能危及員工的安全。此外,有關氣候相關問題的監管變化也可能使包括能源相關投資在內的公司投資貶值。因此,本公司將在作出投資決策前考慮氣候相關問題,以減輕對本公司及股東的潛在影響。

In view of the business nature, the Group's operations do not directly involve the use of natural resources as the Group does not involve in any industrial process nor use any motor vehicles. Hence there had been no direct emission relation to air pollutants and greenhouse gases ("GHG"), no discharges into water and land (Scope 1 as below table). The main emissions and wastes produced by the Group are primarily attributable to its use of electricity and paper (Scope 2 and 3 as below table). Also the Group is not aware of any significant generation of hazardous waste and any non-compliance with relevant laws and regulations in relation to environmental protection during the Reporting period that have significant impact on the Group. The Company also believes that its business operations have minimal direct impact on the environment.

#### **Environmental performance**

The Group believed that the environmental protection as an important component to form a part of our corporate responsibility and are therefore committed to promoting environmental protection activities.

In accordance with the ESG Reporting Guide set out by the Hong Kong Stock Exchange, our environmental performance of "Emissions" and "Use of Resource" during the reporting period are tabulated as below.

#### **Electricity**

The electricity consumed by the Group was mainly used in the office during its normal business operation and supplied by The Hong Kong Electric Co., Ltd. During the Year, the Group has consumed 15,426 kWh (2020: 17,406 kWh) of electricity with a monthly average usage of 1,286 kWh (2020: 1,451 kWh) and 5,142 kWh (2020: 5,802 kWh) per person, which producing  $\rm CO_2$  equivalent emissions of approximately 12,187 kg (2020: 13,751 kg). These consumption of the electricity was mainly attributable by the use of light, office appliances and air-conditioning in the office.

#### Water

There is no direct water supply to the office apart from water uses/affluent discharges at shared facilities of the office building. Water consumption by the Group for the year involved mainly bottled drinking water uses at its offices premises and the Group's business operations do not require any other water usage. The Group's office utilised a total of approximately 24 bottles of drinking water with total of 454 Liter, an average 2 bottles drinking water per month during the year 2021 and 2020.

#### 用電

本集團辦公室於正常業務營運的用電由香港電燈有限公司供應。於本年度,本集團消耗15,426千瓦時(二零二零年:17,406千瓦時)電量,月均使用量為1,286千瓦時(二零二零年:1,451千瓦時)及人均使用量為5,142千瓦時(二零二零年:5,802千瓦時)。產生二氧化碳當量排放約12,187公斤(二零二零年:13,751公斤)。此等用電主要來自辦公室使用燈、辦公室電器及冷氣所致。

#### 用水

除了在辦公室建築物的共用設施之用水/污水排放外,辦公室並無直接供水。本集團本年度的用水量主要是其辦公室物業的瓶裝飲用水而本集團的業務營運毋須其他用水。本集團辦公室於二零二一年及二零二零年年度使用飲用水約24支,總454公升,平均1個月2支瓶裝飲用水。

#### Paper

The Company encourages employees to reduce paper consumption by using duplex printing, reusing papers printed on one side and place for paper waste recycling, also using electronic storage and communication wherever possible. During the year 2021 and 2020, the Group used a total of approximately 8 kg of paper in its normal office operations for printing documents and the total  $\mathrm{CO}_2$  equivalent emissions for the paper used was approximately 38 kg.

#### B. SOCIAL

#### **Employment**

Employees is the most valuable asset to the Group. It is the policy of the Group to employ person which is suitable to the position with equal opportunity (non-discrimination against gender, marital status, disability, age, race, family status, sexual orientation, nationality and religion). Competitive remuneration package will be provided for the employees. The Group is in full compliance with relevant employment laws and regulation just like the "Employment Ordinance" (Chapter 57), "Minimum Wage Ordinance" (Chapter 608), "Sex Discrimination Ordinance" (Chapter 480), "Mandatory Provident Fund Schemes Ordinance" (Chapter 487) and "Race Discrimination Ordinance" (Chapter 602), etc. The Group is not aware of any non-compliance in relation to employment laws and regulations during the Reporting Period.

As at 31st March, 2021 and 31st March, 2020, we have 1 full time employee, 2 executive directors and 4 independent non-executive directors of the Company. All of our employees including directors are senior management and located in Hong Kong and no turnover during the period. By gender, 100% male. By age group, 43% and 57% (2020: 57% and 43%) between age group of 35 to 55 and over 55 respectively.

#### **Health and Safety**

The Group will provide a healthy and safety working environment to the employees. The Group has provided a guideline for work safety including environmental hygiene and cleanliness, machine operation, smoking ban and fire prevention, hazardous materials handling, arrangements in times of typhoons and rainstorms, as well as response to emergencies, etc. By offering opportunities for a flexible work arrangement, the Group also encourage our employees to maintain a healthy work-life balance.

The Group is in full compliance with the "Occupational Safety and Health Ordinance" (Chapter 509), and is not aware of any non-compliance with relevant laws and regulations in relation to health and safety working environment during the Reporting Period that have significant impact on the Group. During the period, there was no staff suffer work-related fatalities and injury.

The outbreak of the COVID-19 was continuing since early 2020 which has brought about additional uncertainties for our employees' health. The Group has purchased additional cleaning and epidemic prevention equipment and consumables such as surgical face masks, sanitizer etc. The Group has implemented the precautionary measures to prevent and control the spread of the COVID-19 at the working place, including compulsory body temperature checks, mandatory wearing of a surgical face mask, limit the visitors to access our office.

#### **Development and Training**

On-the-job training and continuous professional development are important elements to enhance the industry knowledge of the employees of the Group. The Group provide relevant training opportunities to its employees from time to time and encourage employees to attend seminars by themselves for their own professional assertions which include Listing Rules and accountancy update which can boost the competence and efficiency of the employees and hence the Company's professionalism and performance. During the period, all the employees are male and senior management including directors had participated in training and the average number of the hours spent on training per staff is around 50 hours.

#### Labour standards

It is the policy of the Group to comply with the relevant laws and regulations which prohibit the employment of child and force labour.

We strictly check the age of job candidate and in case of holding forged identification documents or providing false personal data will report to relevant regulatory authority.

As the Group operates in the investment field, which is office based, it does not rely on any major suppliers for its business operation in general. The Group mainly purchases office equipment and office supplies through approved suppliers according to their reputation, the quality of goods and services provided. The Group will select on a competitive basis and taken into account factors like their reputation, price, integrity and competence for other suppliers just like external professional service provider. The quality of their service is closely monitored to ensure that the service provided is in accordance with agreed contractual terms. In addition to the increasing concern of the ESG, the Company will also select suppliers with highly promotion of the environmentally preferable products or services by searching their publicly disclosed information and relevant news regarding to ESG. The Group believe the environmental social risks of our supply chain are properly managed and are kept to minimal.

The Group has maintained good practice to select and evaluate its suppliers and their engagements. During the period, there are 2 major office supplies suppliers and 5 major external service providers. All the suppliers were located in Hong Kong.

## 4. BASIS OF PREPARATION AND SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented.

#### (a) Basis of preparation

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by HKICPA, accounting principles generally accepted in Hong Kong. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange ("Listing Rules") and the disclosure requirements of the Hong Kong Companies Ordinance. The consolidated financial statements have been prepared under the historical cost convention except the financial assets at fair value through profit or loss ("FVTPL") and other investment are stated at fair value and on the basis that the Group is a going concern.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payment, leasing transactions that are within the scope of HKFRS 16 Leases, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

### (a) Basis of preparation (continued)

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1: fair values measured based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2: fair values measured based on valuation techniques for which all inputs which have a significant effect on the recorded fair value are observable, either directly or indirectly
- Level 3: fair values measured based on valuation techniques for which all inputs which have a significant effect on the recorded fair value are not based on observable market data (unobservable inputs)

### (b) Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

## (c) Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the assets to working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance and overhaul cost, is normally charged to the profit or loss in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of an item of property, plant and equipment, the expenditure is capitalised as an additional cost of the asset.

Depreciation is provided to write off the cost of property, plant and equipment over their estimated useful lives using the straight-line method. The annual rate used for furniture, fixtures and equipment is 20%. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

#### (i) Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into accountancy collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

### (iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events of default that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

### (v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data and forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Certain of the Group's financial assets amounting to approximately HK\$1,754,000 as at 31<sup>st</sup> March, 2021 (2020: HK\$12,635,000) are measured at fair values with fair values being determined based on significant unobservable inputs using valuation techniques. Judgment and estimation are required in establishing the relevant valuation techniques and the relevant in puts thereof. Changes in assumptions relating to these factors could affect the reported fair values of these instruments. See Note 8(b) for further disclosures.

## Provision of ECL for amounts due from investee companies/ related companies

The loss allowances for amounts due from investee companies/ related companies are based on assumptions about risk of default and expected loss rates. The Group uses judgment in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward-looking estimates at the end of each reporting period. The provision of ECL is sensitive to changes in estimates. The information about the ECL and amounts due from investee companies/related companies are disclosed in Notes 8(a), 19 and 20 respectively.

## 6. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of equity reserves attributable to owners of the Company, comprising issued share capital, share premium and retained earnings/accumulated losses.

The directors of the Company review the capital structure on a semi-annual basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors, the Group will balance its overall capital structure through the payment of dividends and new share issues.

The Group takes on exposure to credit risk, which is the risk that a counterparty will be unable to pay amounts in full when due. Impairment provisions are provided for losses that have been incurred by the end of the reporting period, if any. The Group is responsible for monitoring the amount of credit exposure to investee companies and related companies.

# ECL assessment on amounts due from investee companies/related companies

Amounts due from investee companies/related companies are assessed on the base of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights. The management believes that there are no significant increase in credit risk of amounts due from related companies since initial recognition and the Group provided impairment based on 12m ECL. The management assessed that there are significant increase in credit risk of amounts due from investee companies since initial recognition and the Group provided impairment based on lifetime ECL. The expected credit loss rate for amount due from investee companies for the year ended 31st March, 2020 is 12.16%.

The reversal of ECL made to amounts due from investee companies during the years ended 31<sup>st</sup> March, 2021 was approximately HK\$315,000 (2020: allowance of ECL was approximately HK\$313,000).

The Company and Upbest Assets Management Limited ("UAML") as investment manager had entered into the investment management agreement dated on 25th January, 2019 ("Investment Management Agreement") and agreed that UAML provided assets management services to the Company for a period of three years commencing from 1st April, 2019 to 31st March, 2022. Pursuant to the Investment Management Agreement, monthly investment management fee is payable by the Company in advance and amounts to 1.5% per annum of the net asset value as at the immediately preceding valuation date on the basis of the actual number of days in the relevant calendar month over a year of 365 days. In addition to the management fee, provided that the net asset value as at the end of the relevant financial year exceeds the higher (the "High Watermark") of (i) the net asset value as at the end of the reference year; and (ii) the net asset value as at the end of the most recent financial year after the reference year and in which the performance fee was paid. The Company will pay UAML the performance fee for the relevant financial year in Hong Kong dollars equal to 20% of the amount by which the net asset value as at the end of the relevant financial year exceed the High Watermark.

The annual cap for the investment management fee and performance fee for the financial years ending 31<sup>st</sup> March, 2020, 2021 and 2022 are HK\$8,600,000, HK\$9,100,000 and HK\$9,600,000 respectively. It is expected that the total of investment management fee and performance fee will be less than HK\$10,000,000 per annum and all the applicable percentage ratios (as defined under Rule 14.07 of the Listing Rules) in respect of the Investment Management Agreement are less than 25%. Thus, transaction contemplated under the Investment Management Agreements is considered to be a deminimis transaction for the Company pursuant to Rule 14A.76 of the Listing Rules.

(b) The Company and four of its subsidiaries and Upbest Securities Company Limited ("USCL") have separately entered into the securities brokerage supplemental agreements dated on 25<sup>th</sup> January, 2019 ("2019 Securities Brokerage Supplemental Agreements") in relation to the provision securities brokerage services and agreed that the original agreement will be extended for a period of three years commencing from 1<sup>st</sup> April, 2019 to 31<sup>st</sup> March, 2022. It is expected that the annual brokerage commission will be less than HK\$3,000,000 per annum and all the applicable percentage ratios (as defined under Rule 14.07 of the Listing Rules) are less than 5%. Thus, transaction contemplated under the 2019 Securities Brokerage Supplemental Agreements is considered to be a de-minimis transaction for the Company pursuant to Rule 14A.76 of the Listing Rules.

(f) A subsidiary of the Company has entered into the precious metal supplemental agreement dated 25th January, 2019 ("Precious Metal Supplemental Agreement") with Upbest Gold and Silver Trading Limited ("UGS") in relation to the provision of precious metal margin financing service by UGS to the subsidiary. According the Precious Metal Supplemental Agreement, the subsidiary and UGS agreed that the term for the Precious Metal Financial Assistance Agreement will be extended for a period of three years commencing from 1st April, 2019 to 31st March, 2022 and is subject to renewal by written supplemental agreement between the contract parties.

The interest rate for the precious metal financing service was from 0.25% to 0.50% (2020: 0.25% to 0.50%) per annum above the borrowing costs of UGS for call position. No interest for the precious metal financing service was paid for the years ended 31st March, 2021 and 2020.

The annual cap regarding the securities and bullion margin financial assistance is HK\$64,000,000 for each of the financial years ending  $31^{\rm st}$  March, 2020, 2021 and 2022.
