公司簡介

The Company is a research-driven and market-oriented biopharmaceutical company with 30 years' experience in the pharmaceutical industry in China.

With solid infrastructures in drug development, clinical development, regulatory, manufacturing, sales and marketing, the Group has established extensive partnerships with around 30 international companies and currently markets over 25 proprietary, generic and licensed-in pharmaceutical products in Mainland China, Hong Kong, Macau and Taiwan.

The Group focuses on several key therapeutic areas such as cardiovascular health, woman's health, paediatrics, rare diseases, oncology, dermatology, and obstetrics. It maintains a strong and carefully curated project pipeline under different development stages stemming from both internal research and development as well as from the licensing of development, commercialisation, and manufacturing rights from various United States, European and Japanese companies.

The Group carries out its sales and distribution activities in Hong Kong, Macau, Taiwan and Mainland China through Hong Kong and Taiwan offices and branch offices in Chongqing, Guangzhou, Shanghai and Beijing with direct and channel sales network covering most of the provinces and cities in Mainland China, marketing both domestic self-developed and generic products and overseas licensed-in products. Zhaoke Hefei is currently operating the manufacturing plant of the Group located in Hefei, Anhui Province of the PRC, comprising four GMP-compliant workshops for the production of topical gel, lyophilised powder for injection, small volume parenteral solutions and eye gel. Zhaoke Guangzhou is currently operating the manufacturing site in Nansha District, Guangzhou of the PRC which include a complete range of solid dosage production lines for the development and manufacturing of tablets and capsules.

The mission of the Group is to become a successful biopharmaceutical group in Asia providing innovative products to fight diseases and improve health and quality of life.

本集團在藥品發展、臨床發展、規管、製造、銷售及市場推廣方面擁有穩固的基礎建設，已與約三十家國際公司建立廣泛合作關係，且目前於中國內地、香港、澳門及台灣推廣超過二十五種專利、仿製及引進醫藥產品。

本集團致力於心血管健康、女性健康、兒科、罕見病、腫瘤科、皮膚科及產科等多個重要治療領域，擁有經過精心策劃的龐大項目管線，該等管線處於不同開發階段，來自內部研究及開發以及自美國、歐洲及日本公司引進的開發、商品化及生產權。

本集團於香港、澳門、台灣及中國內地透過香港及台灣辦事處以及重慶市、廣州市、上海市及北京市分公司，覆蓋中國內地大部分省市的直銷及管道銷售網絡進行銷售及分銷活動，推廣國內自行研發和仿製的產品及海外引進的產品。兆科合肥現時營運本集團位於中國安徽省合肥市的生產廠房，該廠房設有四間符合GMP的工場，負責生產凝膠劑、注射用凍乾粉針劑、小容量注射劑及眼凝膠。兆科廣州現正在中國廣州市南沙區營運藥廠（包括開發及生產藥片及膠囊的全套固體制劑生產線）。

本集團的使命乃成為亞洲一個成功的生物醫藥集團，提供創新產品以對抗疾病，改善健康及提高生活質素。

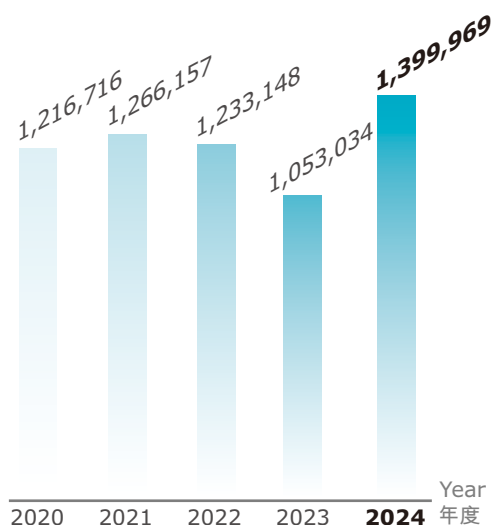

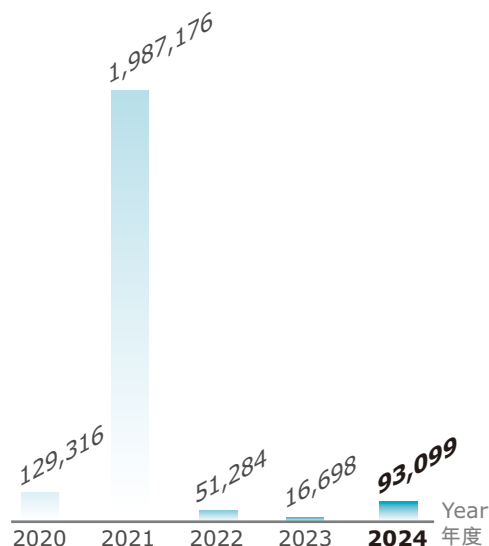
REVENUE (HK\$'000)

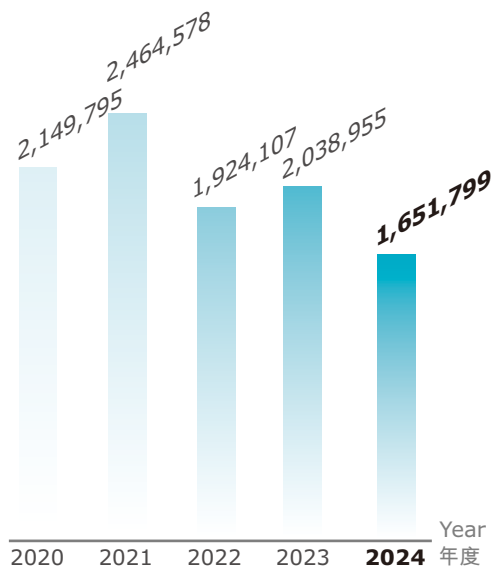
PROFIT ATTRIBUTABLE TO THE OWNERS OF THE COMPANY (HK\$'000)

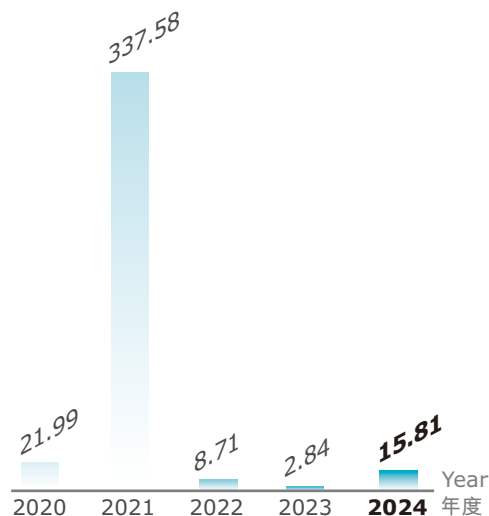
EQUITY ATTRIBUTABLE TO THE OWNERS OF THE COMPANY (HK\$'000)

Chairman's Statement

主席報告

Dear Shareholders,

I am delighted to present the annual report for 2024 on behalf of the Company and the Board.

In 2024, the Chinese pharmaceutical industry was marked by rapid growth and significant innovation. This progress was driven by an aging population with increasing medical needs and strong government support for healthcare innovations. While the market grows, propelled by breakthroughs in biologics and AI-driven drug discovery, it also faces challenges such as pricing reforms, VBP policies, and global geopolitical issues like trade tensions. Meanwhile, the agility of the NMPA in aligning with international standards and expediting approval processes has accelerated the availability of advanced therapies, especially in oncology and rare diseases.

In such a dynamic and challenging environment, 2024 marked a transformative year for the Group. Through resilient implementation efforts, the Group achieved a profit attributable to the Shareholders of HK\$93.1 million in 2024, a remarkable increase from HK\$16.7 million in the prior year, after overcoming challenges. Basic earnings per share surged to HK15.81 cents, up from HK2.84 cents in 2023, reflecting the strength of our strategic execution. To reward Shareholders for their steadfast support, the Board has recommended a final dividend of HK2.5 cents per share, which, combined with the interim dividend of HK2.0 cents per share, brings the total dividend for the year to HK4.5 cents per share, a 150% increase over 1.8 HK cents in 2023. Subject to the approval of the Shareholders at the forthcoming AGM, the final dividend will be paid on 16 June 2025.

These results were driven by a historical revenue milestone of nearly HK\$1.4 billion in 2024, representing 32.9% year-on-year growth. This impressive performance reflects our ability to navigate transitional challenges in recent years, including the expiration of legacy licensed product agreements and the time required to scale newly launched products. Having emerged decisively from this adjustment period, our growth is now underpinned by a balanced and resilient portfolio, with strong contributions from licensed-in, in-house, and high-quality generic products. This success underscores the strategic value of our diversified approach, which positions us for sustained momentum.

In addition to our strategic sales initiatives, our manufacturing capabilities are also critical to our success. A cornerstone of these capabilities is our state-of-the-art Nansha manufacturing facilities, established since 2015, which represent a significant investment in our production infrastructure. These facilities, equipped with advanced production lines for a diverse range of drug formulations, uphold the highest standards of quality and efficiency. Alongside our Hefei sites, the progressive development of the Nansha facility has further bolstered our product portfolio. By 2024, this investment began to bear fruit, with an array of marketable products emerging and starting to contribute meaningfully to our revenue.

各位尊敬的股東：

本人欣然代表本公司及董事會呈列二零二四年的年度報告。

二零二四年乃標誌着中國醫藥行業快速增長及重大創新的一年。此進程由老化人口帶動，醫療需要日增，政府大力支持醫療創新。雖然市場增長，在生物製藥及人工智能驅動的藥物探索取得突破，惟同時面對諸如定價改革、藥品集採政策，以及貿易角力等環球地緣政治議題的挑戰。此外，國家藥監局因應國際準則靈活變通，加快審批流程，已促成多種先進療法（尤其治療腫瘤及罕見病）的誕生。

在動盪紛擾的環境下，本集團於二零二四年轉型，努力不懈地克服重重難關，得以於二零二四年錄得股東應佔溢利93,100,000港元，較去年的16,700,000港元顯著增加。每股基本盈利由二零二三年的2.84港仙急增至15.81港仙，本集團的策略執行力不言而喻。為回饋股東鼎力支持，董事會建議派發末期股息每股2.5港仙，連同中期股息每股2.0港仙，本年度的股息總額為每股4.5港仙，較二零二三年的1.8港仙增加150%。待股東於應屆股東週年大會上批准後，末期股息將於二零二五年六月十六日派付。

此等成果乃歸功於二零二四年錄得近14億港元的歷史性收益里程碑，同比增長32.9%。驕人表現反映本集團近年駕馭過渡性挑戰的能力，挑戰包括傳統產品引進協議到期及擴展新推產品需時。隨着在調整期內當機立斷，本集團的增長見於具抗逆能力的均衡產品組合，引進產品、自主產品及優質仿製產品同樣作出重大貢獻。此成果足證本集團多元化方針的策略價值，使我們能夠乘勢而起。

除策略銷售舉措外，我們的生產能力亦居功至偉。生產能力的基石乃本集團於二零一五年成立的頂尖南沙生產設施，為我們一項重要的生產基建投資。該等設施配備一系列藥劑的先進生產線，依循最高的品質及效率標準。聯同我們的合肥基地，南沙設施的逐步發展已進一步增強我們的產品組合。於二零二四年，此項投資已見成果，陸續出現可上市產品，開始為收益作出實質貢獻。



Our drug development pipeline continues to advance, focusing on major therapeutic areas such as cardiovascular health, women's health, paediatrics, rare diseases, dermatology, obstetrics, and oncology. During the Reporting Year, we obtained approvals for 2 new products. Building on this momentum, subsequent to the Reporting Year, we received approval for Ciprofloxacin Hydrochloride and Fluocinolone Acetonide Ear Drops, further strengthening our market presence and expanding our product offerings. Currently, the CDE is reviewing the ANDA/NDA of 4 projects, including Prasterone and PD-L1 for Small Cell Lung Cancer, reflecting significant progress in our pipeline. Our R&D strategy focuses on delivering innovative treatments while ensuring marketability and profitability, and we also eliminate unsuitable projects to optimise our resources and efforts, positioning us for sustained growth. As part of this process, HK\$19 million has been recognised as non-recurring impairment charges in the Reporting Year.

As part of our long-standing plan to streamline asset efficiency and restructure non-core holdings, the resumption of land assets in Nansha under the December 2024 compensation agreement, aligned with government urban planning initiatives, will allow us to free up capital once the compensation is received, thereby enhancing our future cash flow and supporting our core pharmaceutical priorities.

In the journey of AI-driven innovation applications, we have collaborated with Auransa Inc., a U.S.-based AI-driven pharmaceutical company dedicated to developing precision medicines in areas of significant unmet need, to manufacture its AU409, a novel, AI-derived drug, targeting advanced hepatocellular carcinoma, at our facility in China under stringent U.S. FDA standards. We are also conducting its Phase I clinical trial, with the first patient enrolled at Hong Kong's Queen Mary Hospital in July 2024. The trial is expected to conclude by the second quarter of 2025, and the results will support China's new drug registration thereof. This collaboration marks the beginning of a new approach to drug discovery, and we will further strengthen our cooperation with Auransa Inc. in the field of AI.

Amid industry complexities, we are committed to leveraging domestic R&D expertise and forming strategic partnerships to provide affordable, high-quality therapies. This ensures that we effectively navigate the industry's challenges and contribute meaningfully to improving patient outcomes and supporting China's efforts in advancing life sciences.

In conclusion, despite the ongoing challenges, we remain committed to long-term growth through cost optimisation and maintaining high-quality standards. By focusing on sustainability, supply chain resilience, and continuous technology improvement, we are well-positioned to navigate the evolving industry landscape.

我們持續推進藥物開發管線，專注於心血管健康、女性健康、兒科、罕見病、皮膚科、產科及腫瘤科等主要治療領域。於報告年度內，我們已為兩款新產品取得批准。承接此走勢，我們於報告年度後再取得環內沙星氣輕鬆滴耳液的批文，進一步鞏固我們的市場地位並擴大產品種類。現時，藥審中心正評審四個項目的簡化新藥申請／新藥申請，包括普拉羧酮及治療小細胞肺癌的PD-L1，可見管線進度理想。我們的研發策略重點為交付創新療法之餘，同時確保營銷能力及盈利能力，並消取不合適的項目，善用資源及人力以保持增長。就此，本集團已於報告年度確認19,000,000港元為非經常減值支出。

作為精簡資產效率及重組所持非核心資產的長期計劃一部分，南沙土地資產配合政府城市規劃倡議根據二零二四年十二月補償協議被收回，將使我們可在收訖補償後釋放資本，從而增強未來現金流，支持優先處理核心藥物。

在人工智能驅動的創新應用方面，我們與Auransa Inc.合作於我們的中國設施根據嚴格的美國食品藥品監督管理局規範生產AU409（一種針對晚期肝細胞癌的人工智能生成創新藥物）。Auransa Inc.為一間以美國為基地的人工智能驅動製藥公司，致力於開發針對需求缺口巨大領域的精準藥物。我們現正進行其第I期臨床試驗，首名患者於二零二四年七月在香港瑪麗醫院入組。試驗預期於二零二五年第二季度結束，結果將有助該藥於中國進行新藥註冊。此合作意味翻開藥物探索的新篇章，而我們將會進一步加強與Auransa Inc.在人工智能領域的合作。

行情複雜，我們致力起用國內研發專才及組成策略合作關係，以提供可負擔的優質療法。此舉確保我們有效地克服行業挑戰，切實地改善患者病情，以及支持中國推進生命科學的工作。

總括而言，儘管挑戰持續，我們仍致力透過優化成本及維持優質水平，力爭長期增長。憑藉可持續發展能力、供應鏈的韌性及技術不斷改良，我們已作好準備，在不斷演化的行業格局中邁步向前。

BUSINESS REVIEW

Revenue and Profit

The Group recorded revenue of HK\$1,399,969,000 for the Reporting Year, representing a substantial increase of 32.9% compared to the prior year's revenue of HK\$1,053,034,000. Licensed-in products continued to deliver strong results, with sales amounting to HK\$553,237,000 (2023: HK\$467,276,000), contributing 39.5% (2023: 44.4%) of the Group's total revenue. Proprietary and generic products also demonstrated strong momentum, with combined sales totalling HK\$846,732,000 (2023: HK\$585,758,000), accounting for 60.5% (2023: 55.6%) of the Group's revenue.

Licensed-in products delivered notable growth, with Bredinin® achieving a 24.5% increase in sales to HK\$133.8 million and Teglutik® recording a remarkable sales growth of 143.4%, reaching HK\$20.7 million. Trittico® also demonstrated significant progress, with sales surging 137.8% to HK\$120.7 million, while Ferplex remained a key contributor with sales of HK\$185.8 million, despite a year-on-year decline of 9.3%.

In-house products excelled, with Nadroparin Calcium Injection (立騰菁®), a VBP product, achieving an outstanding 130.4% growth, with sales reaching HK\$192.7 million. Yallaferon rebounded strongly with a 12.8% increase, recording sales of HK\$254.8 million. Generic products also performed well, with total sales increasing 59.9% to HK\$255.6 million, led by Treprostinil Injection's (芮旋爾®) robust growth of 62.3%, achieving sales of HK\$184.4 million.

The Group achieved a record-high revenue during the Reporting Year, showcasing its resilience and adaptability in addressing transitional challenges from prior years. These include the expiration of legacy licensed-in product agreements, and the time required to scale newly launched products. Through strategic execution, a commitment to innovation, and the optimisation of its product portfolio, the Group has not only overcome these hurdles but also delivered impressive results that position it for long-term growth and success.

During the Reporting Year, the Group achieved a gross profit of HK\$753,355,000, representing a substantial increase of 36.6% compared to HK\$551,311,000 in the prior year. The gross profit margin improved to 53.8%, up from 52.4% in 2023, reflecting enhanced profitability and operational efficiencies. The increase in gross profit was achieved despite ongoing challenges, including pressures on supply costs and the continued inclusion of products under the VBP programme, which typically carry lower profit margins. These results highlight the Group's ability to adapt and optimise its operations to deliver improved financial performance while navigating a competitive market environment.

業務回顧

收益及溢利

於報告年度，本集團錄得收益1,399,969,000港元，較上一年度的收益1,053,034,000港元大幅增加32.9%。引進產品繼續交出上佳業績，銷售額為553,237,000港元（二零二三年：467,276,000港元），佔本集團總收益的39.5%（二零二三年：44.4%）。專利及仿製產品亦展現強勁勢頭，合併銷售額合共846,732,000港元（二零二三年：585,758,000港元），佔本集團收益的60.5%（二零二三年：55.6%）。

引進產品顯著增長，《布累迪寧®》的銷售額增加24.5%至133,800,000港元，而《芮舒延®》的銷售額則錄得驚人增幅143.4%，達到20,700,000港元。《曲特格®》亦取得重大進展，銷售額急增137.8%至120,700,000港元，而《菲普利®》即使同比下跌9.3%，仍然是主要貢獻來源，銷售額為185,800,000港元。

自主產品表現出類拔萃。藥品集採產品那曲肝素鈣注射液《立騰菁®》錄得130.4%的卓越增長，銷售額達192,700,000港元。《尤靖安®》反彈凌厲，增長12.8%，錄得銷售額254,800,000港元。仿製產品同樣表現理想，總銷售額增加59.9%至255,600,000港元，主要由曲前列尼爾注射液《芮旋爾®》之銷售額強勁增長62.3%至184,400,000港元所帶動。

於報告年度，本集團的收益創下歷史新高，展現出多年來應對過渡性挑戰的無比韌力及適應力。挑戰包括傳統產品引進協議到期及擴展新推產品需時。通過策略執行、致力創新及優化產品組合，本集團不單克服重重難關，更交出理想業績，為長遠增長及成功奠下基礎。

於報告年度，本集團錄得毛利753,355,000港元，較去年的551,311,000港元大幅增加36.6%。毛利率由二零二三年的52.4%上升至53.8%，反映盈利能力及經營效率提升。面對普遍拖低利潤率的持續挑戰，包括供應成本壓力及產品繼續納入藥品集採計劃，毛利依然錄得增長。此等業績彰顯本集團能夠適應並優化其業務營運，從而改善財務表現，在充滿競爭的市場環境中乘風破浪。

The Group spent a total of HK\$193,085,000 on R&D activities, representing 13.8% of annual revenue (2023: HK\$219,849,000 or 20.9% of revenue). Of this amount, HK\$83,829,000 (2023: HK\$96,804,000) was recognised as expenses, while HK\$109,256,000 (2023: HK\$123,045,000) was capitalised as intangible assets. The reduction in R&D expenditure reflects the Group's strategic focus on balancing investment in innovation with financial discipline. Key R&D activities included the development of new drugs across major therapeutic areas such as cardiovascular health, women's health, paediatrics, rare diseases, dermatology, and obstetrics, with oncology handled by a dedicated R&D arm. Although overall R&D spending has decreased, the Group remains firmly dedicated to long-term growth by channeling investments into high-potential projects. This focused approach enables the Group to drive innovation while safeguarding a strong and stable financial position for future endeavours.

The Group's selling and distribution expenses amounted to HK\$387,292,000 during the Reporting Year, reflecting an increase of HK\$82,996,000 or 27.3% compared to the previous year, where expenses totalled HK\$304,296,000. The selling expenses to revenue ratio improved to 27.7% compared to 28.9% in the prior year, demonstrating the Group's efficient allocation of resources. This increase in expenses was mainly attributable to expanded efforts for the launch and promotion of new products, alongside investments in strengthening distribution channels and executing brand-building initiatives for selected products.

During the Reporting Year, the Group's administrative expenses totalled HK\$195,298,000, representing an increase of HK\$6,686,000 or 3.5% compared to the previous year, where expenses were HK\$188,612,000. The Group remains committed to operating its business efficiently and effectively, implementing cost-saving measures to enhance operational performance and profitability while carefully managing expenditure.

The net profit attributable to the owners of the Company in 2024 was HK\$93,099,000, a substantial improvement from HK\$16,698,000 in 2023, despite several factors impacting the overall result. These included a provision for the diminution in value of the land use rights in Nansha under resumption, amounting to HK\$6,705,000, a provision for losses related to a financial guarantee issued for an associate amounting to HK\$12,967,000, and an impairment loss of HK\$19,195,000 recognised in relation to the elimination of certain R&D projects during the Reporting Year.

本集團已動用合共193,085,000港元於研發活動，佔年度收益的13.8%（二零二三年：219,849,000港元或收益的20.9%）。當中，83,829,000港元（二零二三年：96,804,000港元）已確認為費用，而109,256,000港元（二零二三年：123,045,000港元）已資本化作為無形資產。研發支出減少反映本集團的策略集中於創新投資與財務紀律之間的平衡。主要研發活動包括心血管健康、女性健康、兒科、罕見病、皮膚科及產科等各個主要治療領域的新藥開發，而腫瘤科則由一支專責研發分支負責。儘管整體研發費用減少，惟本集團仍堅定不移地將投資引進高潛力項目來實現長期增長。此重點工作方針讓本集團可推動創新之餘，同時為未來工作保有強大而穩定的財務狀況。

於報告年度，本集團的銷售及分銷費用為387,292,000港元，較去年的費用合共304,296,000港元增加82,996,000港元或27.3%。銷售費用對收益的比率改善至27.7%，而去年為28.9%，足證本集團有效分配資源。費用增加主要由於擴大推出及宣傳新產品的工作，以及加強分銷渠道及就選定產品進行品牌建立工作的投資所致。

於報告年度，本集團的行政費用合共195,298,000港元，較去年的費用188,612,000港元增加6,686,000港元或3.5%。本集團仍會致力以具效益及效率的方式經營其業務，在推行減省成本措施以提升營運表現及盈利能力的同時，審慎管理支出。

儘管於報告年度的整體業績受多重因素影響，包括正在收回的南沙土地使用權減值撥備6,705,000港元、與為一間聯營公司發出的財務擔保有關係的虧損撥備12,967,000港元，以及就取消若干研發項目確認之減值虧損19,195,000港元，惟二零二四年的本公司擁有人應佔純利為93,099,000港元，較二零二三年的16,698,000港元大幅改善。

Manufacturing Facilities and Production Capability

The Group's manufacturing facilities have achieved significant advancements in production capabilities and efficiency. At the Hefei site, previous equipment upgrades have enabled the facility to focus on critical inspections, including U.S. FDA site inspections and Good Manufacturing Practice (GMP) compliance for specific products. During the Reporting Year, a new pre-filled production line became operational, significantly boosting capacity for VBP products, namely Fondaparinux Sodium Injection (立暢青®) and Nadroparin Calcium Injection (立騰菁®). The Hefei facility recorded a remarkable 34% increase in total production volume in 2024 compared to the prior year, including an impressive 77% surge in pre-filled syringe production volume. This growth was driven by production mode optimisation, improved yields, and efficient equipment maintenance. Meanwhile, the Nansha site successfully scaled up production of Azilsartan Tablets (憩曇平®) and advanced validation batch production for Fentanyl aerosol inhalation, following the success of its Phase II clinical trial. Both manufacturing sites remain steadfast in their commitment to enhancing production by improving yields, conserving energy, reducing costs, and boosting efficiency to meet the demands of an evolving market environment.

Drug Development

The Group currently maintains a strong and carefully curated project pipeline, spanning early- to late-stage development, with a focus on selecting and advancing high-potential opportunities.

Major Therapeutic Areas

The Group is currently developing several assets across major therapeutic areas, including cardiovascular health, women's health, paediatrics, rare diseases, dermatology, and obstetrics, which includes late-stage programs such as (1) the NDA for Intrarosa® in the treatment of vulvovaginal atrophy (VVA); (2) ANDA for Sugammadex Sodium Injection; and (3) ANDA for Melphalan Hydrochloride for Injection. Additionally, the Group is pursuing R&D projects in rare diseases, such as Neridronate Sodium for Osteogenesis imperfecta and Anfibatide for Thrombotic Thrombocytopenic Purpura, as well as in oncology pain management with a Fentanyl drug-device combination.

製造設施及生產能力

本集團的製造設施已大幅提升生產能力及效率。於合肥基地，過去的設備升級使設施能夠重點處理關鍵核查，包括美國食品藥品監督管理局現場核查及指定產品的藥品生產質量管理規範(GMP)符合性檢查。於報告年度，一條新的預充式生產線投入運作，大大提高藥品集採產品(即磺達肝癸鈉注射液《立暢青®》及那曲肝素鈣注射液《立騰菁®》)的產能。合肥設施於二零二四年的總產量較去年明顯增加34%，包括預充式注射器產量急增77%。此增長由完善生產模式、提高產出及有效設備維護等因素帶動。與此同時，南沙基地成功放大生產阿齊沙坦片《憩曇平®》，並於第II期臨床試驗成功後，推進芬太尼氣溶膠吸入劑的驗證批次生產。兩個生產基地藉改善產量、節省能源、降低成本及提高效率，堅持提升生產的承諾，以滿足不斷變化的市場環境需要。

藥物開發

本集團現時保持處於早期至後期開發階段、經過精心策劃的強大項目管道，旨在挑選及推進潛力優厚的機會。

主要治療領域

本集團現正開發心血管健康、女性健康、兒科、罕見病、皮膚科及產科等主要治療領域的多項資產，包括處於後期開發階段的計劃，例如(1)《Intrarosa®》新藥申請，該藥用於治療外陰陰道萎縮；(2)舒更葡糖鈉注射液簡化新藥申請；及(3)注射用鹽酸美法侖簡化新藥申請。此外，本集團亦正進行罕有病的研發項目，例如用於治療成骨不全症的奈立膦酸鹽，用於治療血栓性血小板低下紫斑症的安非博肽，以及芬太尼藥物與儀器結合的腫瘤痛症管理的研發項目。

Oncology Pipeline

China Oncology Focus Limited (“COF”), a 65% owned subsidiary of the Group, serves as the Group’s R&D arm and is a clinical development stage company specialising in oncology, with a particular focus on immuno-oncology. COF has successfully built a robust pipeline of oncology assets, comprising 6 innovative assets and 4 generics, developed through a combination of internal R&D efforts and licensing agreements, including Socazolimab, which was licensed-in Socazolimab and has since been fully acquired during the Reporting Year.

Following the conditional approval of Socazolimab Injection (善克鈺®), an anti-PD-L1 antibody used for treating recurrent or metastatic cervical cancer in the prior year, COF submitted an indication expansion application to the NMPA on 28 June 2024. This submission is based on results from a Phase III multicenter, randomised, double-blinded, placebo-controlled clinical trial of Socazolimab combined with chemotherapy for the first-line treatment of extensive-stage small-cell lung cancer (ES-SCLC).

Moreover, COF is advancing multiple programs, including late-stage trials for osteosarcoma, early-phase trials for glioblastoma, mid- to early-phase evaluations for ovarian, small-cell lung, and pancreatic cancers, and combination trials for melanoma using an oncolytic virus. These efforts reflect COF’s commitment to addressing critical needs in oncology through innovative solutions.

AI-Driven Drug Discovery

In addition, the Group is embarking on a groundbreaking journey in AI-driven drug discovery, partnering with Auransa Inc. to manufacture AU409, an AI-derived drug targeting advanced hepatocellular carcinoma, at its China facility under U.S. FDA standards. Furthermore, the Group is conducting the Phase I clinical trial for AU409, which began in July 2024 and is expected to conclude by the second quarter of 2025. This collaboration marks a new era in AI-driven drug discovery, with plans to deepen cooperation with Auransa Inc. in this field.

New Products Approval

During the year under review and up to date, the Group obtained 3 registration certificate approvals from NMPA.

Levocarnitine Injection

In February 2024, Levocarnitine Injection (5ml: 1g) has obtained drug registration approval granted by the NMPA and is deemed to have passed the consistency evaluation of quality and efficacy of generic drugs.

Epinastine Hydrochloride Tablets

In May 2024, Epinastine Hydrochloride Tablets (20mg) has obtained drug registration approval granted by the NMPA and is deemed to have passed the consistency evaluation of quality and efficacy of generic drugs.

腫瘤管道

由本集團擁有65%權益的附屬公司中國腫瘤醫療有限公司(「COF」)為本集團在腫瘤科方面的研發分支，並為臨床開發階段公司，專研免疫腫瘤療法領域。COF已成功建立強大的腫瘤資產管道，包括六項創新資產及四項仿製藥。該等資產乃通過結合內部研發工作及許可協議開發，包括索卡佐利單抗(為引進的索卡佐利單抗，於報告年度內獲全數收購)。

繼索卡佐利單抗注射液《善克鈺®》(用於治療復發性或轉移性宮頸癌的抗PD-L1抗體)於上一年度取得有條件批文後，COF已於二零二四年六月二十八日向國家藥監局提交適應症擴大申請。該項申請建基於索卡佐利單抗與化療結合作用擴散期小細胞肺癌(ES-SCLC)一線治療的第III期、多中心、隨機、雙盲、安慰劑對照臨床試驗的結果。

此外，COF現正推進多個項目，包括骨肉瘤的後期開發階段試驗，膠質母細胞瘤的早期試驗，卵巢癌、小細胞肺癌及胰臟癌的早至中期評估，以及利用溶瘤病毒的黑色素瘤結合試驗。此等工作顯示COF致力通過創新解決方案應對腫瘤科的關鍵需要。

人工智能驅動的藥物探索

另外，本集團現時聯同Auransa Inc.開展突破性的人工智能驅動藥物探索，於本集團的中國設施根據美國食品藥品監督管理局的規範製造AU409(一種針對晚期肝細胞癌的人工智能生成藥物)。此外，本集團於二零二四年七月開始AU409的第I期臨床試驗，目前仍在進行，預計將於二零二五年第二季度結束。此合作標誌着人工智能驅動藥物探索的新時代，並有計劃在此領域深化與Auransa Inc.的合作。

新產品批准

於回顧年度內及截至目前為止，本集團已取得國家藥監局發出三項註冊證批准。

左卡尼汀注射液

於二零二四年二月，左卡尼汀注射液(5毫升：1克)取得國家藥監局藥品註冊批文，被認定通過仿製藥品質和療效一致性評價。

鹽酸依匹斯汀片

於二零二四年五月，鹽酸依匹斯汀片(20毫克)取得國家藥監局藥品註冊批文，並被認定通過仿製藥品質和療效一致性評價。

Ciprofloxacin Hydrochloride and Fluocinolone Acetonide Ear Drops

In January 2025, Ciprofloxacin Hydrochloride and Fluocinolone Acetonide Ear Drops has obtained drug registration approval granted by the NMPA and are indicated for the treatment of acute otitis externa ("AOE") and acute otitis media with tympanostomy tubes ("AOMT").

Sales and Marketing

In response to the growing competition within the business environment, the Group has focused on strengthening its sales and marketing capabilities. Recognising the critical importance of market access, the Group has invested in equipping its market access team with the skills and expertise needed to navigate the complex healthcare environment in mainland China. These proactive efforts have started yielding positive results, contributing to the successful inclusion of key products in major programs like the NRDL and VBP. The Group's products Treprostinil Injection (芮旋爾®), Teglutik®, and Trittico® were included in the updated NRDL in the prior year, with Treprostinil Injection (芮旋爾®) emerging as a key revenue driver, and Trittico® and Teglutik® showing strong growth. Notably, Treprostinil Injection (芮旋爾®) and Teglutik® reflect the Group's emphasis on addressing rare diseases in recent years, further supporting a well-balanced and diversified product portfolio. This shift has not only enhanced the Group's market position but also expanded its offerings to meet unmet medical needs.

During the Reporting Year, the Group has also achieved procurement platform listings in most of the provinces for two key new products: Socazolimab Injection (善克鈺®) and the Adapalene and Clindamycin Combination Gel (馥霖安®), which are expected to drive future growth.

To date, a total of 10 products from the Group have been successfully included in the updated NRDL, with 2 also featured in the VBP program. This highlights the Group's ongoing commitment to broadening market access and enhancing patient affordability.

Corporate Development

On 27 December 2024, the Group finalised the resumption of land use rights for a parcel in Nansha District, Guangzhou, designated for medical and sanitary purposes. The total compensation of RMB89.2 million (approximately HK\$94.6 million) was calculated based on the land's original acquisition cost and an idle land levy. While the resumption is expected to result in an estimated impairment of approximately HK\$6.7 million recognised in the Reporting Year, the land was still under construction and did not impact the Group's operations. Importantly, the proceeds from this resumption will release valuable capital upon receipt, bolstering future cash flow and enabling the Group to prioritise and strengthen its core pharmaceutical initiatives.

環丙沙星氟輕鬆滴耳液

於二零二五年一月，環丙沙星氟輕鬆滴耳液取得國家藥監局藥品註冊批文，用於治療急性外耳炎，以及結合通氣管治療急性中耳炎。

銷售及營銷

為應對營商環境日趨激烈的競爭，本集團重點加強銷售及營銷能力。本集團肯定市場准入的重要性，已為市場准入團隊裝備必要技能及知識作出投資，以於中國內地複雜的醫療環境中大展拳腳。這些具前瞻性的工作已開始取得回報，成功使多款主要產品獲納入醫保藥品目錄及藥品集採計劃等重點計劃。本集團的產品曲前列尼爾注射液《芮旋爾®》、《芮舒延®》及《曲特格®》於去年獲納入最新版醫保藥品目錄，曲前列尼爾注射液《芮旋爾®》漸已成為主要收益動力，而《芮舒延®》及《曲特格®》則呈現強勁增長。值得注意的是，曲前列尼爾注射液《芮旋爾®》及《芮舒延®》反映本集團近年針對罕有病的重點工作，進一步支持兼顧多元平衡的產品組合。此轉變不單提高本集團的市場地位，更可拓展其產品至應付醫療需求缺口。

於報告年度，本集團亦已為兩款主要新產品（索卡佐利單抗注射液《善克鈺®》以及阿達帕林克林霉素凝膠《馥霖安®》）納入大部分省份的採購平台目錄，預期會成為未來增長動力。

截至目前為止，本集團共有十款產品已成功獲納入最新版醫保藥品目錄，有兩款同時納入藥品集採計劃，突顯本集團在擴大市場准入及提高患者負擔能力方面的持續努力。

企業發展

於二零二四年十二月二十七日，本集團落實收回廣州市南沙區一幅土地（指定作為醫療衛生用地）的土地使用權。補償總額人民幣89,200,000元（約94,600,000港元）乃基於該土地的原收購成本及閒置土地徵費計算。儘管收回行動預料會導致於報告年度確認估計減值約6,700,000港元，惟該土地仍然在建，不會影響本集團營運。重點在於收訖收回行動的所得款項將可釋放寶貴資本，加強未來現金流，使本集團可優先執行及加大其核心藥品活動。

Revenue and Net Profit Attributable to the Owners of the Company

The Group's revenue increased from HK\$1,053,034,000 in 2023 to HK\$1,399,969,000 in 2024, representing an increase of HK\$346,935,000 or 32.9%. During the Reporting Year, sales of proprietary and generic products increased by 44.6% and sales of licensed-in products increased by 18.4%.

Net profit attributable to the owners of the Company increased by 457.5% from HK\$16,698,000 in 2023 to HK\$93,099,000 in 2024.

Gross Profit Margin

Gross profit margin for the Reporting Year increased by 1.4 percentage points from 52.4% in 2023 to 53.8% in 2024, reflecting enhanced profitability and operational efficiencies. The increase in gross profit was achieved despite ongoing challenges, including pressures on supply costs and the continued inclusion of products under the VBP programme, which typically carry lower profit margins.

Other Income

Other income was HK\$62,450,000 for the Reporting Year, a decrease of 19.2% or HK\$14,807,000 as compared to the same period in last year. Other income included development grants from local government, rental and utilities income, milestone income and research and development service income. Compared to the year 2023, the decreased level of government and development grants counterbalanced the milestone income earned. As a result, the overall level of other income for the Reporting Year dropped.

財務回顧

收益及本公司擁有人應佔純利

本集團收益由二零二三年的1,053,034,000港元增至二零二四年的1,399,969,000港元，增加346,935,000港元或32.9%。於報告年度內，專利及仿製產品的銷售增加44.6%，而引進產品的銷售亦增加18.4%。

本公司擁有人應佔純利由二零二三年的16,698,000港元增加457.5%至二零二四年的93,099,000港元。

毛利率

報告年度的毛利率由二零二三年的52.4%上升1.4個百分點至二零二四年的53.8%，反映盈利能力及經營效率提升。面對普遍拖低利潤率的持續挑戰，包括供應成本壓力及產品繼續納入藥品集採計劃，毛利依然錄得增加。

其他收入

報告年度的其他收入為62,450,000港元，較去年同期減少19.2%或14,807,000港元。其他收入包括地方政府授予的開發補助、租金及公共服務收入、里程碑收入以及研究及開發服務收入。與二零二三年度比較，政府及開發補助金水平的減少，抵銷了已賺取的里程碑收入水平減幅。因此，報告年度的其他收入水平整體下跌。



Other Gains and Losses, Net

Other gains and losses recorded a net loss of HK\$22,542,000 for the Reporting Year, shifting from a net gain of HK\$5,977,000 in 2023. This decrease was primarily driven by the absence of one-time gain of HK\$41.6 million from the disposal of intangible assets in 2023, and the marked increase in the impairment losses provision of HK\$25.9 million on right-of-use assets and intangible assets. Although there were improvements in foreign exchange gains and reduced fair value losses, these positive factors were insufficient to offset the overall unfavorable outcome during the Reporting Year.

Selling and Distribution Expenses

The Group's selling and distribution expenses amounted to HK\$387,292,000 during the Reporting Year, reflecting an increase of HK\$82,996,000 or 27.3% compared to the previous year's total of HK\$304,296,000. The selling expenses to revenue ratio improved to 27.7% compared to 28.9% in the prior year, demonstrating the Group's efficient allocation of resources. This increase in expenses was mainly attributable to expanded efforts to launch and promote new products, alongside investments in strengthening distribution channels and executing brand-building initiatives for selected products.

Administrative Expenses

Administrative expenses for the Reporting Year totalled HK\$195,298,000, representing an increase of HK\$6,686,000 or 3.5% compared to the previous year's total of HK\$188,612,000. The Group remains committed to operating its business efficiently and effectively, implementing cost-saving measures to enhance operational performance and profitability while carefully managing expenditure.

Research and Development Expenses

R&D expenses for the Reporting Year decreased by HK\$12,975,000 compared to the corresponding year to HK\$83,829,000, and accounted for 6.0% of the Group's revenue, decreased by 3.2 percentage points from the prior year's 9.2%. Together with the capitalised R&D costs of HK\$109,256,000 (2023: HK\$123,045,000), total amount spent in R&D activities during the Reporting Year was HK\$193,085,000, decreased by HK\$26,764,000 or 12.2% compared to the corresponding year.

Taxation

Income tax expense for the Reporting Year increased by HK\$18,665,000 compared to the same period last year to HK\$29,501,000. The Group's effective tax rate was decreased by 5.1 percentage points from approximately 35.2% in the prior year to 30.1% for the Reporting Year. Less impairment losses on assets with no tax impact with higher utilisation of unrecognised tax loss led to the decrease in effective rate in the Reporting Year.

其他收益及虧損淨額

報告年度的其他收益及虧損錄得虧損淨額22,542,000港元，而二零二三年則錄得收益淨額5,977,000港元。減少主要是由於缺乏二零二三年的出售無形資產的一次性收益41.6百萬港元，以及使用權資產及無形資產的減值虧損撥備大幅增加25.9百萬港元所致。於報告年度內，儘管外匯收益改善及公平值虧損減少，惟該等正面因素不足以抵銷整體不利結果。

銷售及分銷費用

本集團於報告年度的銷售及分銷費用為387,292,000港元，較去年合共304,296,000港元上升82,996,000港元或27.3%。銷售費用佔收益比率由去年的28.9%改善至27.7%，顯示本集團資源分配得當。費用上升主要是由於加大力度推出並推廣新產品，以及就選定產品作出投資以強化分銷渠道並執行建立品牌的行動。

行政費用

報告年度的行政費用合共為195,298,000港元，較去年合共188,612,000港元上升6,686,000港元或3.5%。本集團繼續致力以具效益及效率的方式經營其業務，推行減省成本措施以提升營運表現及盈利能力，同時審慎管理開支。

研究及開發費用

報告年度的研發費用較去年減少12,975,000港元至83,829,000港元，佔本集團收益6.0%，較去年的9.2%下降3.2個百分點。連同資本化的研發成本109,256,000港元（二零二三年：123,045,000港元），於報告年度內用於研發活動的總額為193,085,000港元，較去年減少26,764,000港元或12.2%。

稅項

報告年度的所得稅開支較去年同期上升18,665,000港元至29,501,000港元。於報告年度內，本集團實際稅率由去年約35.2%下降5.1個百分點至30.1%。並無稅務影響的資產的減值虧損減少連同增加動用未確認稅項虧損均導致報告年度內的實際稅率下降。

- ZKO is an ophthalmic pharmaceutical company principally engaged in the research and development, manufacturing and commercialisation of therapies that address significant unmet medical needs. The Group directly held 138,192,000 shares of ZKO, representing 25.3% of the total issued shares of ZKO as at 31 December 2024. During the Reporting Year, the Group did not receive any dividend income from ZKO. The Group takes a longer-term view on this investment and will closely monitor the progress of the clinical development programs of ZKO.

The Group will closely monitor the performance of its investment portfolio, continue to invest strategically, and explore opportunities to monetise some of the existing investments if suitable market opportunities arise.

Save as disclosed above, the Group did not have any significant investment as at 31 December 2024.

Liquidity and Financial Resources

The Group's principal sources of working capital in the current year mainly included cash flow generated from operating activities and bank borrowings.

As at 31 December 2024, the Group's current ratio (current assets divided by current liabilities) was 1.02 (31 December 2023: 1.01). As at 31 December 2024, the Group had net cash position of HK\$2,980,000 (31 December 2023: net debt of HK\$19,563,000) which represented by below:

Treasury Policies

The Group adopts a conservative approach towards its treasury policies. The Group strives to reduce exposure to credit risk by performing ongoing credit evaluations of the financial conditions of its customers. To manage liquidity risk, the management of the Group closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and commitments can meet its funding requirements.

Foreign Exchange Exposure

Currently, the Group earns revenue and incurs costs mainly in Renminbi, Hong Kong Dollars, European Union Euro, Japanese Yen, New Taiwan Dollars, Thai Baht and United States Dollars. The Directors believe that the Group does not have foreign exchange problems in meeting its foreign exchange requirements. The Group will continue to monitor closely its foreign currency exposure and to consider hedging significant foreign currency exposure when necessary.

PROSPECT

The Group is navigating a dynamic and competitive landscape as China's pharmaceutical industry undergoes significant transformation. A primary challenge stems from the integration of lower-margin products into the national reimbursement scheme and the VBP program, necessitating a meticulous and adaptive operational strategy. Moreover, rising operating costs and inflationary pressures continue to heighten operational complexities. These challenges underscore the importance of strategic management, cost efficiency, and innovation in maintaining a competitive edge. Encouragingly, increasing sales volumes and advancements in manufacturing efficiency are expected to alleviate some of these pressures.

In response, the Group remains steadfast in its commitment to implementing rigorous cost-control measures and enhancing operational efficiency across its value chain. With particular emphasis on sales and R&D functions, the Group aligns with industry-wide trends by prioritising lean operations to counter VBP-driven margin compression. It is also accelerating innovation in areas such as biologics and digital health solutions, including AI-driven drug discovery, to capitalise on China's broader push for pharmaceutical innovation.

While maintaining a cautious outlook, the Group is resolute in its objectives and optimistic about its long-term sustainability and value creation for the Shareholders. The Group is also actively working to enhance profitability by refining its product mix and optimising resources efficiency. By leveraging strategic initiatives, embracing innovation, and upholding its commitment to sustainability, the Group is poised to deliver enhanced value and reward its shareholders for their continued trust and support.

The principal activity of the Company is investment holding and the principal activities of the Group are the developing, manufacturing and sale and marketing of pharmaceutical products.

The Board has resolved to recommend a final dividend for the year ended 31 December 2024 (the "Final Dividend") equivalent to HK\$0.025 per share (2023: HK\$0.010 per share) in cash to the shareholders whose names appear on the register of members of the Company as at the close of business on 2 June 2025. Together with the interim dividend of HK\$0.020 per share (2023: HK\$0.008 per share) paid on 3 October 2024, total distribution of dividend by the Company for the year ended 31 December 2024 will be HK\$0.045 per share (2023: HK\$0.018 per share).

Dr. Li Xiaoyi ("Dr. Li") is a non-executive Director and he serves as a senior adviser to the Company. Dr. Li has a three-year service contract with the Company from 29 April 2021. Director's fee is HK\$300,000 per annum and bonus will not be paid for service as a non-executive director and senior adviser to the Company. Director's fee is determined by the Board with reference to the market rate. The term of Dr. Li's appointment is subject to retirement and re-election at the AGM in accordance with the Company's Articles of Association. Dr. Li has a three-year consulting contract with the Company from 1 December 2021 for service as a senior adviser to the Company and is entitled to a service fee of HK\$100,000 per month. The consulting contract is renewed for 3 years from 1 October 2024 at a service fee of HK\$200,000 per month.

In accordance with supplementary agreement dated 16 April 2017 signed between the Company and each of Ms. Lee, Ms. Leelalertsuphakun and Dr. Li (prior to his re-designation as a non-executive Director with effect from 29 April 2021), employment terms of executive Directors have been revised as follows:

1. Executive Directors are entitled to annual management bonus 1.5% to 3.0% (determined based on the growth in net profits of the Group) on the net profit of the Group for the preceding financial year. Such sum of the management bonus will be shared between all the executive Directors in such proportion with reference to their monthly salary in the final month of the complete financial year.
2. The annual salary increment shall be equal to official inflation rate if the growth in net profits of the Group is equal to or less than 15%, or should the growth exceed 15%, the sum of the official inflation rate and half of the positive difference between the growth in net profits and the 15% threshold.
3. Each of executive Directors will be entitled to lump sum payment upon retirement and monthly pension payment after retirement if he/she has engaged in continuous service with the Company for certain years.

In accordance with the supplemental agreement dated 20 December 2021 signed between the Company and each of Ms. Lee and Ms. Leelalertsuphakun, employment terms of executive Directors have been revised. The revised terms state that the annual salary increment shall be equal to official inflation rate plus half of the positive difference between the growth in net profits and the 15% threshold, which shall not be less than 10% or more than 30% of their salary for the immediately preceding calendar year.

Dr. Tsim Wah Keung, Karl ("Dr. Tsim") was appointed on 20 September 2004 as an independent non-executive Director. Contract with Dr. Tsim was renewed for three years from 20 September 2022. Director's fees for Dr. Tsim are HK\$216,000 per annum and bonus will not be paid.

Dr. Chan Yau Ching, Bob had a three-year service contract with the Company from 12 October 2007. The contract was renewed for three years from 12 October 2022. Director's fee is HK\$216,000 per annum and bonus will not be paid.

The total number of Shares which may be issued upon exercise of all options to be granted under the 2012 Share Option Scheme shall be subject to a maximum limit of 10% of the Shares in issue on 10 May 2012, the date on which the 2012 Share Option Scheme is conditionally adopted and approved by the Shareholders at the AGM, which is 47,023,543 Shares.

The total number of Shares available for issue under the 2012 Share Option Scheme as at 31 December 2024 were Nil, representing 0% of the Company’s total number of issued shares as at the date of this annual report. As at 31 December 2024, the number of Shares in respect of which options had been granted and remained outstanding under the 2012 Share Option Scheme was 23,017,000 (31 December 2023: 24,367,000), representing 3.9% (31 December 2023: 4.1%) of the Shares in issue at the date of this annual report.

During the year ended 31 December 2024, the Group conducted certain transactions with parties deemed as "related parties" under applicable accounting standards. The details of these transactions are set out in note 43 to the consolidated financial statements. Save for the transactions mentioned in the section headed "Connected Transactions and Continuing Connected Transactions" which is subject to announcement and disclosure requirements under Chapter 14A of the Listing Rules, certain transactions mentioned in note 43 to the consolidated financial statements also constituted connected transactions or continuing connecting transactions as defined in Chapter 14A of the Listing Rules but are exempt from the disclosure requirements under Chapter 14A of the Listing Rules.

CONNECTED TRANSACTIONS AND CONTINUING CONNECTED TRANSACTIONS

During the year, the Company and the Group had the following continuing connected transactions, and details of which have been disclosed in compliance with the requirements of Chapter 14A of the Listing Rules.

Continuing Connected Transactions

1. Provision of financial guarantee to PPI, an associate of the Group

On 11 February 2020 (as supplemented), the Company as guarantor provided a corporate guarantee in favour of a bank as a security for the provision of a revolving loan facility of up to HK\$13,000,000, a demand loan facility of up to HK\$40,000,000 and an overdraft facility of up to HK\$6,000,000, provided that the total outstanding balance of the overdraft facility and revolving loan facility shall not at any time exceed HK\$13,000,000, to PPI for the purpose of funding its normal commercial operation.

The above continuing connected transactions have been reviewed by the independent non-executive Directors and they have confirmed that the transactions:

- have been entered into in the usual and ordinary course of businesses of the Company and its subsidiaries.
- are conducted on normal commercial terms.
- are entered into in accordance with the terms of relevant agreements that are fair and reasonable and in the interests of shareholders as a whole.
- have not exceeded the cap disclosed in previous announcements.

KEY RISKS AND UNCERTAINTIES

The Board acknowledges its responsibility for the effectiveness of the internal control and risk management systems of the Group, which are designed to manage the risk of failure to achieve business objectives and provide reasonable assurance against material misstatement or loss.

Business Risk

The Group's business risks include rapid change in the general market conditions, downturn pressure on the overall economy of China and price competition from other market players. The Board is responsible for the overall management of the business and review of material business decisions involving material risks exposures from time to time.

Financial Risk

The Group adopts financial risk management policies to manage its currency risk, interest rate risk, credit risk, and liquidity risk. The Board also reviews monthly management accounts, capital structure and key operating data of the Group.

Compliance Risk

The Board adopts procedures to ensure the Group is in compliance with applicable laws, rules and regulations. The Group engages professional advisers and consultants to keep the Group abreast of the latest developments in the regulatory environment, including legal, financial, environmental, and operational developments. The Group also adopts a strict policy in prohibiting any unauthorised use or dissemination of confidential or inside information.

Operational Risk

The Group adopts procedures to manage its operational risk, such as inadequate management efficiency, inefficient raw material procurement, and production facilities utilisation. The Board has reviewed the effectiveness of the Group's internal control and risk management systems covering business, financial, compliance and operational risks of the Group and is satisfied that such systems are effective and adequate.

RELATIONSHIPS WITH EMPLOYEES, CUSTOMERS AND SUPPLIERS

The sustainability of the Group's business relies on the growth of the Group's employees. Remuneration packages of the employees are generally structured with reference to prevailing market terms and individual qualifications. Salaries and wages are normally reviewed on an annual basis based on performance appraisals and other relevant factors.

Apart from salary payments, there are other staff benefits including mandatory provident fund, medical insurance and performance related bonus. Share options may also be granted to eligible employees of the Group.

Relationship is the fundamentals of business. The Group fully understands this principal and thus maintain good relationship with the customers to fulfil their immediate and long-term need.

The Group strives to maintain fair and co-operating relationship with the suppliers.

SOCIAL RESPONSIBILITIES AND SERVICES AND ENVIRONMENTAL POLICY

The Group is committed to the long-term sustainability of its businesses and the communities with which it engages. The Group pursues this business approach by managing its business prudently and executing management decisions with due care and attention. Over the years, the Group has been fully committed to environmental protection. Periodic internal control meetings are held to review environmental issues in the production plants to update environmental laws and regulations and to make valuable suggestions and recommendations for improvement.

STAFF RETIREMENT SCHEMES

The group companies operated in Hong Kong are required to participate in a defined contribution retirement scheme set up in accordance with the Mandatory Provident Fund Schemes Ordinance (Cap. 485). Under the scheme, the employees are required to contribute 5% of their monthly salaries up to a maximum of HK\$1,500 and they can choose to make additional contributions. The employer's monthly contributions are calculated at 5% of the employee's monthly salaries up to a maximum of HK\$1,500 (the "Mandatory Contributions"), and are charged to the profit or loss as they become payable in accordance with the rules of the scheme. The assets of the scheme are held separately from those of the Group in an independently administered fund. The employees are entitled to 100% of the employer's Mandatory Contributions upon their retirement at the age of 65 years old, death or total incapacity.

In addition, pursuant to the government regulations in the PRC and Taiwan, the employees of the group companies operated in the PRC and Taiwan are members of a state-managed retirement benefit plan operated by the government of the PRC and Taiwan. Those group companies are required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement is to make the specified contributions.

Certain Directors will be entitled to lump sum payment upon retirement and monthly pension payment after retirement if they have engaged in continuous service with the Company for certain years.

Particulars of the scheme of the Group are set out in note 38 to the consolidated financial statements.

此外，根據中國及台灣政府的規例，本集團於中國和台灣營運公司的僱員為中國及台灣政府運作的國家管理退休福利計劃的成員。該等集團公司均須按工資成本的特定百分比向退休福利計劃供款，以便為福利提供資金。本集團就退休福利僅須承擔的責任為作出特定供款。

若干董事倘若已持續服務本公司指定年期，將有權於退休時享有一次過款項及於退休後享有每月退休金。

AUDITOR

The consolidated financial statements for the years ended 31 December 2021 and 2022 were audited by HLM CPA Limited (“**HLM**”) and the consolidated financial statements for the years ended 31 December 2023 and 2024 were audited by Confucius International CPA Limited (“**Confucius**”).

AUDIT COMMITTEE AND ACCOUNTABILITY

The Board is responsible for presenting a balanced, clear and comprehensible assessment of the Group's performance and prospects. The Board is also responsible for preparing the accounts of the Group, which give a true and fair view of the financial position of the Group on a going concern basis.

The Company set up an audit committee with written terms of reference in compliance with Rules 3.21 and the CG Code as set out in Appendix C1 of the Listing Rules. The primary duties of the Audit Committee are to review and supervise the financial reporting process, internal control and risks management system of the Group.

The Audit Committee is to serve as a focal point for communication between other Directors, the external auditors, the internal auditors (where an internal audit function exists) of the Company, and the management as regards their duties relating to financial and other reporting, risk management, internal controls, external and internal audits and such other financial and accounting matters as the Board determines from time to time. The Audit Committee is to assist the Board in providing an independent review of the effectiveness of the financial reporting process, internal control and risk management system of the Group, overseeing the audit process and performing other duties and responsibilities as may be assigned by the Board from time to time.

Nomination Committee has been established in January 2022 in accordance with the requirement of Appendix C1 of the Listing Rules. The Nomination Committee of the Company comprises one executive Director and two independent non-executive Directors.

Ms. Lee Siu Fong is the chairman of the Nomination Committee and Dr. Chan Yau Ching, Bob and Dr. Tsim Wah Keung, Karl are members of the Nomination Committee. The major roles and functions of the Nomination Committee are as follows:

- Review the structure, size and composition (including the skills, knowledge, experience and diversity of perspectives) of the Board at least annually and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy;
- Identify individuals suitably qualified to become Board members and select or make recommendations to the Board on the selection of, individuals nominated for directorships;
- Assess the independence of independent non-executive directors;
- Make recommendations to the Board on the appointment or re-appointment of directors and succession planning for directors (in particular the chairman or chairlady and the chief executive officer);
- Review the policy on Board diversity (the "Board Diversity Policy") and any measurable objectives for implementing such Board Diversity Policy as may be adopted by the Board from time to time and to review the progress on achieving the objectives; and to make disclosures of its progress on its review results in the annual report of the Company annually; and

Management Committee was established in April 2021 which comprises two executive Directors and several key management personnels of the Group in respect of research and development, manufacturing, sales and marketing and finance. The Management Committee is established for the purpose of effective and timely management of the day-to-day activities and business dealings of the Group, as well as implement all policies and decisions approved by the Board and to assist the Board in implementing the strategic plans of the Group.

Ms. Leelalertsuphakun Wanee is the chairman of the Management Committee and Ms. Lee Siu Fong and several key management personnels are members of the Management Committee. The major roles and functions of the Management Committee are as follows:

- a. Oversee the management and the administrative functions of the day-to-day operations of the Group;
- b. Review the documents from the senior management of the Company on issues relating to its operation, management, strategies and developments (such as vision, mission, and annual strategy of the Company) on a regular basis and make recommendations to the Board regarding any proposed changes;

INTERNAL CONTROL AND RISK MANAGEMENT

The Board is responsible for maintaining sound and effective internal control and risk management systems over the Group's asset and shareholders' interests, as well as for reviewing such systems' effectiveness. Such systems are designed to provide reasonable, but not absolute, assurance against misstatement or loss, and to manage risks of failure in the Group's operational systems. The systems include a well-established organisational structure with clearly defined lines of responsibility and authority, which is designed to safeguard assets from inappropriate use, maintain proper accounts, ensure compliance with regulations and regulate the handling and dissemination of inside information of the Group.

For the year ended 31 December 2024, the Board has, through the Audit Committee with the Group's internal audit team and the assistance of the management, conducted a review of the Group's internal control and risk management system, including without limitation to financial control, operational control, and compliance control. The Board assesses the effectiveness of internal controls by considering reviews performed by the Audit Committee, executive management and auditors.

The Board is of the view that the internal control and risk management systems are effective and there are no irregularities, improprieties, fraud or other deficiencies that suggest material deficiency in the effectiveness of the Group's internal control system.

AUDITOR'S REMUNERATION

Total auditor's remuneration for the fiscal year 2024 in relation to statutory audit work of the Group amounted to HK\$1,235,000 of which a sum of HK\$1,118,000 was payable to Confucius International CPA Limited, auditor of the Company.

DIVERSITY POLICY

Pursuant to the Board Diversity Policy, the Board shall consider the benefits of diversity when it reviews the Board composition. In designing the Board's composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience and qualifications, skills, knowledge, length of service and industry and regional experience. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

Measurable objectives include (i) at least one Director is female; (ii) at least one third of the Board shall be independent non-executive Directors; and (iii) the Board possesses a balance skills appropriate for the requirements of the business of the Company. Such objectives will be reviewed from time to time to ensure their appropriateness. The Board is mindful of the objectives for the factors as set out above for assessing the candidacy of the Board members, and will ensure that any successors to the Board shall follow the gender diversity policy. For the Reporting Year, all items (i) to (iii) have been fulfilled.

The Board comprises seven Directors, among which, three of them are female. The Board are also characterised by significant diversity, whether considered in terms of gender, nationality, length of service, professional background and skills.

At the work place level, as at 31 December 2024, the Group had 1,022 employees in total composing of 497 male and 525 female (i.e. a female-to-male ratio of approximately 51:49), reflecting a gender equality principle generally adhere by the Group. The Group is determined to continue maintain gender diversity and equality in terms of the whole workforce. The Company expects this is achievable with suitable effort in promoting the gender diversity culture, which the Group has been advocating for so.

核數師酬金

於二零二四財政年度，有關本集團法定核數服務的核數師總酬金為1,235,000港元，其中1,118,000港元乃應付予本公司核數師天健國際會計師事務所有限公司。

多元化政策

根據董事會多元化政策，董事會於檢討董事會成員組合時應考慮多元化的好處。本公司於設定董事會成員組合時會從多個方面考慮董事會多元化，包括但不限於性別、年齡、文化及教育背景、種族、專業經驗及資格、技能、知識、服務年期及行業和區域經驗。董事會所有委任均以用人唯才為原則，並在考慮人選時以客觀條件充分顧及董事會多元化的裨益。

可衡量目標包括(i)至少一名董事為女性；(ii)至少三分之一的董事會成員須為獨立非執行董事；及(iii)董事會具備適合本公司業務需要的均衡技能。該等目標將不時予以檢討以確保其適當性。董事會銘記上文所載評估董事會成員候選人資格的因素的目標，並將確保董事會的任何繼任者均應遵循性別多元化政策。就報告年度而言，第(i)至(iii)項均已實現。

董事會由七名董事組成，其中三名為女性。不論從性別、國籍、年資、專業背景及技能方面考慮，董事會亦具有成員十分多元化的特徵。

在工作地點層面，於二零二四年十二月三十一日，本集團共有1,022名僱員，包括497名男性及525名女性(即女性與男性的比例約為51:49)，反映出本集團已大致遵守性別平等原則。本集團決定繼續保持全體員工的性別多元性及平等性。本公司預期通過適當努力促進性別多元文化可實現此目標，而本集團一直倡導如此行事。

In terms of the Board's composition, currently, three of the Directors are independent non-executive Directors, thereby promoting critical review and control of the management process. Our independent non-executive Directors are of sufficient caliber and stature for their views to carry weight. The Board has a mix of background and experience in various fields including accounting and finance, legal, management, investment and pharmaceutical. These diverse backgrounds, when taken together, could provide the Group with considerable experience in a range of activities.

The Nomination Committee will monitor the implementation of the Board Diversity Policy and review the Board composition under diversified perspectives annually to ensure the Board has a balance of skills, experience and diversity of perspectives appropriate to the needs of the businesses of the Company.

DIVIDEND POLICY

The Company has adopted a dividend policy on payment of dividends. Depending on the financial conditions of the Company and the Group and the conditions and factors as set out in the dividend policy (including but not limited to the Group's financial results, cash flow position, business conditions and strategies, future operations and earnings, capital requirements and expenditure plans), dividends may be proposed and/or declared by the Board during a financial year and any final dividend for a financial year will be subject to the shareholders' approval.

INVESTOR RELATIONS

The Company is committed to fair disclosure and comprehensive, transparent reporting. The Board is ultimately responsible for ensuring that there is effective communication with investors and that the Board understands the views of the major Shareholders. On a day-to-day basis, the primary contact with the major Shareholders is through the Board and the chief financial officer of the Company.

Printed copies of the quarterly (on or before fiscal year 2022), interim and annual reports are sent to all Shareholders. The most recent general meeting of the Company was held on 22 May 2024. The meeting was opened to all Shareholders and was attended by substantial Shareholders personally present or by proxy.

As part of a regular programme of investor relations, senior management holds briefings and attends conferences with institutional investors and financial analysts to engage in a two-way communication on the Company's performance and objectives. A wide range of information on the Group's business activities is made available to investors and the public through the websites of the Company and the Stock Exchange. Announcements of the quarterly (on or before fiscal year 2022), interim and annual results are also available on the websites of the Company and the Stock Exchange.

董事會組成方面，目前有三名董事為獨立非執行董事，從而促進批判性檢討及對管理過程的控制。我們的獨立非執行董事具有足夠的才能和地位，其觀點具有影響力。董事會於會計及財務、法律、管理、投資及製藥等多個領域擁有深厚背景及豐富經驗。該等多元化背景結合在一起可為本集團在一系列活動中積累豐富的經驗。

提名委員會將每年從多元化角度監督董事會多元化政策的實施及檢討董事會的組成，確保董事會有平衡的技能、經驗和多元化角度，並且適合本公司業務需要。

股息政策

本公司已採納支付股息的股息政策。視乎本公司及本集團的財務狀況以及股息政策所載的條件及因素(包括但不限於本集團的財務業績、現金流量狀況、業務狀況及策略、未來營運及盈利、資本要求以及支出計劃)，董事會可在財政年度內建議及／或宣派股息，而財政年度的任何末期股息將由股東批准。

投資者關係

本公司致力於提供公平的披露及全面而透明的報告。董事會負有最終責任，確保與投資者進行有效溝通，以及董事會了解大股東的意見。與大股東的聯絡主要透過董事會及本公司財務總監進行。

季度(二零二二財務年度或之前)、中期及年度報告的印刷本均會發送予全體股東。本公司最近期的股東大會於二零二四年五月二十二日舉行。全體股東均可出席，而主要股東已親身或委派代表出席。

OPINION

We have audited the consolidated financial statements of Lee's Pharmaceutical Holdings Limited (the "**Company**") and its subsidiaries (collectively referred to as the "**Group**") set out on pages 75 to 229, which comprise the consolidated statement of financial position as at 31 December 2024, and consolidated statement of profit or loss, consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of material accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2024, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("**HKFRSs**") issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("**HKSAs**") issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "**Code**"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

意見

本核數師(以下簡稱「我們」)已審計列載於第75頁至第229頁李氏大藥廠控股有限公司(「貴公司」)及其附屬公司(統稱為「貴集團」)的綜合財務報表，此綜合財務報表包括於二零二四年十二月三十一日的綜合財務狀況表及截至該日止年度的綜合損益表、綜合損益及其他全面收益表、綜合權益變動表及綜合現金流量表以及綜合財務報表附註，包括重大會計政策概要。

我們認為，該等綜合財務報表已根據香港會計師公會頒布的《香港財務報告準則》真實而中肯地反映了貴集團在二零二四年十二月三十一日的綜合財務狀況以及截至該日止年度的綜合財務表現及綜合現金流量，並已遵照香港《公司條例》的披露規定妥為擬備。

意見的基礎

我們已根據香港會計師公會頒布的《香港審計準則》進行審計。我們在該等準則下承擔的責任已在本報告「核數師就審計綜合財務報表承擔的責任」部分中作進一步闡述。根據香港會計師公會頒布的《專業會計師道德守則》(以下簡稱「守則」)，我們獨立於貴集團，並已遵循守則履行其他道德責任。我們相信，我們所獲得的審計憑證能充足及適當地為我們的審計意見提供基礎。



KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Revenue Recognition **(Refer to Notes 7 and 8 to the Consolidated Financial Statements)**

The Group's revenue amounted to HK\$1,400 million for the year ended 31 December 2024. Sales of goods are recognised as revenue when goods are delivered and titles have been passed.

We identified the recognition of revenue as a key audit matter because revenue is one of the key performance indicators of the Group and therefore there is an inherent risk of manipulation of the timing of recognition of revenue.

Our response

Our main procedures in relation to revenue recognition included:

- Obtaining evidence regarding the transfer of control of ownership.
- Testing the key internal controls over revenue recognition, and assessing whether the accounting policy related to revenue recognition was applied appropriately and consistently throughout the year.
- On a sample basis, making selections from sales records and delivery records, and tracing to their contracts, delivery orders and customer's acknowledgement of receipts, and paying special attention to samples before and after the end of the reporting period to assess whether the relevant revenue was recognised in the correct period.

Based on our procedures described, we found that the amount and timing of the revenue recorded were supported by available evidence.

關鍵審計事項

關鍵審計事項是根據我們的專業判斷，認為對本期財務報表的審計最為重要的事項。這些事項是在我們審計整體綜合財務報表及出具意見時進行處理的。我們不會對這些事項提供單獨的意見。

收益確認 **(參閱綜合財務報表附註7及8)**

貴集團於截至二零二四年十二月三十一日止年度的收益為1,400百萬港元。銷售貨品於交付貨品及所有權已易手時確認。

我們將收益確認識別為關鍵審計事項，乃由於收益為貴集團關鍵業績指標之一，因此存在操縱收益確認時點的內在風險。

我們的回應

我們有關收益確認的主要程序包括：

- 取得有關擁有權的控制權轉移的憑證。
- 測試與收益確認相關的關鍵內部控制，並評估收益確認的相關會計政策在本年度是否適當且一貫地運用。
- 以抽查為基礎，從銷售記錄及交付記錄中作出甄選，追查與該筆銷售相關的合同、交付單及客戶確認收據，特別關注報告期完結前後的樣本，以評估相關收益是否在正確的期間確認。

基於上述程序，我們發現所記錄收益的金額及時間可以現有憑證佐證。

Valuation of Retirement Benefits on Defined Benefit Plan **(Refer to Note 38 to the Consolidated Financial Statements)**

The Group entered into service contracts with the eligible directors to provide certain retirement benefits. There is judgement in determining valuation of the retirement benefits as recorded at the end of the reporting period. The valuation is based on a number of assumptions including discount rate, growth rate of salary and life expectancy. As at 31 December 2024, the Group reported retirement benefits of HK\$123 million.

Our response

Our main procedures in relation to the valuation of the retirement benefits on defined benefit plan included:

- Assessing the independence and competence of the independent external valuer appointed by the Group to calculate the fair value of the retirement benefits.
- Assessing the accuracy and relevance of the input data provided by management to the independent external valuer by challenging and corroborating the market data and information from similar transactions from independent sources.
- Evaluating appropriateness of the methodology and assumptions used by the independent external valuer.
- Testing mathematical accuracy of the underlying valuation.

We found the methodology and key assumptions to be reasonable.

Intangible Assets Recognition and Impairment Assessment **(Refer to Note 20 to the Consolidated Financial Statements)**

As at 31 December 2024, the Group reported intangible assets of HK\$1,135 million, of which HK\$823 million were capitalised development expenditure and HK\$312 million were license fees.

Development expenditure mainly comprised of development of pharmaceutical products. The Group capitalised eligible product development costs upon meeting the criteria as described in Hong Kong Accounting Standard 38 "Intangible Assets" ("HKAS 38"). Capitalisation criteria assessment requires significant management judgement and there is measurement uncertainty at inception and throughout the lives of the individual projects.

對定額福利計劃的退休福利進行估值

貴集團與合資格董事訂有服務合約以提供若干退休福利。在釐定退休福利於報告期完結時的估值時須作出判斷。有關估值乃以多項假設為基礎，包括貼現率、薪金增長率及預期壽命。於二零二四年十二月三十一日，貴集團錄得退休福利123百萬港元。

我們的回應

我們有關定額福利計劃的退休福利估值的主要程序包括：

- 評估 貴集團為計算退休福利公平值委聘的獨立外部估值師的獨立性及能力。
- 通過質疑及核實源自獨立來源的類似交易的市場數據及資料，評估管理層向獨立外部估值師提供的輸入數據是否準確及相關。
- 評估獨立外部估值師所採用方法與假設是否合適。
- 測試相關估值計算的算術準確性。

我們發現該等方法及主要假設誠屬合理。

無形資產確認及減值評估

(參閱綜合財務報表附註20)

於二零二四年十二月三十一日，貴集團錄得無形資產1,135百萬港元，當中823百萬港元為已撥充資本的開發支出及312百萬港元為專利費。

開發支出主要包括開發醫藥產品。貴集團在合資格產品開發成本符合《香港會計準則》第38號「無形資產」(「香港會計準則第38號」)所述條件時將之撥充資本。評定資本化條件須作出重大管理判斷，且個別項目開始及整個年期均涉及計量上的不明朗性。



Management is required to assess at the end of each reporting period whether any indicator of impairment exists, which requires significant management judgement and assumptions with reference to the ability to use or sell the products, its future market or economic development.

Our response

Our main procedures in relation to the recognition of intangible assets included:

- Gaining an understanding of the business process undertaken by management to assess the appropriate accounting treatment for each project.
- Assessing the reasonableness of recognition and eligibility criteria for intangible assets by challenging the key assumptions used or estimates made in capitalising the cost.
- Testing on a sample basis the expenditure capitalised against source documents and signed contracts.
- Assessing the ownership of license fees.

Our main procedures in relation to the impairment assessment of intangible assets included:

- Assessing management's determination of the impairment based on our understanding of the nature of the Group's business.
- Assessing whether there are any indicators of impairment by understanding the business and rationale for the products under development.
- Discussing with and interviewing the responsible staff and managers on the progress and future prospects of respective development projects.
- Selecting products with significant development cost and request for independent valuation to be done for impairment assessment.

Based on our procedures described, we found the recognition and impairment assessment on intangible assets to be reasonable.

我們有關確認無形資產的主要程序包括：

Fair Value Measurement of Unlisted Investments Held As Financial Assets at Fair Value Through Other Comprehensive Income and Through Profit Or Loss (Refer to Notes 23 and 24 to the Consolidated Financial Statements)

The Group held several unlisted investments which were measured using either market observable inputs or unobservable inputs, and valuation techniques. The Group's fair value measurement of the financial assets arising from the unobservable inputs used in determining the fair value of the unlisted investments was grouped under level 3 of fair value hierarchy.

As at 31 December 2024, the Group's unlisted investments which were measured at fair value amounted to HK\$104 million, which had significant unobservable inputs in the valuation, and categorised within level 3 of fair value hierarchy, representing 3.97% of the Group's total assets as at 31 December 2024.

The valuations of these unlisted investments are conducted by an independent qualified valuer. The appropriateness of the valuation is dependent on determination of different valuation techniques and certain key assumptions. With different valuation techniques and assumptions applied, the valuation result can vary significantly.

As the unlisted investments are considered significant due to the size of the balance and the inherent judgement involved in determining the fair value measurement, is considered as a key audit matter.

The fair value was determined using market approach, income approach and reference to the prices of underlying investment portfolio quoted by administrator. The determination of fair value measurement requires the management to exercise their judgement to ensure the appropriateness of the estimates and assumptions.

持作按公平值透過其他全面收益及透過損益列賬之財務資產之非上市投資之公平值計量

(參閱綜合財務報表附註23及24)

貴集團持有若干非上市投資，乃以市場上可觀測輸入數據或不可觀測輸入數據及估值技術計量。貴集團在釐定非上市投資公平值時使用不可觀測數據所產生財務資產公平值計量乃歸屬於第三級公平值等級的組別內。

於二零二四年十二月三十一日，貴集團以公平值計量的非上市投資為104百萬港元，該等非上市投資的估值採用了重大不可觀測數據，並分類於第三級公平值等級的組別內，佔貴集團於二零二四年十二月三十一日資產總值的3.97%。

該等非上市投資的估值由獨立合資格估值師進行。估值的合適性取決於不同估值技術的釐定與若干關鍵假設。視乎不同估值技術與所應用的假設，估值結果可能有很大的差異。

由於計量非上市投資公平值所涉及的結餘規模與固有判斷被視為屬重大，故被視為關鍵審計事項。

公平值的計量採用市場法、收入法及參考基金管理人所報的相關投資組合價格。釐定所計量公平值須管理層在確保估計及假設的合適性上作出判斷。



Our response

Our procedures in relation to management's fair value measurement of unlisted investments included:

- Evaluating the independent professional valuer's competence, capabilities and objectivity.
- Focusing on the valuation methodologies and assumptions of unlisted fund investments that were classified as level 3 in the fair value hierarchy and involving valuation specialists in evaluating and assessing:
 - the valuation techniques through comparison with the valuation techniques that are commonly used in the market;
 - the validation of observable inputs using external market data; and
 - the reasonableness of management's assumptions.
- Checking the accuracy and reasonableness of the input data provided by management to the independent professional valuer.
- Review sensitivity analysis in consideration of the potential impact of reasonably possible upside or downside changes in these key assumptions.

Based on our procedures described, we found the impairment assessment on unlisted investments adopted by management to be reasonable.

OTHER INFORMATION

The directors of the Company are responsible for the other information. The other information comprises the information included in the annual report, but does not include the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

1. GENERAL INFORMATION

Lee's Pharmaceutical Holdings Limited (the "Company") is a limited company incorporated in the Cayman Islands and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The addresses of the registered office and principal place of business of the Company are disclosed in the section headed "Corporate Information" in this annual report.

The principal activities of the Company and its subsidiaries (collectively referred to as the "Group") are the developing, manufacturing and sales and marketing of pharmaceutical products.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company.

2. APPLICATION OF NEW AND AMENDMENTS TO HONG KONG FINANCIAL REPORTING STANDARDS ("HKFRSs")

New and amendments to HKFRSs that are mandatorily effective for the current year

Statement of compliance

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In additions, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("**Listing Rules**") and the Hong Kong Companies Ordinance ("**CO**").

Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 "Share-based Payment" ("**HKFRS 2**"), leasing transactions that are accounted for in accordance with HKFRS 16 "Leases" ("**HKFRS 16**"), and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of Assets" ("**HKAS 36**").

合規聲明

本綜合財務報表已根據香港會計師公會頒佈之香港財務報告準則編製。就編製綜合財務報表而言，如果合理預期有關資訊可能影響主要使用者所作出之決定，則被視作重大。此外，本綜合財務報表包括香港聯合交易所有限公司證券上市規則（「**上市規則**」）及香港公司條例（「**公司條例**」）規定之適用披露資料。

編製基準

本綜合財務報表乃根據歷史成本慣例編製，惟於各報告期末，若干財務工具乃按公平值計量。

歷史成本一般基於為交換貨品及服務而給予之代價之公平值。

公平值指市場參與者之間在計量日進行之有序交易中出售一項資產所收取之價格或轉移一項負債所支付之價格，無論該價格乃直接觀察到之結果，或是採用其他估值技術作出之估計。在對資產或負債之公平值作出估計時，本集團考慮了市場參與者在計量日為該資產或負債進行定價時將會考慮之該等特徵。於本綜合財務報表內計量及／或披露之公平值均按此基準釐定，惟香港財務報告準則第2號「以股份支付之款項」（「**香港財務報告準則第2號**」）範圍內之以股份支付之交易、按照香港財務報告準則第16號「租賃」（「**香港財務報告準則第16號**」）入賬之租賃交易及與公平值類似但並非公平值之計量（如香港會計準則第2號「存貨」中之可變現淨值或香港會計準則第36號「資產減值」（「**香港會計準則第36號**」）中之使用價值）除外。

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- The size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- Potential voting rights held by the Group, other vote holders or other parties;
- Rights arising from other contractual arrangements; and
- Any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

當本集團擁有被投資方之表決權少於大多數，而該等表決權足以使本集團在單方面實際指示該被投資方之相關活動，則本集團對被投資方擁有權力。本集團於評估是否擁有足以擁有權力之被投資方表決權時，考慮所有相關事實及情況，包括：

- 本集團持有之表決權數量相對於其他表決權持有人持有之表決權數量及分散程度；
- 本集團、其他表決權持有人或其他方所持有之潛在表決權；
- 從其他合約安排產生之權利；及
- 任何額外事實及情況，顯示本集團擁有或並無擁有於需要作出決定時指示相關活動之現有權力，包括於過往股東大會上之表決模式。

對一間附屬公司之綜合入賬乃由本集團獲得對該附屬公司之控制權開始，並於本集團失去對該附屬公司之控制權時終止。具體而言，年內所收購或出售之附屬公司收益及開支乃由本集團獲得控制權當日起包含於綜合損益表內，直至本集團失去對該附屬公司之控制權當日終止。

損益及其他全面收益之各項目乃歸屬於本公司擁有人及非控股權益。附屬公司之全面收益總額乃歸屬於本公司擁有人及非控股權益，即使此舉會導致非控股權益擁有虧絀結餘。

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent the interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Changes in the Group's interests in existing subsidiaries

Changes in the Group's interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests.

Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

附屬公司之非控股權益與本集團於當中之權益分開呈列，而該等權益指賦予持有人權利於清盤時按比例分佔相關附屬公司淨資產之權益。

本集團於現有附屬公司之權益之變動

本集團於現有附屬公司權益之變動並無導致本集團失去對該等附屬公司之控制權，會作為權益交易入賬。本集團權益之相關部分及非控股權益之賬面金額經調整以反映彼等於附屬公司之有關權益變動包括根據本集團與非控股權益之權益比例重新劃撥本集團與非控股權益之相關儲備。

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary and non-controlling interests (if any) are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary attributable to the owners of the Company. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9 "Financial Instruments" ("HKFRS 9") or, when applicable, the cost on initial recognition of an investment in an associate.

Business combinations

A business is an integrated set of activities and assets which includes an input and a substantive process that together significantly contribute to the ability to create outputs. The acquired processes are considered substantive if they are critical to the ability to continue producing outputs, including an organised workforce with the necessary skills, knowledge, or experience to perform the related processes or they significantly contribute to the ability to continue producing outputs and are considered unique or scarce or cannot be replaced without significant cost, effort, or delay in the ability to continue producing outputs.

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

業務合併

業務是一套綜合之活動及資產，包含共同為建設產出之能力作出重大貢獻之輸入及實質性流程。如所收購之流程對持續產生產出之能力至關重要，包括具備履行相關流程之必要技能、知識或經驗的經統籌人力資源，或對持續產生產出之能力有重大貢獻並被視為獨特或罕有或非得以重大成本、精力取代之流程，或拖累持續產生產出能力之流程，則該等流程被視為實質性。

業務收購乃採用收購法入賬。於業務合併轉撥之代價按公平值計量，而計算為本集團轉撥之資產及本集團產生之負債(至被收購方之前擁有人及本集團為交換被收購方之控制權而發行之股權)於收購日期之公平值總和。與收購事項有關之成本一般於產生時在損益確認。

Contingent assets are not recognised.

Except for certain recognition exemptions, the identifiable assets acquired and liabilities assumed must meet the definitions of an asset and a liability in the International Accounting Standards Committee’s Framework for the Preparation and Presentation of Financial Statements (replaced by the Conceptual Framework for Financial Reporting issued in September 2010).

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 “Income Taxes” and HKAS 19 “Employee Benefits” respectively;
- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 at the acquisition date;

Right-of-use assets are recognised and measured at the same amount as the relevant lease liabilities, adjusted to reflect favourable or unfavourable terms of the lease when compared with market terms.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net amount of the identifiable assets acquired and the liabilities assumed as at acquisition date. If, after reassessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the relevant subsidiary's net assets in the event of liquidation are initially measured at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets or at fair value. The choice of measurement basis is made on a transaction-by-transaction basis.

When the consideration transferred by the Group in a business combination includes a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively. Measurement period adjustments are adjustments that arise from additional information obtained during the "measurement period" (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for the contingent consideration that does not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured to fair value at subsequent reporting dates, with the corresponding gain or loss being recognised in profit or loss.

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control), and the resulting gain or loss, if any, is recognised in profit or loss or other comprehensive income, as appropriate. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income and measured under HKFRS 9 would be accounted for on the same basis as would be required if the Group had disposed directly of the previously held equity interest.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted retrospectively during the measurement period (see above), and additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

Investments in subsidiaries

Investments in subsidiaries are included in the Company's statement of financial position at cost less any identified impairment losses. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units ("CGUs") (or group of CGUs) that is expected to benefit from the synergies of the combination, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

A CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount of the CGU (or group of CGUs) is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit (or group of CGUs). Any impairment loss for goodwill is recognised directly in profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant CGU or any of the CGU within the group of CGUs, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal. When the Group disposes of an operation within the CGU (or a CGU within a group of CGUs), the amount of goodwill disposed of is measured on the basis of the relative values of the operation (or the CGU) disposed of and the portion of the CGU (or the group of CGUs) retained.

The Group's policy for goodwill arising on the acquisition of an associate is described below.

Investments in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. Changes in net assets of the associate other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

Investments in associates (Continued)

The Group assesses whether there is an objective evidence that the interest in an associate may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill, that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When the Group ceases to have significant influence over an associate, it is accounted for as a disposal of the entire interest in the investee with a resulting gain or loss being recognised in profit or loss. When the Group retains an interest in the former associate and the retained interest is a financial asset within the scope of HKFRS 9, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition. The difference between the carrying amount of the associate at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing the relevant interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant associate.

When a group entity transacts with an associate of the Group, profits and losses resulting from the transactions with the associate are recognised in the Group's consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

Changes in the Group's interests in associates

When the Group reduces its ownership interest in an associate but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

When the Group increases its ownership interest in an associate but the Group continues to use the equity method, goodwill is recognised at acquisition date if there is excess of the consideration paid over the share of carrying amount of net assets attributable to the additional interests in associates acquired. Any excess of share of carrying amount of net assets attributable to the additional interests in associates acquired over the consideration paid are recognised in the profit or loss in the period in which the additional interests are acquired.

Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates or enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

Further details of the Group's revenue and other income recognition policies are as follows:

Manufacturing of proprietary and generic products and trading of licensed-in products

Revenue from manufacturing of proprietary and generic products and trading of licensed-in products are recognised at a point in time when control of the asset is transferred to the customer, generally on delivery of the product and accepted by the customers. No right of return by customers is allowed based on contractual terms. Revenue is thus recognised when the products are delivered to the customers and the customers accepted the products. There is generally only one performance obligation and the consideration include no variable amount.

Other income

Licensing income is recognised over time on a time proportion basis throughout the license period as providing the licensees the right to use the Group's intellectual property.

Research and development service income is recognised when the Group renders the services and all the benefits are received and consumed simultaneously by customer throughout the contract period. Thus, the Group satisfies a performance obligation and recognises as over time.

Rental and utilities income is recognised on a time proportion basis over the lease terms.

Interest income is accrued on a time basis on the principal outstanding at the applicable interest rate, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Contract balances

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer. If a customer pays consideration before the Group transfers goods or services to the customer, a contract liability is recognised when the payment is made or the payment is due (whichever is earlier). Contract liabilities are recognised as revenue when the Group performs under the contract.

A contract asset and a contract liability relating to the same contract are accounted for and presented on a net basis.

Leases

Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified or arising from business combinations on or after the date of initial application of HKFRS 16, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

The Group as a lessee

(a) Allocation of consideration to components of a contract

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

(b) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to leases of machinery and equipment and premises that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. It also applies the recognition exemption for lease of low-value assets. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis or another systematic basis over the lease term.

The cost of right-of-use asset includes:

- the amount of the initial measurement of the lease liability;
- any lease payments made at or before the commencement date, less any lease incentives received;
- any initial direct costs incurred by the Group; and
- an estimate of costs to be incurred by the Group in dismantling and removing the underlying assets, restoring the site on which it is located or restoring the underlying asset to the condition required by the terms and conditions of the lease.

Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

When the Group obtains ownership of the underlying leased assets at the end of the lease term, upon exercising purchase options, the cost of the relevant right-of-use assets and the related accumulated depreciation and impairment loss are transferred to property, plant and equipment.

The Group presents right-of-use assets in "property, plant and equipment", the same line item within which the corresponding underlying assets would be presented if they were owned.

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise, except for exchange differences on monetary items receivable from or payable to a foreign operation for which settlement is neither planned nor likely to occur (therefore forming part of the net investment in the foreign operation), which are recognised initially in other comprehensive income and reclassified from equity to profit or loss on disposal or partial disposal of the Group's interests in associates.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong Dollars) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

In addition, in relation to a partial disposal of a subsidiary that does not result in the Group losing control over the subsidiary, the proportionate share of accumulated exchange differences is re-attributed to non-controlling interests and are not recognised in profit or loss. For all other partial disposals, the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

Goodwill and fair value adjustments on identifiable assets acquired on an acquisition of a foreign operation are treated as assets and liabilities of the foreign operation and translated at the rate of exchange prevailing at the end of each reporting period. Exchange differences arising are recognised in other comprehensive income.

Borrowing costs

Borrowings costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost to those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grant will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as a deduction from the carrying amount of the relevant asset in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purposes of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other income" in profit or loss.

Retirement benefits

Defined contribution plan

Retirement benefits are provided to eligible staff of the Group. Hong Kong employees enjoy retirement benefits under the Mandatory Provident Fund Scheme. The employer's monthly contribution is 5% of each employee's monthly salary with maximum amount of HK\$1,500 per month for each employee.

The pension schemes covering all the Group's employees in the People's Republic of China (the "PRC") and Taiwan are defined contribution schemes at various funding rates, and are in accordance with the local practices and regulations.

Payments to defined contribution retirement benefit plans (including state-managed retirement benefit schemes and the Mandatory Provident Fund Scheme) are recognised as an expense when employees have rendered service entitling them to the contributions.

政府補助直至合理保證本集團將遵守彼等所附帶之條件及該補助將獲接獲，方予確認。

退休福利

定額供款計劃

本集團為其合資格之員工提供退休金福利。香港僱員可獲得強制性公積金計劃之退休福利。僱主之每月供款是每位僱員月薪之5%，每位僱員每月最多獲供1,500港元。

本集團為所有中華人民共和國(「中國」)及台灣僱員而設之退休金計劃是按多個供款率定額供款之計劃，供款率按當地慣例及規定而制定。

用以支付界定之供款退休福利計劃(包括國家管理退休福利計劃及強制性公積金計劃)之款項於僱員已提供使彼等有權享受供款之服務時確認為開支。

Defined benefit plan

For defined retirement benefits plan, the cost of providing benefits is determined by the valuation conducted by independent valuer at the end of the reporting period, amortised over the expected average remaining working lives of the participating directors.

The retirement benefits recognised in the consolidated statement of financial position represents the cost of providing benefits, based on the valuation.

Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the service. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Equity-settled share-based payment transactions

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date. Details regarding the determination of the fair value of equity-settled share-based transactions are set out in note 37 to the consolidated financial statements.

The fair value of the equity-settled share-based payments determined at the grant date without taking into consideration all non-market vesting conditions is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity (share-based compensation reserve). At the end of each reporting period, the Group revises its estimate of the number of equity instruments expected to vest based on assessment of all relevant non-market vesting conditions. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share-based compensation reserve.

When share options are exercised, the amount previously recognised in share-based compensation reserve will be transferred to share premium. When share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share-based compensation reserve will be transferred to retained profits.

Taxation

Income tax expense represents the sum of current and deferred income tax expenses.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit/loss before taxation because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 "Income Taxes" requirements to the lease liabilities and the related assets separately. The Group recognised a deferred tax asset related to lease liabilities to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised and a deferred tax liability for all taxable temporary difference.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

In assessing any uncertainty over income tax treatments, the Group considers whether it is probable that the relevant tax authority will accept the uncertain tax treatment used, or proposed to be use by individual group entities in their income tax filings. If it is probable, the current and deferred taxes are determined consistently with the tax treatment in the income tax filings. If it is not probable that the relevant taxation authority will accept an uncertain tax treatment, the effect of each uncertainty is reflected by using either the most likely amount or the expected value.

Property, plant and equipment

Property, plant and equipment are tangible assets that are held for use in the production or supply of goods or services, or for administrative purposes (other than construction in progress as described below), are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Some properties comprise a portion that is held to earn rentals and another portion is held for use in the supply of goods or services or for administrative purpose. If these portions could be sold separately (or leased out separately under a finance lease), these portions shall be accounted for separately, if the portions could not be sold separately, the property is classified as property, plant and equipment.

Depreciation is recognised so as to write off the cost of assets (other than construction in progress) less their residual values over their useful lives, using the straight-line method, at the following rates per annum:

Office and laboratory equipment and electronic equipment	10%–33%

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Intangible assets

License fee (intangible assets acquired separately)

License fees are consideration paid for the license contracts and are carried at cost less accumulated amortisation and accumulated impairment losses. License fees with finite useful lives are amortised from the date they are ready for intended use over the remaining license period. The license period ranges from 3 to 10 years, with certain licenses contain renewal clause.

Both the period and method of amortisation are reviewed annually, with the effect of any changes in estimate being accounted for on a prospective basis.

License fees with indefinite useful lives are carried at cost less accumulated impairment losses, if any.

Development cost (internally-generated intangible assets – research and development expenditure)

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development of licensed-in products or from the development phase of internal projects is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it;

Intangible assets acquired in a business combination

Intangible assets acquired in a business combination and recognised separately from goodwill are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in a business combination are reported at cost less accumulated amortisation and accumulated impairment losses, on the same basis as intangible assets that are acquired separately.

Derecognition of intangible assets

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in profit or loss when the asset is derecognised.

Impairment on property, plant and equipment, right-of-use assets and intangible assets other than goodwill

At the end of each reporting period, the Group reviews the carrying amounts of its property, plant and equipment, right-of-use assets, and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of property, plant and equipment, right-of-use assets, and intangible assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the CGU to which the asset belongs.

In addition, the Group assesses whether there is indication that corporate assets may be impaired. If such indication exists, corporate assets are also allocated to individual CGUs, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of CGUs for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a CGU) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a CGU) is estimated to be less than its carrying amount, the carrying amount of the asset (or a CGU) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a CGU, the Group compares the carrying amount of a group of CGUs, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of CGUs, with the recoverable amount of the group of CGUs. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of CGU. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of CGUs. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or CGU or a group of CGUs) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a CGU or a group of CGUs) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on weighted average method. Cost of finished goods and work in progress comprises raw materials, direct labour, other direct cost and related production overheads (based on normal operating capacity). Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle that obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

存貨

存貨按成本及可變現淨值兩者之較低者列賬。存貨之成本按加權平均法釐定。製成品及在製品成本包括原材料、直接人工費用、其他直接成本及相關之間接生產費用(按正常運營能力計)。可變現淨值指存貨之估計銷售價格減完成之所有估計成本及作出銷售之所需成本。

撥備

若本集團須就過往事件而承擔現有責任(法律上或推定)，及本集團有可能須履行該責任並對責任之金額可作出可靠估計時，則會確認撥備。

確認為撥備之金額為於報告期末履行現時責任所需代價之最佳估計，而估計乃經考慮圍繞責任之風險及不明朗因素而作出。倘撥備以估計履行現時責任之現金流量計量時，其賬面金額為該等現金流量之現值(倘貨幣時間價值之影響屬重大)。

當結算撥備所需之部分或全部經濟利益預期可自第三方收回時，倘大致確定將可獲償付及應收款項金額可作可靠估算，則將應收款項確認為資產。

倘需要流出經濟利益之可能性不大，或責任金額無法可靠地估計，則責任乃披露為或然負債，除非經濟利益流出之可能性極低則另作別論。可能出現之責任，其存在與否將取決於日後會否發生一宗或多宗事件，除非經濟利益流出之可能性極低，否則該等責任亦披露為或然負債。

Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss ("FVTPL")) added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

當集團實體成為工具合約條款之一方時，會確認財務資產及財務負債。所有一般性購買或銷售財務資產按交易日期基準確認及取消確認。一般性購買或銷售為按於市場規定或慣例確立之時間期限內交付資產之財務資產之購買或銷售。

財務資產及財務負債初始以公平值計量，惟客戶合約所產生之應收貿易賬款乃根據香港財務報告準則第15號作初始計量。直接歸屬於購置或發行財務資產及財務負債(按公平值透過損益列賬之財務資產或財務負債除外)之交易費用在初始確認時於各財務資產或財務負債(視何者適用而定)之公平值計入或扣除。直接歸屬於購置按公平值透過損益列賬之財務資產或財務負債之交易費用即時在損益確認。

實際利率法為計算財務資產或財務負債之攤銷成本以及於相關期間分配利息收入及利息開支之方法。實際利率乃於初始確認時按財務資產或財務負債之預期可使用年期或適用之較短期間內確切貼現估計未來現金收入及款項(包括構成實際利率不可或缺部分之所有已付或已收費用及點數、交易成本及其他溢價或貼現)至賬面淨額之利率。

In addition, the Group may irrevocably designate a financial asset that are required to be measured at the amortised cost or FVTOCI as measured at FVTPL if doing so eliminates or significantly reduces an accounting mismatch.

(i) Amortised cost and interest income

Interest income is recognised using the effective interest method for financial assets measured subsequently at amortised cost and debt instruments/receivables subsequently measured at FVTOCI. Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset, except for financial assets that have subsequently become credit-impaired (see below). For financial assets that have subsequently become credit-impaired, interest income is recognised by applying the effective interest rate to the amortised cost of the financial asset from the next reporting period. If the credit risk on the credit-impaired financial instrument improves so that the financial asset is no longer credit-impaired, interest income is recognised by applying the effective interest rate to the gross carrying amount of the financial asset from the beginning of the reporting period following the determination that the asset is no longer credit-impaired.

Investments in equity instruments/partnership interest at FVTOCI are subsequently measured at fair value with gains and losses arising from changes in fair value recognised in other comprehensive income and accumulated in the investment revaluation reserve; and are not subject to impairment assessment. The cumulative gain or loss will not be reclassified to profit or loss on disposal of the equity investments/partnership interests, and will be transferred to retained profits.

Dividends from these investments in equity instruments are recognised in profit or loss when the Group's right to receive the dividends is established, unless the dividends clearly represent a recovery of part of the cost of the investment. Dividends are included in profit or loss.

- (iii) Financial assets as at FVTPL

Financial assets that do not meet the criteria for being measured at amortised cost or FVTOCI or designated as FVTOCI are measured at FVTPL.

This category contains investments in life insurance policies. The Group accounts for the investments at FVTPL.

Financial assets at FVTPL are measured at fair value at the end of each reporting period, with any fair value gains or losses recognised in profit or loss. The net gain or loss recognised in profit or loss excludes any dividend or interest earned on the financial asset and is included in the "other gains and losses" line item.

按公平值透過其他全面收益列賬之權益工具／合夥權益之投資其後按公平值計量，其公平值變動產生之收益及虧損於其他全面收益確認並於投資重估儲備累積，無須作減值評估。累計損益將不重新分類至出售股本投資／合夥權益之損益，並將轉為保留溢利。

當本集團確認收取股息之權利時，該等權益工具投資之股息於損益內確認，除非該等股息明確意味着收回部分投資成本則作別論。股息乃計入損益內。

- (iii) 按公平值透過損益列賬之財務資產

未符合按攤銷成本或按公平值透過其他全面收益列賬或指定為按公平值透過其他全面收益列賬計量之財務資產，均以按公平值透過損益列賬之方式計量。

The Group performs impairment assessment under expected credit loss ("ECL") model on financial assets (including trade and other receivables (excluding prepayments and other items which were not financial instruments), deposits, advance to associates, pledged deposits, time deposits and cash and bank balances) which are subject to impairment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables without significant financing component. The ECL on these assets are assessed collectively using a provision matrix with appropriate groupings.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

本集團根據香港財務報告準則第9號對出現減值之財務資產(包括應收貿易賬款及其他應收款項(不包括預付款及其他非財務工具項目)、存款、墊付予聯營公司之款項、已抵押存款、定期存款以及現金及銀行結餘)按預期信貸虧損模型進行減值評估。預期信貸虧損之金額於各報告日期更新,以反映自初始確認以來信貸風險之變動。

全期預期信貸虧損指將相關工具之預期使用期內所有可能之違約事件產生之預期信貸虧損。相反,12個月預期信貸虧損將預期於報告日期後12個月內可能發生之違約事件導致之全期預期信貸虧損部分。評估乃根據本集團之歷史信貸虧損經驗進行,並根據債務人特有之因素、一般經濟狀況以及對報告日期當前狀況之評估以及對未來狀況之預測作出調整。

本集團一直就並無重大融資成分之應收貿易賬款確認全期預期信貸虧損。該等資產之預期信貸虧損對使用適宜組別之撥備矩陣進行集體評估。

對於所有其他工具,本集團計量之虧損撥備等於12個月預期信貸虧損,除非自初始確認後信貸風險顯著增加,則本集團確認全期預期信貸虧損。應否確認全期預期信貸虧損之評估乃基於自初始確認以來發生違約之可能性或風險是否顯著增加。

(i) Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

於評估自初始確認後信貸風險是否顯著增加時，本集團將於報告日期財務工具發生之違約風險與初始確認日起財務工具發生之違約風險進行比較。在進行該評估時，本集團會考慮合理且可支持之定量及定性資料，包括無需付出不必要之成本或努力而可得之歷史經驗及前瞻性資料。

特別是，在評估信貸風險是否顯著增加時，會考慮以下資料：

- 財務工具之外部(如有)或內部信貸評級之實際或預期顯著惡化；
- 外部市場信貸風險指標之顯著惡化，如信貸利差大幅增加，債務人之信貸違約掉期價格；
- 預計會導致債務人償還債務能力大幅下降之業務、財務或經濟狀況之現有或預測之不利變化；
- 債務人經營業績之實際或預期顯著惡化；
- 導致債務人償還其債務能力大幅下降之債務人監管、經濟或技術環境之實際或預期之重大不利變化。

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 365 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A debt instrument is determined to have low credit risk if (i) it has a low risk of default, (ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term and (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when it has an internal or external credit rating of "investment grade" as per globally understood definitions.

For loan commitments, the date that the Group becomes a party to the irrevocable commitment is considered to be the date of initial recognition for the purposes of assessing impairment. In assessing whether there has been a significant increase in the credit risk since initial recognition of a loan commitment, the Group considers changes in the risk of a default occurring on the loan to which a loan commitment relates; for financial guarantee contracts, the Group considers the changes in the risk that the specified debtor will default on the contract.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

不論上述評估之結果如何，本集團認為，當合約付款逾期超過365天，則自初始確認以來信貸風險已顯著增加，除非本集團有合理且可支持之資料證明情況並非如此。

儘管上文所述，倘債務工具釐定為於報告日期具有較低信貸風險，則本集團假設債務工具之信貸風險自初始確認以來並無顯著增加。倘出現以下情況，則債務工具被釐定為具有較低信貸風險：(i) 具有低違約風險，(ii) 借款人擁有雄厚實力，可於短期內履行其合約現金流量責任及(iii) 經濟及業務狀況之長期不利變動可能但未必會削弱借款人履行其合約現金流量責任之能力。倘債務工具之內部或外部信貸評級為「投資級別」(根據國際通用釋義)，則本集團認為該債務工具存在較低信貸風險。

就貸款承擔而言，本集團成為不可撤回承諾訂約方當日被視為就評估減值之初始確認日期。評估信貸風險是否自初始確認貸款承擔以來大幅增加時，本集團考慮與貸款承擔有關之貸款出現違約之風險變動；就財務擔保合約而言，本集團考慮指定債務人出現違約之風險變動。

本集團定期監控用以識別信貸風險有否顯著增加之標準之效益，且修訂標準(如適當)以確保標準能在金額逾期前識別信貸風險之顯著增加。

(ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full.

Irrespective of the above, the Group considers default has occurred when a financial asset is more than 365 days pass due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

(iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the borrower;
- a breach of contract, such as a default or past due event;
- the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

(ii) 違約定義

就內部信貸風險管理而言，本集團認為，違約事件在內部制訂或得自外界來源之資料顯示債務人不大可能悉數向債權人(包括本集團)還款時發生。

雖有上文所述，但本集團認為，財務資產逾期超過365日即出現違約，除非本集團有合理且可支持之資料顯示更加滯後之違約標準更為恰當。

(iii) 出現信貸減值之財務資產

財務資產在一項或多項違約事件(對該財務資產估計未來現金流量構成不利影響)發生時出現信貸減值。財務資產出現信貸減值之證據包括下列事件之可觀察數據：

- 發行人或借款人出現重大財務困難；
- 違反合約(如違約或逾期事件)；
- 借款人之放款人因與借款人出現財務困難有關之經濟或合約理由而給予借款人在一般情況下放款人不予考慮之優惠條件；
- 借款人將可能陷入破產或其他財務重組；或
- 該財務資產因出現財務困難而失去活躍市場。

(iv) Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

(v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

(iv) 撇銷政策

當有資料顯示對手方處於嚴重財務困難及無實際收回可能時(例如對手方被清盤或已進入破產程序時,以較早發生者為準),本集團則撇銷財務資產。經考慮法律意見後(倘合適),遭撇銷之財務資產可能仍須按本集團收回程序進行強制執行活動。撇銷構成取消確認事項。任何其後收回在損益確認。

(v) 預期信貸虧損之計量及確認

預期信貸虧損之計量為違約概率、違約虧損(即違約時虧損程度)及違約時風險之函數。違約概率及違約虧損之評估乃基於歷史數據按前瞻性資料作調整。預期信貸虧損之估計反映無偏頗及概率加權之數額,其乃根據加權之相應違約風險而確定。

一般而言,預期信貸虧損為根據合約應付本集團之所有合約現金流量與本集團預期收取之所有現金流量之間之差額(按初始確認時釐定之實際利率貼現)。

4. CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3 to the consolidated financial statements, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on the historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Estimated impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the CGUs to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the CGUs and also to choose a suitable discount rate in order to calculate the present value of those cash flows. As at 31 December 2024, the carrying amount of goodwill is HK\$4,366,000, net of impairment loss provision HK\$2,342,000 (31 December 2023: HK\$4,366,000, net of impairment loss provision HK\$2,342,000). Details of the recoverable amount calculation are disclosed in note 21 to the consolidated financial statements.

Determination of impairment loss event and estimated impairment of trade and other receivables

The Group uses provision matrix to calculate ECL for the trade and other receivables. The provision rates are based on past-due status of debtors as groupings of various debtors on this basis demonstrate similar loss patterns with shared credit risk characteristics. The provision matrix is based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered. In addition, trade and other receivables with significant balances and credit impaired are assessed for ECL individually.

The provision of ECL is sensitive to changes in estimates. Where the actual future cash flows are less than expected, a material impairment loss may arise. As at 31 December 2024, the carrying amount of trade receivables is HK\$161,096,000, net of allowance for ECL of HK\$2,497,000 (31 December 2023: HK\$84,590,000, net of allowance for ECL of HK\$1,921,000).

Fair value measurements of financial instruments

As at 31 December 2024, certain of the Group's financial assets (including financial assets at FVTPL and financial assets at FVTOCI) are measured at fair value with fair value being determined based on significant unobservable inputs using valuation techniques. Judgement and estimation are required in establishing the relevant valuation techniques and the relevant inputs thereof. Changes in assumptions relating to these factors could result in material adjustments to the fair value of these instruments. Details of the fair value measurement are disclosed in note 6 to the consolidated financial statements.

Estimated impairment of intangible assets, property, plant and equipment and right of use assets

Incidental to its principal activities, the Group acquired certain license fees and capitalised development cost relating to the development of pharmaceutical products, since these costs meet the recognition criteria of HKAS 38. The Group reviews the carrying amount of all intangible assets held at the end of the reporting period and HK\$19,195,000 (2023: HK\$1,335,000) impairment was considered necessary for these assets.

As at 31 December 2024, in view of impairment indicators, the Group performed impairment assessment on property, plant and equipment (excluding right-of-use assets) of approximately HK\$294,054,000 (31 December 2023: HK\$325,368,000) and right-of-use assets of approximately HK\$106,532,000 (31 December 2023: HK\$118,001,000) respectively. For the year ended 31 December 2024, impairment on each of property plant and equipment and right-of-use assets were HK\$Nil and HK\$6,705,000 (2023: HK\$22,658,000 and HK\$8,971,000) respectively.

Depreciation

The Group's net carrying amount of property, plant and equipment (excluding right-of-use assets) as at 31 December 2024 was approximately HK\$294,054,000 (31 December 2023: approximately HK\$325,368,000). The Group depreciates the property, plant and equipment, using the straight-line method, at the rates of 2% to 33% (2023: 2% to 33%) per annum, commencing from the date the asset is placed into productive use. The estimated useful lives and dates that the Group places the assets into productive use reflect the directors' estimate of the periods that the Group intends to derive future economic benefits from the use of the assets.

Share-based payments

The Group recognises share-based payments expense on options granted. Share-based payments expense is based on the estimated fair value of each option at its grant date, the estimation of which requires the directors to make assumptions about future volatility of the Group's stock price, future interest rates and the timing with respect to exercise of the options. The effects of a change in one or more of these variables could result in a materially different fair value. The fair value of the share options granted during the year was estimated at HK\$560,000 (2023: not applicable) and the amount associated with share-based payments for the year ended 31 December 2024 is HK\$406,000 (2023: HK\$793,000).

Income taxes

The Group is subject to income taxes in a number of jurisdictions. Significant judgement is required in determining the provision for income taxes in various jurisdictions. There are many transactions and calculations for which the ultimate tax determination is uncertain. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

Financial risk management objectives

The Group's corporate treasury function provides services to the business units, co-ordinates access to domestic and international financial markets, monitors and manages the financial risks relating to the operations of the Group through internal risk reports which analyse exposures by degree and magnitude of risks. These risks include market risk (including foreign currency risk, interest rate risk, and other price risk), credit risk and liquidity risk.

The Group seeks to minimise the effects of these risks and may use derivative financial instruments to hedge risk exposures. The use of financial derivatives is governed by the Group's policies approved by the board of directors, which provide written principles on foreign exchange risk, interest rate risk, credit risk, the use of financial derivatives and non-derivative financial instruments, and the investment of excess liquidity. The Group does not enter into or trade derivative financial instruments for speculative purposes.

There has been no change to the types of the Group's exposure in respect of financial instruments or the manner in which it manages and measures the risks.

Interest rate sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for both derivative and non-derivative instruments at the end of the reporting period. For floating rate liabilities, the analysis is prepared assuming the amount of the liability outstanding at the end of the reporting period was outstanding for the whole year. A 50 basis points (2023: 50 basis points) increase or decrease in variable-rate borrowings is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates. Bank balances are excluded from sensitivity analysis as the directors of the Company consider that the exposure of cash flow rate risk from variable-rate bank balances is insignificant.

If interest rates had been 50 basis points (2023: 50 basis points) higher/lower and all other variables were held constant, the Group's pre-tax profit for the year ended 31 December 2024 would decrease/increase by HK\$1,069,000 (2023: decrease/increase by HK\$964,000). This is mainly attributable to the Group's exposure to interest rates on its variable-rate borrowings.

Other price risk

The Group is exposed to equity price risk mainly through its investment in financial assets measured at FVTPL and FVTOCI with the underlying assets are equity securities. The Group's equity price risk is mainly concentrated on entities operating in biopharmaceutical industry which are either listed in Nasdaq Capital Market®, OTC Stock Market or Hong Kong, or are unlisted.

Other price risk sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to equity price risk at the end of the reporting period.

For the year ended 31 December 2024, if the price of the equity instruments had been 5% (2023: 5%) higher/lower, the Group's pre-tax profit would remain unchanged (2023: increase/decrease by HK\$6,000) as a result of the changes in fair value of financial assets at FVTPL, while the other comprehensive income would increase/decrease by HK\$10,180,000 (2023: increase/decrease by HK\$30,315,000) as a result of the changes in fair value of financial assets at FVTOCI.

Credit risk management

As at 31 December 2024, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by counterparties is the carrying amount of each financial asset as stated in the consolidated statement of financial position.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual trade debt at the end of the reporting period to ensure that adequate ECL provision are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The Group's credit risk exposure is spread over a number of counterparties and customers. Hence, it has no significant concentration of credit risk by single counterparty. Ongoing credit evaluation is performed on the financial condition of receivables.

The credit risk on liquid funds is limited because the counterparties are banks with high credit ratings.

The Group does not hold any collateral or other credit enhancements to cover its credit risks associated with its financial assets.

On 11 February 2020 (as supplemented), the Company as guarantor provided a corporate guarantee in respect of a loan facility granted to an associate of the Group up to an aggregate amount of approximately HK\$13,000,000. At the end of the reporting period, the directors of the Company have performed an impairment assessment and concluded that there has been a significant increase in credit risk since initial recognition of the financial guarantee contract. Accordingly, the loss allowance for financial guarantee issued by the Group is measured at an amount equal to lifetime ECLs (credit impaired). As at 31 December 2024, the loss allowance in respect of the financial guarantee of approximately HK\$12,967,000 (31 December 2023: HK\$Nil) was made in accordance with ECLs model under HKFRS 9. Details of the financial guarantee contract and quantitative disclosures are set out in note 42 to the consolidated financial statements.

Liquidity risk management

Ultimate responsibility for liquidity risk management rests with the board of directors, which has built an appropriate liquidity risk management framework to meet the Group's short, medium and long-term funding and liquidity management requirements. The Group manages liquidity risk by maintaining adequate reserves, banking facilities and reserve borrowing facilities, by continuously monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities.

Profits of other group entities not qualifying for the two-tiered profits tax rates regime will continue to be taxed at a flat rate of 16.5%. Accordingly, the Hong Kong Profits Tax of the qualifying group entity is calculated at 8.25% on the first HK\$2 million of the estimate assessable profits and at 16.5% on the estimate assessable profits above HK\$2 million.

The income tax provision of the Group in respect of its operations in PRC was calculated at the tax rate of 25% (2023: 25%) on the estimated assessable profits for the year, if applicable, based on existing legislation, interpretations and practices in respect thereof, except for a subsidiary which is entitled to preferential tax treatment of 15% (2023: 15%) for three years upon grant of the certificates as they are qualified as "new high technology enterprise".

Impairment of intangible assets

During the year ended 31 December 2024, the management of the Company has conducted a review of its intangible assets portfolio and concluded there is impairment of HK\$19,195,000 (2023: HK\$1,335,000) provision in respect of a license under development and a launched product.

Development programme

The Group has over 40 early- to late-stage development in various therapeutics areas. Key development programme is set out below:

1. Anfibatide

Anfibatide is a new molecular entity discovered and developed by the Group. It is a first-in-class platelet GPIIb/IIIa receptor antagonist that has fast onset, potent, and reversible antithrombotic effect among healthy subjects without impairing coagulation or prolonging bleeding time. As at 31 December 2024 and 2023, Anfibatide was not ready for sales and the Group continues the underlying research and development activities. As such, it is subject to annual impairment test based on its recoverable amount. Management determined the recoverable amount of this asset using the value in use calculations. These calculations use cash flow projections based on management's expectations of timing of commercialisation, royalty rate and success rate of commercialisation over useful life of Anfibatide. The valuation is considered to be level 3 in the fair value measurement hierarchy due to unobservable inputs used in the valuation.

Investments revaluation reserve

Investments revaluation reserve represents the cumulative fair value changes, net of tax, of financial assets at FVTOCI until they are disposed of or impaired.

Exchange reserve

Exchange reserve relating to the translation of the net assets of the Group's foreign subsidiaries from their functional currencies to the Group's presentation currency are recognised directly in other comprehensive income and accumulated in the exchange reserve. Such exchange differences accumulated in the exchange reserve will be reclassified to profit or loss upon the disposal of the foreign subsidiaries.

37. SHARE OPTION SCHEMES

38. EMPLOYEE RETIREMENT BENEFITS

Defined contribution plan

The Group operates a Mandatory Provident Fund Scheme (the “MPF Scheme”) under the Hong Kong Mandatory Provident Fund Scheme Ordinance for all qualifying employees in Hong Kong. The assets of the MPF Scheme are held separately from those of the Group, in funds under the control of independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees’ relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest immediately, there is no forfeited contributions that may be used by the Group to reduce the existing level of contribution.

The total expenses recognised in profit or loss of HK\$754,000 (2023: HK\$754,000) represents contributions payable to the MPF Scheme by the Group at rates specified in the rules of the plans.

The employees of the Group’s subsidiaries in the PRC and Taiwan are members of a state-managed retirement benefit plan operated by the government of the PRC and Taiwan. The subsidiaries are required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement benefits is to make the specified contributions.

38. 僱員退休福利

定額供款計劃

Defined benefit plan

Retirement benefits scheme represents the retirement benefits provided to certain directors of the Company in accordance with their service contract (as supplemented).

Each of the eligible directors will be entitled to lump sum payment upon retirement and monthly pension payment after retirement if he/she has engaged in continuous service with the Group for certain years.

The carrying amount of the retirement benefits represents the cost of providing benefits determined by valuation conducted by independent valuer at the end of the reporting period, amortised over the expected average remaining working lives of the eligible employees. The fair value of the retirement benefits at 31 December 2024 was valued by Peak Vision Appraisal Limited, an independent professional valuer not connected to the Group. 3. Change in ownership interest in subsidiaries

In February 2024, the Group sold 1,000 shares in Lee Thailand to a third party for a consideration of US\$4,000 (equivalent to approximately HK\$31,000) and upon completion, the Group's shareholding in Lee Thailand in decreased from 51% to 49%.

Although the Group has only 49% equity interests in Lee Thailand, the directors of the Company conclude that the Group has control over the board of Lee Thailand in directing its relevant operating and financing activities on the basis of the Group's shareholding. The 51% equity interest in Lee Thailand are owned by few individuals with none of them is holding more than 40%.

As the Group retained control Lee Thailand, the Group recognised a gain on partial disposal of interests in a subsidiary of approximately HK\$22,000 under "other reserves" within equity, and an increase in non-controlling interests of approximately HK\$9,000.

For the year ended 31 December 2023

In December 2023, the Group further acquired 1% equity interest in Lee Thailand from the existing non-controlling interests for consideration of US\$2,000 (equivalent to approximately HK\$15,000) and upon completion, the Group's shareholding in Lee Thailand is increased from 50% to 51%.

As the Group retained control over Lee Thailand, the Group recognised a loss on acquisition of additional interest in a subsidiary of approximately HK\$9,000 under "other reserves" within equity, and a decrease in non-controlling interests of approximately HK\$6,000.
