CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders,

On behalf of the Board of Directors of Moody Technology Holdings Limited (the "Company") and its subsidiaries (collectively the "Group"), I report to shareholders our annual report for the year ended 31 December 2023 (the "Year" or "Period").

RESULTS

The Group recorded revenue of approximately RMB140.3 million for the year ended 31 December 2023, representing an increase of approximately 54.9% as compared with the revenue of RMB90.5 million for the year ended 31 December 2022. The Group's products experienced a gross profits margin of approximately 10.6%, as compared with a gross profits margin of approximately 8.2% from previous year. Loss attributable to owners of the Company for the Year increased from loss of approximately RMB140.5 million in 2022 to loss of approximately RMB811.4 million in 2023, representing an increase of approximately 477.5% as compared with the last year, which was mainly attributable to a loss on derecognition of financial liabilities of approximately RMB756.2 million in 2023 (2022: Nil). Sales of shoes, clothes and others contributed revenue amounted to approximately RMB83.6 million (2022: RMB66.8 million) for the year ended 31 December 2023. Sales of fabrics contributed revenue amounted to approximately RMB13.6 million (2022: RMB23.7 million) for the year ended 31 December 2023. Upon the completion of the acquisition of new subsidiaries, the revenue from sales of elastic webbings was approximately RMB31.8 million during the Year. During the Year, the Group also commenced a new business in digital marketing services which contributed revenue of approximately RMB11.3 million.

本人謹代表滿地科技股份有限公司(「本公司」) 及其附屬公司(統稱「本集團」)向股東報告截 至二零二三年十二月三十一日止年度(「本年度」 或「本期間」)之年報。

業績

截至二零二三年十二月三十一日止年度,本集 團錄得收益約人民幣140.3百萬元,較截至二 零二二年十二月三十一日止年度的收益人民幣 90.5百萬元增加約54.9%。本集團產品錄得毛 利率約10.6%,而上一年度毛利率為約8.2%。 本年度本公司擁有人應佔虧損由二零二二年虧 損約人民幣140.5百萬元增至二零二三年虧損 約人民幣811.4百萬元,較去年增加約477.5%, 主要由於二零二三年終止確認金融負債之虧損 約人民幣756.2百萬元(二零二二年:無)。截至 二零二三年十二月三十一日止年度, 鞋履、服 裝及其他銷售貢獻收益約為人民幣83.6百萬元 (二零二二年:人民幣66.8百萬元)。截至二零 二三年十二月三十一日止年度,面料銷售貢獻 收益約為人民幣13.6百萬元(二零二二年:人民 幣23.7百萬元)。完成收購新附屬公司後,本年 度彈性織帶銷售的收益約為人民幣31.8百萬元。 於本年度,本集團亦啟動數字營銷服務的新業 務,該業務貢獻收益約為人民幣11.3百萬元。

OUTLOOK

In 2023, the issue of the scheme shares to the scheme creditors had been completed. It provided a solid foundation for the Company to complete the acquisition of subsidiaries and develop new business during the year. The Group had commenced the digital marketing services business during the year, which mainly comprised of design and production of media advertising. Through cooperating with mainstream media and building up an experienced advertising team, the management is confident that such a new business will further increase the income source of the Group in 2024.

Furthermore, the management will continue our effort to explore various business opportunities through mergers and acquisition to strength the capacity of the Group. The management will also closely monitor the Group's financial performance, financial position and cash flow in order to maintain the normal operation of the Group.

OVERVIEW

During the Year, the Group's revenue increased from approximately RMB90.5 million for the year ended 31 December 2022 to RMB140.3 million for the year ended 31 December 2023. Loss attributable to owners of the Company increased by 477.5% to approximately RMB811.4 million against last year. Basic and diluted loss per share decreased from loss per share of RMB2.16 in 2022 to loss per share of RMB0.24 in 2023.

INDUSTRY REVIEW

According to the Ministry of Industry and Information Technology of China, total profits of China's major textile enterprises rose 7.2% to RMB180.2 billion year-on-year in 2023. The combined operating revenue of these firms stood at RMB4.70 trillion, edging down 0.8% from 2022. China's textile and garment exports hit US\$293.6 billion in 2023, down 8.1% from the previous year.

BUSINESS REVIEW

During the Year, the Group had four product segments (2022: two), namely fabrics, shoes and clothing, elastic webbings and digital marketing services. The Group's revenue also included sales of elastic webbings upon the completion of acquisition of Leader Elastic Limited and its subsidiaries on 28 April 2023 that their financial results had been consolidated into the Group's consolidated financial statements. In addition, the Group commenced a new business in digital marketing services.

A subsidiary in Fujian was incorporated and commenced to manufacture and sell different types of clothing products including T-shirts, jackets, pants and hoodies, etc. to the customers mainly in the PRC since the second half of 2022. In 2023, the local sales of the products had a stable growth with an increase in average sales amounts per customer (2023: approximately RMB1.0 million; 2022: approximately RMB0.2 million). Based on the performance in the previous years, the profit margins of the local sales are higher than the export sales of the clothing products, the Group hence concentrated on the local markets and did not generate any revenue from the export sales during the Year.

The Group's fabrics business was mainly manufacturing and sales of dyed garment fabrics. The average price of fabrics products was approximately RMB5.2 per meter in 2023 (2022: RMB5.2 per meter). Since the management intended to put more effort and resources on the new business segments of the Group in the second half of 2023, the quantities of fabrics sold decreased from approximately 4.56 million meters in 2022 to approximately 2.61 million meters in 2023 which decreased the overall revenue from this product segment in 2023.

概覽

於本年度,本集團的收益由截至二零二二年十二 月三十一日止年度的約人民幣90.5百萬元增加至 截至二零二三年十二月三十一日止年度的約人民 幣140.3百萬元。本公司擁有人應佔虧損較去年增 加477.5%至約人民幣811.4百萬元。每股基本及 攤薄虧損由二零二二年每股虧損人民幣2.16元減 少至二零二三年每股虧損人民幣0.24元。

行業回顧

根據中國工業和信息化部的資料,於二零二三年, 中國主要紡織企業溢利總額同比增長7.2%,達人 民幣1,802億元。該等企業的經營收益合計為人民 幣4.70萬億元,較二零二二年下降0.8%。於二零 二三年,中國紡織品服裝出口額達2,936億美元, 較上一年下降8.1%。

業務回顧

於本年度,本集團擁有四個產品分部(二零二二 年:兩個),即面料、鞋履及服裝、彈性織帶及數 字營銷服務。於二零二三年四月二十八日完成收 購利達彈性織物有限公司及其附屬公司後,本集 團之收益亦包括銷售彈性織帶,其財務業績已併 入本集團之綜合財務報表。此外,本集團已開展 數字營銷服務新業務。

一間附屬公司已於福建註冊成立並自二零二二年 下半年開始向主要位於中國的客戶生產和銷售不 同種類服裝產品,包括T恤、夾克、褲子和連帽衫 等。於二零二三年,本地產品銷售錄得穩定增長, 每位客戶平均銷售額有所增加(二零二三年:約 人民幣1.0百萬元;二零二二年:約人民幣0.2百萬 元)。根據過往數年的表現,服裝產品的本地銷售 利潤率高於出口銷售,因此,本集團專注於本地 市場且本年度出口銷售並無產生任何收益。

本集團面料業務主要為製造及銷售色布。面料產品於二零二三年的平均價格為每米約人民幣5.2元(二零二二年:每米人民幣5.2元)。由於管理層擬於二零二三年下半年投入更多精力及資源於本集團的新業務分部,面料銷售量由二零二二年的約4.56百萬米減少至二零二三年的約2.61百萬米, 令該產品分部於二零二三年的整體收益有所減少。



The Group's elastic webbings products comprised of certain types of dyed strap, including jacquard tape, knitted strap and bundle strap, etc. which were mainly manufactured and sold by Zhuhai Sundust Technology Holdings Limited (formerly named as Zhuhai Sundust Apparel Co. Ltd.) ("Zhuhai Sundust"), a public company incorporated in the PRC whose shares are listed on the National Equities Exchange and Quotations in the PRC (Stock code: 872634), and its subsidiaries, which were newly acquired by the Group during the Year.

The Group also developed a new business line in digital marketing services which was under the business subgroup of Zhuhai Sundust during the Year. During the period, the Group offers diversified digital marketing services including performance-based advertising services, display-based advertising services and short video exposure services. To fulfill contracts with certain customers, the Group enters into cooperation agreements with third party platforms and places the advertisements of the Group's customers displayed on third party platforms, such as Facebook, TapTap and Google. Through cooperating with the mainstream media and building up an experienced advertising team, the management is confident that such a new business will increase the income source of the Group.

FINANCIAL REVIEW

Revenue

The Group's revenue mainly generated from sales of shoes and clothes, manufacturing and sales of fabrics and elastic webbings and provision of digital marketing services. The total revenue increased from approximately RMB90.5 million for the year ended 31 December 2022 to approximately RMB140.3 million for the year ended 31 December 2023.

The manufacturing and sales of clothing products in the PRC, which was commenced by the Group in the second half of 2022, had a stable growth in 2023 with an increase in average sales amounts per customer (2023: approximately RMB1.0 million; 2022: approximately RMB0.2 million), resulting in an increase in revenue from RMB66.8 million in 2022 to approximately RMB83.6 million in 2023. Based on the performance in the previous years, the profit margins of the local sales are higher than the export sales of the clothing products, the Group hence concentrated on the local markets and did not generate any revenue from the export sales during the Year.

For the products segments, the average price of fabrics products was approximately RMB5.2 per meter in 2023 (2022: RMB5.2 per meter) and the quantities of fabrics sold decreased from approximately 4.56 million meters in 2022 to approximately 2.61 million meters in 2023 which decreased the overall revenue from approximately RMB23.7 million in 2022 to approximately RMB13.6 million in 2023.

於本年度,本集團亦開發數字營銷服務新業務線, 其屬於珠海泓利旗下的業務子集團。於期內,本 集團提供效果性廣告服務、展示性廣告服務及短 視頻曝光服務等多元化數字營銷服務。為履行與 部分客戶簽訂的合同,本集團與第三方平台簽訂 合作協議,將本集團客戶的廣告投放到第三方平 台,如Facebook、TapTap及Google。透過與主流媒 體的合作並建立一支經驗豐富的廣告團隊,管理 層對有關新業務將增加本集團的收入來源充滿信 心。

<u>財務回顧</u> 收益

本集團的收益主要來自銷售鞋履及服裝、製造及 銷售面料及彈性織帶以及提供數字營銷服務。總 收益由截至二零二二年十二月三十一日止年度的 約人民幣90.5百萬元增加至截至二零二三年十二 月三十一日止年度的約人民幣140.3百萬元。

本集團於二零二二年下半年開始於中國製造及銷售服裝產品,其於二零二三年穩定增長,每位客 戶平均銷售額有所增加(二零二三年:約人民幣1.0 百萬元;二零二二年:約人民幣0.2百萬元),導致 收益由二零二二年的人民幣66.8百萬元增加至二 零二三年的約人民幣83.6百萬元。根據過往數年 的表現,服裝產品的本地銷售利潤率高於出口銷 售,因此,本集團專注於本地市場且本年度出口 銷售並無產生任何收益。

就產品分部言,面料產品於二零二三年的平均價 格為每米約人民幣5.2元(二零二二年:每米人民 幣5.2元)且面料銷售量由二零二二年的約4.56百 萬米減少至二零二三年的約2.61百萬米,令整體 收益由二零二二年的約人民幣23.7百萬元減少至 二零二三年的約人民幣13.6百萬元。

The manufacturing and sales of elastic webbing comprised of sales of certain types of dyed strap, including jacquard tape, knitted strap and bundle strap, etc. The revenue contributed from this product segment was approximately RMB31.8 million for the Year. In addition, the new business segment of digital marketing services was commenced in the second half of 2023, which contributed revenue of approximately RMB11.3 million for the Year.

Cost of sales

The Group's cost of sales increased by 50.9% from approximately RMB83.1 million for the year ended 31 December 2022 to approximately RMB125.5 million for the year ended 31 December 2023. Such increase in cost of sales was in line with the increased turnover during the Year.

銷售成本

截至二零二三年十二月三十一日止年度,本集團 銷售成本由截至二零二二年十二月三十一日止 年度約人民幣83.1百萬元增加50.9%至約人民幣 125.5百萬元。銷售成本增加與本年度營業額增加 一致。

Gross profits

The gross profits of the Group increased from approximately RMB7.4 million, representing a gross profits margin of approximately 8.2% in 2022 to approximately RMB14.8 million, representing a gross profits margin of approximately 10.6% in 2023. An increase in overall gross profits margins was mainly attributable to the stable growth in the local sales of clothing products with higher profits margins (2023: 13.1%; 2022: 10.5%) during the Year.

毛利

本集團的毛利由二零二二年的約人民幣7.4百萬 元(毛利率約為8.2%)增加至二零二三年的約人 民幣14.8百萬元(毛利率約為10.6%)。整體毛利 率增加乃主要由於本年度的服裝產品利潤率較高 (二零二三年:13.1%;二零二二年:10.5%),本 地銷售額穩定增長。

Other income

An increase in other income by 31.8% from approximately RMB2.1 million for the year ended 31 December 2022 to approximately RMB2.8 million for the year ended 31 December 2023 was mainly attributable to the increase of interest income from placement of fixed deposits as well as an increase in a consultancy fee income of RMB0.7 million (2022: Nil) during the year.

Loss on derecognition of financial liabilities

The Group recognised a loss of approximately HK\$858.1 million (equivalent to RMB756.2 million) for the Year (2022 : Nil) from the issue of the Scheme Shares in accordance with the relevant accounting standards. Such loss was one-off and non-cash in nature and did not have any effect on net equity deficit amounts in the consolidated financial position as at 31 December 2023.

The Group recognised a loss on derecognition of financial liabilities of approximately HK\$858.1 million (equivalent to RMB756.2 million) for the year ended 31 December 2023 (2022 : Nil). Such loss is recognised in accordance with the requirement of HK(IFRIC) Interpretation 19 as a result of the issuance of 3,262,705,241 shares at an issue price of HK\$0.317 per share on 4 January 2023 to the Scheme Creditors. The issue price is at a significant discount to the closing market price on the relevant date i.e. HK\$0.580 per share. Such loss was reflected in the Group's consolidated statement of profit or loss and other comprehensive income for the year ended 31 December 2023 and in the contribution surplus of the Group's consolidated statement of financial position and did not have any impact on the net amount of the Group's capital deficiency as at 31 December 2023.

Net foreign exchange gains/losses

The net foreign exchange gains of approximately RMB9.1 million was affected by the appreciation of RMB against HK\$ in 2023. The net foreign exchange loss of approximately RMB58.2 million was mainly derived from the bonds principles and interests of approximately RMB913.2 million (equivalent to HK\$1,030 million) which were dominated in HK\$, as affected by the depreciation of RMB against HK\$ in 2022.

Selling and distribution expenses

The increase in selling and distribution expenses by 82.5% from approximately RMB5.9 million for the year ended 31 December 2022 to approximately RMB10.8 million for the year ended 31 December 2023 mainly because more staff cost, travelling and entertainment expenses were incurred during the Year.

其他收入

其他收入由截至二零二二年十二月三十一日止 年度約人民幣2.1百萬元,增加31.8%至截至二 零二三年十二月三十一日止年度約人民幣2.8 百萬元,主要是由於本年度定期存款利息收入 增加及顧問費收入增加人民幣0.7百萬元(二零 二二年:無)所致。

終止確認金融負債產生的虧損

根據相關會計準則,本集團於本年度因發行計 劃股份而確認一項虧損約858.1百萬港元(相 當於人民幣756.2百萬元)(二零二二年:無)。 該項虧損屬一次性非現金性質,對二零二三年 十二月三十一日的合併財務狀況中的權益淨虧 絀金額並無任何影響。

銷售及分銷開支

銷售及分銷開支由截至二零二二年十二月 三十一日止年度約人民幣5.9百萬元,增加 82.5%至截至二零二三年十二月三十一日止年 度約人民幣10.8百萬元,主要由於本年度員工 成本、差旅及酬酢開支增加。

General and administrative expenses

The increase in general and administrative expenses by 27.3% from approximately RMB32.0 million for the year ended 31 December 2022 to approximately RMB40.8 million for the year ended 31 December 2023 was mainly attributable to (i) an increase in research and development of RMB3.4 million from elastic webbings business; (ii) an increase in legal and professional fees from approximately RMB4.7 million in 2022 to approximately RMB6.7 million in 2023.

Finance costs

The decrease in finance costs by 61.0% from approximately RMB52.6 million for the year ended 31 December 2022 to approximately RMB20.5 million for the year ended 31 December 2023 was mainly because of the Group did not incur any interests on bonds during the year as compare to the accrual of the interest expenses for the bonds in last year until the creditor's scheme (the "Scheme") has become effective on 5 September 2022.

Income tax credit/(expense)

Income tax credit of approximately RMB31,000 was recognised for the Year as compared to income tax expenses of approximately RMB0.7 million recognised in 2022.

CAPITAL STRUCTURE, LIQUIDITIES AND FINANCIAL RESOURCES

During the Year, the cash of the Group was mainly used in the operating activities and generated from financing activities. For the year ended 31 December 2023, net cash used in operating activities of the Group amounted to RMB120.3 million as compared to RMB12.5 million in 2022. Net cash generated from financing activities of the Group amounted to approximately RMB140.0 million in 2023 as compared to net cash used in financing activities of the Group amounted to approximately RMB12.2 million in 2022 mainly due to increased proceeds from three placing of new shares completed during the year.

Our primary uses of cash are to satisfy our working capital needs and our capital expenditure needs. Since our establishment, our working capital needs and capital expenditure requirements have been principally financed through a combination of shareholders' equity, cash generated from operations, and borrowings. The Group adopts a prudent cash and financial management policy.

In order to achieve better cost control and minimize the cost of funds, the Group's treasury activities and cash and cash equivalents are generally deposited with certain financial institutions such as banks denominated mostly in Renminbi and Hong Kong dollars.

During the Year, the Company had completed the issue of scheme shares and three placing of new shares.

In view of such circumstances, the Directors of the Company had assessed the Group's current liquidity, performance and available sources of financing in considering the Group's ability to continue as a going concern.

The management's position on the Audit Qualification

The Directors have also taken or will continue to implement the measures to mitigate the Group's liquidity pressure and improve the conditions of cash flow, and on the assumption of successful and continued implementation of such measures, and taking into account the Group's cash flow projections which covers a period of not less than 12 months from 31 December 2023, the management of the Company and also the Directors are satisfied that it is appropriate to prepare the Group's consolidated financial statements on a going concern basis. The Directors are of the view that the Group, based on the continuing effort of the action plan as detailed below, will have sufficient cash resources to satisfy future working capital and other financing requirements as and when they fall due in the next twelve months from the reporting date.

The consolidated financial statements have therefore been prepared on a going concern basis, the validity of which however depends on the outcome of the continuing action plan, including:

- (i) the Group's continued ability to negotiate with the creditor banks to renew or extend the existing borrowings as they fall due; and
- (ii) the Group's continued ability to generate operating cash flows and obtain additional resources of financing to finance the Group's businesses and other funding needs.

審核保留意見

誠如本年報附註3所詳述,該等情況存在表明出 現重大不明朗性,可能會對本集團的持續經營 能力產生重大疑問。鑑於有關情況,本公司董 事於考慮本集團的持續經營能力時,已評估本 集團當前的流動資金、表現及可動用融資來源。

管理層對審核保留意見之立場

董事亦已採取或將繼續實施措施,以舒緩本集 團的流動資金壓力並改善現金流狀況,及假設 成功並繼續實施該等措施,且經計及本集團的 現金流預測(涵蓋自二零二三年十二月三十一 日起不少於12個月期間)的情況下,本公司管 理層以及董事均信納,按持續經營基準編製本 集團之綜合財務報表屬適當。董事認為,基於 下文所詳述行動計劃的持續努力,本集團將有 充足的現金資源來滿足於報告日期起未來12個 月內到期的未來營運資金及其他融資需求。

因此,综合財務報表乃按持續經營基準編製, 然而其有效性乃取決於持續行動計劃的結果, 包括:

- (i) 本集團與債權銀行磋商,續期或延期現有 到期借款的持續能力;及
- (ii) 本集團產生經營現金流及取得額外融資 資源以撥付本集團業務及其他資金需求 的持續能力。

In this regard, the Auditor had requested for the Company to provide, including but not limited to, (i) the duly signed extension agreements in relation to the existing borrowings entered into between the Group and the creditor banks and (ii) the duly signed agreements in relation to the fund-raising activities with any potential investors. Up to the date of the annual report, the Group has not entered into any extension agreements with the creditor banks to renew or extend the existing borrowings as they fall due. In addition, the Company has been in discussion with a placing agent and potential investors regarding a potential fund raising exercise by way of issuance of new shares, but the major terms have not been concluded and no legally binding agreement has yet been entered into by the Company with any party for the potential fund raising.

Further to as set out in the annual report, in the view of (i) whether the Group would successfully secure new financing from the financial institutions to fund its operations and financial obligations as and when they fall due as well as restructuring of the existing borrowings by extending the payment schedule; (ii) whether the Group would have successful negotiations with the lenders of the defaulted borrowing that they will not take any actions against the Group to exercise their rights to demand immediate payment of the principals and interests of these borrowings; (iii) whether the Group would successfully obtain external source of funding from potential investors by issuance of new shares; and (iv) the Group's ability to generate operating cash flows to meet the Group's ongoing funding needs as well as successfully control operations costs and capital expenditure, and implement various strategies to enhance the Group's revenue, which may constitute the possible cumulative effects on the consolidated financial statements, the Auditor disclaimed their opinion on the consolidated financial statements in respect of the material uncertainty relating to the going concern basis (the "Audit Qualification").

Audit Committee's view towards the Audit Qualification

The audit committee of the Company (the "Audit Committee") had critically reviewed the Audit Qualification and also the Directors' position and Action Plan (as defined below) of the Group to address the Audit Qualification. The Audit Committee is in agreement with the Directors with respect to the Audit Oualification and the Group's ability to continue as a going concern, and in particular the Action Plan to be implemented by the Directors or the Group. The Audit Committee's views are based on (i) a critical review of (a) the Directors' Action Plan to address the Audit Qualification (and the assumption of successful and continued implementation), and (b) a review of the Group's cash flow projections which covers a period of not less than 12 months from 31 December 2023, and also (ii) discussions between the Audit Committee, the Auditor and the Directors regarding the Audit Qualification. The Audit Committee is also of the view that the Directors shall and continue its efforts in implementing the Action Plan with the intention of mitigating the Group's liquidity pressure and removing the Audit Qualification.

Status and results of the action plan of the Group to address the Audit Qualification for the year ended 31 December 2023

Reference is made to the Company's announcements dated 23 October 2020, 9 September 2021 and 30 June 2022 in relation to, among others, the action plans (the "Action Plan") of the Company to address and remove the audit modification for the years ended 31 December 2020, 2021 and 2022, and the announcements dated 11 November 2020, 11 April 2022, 18 May 2022, 9 June 2022, 28 June 2022, 5 September 2022, 4 January 2023, 28 August 2023 and 30 August 2023 and the circular of the Company dated 21 July 2022 (the "Circular") in relation to, inter alia, the Scheme. Unless otherwise defined, terms used herein shall bear the same meanings as defined in the aforementioned announcements and the Circular.

審核委員會對審核保留意見的見解

本公司審核委員會(「審核委員會」)已嚴格審 閱審核保留意見以及董事的立場及本集團回應 審核保留意見的行動計劃(定義見下文)。審核 委員會認同董事對審核保留意見及本集團將實 經營能力的見解,特別是董事或本集團將實 施之行動計劃。審核委員會的見解乃基於(i)嚴格 審閱(a)董事回應審核保留意見的行動計劃() 服 證計劃成功且持續實施),及(b)審閱本集團 約 一日 起計劃成功且持續實施),及(b)審閱本集團 約 一日 起計劃成功且持續實施),以及(ii)審核 個 月期間的現金流預測,以及(ii)審核委員會 、核數師及董事就審核保留意見的討論。審 核委員會亦認為董事應繼續致力實施行動計劃, 以減輕本集團的流動資金壓力及剔除審核保留 意見。

茲提述本公司日期為二零二零年十月二十三日、 二零二一年九月九日及二零二二年六月三十 日之公告,內容有關(其中包括)本公司回應及 剔除截至二零二零年、二零二一年及二零二二 年十二月三十一日止年度的審核保留意見的行 動計劃(「行動計劃」),及日期為二零二零二 年五月十八日、二零二二年四月十一日、二零 二二年五月十八日、二零二二年六月九日、二 零二二年六月二十八日、二零二三年九月五日、 二零二三年一月四日、二零二三年八月二十八 日及二零二三年八月三十日之公告以及本公司 日期為二零二二年七月二十一日之通函(「通 函」),內容有關(其中包括)計劃。除另有界定 外,本公告所用詞彙具有上述公告及通函所界 定的相同涵義。

(i) Implementation of the Scheme

As disclosed in the announcement of the Company dated 4 January 2023, an aggregate of 3,262,705,241 Scheme Shares were allotted and issued to the Scheme Creditors at the issue price of HK\$0.317 per Scheme Share for settlement of the all the Admitted Claims of the Scheme Creditors totaling approximately HK\$1,034.3 million (equivalent to RMB911.5 million). Upon Completion, all the Admitted Claims owing by the Company to the Scheme Creditors, including all amount owing by the Company under the Bonds (including the Notes), have been discharged and released in full.

As such, the Group's current borrowings decreased from approximately RMB955.0 million as at 31 December 2022 to approximately RMB200.4 million as at 31 December 2023. The Group's non-current borrowings decreased from approximately RMB121.1 million as at 31 December 2022 to Nil as at 31 December 2023.

(ii) Negotiation with the local creditor banks in the PRC to renew or extend the existing bank borrowings owed by the PRC subsidiaries of the Group in Hubei and Fujian

As at 31 December 2023, the secured bank borrowings and unsecured bank borrowings amounted to approximately RMB147.7 million and RMB52.7 million, respectively, which includes the current bank borrowings (the "Current Bank Borrowing") of approximately RMB37.5 million (2022: RMB60 million) and the overdue bank borrowings (the "Overdue Bank Borrowing") amounted to RMB162.9 million (2022: RMB103.0 million).

The Overdue Bank Borrowing were defaulted by (a) Shishi City Yingfeiling Supply Chain Management Limited ("Yingfeiling"), the Company's subsidiary in Fujian; (b) Fengtai (Hubei) Textile Co. Limited ("Fengtai Hubei"); and (c) Hongtai (Hubei) Sales Co., Limited ("Hongtai Hubei"), both the Company's subsidiaries in Hubei, due to temporary shortage of funds. The Overdue Bank Borrowings in relation to Yingfeiling, Fengtai Hubei and Hongtai Hubei of approximately RMB45.7 million, approximately 107.1 million and approximately RMB10.0 million have become overdue since the financial year ended 31 December 2017 and 31 December 2023, respectively. The Overdue Bank Borrowings in relation to Hongtai Hubei have become overdue since the financial year ended 31 December 2023.

(i) 實施計劃

因此,本集團的流動借款由二零二二年 十二月三十一日的約人民幣955.0百萬元 減少至二零二三年十二月三十一日的約 人民幣200.4百萬元。本集團的非流動借 款由二零二二年十二月三十一日的約人 民幣121.1百萬元減少至二零二三年十二 月三十一日的零。

(ii) 與中國當地的債權銀行磋商,以續期 或延期本集團於湖北和福建的中國附 屬公司結欠之現有銀行借款

於二零二三年十二月三十一日,有抵押銀 行借款及無抵押銀行借款分別約為人民幣 147.7百萬元及人民幣52.7百萬元,當中 包括即期銀行借款(「即期銀行借款」)約 人民幣37.5百萬元(二零二二年:人民幣 60百萬元)以及逾期銀行借款(「逾期銀行 借款」)為人民幣162.9百萬元(二零二二 年:人民幣103.0百萬元)。

Up to the date of the annual report, the Company is still in the process of negotiating with the relevant banks on the terms of extension of the Overdue Bank Borrowings and has yet to receive any update as to the expected timeline of entering into of the extension agreement. As at the date of the annual report, the Company has not received any demand for immediate payment of the Current Bank Borrowings, and is not expecting to receive any of such demand given the past communications with the relevant banks. The Company will continue to follow up with the banks in relation to further extension of the repayment of the Current Bank Borrowing by their due dates and will try to convince the relevant banks not to demand for repayment of the Overdue Bank Borrowings until the entering into of the relevant extension agreements. In addition, the Company is also considering the feasibility to repay the Overdue Bank Borrowing by the Company's fund raising activities or selling certain of the Group's property, plant and equipment in Quarter 2 or 3 of 2024.

Fengtai Hubei

On 13 May 2020, a claim was brought by Industrial and Commercial Bank of China Limited Huanggang Huangmei Branch (中國工商銀行股份有限公司黃岡黃梅支行) ("ICBC Branch") against Fengtai Hubei for payment of an outstanding principal of approximately RMB6.3 million together with an outstanding interest of approximately RMB2.2 million. On 3 December 2020, the Huanggang Intermediate People's Court of Hubei Province (湖北省黃岡市中級人民法院) issued a civil judgment (民事判決書), pursuant to which the court ordered Fengtai Hubei to repay the outstanding principal and all outstanding interest accrued thereon. As per the agreement with the ICBC Branch, Fengtai Hubei is currently repaying the debts by installment. Since 1 January 2023 to the date of the annual report, Fengtai Hubei had repaid the outstanding sum amounted to approximately RMB0.11 million to ICBC Branch.

Fengtai Hubei will continue to repay the Overdue Bank Borrowings (including the outstanding sum mentioned in the legal action above) by installment depending on its liquidity. Pursuant to the bank loan agreements entered between Fengtai Hubei and the creditor banks, Fengtai Hubei is subject to penalty interest expenses until the full repayment of the overdue loans.

Hongtai Hubei

Pursuant to the bank loan agreements entered between Hongtai Hubei and the creditor banks, Hongtai Hubei is subject to penalty interest expenses until the full repayment of the overdue loans.

Save as disclosed above and up to the date of the annual report, the local creditor banks have not demanded immediate repayment for its overdue loans, and the Company has not been informed of any further legal actions taken by the banks in relation to the Overdue Bank Borrowings.

Yingfeiling

Upon the forced sale of the buildings in Shishi (details of which are set out in the Company's announcement dated 20 April 2020), the operation of Yingfeiling had been suspended since April 2020. Based on the audited financial information as at 31 December 2023, Yingfeiling had net current liabilities of approximately RMB160.5 million and net liabilities of approximately RMB126.4 million. Based on the above, Yingfeiling does not have sufficient funds to repay the Overdue Bank Borrowings. Up to the date of the annual report, the Company has not been informed of and there are no further legal actions taken by the banks in relation to the Overdue Bank Borrowings. The Group will continue its effort to negotiate with the banks for the extension of the Overdue Bank Borrowings.

(iii) Fundraising from the financing activities

For the year ended 31 December 2023, the Company had completed the issue of the Scheme Shares and three placing of new shares of which the details were disclosed as above.

The Group will continue to generate operating cash flows and seek other alternative financing, including but not limited to the placing of new shares by general mandate and/or specific mandate if necessary in the Quarter 2 or 3 of 2024.

(iv) Exploring new business opportunities Acquisition of Leader Elastic Limited

On 28 April 2023, the Group completed the acquisition of 80.95% equity interests of Leader Elastic Limited ("Leader Elastic"), a company with limited liability incorporated under the laws of Hong Kong. Leader Elastic owns approximately 84.14% issued share capital of Zhuhai Sundust Apparel Co. Ltd, a public company established in the PRC whose shares are listed on the National Equities Exchange and Quotations in the PRC (stock code: 832674). The principal activity of Leader Elastic and its subsidiaries is investment holding and sales of elastic webbing used for bras, underwear in the PRC. The consideration for the acquisition was HK\$21,000,000 (equivalent to approximately RMB18,546,000).

The acquisition was in line with the Company's business strategy to expand the Company's business in the production and the sales of elastic webbing used for bras and underwear, and strengthen the products, revenue sources and cash flow position of the Group in future.

(iii) 融資活動所籌集之資金

截至二零二三年十二月三十一日止年度, 本公司已完成發行計劃股份及三次新股 配售,其詳情於上文披露。

本集團將持續產生經營性現金流,並尋求 其他融資渠道,包括但不限於於二零二四 年第二季度或第三季度根據一般授權和/ 或特別授權(如必要)配售新股份。

(iv) 物色新商機

收購利達彈性織物有限公司 於二零二三年四月二十八日,本集團完 成收購利達彈性織物有限公司(「利達彈 性織物」)80.95%的股權,利達彈性織物 為一家根據香港法律註冊成立的有限公司。利達彈性織物擁有珠海泓利服飾股份 有限公司(一間於中國成立的公眾公司, 其股份於中國全國中小企業股份轉讓份 行股本約84.14%。利達彈性織物及其國 銷售用於文胸及內衣的彈性織帶。收購 代價為21,000,000港元(相當於約人民幣 18,546,000元)。

是項收購符合本公司的經營策略,以拓展 本公司用於文胸及內衣的彈性織帶的製造 和銷售業務,且日後將增強本集團的產品、 收入來源及現金流量狀況。

Since the acquisition, Leader Elastic Group has contributed revenue of approximately RMB43,076,000 to the Group's turnover and loss of approximately RMB10,516,000 to the Group's profit for the period between the date of acquisition and the end of reporting period.

Development of new business segment

The Group also developed a new business line in digital marketing services which was under the business subgroup of Zhuhai Sundust during the Year. During the period, the Group offers diversified digital marketing services including performance-based advertising services, display-based advertising services and short video exposure services. To fulfill contracts with certain customers, the Group enters into cooperation agreements with third party platforms and places the advertisements of the Group's customers displayed on third party platforms, such as Facebook, TapTap and Google. Through cooperating with the mainstream media and building up an experienced advertising team, the management is confident that such a new business will increase the income source of the Group. Such new business segment contributed to the Group's revenue of approximately RMB11.3 million with segment profit of approximately RMB0.8 million for the year ended 31 December 2023.

Save for the above, the Company will continue to approach other various potential business partners for the development of the Group's new business, such business partners are engaged in various industries including but not limited to environmental protection and garment business, etc. When evaluating the potential business development opportunities, the Company takes into account of the profitability, assets and liabilities level, cash flows as well as industry prospects of such businesses, with an objective to enhance the Company's financial performance. Up to the date of the annual report, the Company is still in preliminary negotiations with these business partners and no agreements has been made between the Company and any of these business partners. The views of the Directors (including Audit Committee) on the effectiveness of the plan to resolve the Audit Issue

Based on the Company's discussion with the Auditor, the Board is given to understand that if all of the above Action Plan had been completed as at 31 December 2024, the Audit Qualification would not have been issued. The Auditor has advised the Directors that as the Audit Qualification relates to a going concern issue. in preparing the financial statements for the year ending 31 December 2024, the Directors are responsible for assessing the Company's ability to continue as a going concern and the appropriateness of preparing the Group's consolidated financial statements on a going concern basis, based on the conditions and circumstances as at 31 December 2024. In accordance with the Hong Kong Standards on Auditing, the Auditor needs to obtain sufficient appropriate audit evidence regarding the appropriateness of the Directors' use of the going concern basis of accounting in the preparation of the Group's consolidated financial statements, and to conclude, based on the audit evidence obtained, whether a material uncertainty exists regarding the Company's ability to continue as a going concern.

The Directors' assessment of the Company's ability to continue as a going concern as at 31 December 2024 would need to take into consideration of the then conditions and circumstances and also include cash flow projections covering a period of not less than 12 months from 31 December 2024. As such, the Auditor is unable to ascertain whether the Audit Qualification can be removed in the next financial year based purely on the Action Plan, given sufficient appropriate audit evidence is yet to be obtained regarding the Directors' future assessment as at 31 December 2024.

董事就評估二零二四年十二月三十一日本公司 的持續經營能力需考慮當時狀況及情況,並需 包括涵蓋由二零二四年十二月三十一日起計不 少於十二個月期間的現金流量預測。因此,核 數師無法純粹基於行動計劃確定能否於下一個 財政年度剔除審核保留意見,因尚未就董事於 二零二四年十二月三十一日的未來評估取得充 分適當審核憑證。

Having said that, the Audit Committee considers that the proposed Action Plan would still be effective in assisting the Company to remove the Audit Qualification in the next financial year given that, in particular, the Company is contemplating to conduct further fundraising activities to generate cash flows, and the proceeds generated thereof can be used by the Company to fully or partially to settle the Current Bank Borrowings and Overdue Bank Borrowings. In addition, the Company will also consider selling certain property, plant and equipment to fully or partially settle the Current Bank Borrowings and Overdue Bank Borrowings. Therefore, assuming if (i) the Company and the creditors (including the local creditor banks in the PRC) have come up with a preliminary plan in settling the outstanding debts, and/or the Current Bank Borrowings and Overdue Bank Borrowings can be settled by the proceeds generated from the future fundraising activities conducted by the Company or proceeds for disposal of property, plant and equipment; and (ii) there is a satisfactory completion of review of the Directors' assessment of the Company's going concern by the Auditor together with sufficient and appropriate evidence, the Audit Qualification is expected to be removed in connection with the audit of the consolidated financial statements of the Group for the year ending 31 December 2024.

Impact of the Audit Qualification on the Company's financial position

Should the Group fail to achieve the Action Plans, it might not be able to continue to operate as a going concern, and adjustments would have to be made to write down the carrying value of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities. The effect of these adjustments has not been reflected in the consolidated financial statements of the Group for the year ended 31 December 2023. 儘管如此,審核委員會認為建議的行動計劃仍 將有效地幫助本公司在下一個財政年度剔除審 核保留意見,特別是考慮到本公司正在考慮開 展進一步的籌資活動以產生現金流,而本公司 可將由此產生的所得款項全部或部分用於清償 即期銀行借款及逾期銀行借款。此外,本公司 還將考慮出售若干物業、廠房及設備,以全部 或部分清償即期銀行借款及逾期銀行借款。因 此,假設(i)本公司及債權人(包括中國之當地債 權銀行)就尚欠債務達成初步之還款計劃,及/ 或即期銀行借款及逾期銀行借款可通過本公司 未來開展的籌資活動所產生的所得款項或處置 物業、廠房及設備的所得款項進行結算;及(ii) 建同充分適當憑證圓滿地完成審閱管理層對本 公司持續經營的評估,預期可就審核本集團截 至二零二四年十二月三十一日止年度的綜合財 務報表剔除審核保留意見。

審核保留意見對本公司財務狀況的影響

倘本集團未能實施上述計劃行動,其未必能在 持續經營的基礎上繼續經營,本集團須作出調 整以將其資產賬面價值撇減至資產之可收回金 額,以就可能進一步產生的負債計提撥備,同 時將非流動資產及非流動負債重新分類為流動 資產和流動負債。該等調整的影響尚未反映於 本集團截至二零二三年十二月三十一日止年度 的綜合財務報表中。

The Company has adopted the Corporate Governance Code (the "CG Code") contained in Appendix C1 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (the "Listing Rules") as its own code of corporate governance. The manner in which the principles and code provisions in the CG Code are applied and implemented during the year ended 31 December 2023 and up to the date of this annual report (the "Period") is explained in this Corporate Governance Report.

CORPORATE GOVERNANCE

The Company was committed to maintaining high level of corporate governance and has steered its development and protected the interests of its shareholders in an enlightened and open manner. The Board comprises three executive Directors and three independent non-executive Directors. The Board has complied with the applicable code provisions as set out in the CG Code throughout the year save for code provision C.1.8.

Code provision C.1.8 of the CG Code stipulates that the Company should arrange appropriate insurance cover in respect of legal action against its Directors. Currently, the Company does not consider necessary to have insurance cover for legal action against its Directors and will monitor any changes to the situation and make necessary action. The Board believes with the current internal control system and the close supervision of the management, the Directors' risk of being sued or getting involved in litigation in their capacity as Directors is relatively low.

The Company will, from time to time, review and enhance its corporate governance practices to ensure that these continue to meet the requirements of the CG Code.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") set out in Appendix C3 to the Listing Rules as its code of conduct regarding dealings in the securities of the Company by the Directors.

Having made specific enquiries, all the Directors confirmed that they have complied with the required standards set out in the Model Code during the Year. Employees who are likely to be in possession of inside information of the Company are also subject to compliance with guidelines on no less exacting terms than the Model Code. 本公司已採納香港聯合交易所有限公司(「聯交 所」)證券上市規則(「上市規則」)附錄C1所載 的企業管治守則(「企業管治守則」)為其自身 企業管治守則。截至二零二三年十二月三十一 日止年度至截至本年報日期止(「期間」),企業 管治守則內的有關原則及守則條文的應用及實 施方式於本企業管治報告內説明。

企業管治

本公司致力於保持高水平企業管治,以開明和 開放的理念維護本公司的發展及保障股東的權益。董事會由三位執行董事及三位獨立非執行 董事組成。除守則條文第C.1.8條外,董事會已 於整個年度內遵守企業管治守則載列之適用守 則條文。

企業管治守則之守則條文第C.1.8條規定,本公 司應就向其董事提出的法律行動安排合適的保 險保障。目前,本公司認為暫無必要就向其董 事提出的法律行動提供保險保障,惟將會監控 任何情況變動以作出必要行動。董事會相信, 透過現有的內部監控系統及管理層的密切監督, 各董事以董事身份被控告或牽涉於訴訟的風險 相對較低。

本公司將不時審閱及加強其企業管治常規以確 保其持續符合企業管治守則的規定。

董事的證券交易

本公司已採納上市規則附錄C3所載的上市發 行人董事進行證券交易的標準守則(「標準守 則」),作為董事進行本公司證券交易的行為守 則。

於作出特定查詢後, 全體董事確認彼等於年內 已遵守標準守則所載規定準則。可能取得本公 司內幕消息的僱員亦須遵守其條款不遜於標準 守則的指引。

THE BOARD OF DIRECTORS

Responsibilities

The Board is responsible for leadership and control of the Company and oversees the businesses, strategic decisions and performance of the Group. The Board has delegated to the executive Directors and senior management the authority and responsibility for the day-to-day management and operation of the Group. In addition, the Board has established Board committees and has delegated to these Board committees various responsibilities as set out in their respective terms of reference.

All Directors carry out duties in good faith, in compliance with applicable laws and regulations, and in the interests of the Company and its shareholders at all times.

Board Composition

The Board currently comprises six members, consisting of three executive Directors and three independent non-executive Directors.

The Company has throughout the Period met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors with at least one independent non-executive Director possessing appropriate professional qualifications, and accounting or related financial management expertise. At all times during the Period, the independent non-executive Directors represent at least one-third of the Board.

董事會 責任

董事會負責領導及監控本公司並監察本集團的 業務、策略性決定及表現。董事會已向執行董 事及高級管理層轉授本集團日常管理及營運的 權力及責任。此外,董事會已設立董事委員會, 並向該等董事委員會轉授其各自職權範圍載列 的各項責任。

全體董事時刻本著誠信,根據適用法律及法規 及從本公司及其股東利益出發履行職責。

董事會組成

董事會目前由六名成員組成,包括三名執行董 事及三名獨立非執行董事。

本公司於整個期間一直履行上市規則有關委任 至少三名獨立非執行董事且至少一名獨立非執 行董事須具備合適專業資格以及會計或相關財 務管理專業知識的規定。於整個期間,獨立非 執行董事至少佔董事會三分之一席位。

The Company has received written annual confirmation from each independent non-executive director of his independence pursuant to the requirements of the Listing Rules. The Company considers all independent non-executive Directors to be independent in accordance with the independence guidelines as set out in the Listing Rules.

All Directors, including the independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. Independent non-executive Directors are invited to serve on the Audit Committee, Remuneration Committee and Nomination Committee of the Company.

The Board members have no financial, business, family or other material/relevant relationship with each other.

Chairman and Chief Executive Officer

As at the date of this annual report, the Acting Chairman of the Company, Mr. Li Wanyuan, leads the Board in the determination of the strategy of the Group and in the achievement of its objectives. He is responsible for organizing the business of the Board, ensuring its effectiveness and setting agenda but not involved in the day-to-day business of the Group.

Mr. Liu Junting has been appointed as the Chief Executive Officer of the Company since 2 August 2023. The duties and responsibilities of the Chief Executive Officer of daily operation of the Group are carried out by the executive Directors and they are accountable to the Board for financial and operational performance of the Group.

Appointment and Re-election of Directors

Pursuant to the Company's Bye-laws, at each annual general meeting of the Company, one third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement by rotation at least once every three years. The Directors to retire by rotation shall include any Director who wishes to retire and not to offer himself for reelection. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment and so that as between persons who became or were last re-elected Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. Any Director appointed pursuant to Bye-law 83(2) shall not be taken into account in determining which particular Directors or the number of Directors who are to retire by rotation.

The following Directors will retire by rotation and offer themselves for re-election in the forthcoming AGM to be held on 24 May 2024:

The procedures and process of appointment, re-election and removal of directors are laid down in the Company's articles of association. Pursuant to the Company's articles of association, all Directors are subject to retirement by rotation at least once every three years and any new Director appointed to fill a causal vacancy shall hold office until the first general meeting of the Company after his appointment and be eligible for re-election and any Director appointed as an addition to the Board shall hold office until the next annual general meeting of the Company after his appointment and be eligible for re-election. Where vacancies arise at the Board, candidates will be proposed and put forward to the Board by the Nomination Committee.

Induction and Continuing Development of Directors

Each newly appointed Director receives a comprehensive induction on the first occasion of his appointment to ensure appropriate understanding of the business and operations of the Company and full awareness of director's responsibilities and obligations under the Listing Rules and relevant statutory requirements.

According to code provision C.1.4 of the CG Code, all Directors should participate in continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. The Company should be responsible for arranging and funding suitable training, as well as placing an appropriate emphasis on the roles, functions and duties of the Directors.

During the Period, the Company has provided seminars for the Directors on updates of the Listing Rules and the CG Code. The Directors are also encouraged to keep up-to-date their knowledge of directors' duties and responsibilities by reading relevant materials or attending relevant training courses.

Board Meetings

Board Practices and Conduct of Meetings

Directors' resolutions were passed by way of written resolutions or by physical meetings during the Period. The Board is expected to meet regularly and at least two times a year. The Company has to comply with the CG Code provisions with regard to the conduct of meetings, has annual meeting schedules and draft agenda of each meeting made available to directors in advance and serve notice of regular Board meetings to all directors at least 14 days before the meeting. For other Board and committee meetings, reasonable notice is required to be given.

Board papers together with all appropriate, complete and reliable information have to be sent to all Directors at least 3 days before each Board meeting or committee meeting to keep Directors apprised of the latest developments and financial position of the Company and to enable them to make informed decisions. The Board and each Director also have separate and independent access to the senior management where necessary.

The Bye-laws contain provisions requiring Directors to abstain from voting and not to be counted in the quorum at meetings for approving transactions in which such directors or any of their associates have a material interest. 本公司須遵守企業管治守則中有關會議程序、 年度會議日程表及召開每次會議前向董事發出 草擬議程,以及於常規董事會會議前至少14日 向全體董事送達通知的條文。如屬其他董事會 及委員會會議,則須發出合理通知。

BOARD COMMITTEES

The Company established a nomination committee (the "Nomination Committee"), a remuneration committee (the "Remuneration Committee") and an audit committee (the "Audit Committee") on 27 March 2014 with written terms of reference in compliance with the CG Code. The Company also established a regulatory compliance committee (the "Regulatory Compliance Committee") on 26 February 2014.

Nomination Committee

The Nomination Committee comprises three members namely Mr. Li Wanyuan, Mr. Lin Yugang, and Mr. Chow Yun Cheung. Mr. Li Wanyuan was appointed as the chairman of the Nomination Committee on 2 August 2023.

The primary duties of the Nomination Committee include reviewing the Board structure and composition, developing and formulating relevant procedures for nomination and appointment of directors, making recommendations to the Board on the appointment and succession planning of directors, and assessing the independence of the independent non-executive Directors based on criteria such as integrity, accomplishment, experience, professional and educational background and time commitments.

DIRECTOR NOMINATION POLICY

The director nomination policy of Company aims to set out the criteria and process in the nomination and appointment of directors of the Company; ensure that the board (the "Board") of directors of the Company has a balance of skills, experience and diversity of perspectives appropriate to the Company; and ensure the Board continuity and appropriate leadership at Board level.

董事委員會

本公司於二零一四年三月二十七日根據企業管 治守則成立提名委員會(「提名委員會」)、薪酬 委員會(「薪酬委員會」)及審核委員會(「審核 委員會」),並制訂書面職權範圍。本公司亦於 二零一四年二月二十六日成立監管合規委員會 (「監管合規委員會」)。

提名委員會

提名委員會包括三名成員,即李萬元先生、林 宇剛先生及周潤璋先生。李萬元先生於二零 二三年八月二日獲委任為提名委員會主席。

提名委員會的主要職責包括檢討董事會架構及 組成、草擬及制定提名及委任董事的相關程序、 就董事委任及接任計劃向董事會作出建議及根 據操守、成就、經驗、專業及教育背景以及投入 之時間等基準評估獨立非執行董事的獨立性。

董事提名政策

本公司董事提名政策旨在載列本公司提名及委 任董事的標準及程序:確保本公司的董事會(「董 事會」)成員具備切合本公司所需的技能、經驗 及多元觀點:及確保董事會的持續性及維持董 事會層面的適當領導角色。

Criteria for nomination and appointment of Directors

The criteria for selecting any candidate for directorship are set out as follows:

- bringing an independent judgment and making constructive recommendation on issues of strategy, policy, performance, accountability, resources, key appointments and standards of conducts;
- taking the lead where potential conflicts of interests arise;
- serving on the Audit Committee, and the Remuneration Committee and the Nomination Committee (in the case of candidate for Non-Executive Director) and other relevant Board Committees, if invited;
- devoting sufficient time to the Board and/or any Committee(s) on which he or she serves so as to allow them to benefit from his or her skills, expertise, and varied backgrounds and qualifications and diversity through attendance and participation in the Board;
- scrutinising the Company's performance in achieving agreed corporate goals and objectives, and monitoring the reporting of performance;
- ensuring the Nomination Committees on which he or she serves to perform their powers and functions conferred on them by the Board; and
- conforming to any requirement, direction and regulation that may from time to time be prescribed by the Board or contained in the constitutional documents of the Company or imposed by legislation or the Listing Rules, where appropriate.

If the candidate is proposed to be appointed as an INED, his or her independence shall be assessed in accordance with, among other things, the factors as set out in Rule 3.13 of the Listing Rules, subject to any amendments as may be made by the Stock Exchange from time to time. Where applicable, the totality of the candidate's education, qualifications and experience shall also be evaluated to consider whether he or she has the appropriate professional qualifications or accounting or related financial management expertise for filling the office of an INED with such qualifications or expertise as required under Rule 3.10(2) of the Listing Rules.

董事提名及委任標準

- 對董事會及/或所服務的任何委員會投入 充足時間,從而透過出席及參與董事會而 令董事會及任何委員會受惠於其技能、專 長、各種背景及資格以及多元觀點;
- 監察本公司在達致議定企業宗旨及目標 方面的表現以及監督表現的申報情況;
- 確保所服務的提名委員會履行董事會授 予的權力及職能;及
- 遵守董事會不時指定或本公司章程文件 不時所載或法例或上市規則不時施加的 任何規定、指示及規例(如適用)。

如建議委任候選人為獨立非執行董事,則須根 據(其中包括)上市規則第3.13條(經聯交所可 能不時作出修訂)所載的因素評估其獨立性。如 適用,則亦須評估該候選人的學歷、資格及經 驗等整體情況,以考慮其是否具備合適的專業 資格或會計或相關財務管理專長(即上市規則 第3.10(2)條所規定的相關資格或專長)以擔任 獨立非執行董事。

Nomination process

(a) Appointment of New Director

- (i) The Nomination Committee and/or the Board should, upon receipt of the proposal on appointment of new director and the biographical information (or relevant details) of the candidate, evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship.
- (ii) If the process yields one or more desirable candidates, the Nomination Committee and/or the Board should rank them by order of preference based on the needs of the Company and reference check of each candidate (where applicable).
- (iii) The Nomination Committee should then recommend to the Board to appoint the appropriate candidate for directorship, as applicable.
- (iv) For any person that is nominated by a shareholder for election as a director at the general meeting of the Company, the Nomination Committee and/or the Board should evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship. Where appropriate, the Nomination Committee and/or the Board should make recommendation to shareholders in respect of the proposed election of director at the general meeting.

(b) Re-election of Director at General Meeting

- (i) The Nomination Committee and/or the Board should review the overall contribution and service to the Company of the retiring director and the level of participation and performance on the Board.
- (ii) The Nomination Committee and/or the Board should also review and determine whether the retiring director continues to meet the criteria as set out above.
- (iii) The Nomination Committee and/or the Board should then make recommendation to shareholders in respect of the proposed re-election of director at the general meeting.

(c) Re-election of INED at General Meeting

Where the Board proposes a resolution to elect an individual as an INED at the general meeting, it should set out in the circular to shareholders and/or explanatory statement accompanying the notice of the relevant general meeting:

- the process used for identifying the individual and why the Board believes the individual should be elected and the reasons why it considers the individual to be independent;
- (ii) if the proposed INED will be holding their seventh (or more) listed company directorship, why the Board believes the individual would still be able to devote sufficient time to the Board;
- (iii) the perspectives, skills and experience that the individual can bring to the Board; and
- (iv) how the individual contributes to diversity (including gender diversity) of the Board.

The Nomination Committee will conduct regular review on the structure, size and composition of the Board and this Policy and where appropriate, make recommendations on changes to the Board to complement the Company's corporate strategy and business needs, to comply with all applicable laws and regulations from time to time and maintain good corporate governance practice.

On 27 March 2014, the Board adopted a board diversity policy which aims to set out the approach to achieve diversity on the Board. All Board appointments will be based on merit while taking into account diversity including gender diversity. The Nomination Committee will regularly review the measurable objectives to ensure its effectiveness to achieve diversity on the Board. The following measurable objectives have been set for implementing the board diversity policy:

- inclusion of candidates for Board members with overseas working experience (outside of PRC);
- ensuring that there is no limitation on gender on selection of Directors;
- inclusion of candidates for Board members with working experience in other industries; and
- inclusion of candidates for Board members with knowledge and skills in different aspects.

As at the date of this annual report, the above objectives have been achieved, 1 out of 6 members of the Board has overseas working experience and 2 out of 6 members of the Board have accounting or other professional qualifications.

The Nomination Committee shall meet at least once a year. The Nomination Committee has adopted a written nomination procedure (the "Nomination Procedure") specifying the process and criteria for the selection and recommendation of candidates for directorship of the Company. The Nomination Committee shall, based on those criteria as set out in the Nomination Procedure (such as appropriate experience, personal skills and time commitment etc.), identify and recommend the proposed candidate to the Board for approval of an appointment.

New Directors, on appointment, will be given an induction package containing all key legal and Listing Rules' requirements as well as guidelines on the responsibilities and obligations to be observed by a Director. The package will also include the latest published financial reports of the Company and the documentation for the corporate governance practices adopted by the Board. The senior management will subsequently conduct such briefing as is necessary to give the new Directors more detailed information on the Group's businesses and activities.

Remuneration Committee

The Remuneration Committee comprises three members who are all the independent non-executive Directors, namely Mr. Lin Yugang, Mr. Chow Yun Cheung and Mr. Li Gang. Mr. Lin Yugang is the chairman of the Remuneration Committee.

The primary functions of the Remuneration Committee include making recommendations on and approving the remuneration policy and structure and remuneration packages of the executive Directors and the senior management. GOING CONCERN ISSUE

The Group incurred a loss of approximately RMB816,320,000 for the year ended 31 December 2023, the Group had net current liabilities and capital deficiency of approximately RMB339,788,000 and RMB146,126,000 respectively as at 31 December 2023. In addition, as disclosed in note 25 to the consolidated financial statements, as at 31 December 2023, the Group's bank borrowings of approximately RMB200,371,000 are subject to renewal or to be fully repaid within the next twelve months, of which approximately RMB162,864,000 were overdue. Furthermore, The Group recorded net operating cash outflow of approximately RMB120,283,000 for the year ended 31 December 2023 with the Group's total bank and cash balance remaining at a low level of RMB17,377,000 as of 31 December 2023. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern. Therefore, the Group may be unable to realise its assets and discharge its liabilities in the normal course of business.

持續經營事宜

截至二零二三年十二月三十一日止年度,本集 團產生虧損約人民幣816,320,000元,而於二零 二三年十二月三十一日[,]本集團有流動負債淨 額及資本虧絀分別約人民幣339,788,000元及 人民幣146,126,000元。此外,如合併財務報表 附註25所披露,於二零二三年十二月三十一日, 本集團約人民幣200,371,000元的銀行借款須 重續或於未來十二個月內悉數償付,其中約人 民幣162,864,000元已逾期。另外,本集團於截 至二零二三年十二月三十一日止年度錄得經營 現金流出淨額約人民幣120,283,000元,且截至 二零二三年十二月三十一日,本集團的銀行及 現金結餘總額維持在人民幣17,377,000元的低 位。該等情況説明存在重大不明朗因素,可能 對本集團的持續經營能力造成重大疑問。因此, 本集團可能無法於正常業務過程中變現資產及 償還債務。

Having carefully considered the liquidity and working capital requirements for the next twelve months, the directors of the Company are of the opinion that it is appropriate to prepare the consolidated financial statements on going concern basis. Certain plans and measures have been or will be taken by director of the Company to mitigate the Group's liquidity pressure and to improve its cashflows which include, but are not limited to, the following:

- (a) The Group will negotiate with certain financial institutions, including the existing major lenders, for options of restructuring of the Group's existing borrowings or new financing;
- (b) The Group will continue its ongoing efforts to convince the lenders of the defaulted borrowing not to take any actions against the Group for immediate payment of the principals and interest of these borrowings;
- (c) Obtain external source of funding from potential investors by issuance of new shares; and
- (d) The Directors of the Company have been taking various cost control measures to tighten the costs of operations and capital expenditure and implementing various strategies to enhance the Group's revenue.

The Directors of the Company are of the opinion that, considering the abovementioned plans and measures, the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within twelve months from 31 December 2023. Accordingly, they are satisfied that it is appropriate to prepare the consolidated financial statements on a going concern basis.

經審慎考慮未來十二個月的流動資金及營運資金 需求後,本公司董事認為以持續經營為基礎編製 合併財務報表是適當的。本公司董事已或將要採 取若干計劃及措施,以紓緩本集團的流動資金壓 力及改善其現金流狀況,包括但不限於以下內容:

- (a) 本集團將與若干金融機構(包括現有主要貸款人)就重組本集團現有借款或新融資的方案進行磋商;
- (b) 本集團將繼續努力說服違約借款的貸款人 不要對本集團採取任何行動,要求立即償還 該等借款的本金及利息;
- (c) 通過發行新股從潛在投資者獲得外部資金 來源;及
- (d) 本公司董事一直採取各項成本控制措施以 收緊營運成本及資本開支,並實施多項策略 以增加本集團的收入。

本公司董事認為,考慮到上述計劃及措施,本集 團將有足夠的營運資金為其營運提供資金,並在 二零二三年十二月三十一日起十二個月內到期時 履行其財務責任。因此,彼等確信根據持續經營 基準編製合併財務報表屬適當。

Notwithstanding the above, material uncertainties exist as to whether the Group will be able to achieve its plans and measures as described above. Whether the Group will be able to continue as a going concern would depend upon the following:

- (a) successfully securing new financing from the financial institutions to fund its operations and financial obligations as well as restructuring of the existing borrowings to extend the payment schedule;
- (b) successful negotiations with the lenders of the defaulted borrowing that they will not take any actions against the Group to exercise their rights to demand immediate payment of the principals and interests of these borrowings;
- (c) successful obtain external source of funding from potential investors by issuance of new shares; and
- (d) the Group's ability to generate operating cash flows to meet the Group's ongoing funding needs as well as successfully controlling operations costs and capital expenditure, and implementing various strategies to enhance the Group's revenue.

Should the Group be unable to continue as a going concern, adjustments would have to be made to the consolidated financial statements, to write down the value of assets to their recoverable amounts, to provide for further liabilities which might arise and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effect of these adjustments has not been reflected in the consolidated financial statements.

- (c) 成功通過發行新股從潛在投資者獲得外部 資金來源;及
- (d) 本集團產生營運現金流,以滿足本集團的持續資金需求的能力,以及成功控制營運成本 及資本開支,並實施多項策略提升本集團之 收益。

倘本集團無法持續經營,則必須對合併財務報表 作出調整,以將資產之價值撇減至其可收回金額, 以撥備可能出現之任何額外負債,並將非流動資 產及非流動負債分別重新分類為流動資產及流動 負債。該等調整之影響並無於合併財務報表內反 映。

DELEGATION OF MANAGEMENT FUNCTIONS

The Board reserves for its decision all major matters of the Company including approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of directors and other significant financial and operational matters.

All Directors have full and timely access to all relevant information as well as the advice and services of the Company Secretary, with a view to ensure that Board procedures and all applicable laws and regulations are followed. Each Director is normally able to seek independent professional advice in appropriate circumstances at the Company's expense, upon making request to the Board.

The day-to-day management, administration and operation of the Company are delegated to the executive Directors and the senior management. The delegated functions and responsibilities are periodically reviewed. Approval has to be obtained from the Board prior to any significant transactions entered into by the aforesaid officers.

ACCOUNTABILITY AND AUDIT

The Directors acknowledge their responsibility for preparing the financial statements of the Company for the year ended 31 December 2023.

The Board is responsible for presenting a balanced, clear and understandable assessment of annual and interim reports, price sensitive announcements and other disclosures required under the Listing Rules and other statutory and regulatory requirements.

The management has provided to the Board such explanation and information as are necessary to enable the Board to carry out an informed assessment of the Company's financial statements, which are put to the Board for approval.

The reporting responsibility of the external auditor of the Company on the consolidated financial statements of the Group are set out in the Independent Auditor's Reports in this annual report.

管理職能之轉授

本公司日常管理、行政及營運轉授予執行董事 及高級管理人員。轉授的職能及職責會定期檢 討。上述高級職員在訂立任何重大交易前須向 董事會取得批准。

問責及審核

董事確認彼等編製本公司截至二零二三年十二 月三十一日止年度財務報表之責任。

根據上市規則規定及其他法定及監管規定,董 事會須負責就年度及中期報告、股價敏感公告 及其他披露呈報持平、清晰且易於理解之評估。

管理層向董事會提供所需相關説明及資料,使 董事會可就提呈董事會批准之本公司財務報表 作出知情評估。

本公司外聘核數師關於本集團合併財務報表的申報責任載於本年報獨立核數師報告。

INTERNAL CONTROL AND RISK MANAGEMENT

The Board is responsible for maintaining an adequate internal control system to safeguard shareholder investments and Company assets and with the support of the Audit Committee, reviewing the effectiveness of such system on an annual basis. The Group has developed its systems of internal control and risk management. The internal control system of the Group is designed to facilitate effective and efficient operations, to ensure reliability of financial reporting and compliance with applicable laws and regulations, to identify and manage potential risks and to safeguard assets of the Group.

Certain internal control deficiencies were identified and reported to the Board. The Group is ongoing to locate an internal control advisor to review the internal control system of the Group, and conduct remedies for any deficiencies identified on considered necessary in due course.

AUDITOR'S REMUNERATION

For the year ended 31 December 2023, the remuneration paid/payable to the Company's auditor, McMillan Woods (Hong Kong) CPA Limited, amounted to approximately RMB996,000 in respect of the annual audit service.

INDEPENDENT AUDITOR

The Audit Committee reviews and monitors the independent auditor's independence, objectivity and effectiveness of the audit process. It receives letter every year from the independent auditor confirming their independence and objectivity and holds meetings with representatives of the independent auditor to consider the scope of its audit, approve its fees, and the scope and appropriateness of non-audit services, if any, to be provided by it. The Audit Committee also makes recommendations to the Board on the appointment and retention of the independent auditor.



The Directors to retire by rotation shall include any Director who wishes to retire and not to offer himself for reelection. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment and so that as between persons who became or were last re-elected Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. None of the Directors has a service contract with the Company or any of its subsidiaries which is not determinable by the Group within one year without payment of compensation other than statutory compensation.

DISCLOSURE PURSUANT TO RULE 13.51B(1) OF THE LISTING RULES

Pursuant to the service contracts entered into by each of executive directors as disclosed in the paragraph headed "Directors' services contracts" above, each of Mr. Li Wanyuan, Mr. Liu Junting and Ms. Lin Yuxi is entitled to a monthly salary of HK\$30,000, HK\$20,000 and HK\$20,000, respectively. REPORT EMOLUMENT POLICY

The emolument policy of the employees of the Group is set up by the management on the basis of their merit, qualifications and competence.

The Remuneration Committee considers and recommends to the Board on the remuneration and other benefits paid by the Company to the Directors by reference to the Company's operating results, individual performance and comparable market rates. The remuneration of all Directors is subject to regular monitoring by the Remuneration Committee to ensure that the levels of their remuneration and compensation are appropriate.

As at 31 December 2023, the Group had a total workforce of 190 (as at 31 December 2022: 167). Employee costs including directors' emoluments totalled RMB31.8 million for the year of 2023 (2022: RMB10.7 million). The Group recruited and promoted individual persons according to their strength and development potential. The Group determined the remuneration packages of all employees including the Directors with reference to individual performance and current market salary scale.

The Group regularly reviews the emolument package of the existing employees, considers increment of salaries and conducts some long term incentive scheme when appropriate.

The Board may, at its discretion, grant options pursuant to the Share Option Scheme to Directors (including the independent non-executive Directors), the Company's subsidiaries, employees of the Group and other persons the Board considers have contributed or will contribute to the Group. The maximum number of shares in respect of which options may be granted under the Share Option Scheme must not in aggregate exceed 10% of the issued share capital of the Company (i.e. 100,000,000 shares), unless otherwise approved by the shareholders of the Company in general meeting and/or other requirements prescribed under the Listing Rules. The subscription price of a share in respect of a particular option shall be not less than the highest of (a) the official closing price of the Shares on the daily quotation sheet of the Stock Exchange; (b) the average official closing price of the shares on the daily quotation sheet of the Stock Exchange for the five business days immediately preceding the date of grant; and (c) the nominal value of a share. The Share Option Scheme shall remain effective within a period of 10 years from that date.

As at 31 December 2015 and 2016, 50,000,000 share options and 50,000,000 share options were granted and exercised, respectively, representing maximum number of shares to be granted under the Share Option Scheme. The aggregate purchases attributable to the Group's largest and five largest suppliers were 25% and 43% of the Group's total purchases respectively during the year under review (2022: 17% and 49%).

During the year, none of the Directors, their associates or any shareholders (who to the knowledge of the Directors owned more than 5% of the issued share capital of the Company) had any interest in any of the five largest customers or suppliers of the Group.

The Board intends to adopt a prudent dividend payment policy which will base on the main factor of the Group's profitability for the year. The Board has resolved not to recommend the payment of any final dividend for the year ended 31 December 2023 (2022: Nil). As there is no interim dividend payable during the year, there will be no dividend distribution for the whole year at 2023.

We were engaged to audit the consolidated financial statements of Moody Technology Holdings Limited (the "Company") and its subsidiaries (the "Group") set out on pages 67 to 162, which comprise the consolidated statement of financial position as at 31 December 2023, and the consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of material accounting policy information.

We do not express an opinion on the consolidated financial statements of the Group. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient and appropriate audit evidence to provide a basis for an audit opinion on these consolidated financial statements. In all other respects, in our opinion, the consolidated financial statements have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

吾等並無就 貴集團合併財務報表發表任何意 見。由於吾等之報告不發表意見的基準一節所 述事宜的重大性,吾等未能獲取充足及適當的 審核證據,作為就該等合併財務報表發表審核 意見的依據。在所有其他方面,吾等認為,合併 財務報表已遵照香港公司條例的披露規定妥為 編製。

BASIS FOR DISCLAIMER OF OPINION

Material uncertainty related to going concern

We draw attention to note 3 to the consolidated financial statements which mentions that the Group incurred a loss of approximately RMB816,320,000 for the year ended 31 December 2023, and as at 31 December 2023, the Group had net current liabilities and capital deficiency of approximately RMB339,788,000 and RMB146,126,000, respectively. In addition, as disclosed in note 25 to the consolidated financial statements, as at 31 December 2023, the Group's bank borrowings of approximately RMB200,371,000 are subject to renewal or to be fully repaid within the next twelve months, of which approximately RMB162,864,000 were overdue. Furthermore, the Group recorded net operating cash outflow of approximately RMB120,283,000 for the year ended 31 December 2023 with the Group's total bank and cash balance remaining at a low level of approximately RMB17,377,000 as of 31 December 2023. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern.

The directors of the Company have been undertaking a number of plans and measures to improve the Group's liquidity and financial position, which are set out in note 3 to the consolidated financial statements. The consolidated financial statements have been prepared on a going concern basis, the validity of which depends on the outcome of these plans and measures, which are subject to multiple uncertainties, including:

- a. successfully secure new financing from the financial institutions to fund its operations and financial obligations as and when they fall due as well as restructuring of the existing borrowings by extending the payment schedule;
- b. successful negotiations with the lenders of the defaulted borrowings that they will not take any actions against the Group to exercise their rights to demand immediate payment of the principals and interests of these borrowings;
- c. successful obtain external source of funding from potential investors by issuance of new shares; and
- d. the Group's ability to generate operating cash flows to meet the Group's ongoing funding needs as well as successfully control operations costs and capital expenditure, and implementing various strategies to enhance the Group's revenue.

As a result of these multiple uncertainties, the potential interaction of these uncertainties, and the possible cumulative effect thereof, we were unable to form an opinion as to whether the going concern basis of preparation is appropriate. Should the Group fail to achieve the abovementioned plans and measures, it might not be able to continue to operate as a going concern, and adjustments would have to be made to write down the carrying value of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise and to reclassify non-current assets and noncurrent liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in these consolidated financial statements.

1. CORPORATE INFORMATION

Moody Technology Holdings Limited (the "Company") was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands on 29 April 2013. On 23 May 2019, the board of directors of the Company (the "Board") has been de-registered in the Cayman Islands and duly continued in Bermuda as an exempted company under the laws of Bermuda (the "Change of Domicile"). The address of its registered office is Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda. The principal place of business of the Company in Hong Kong is located at 20/F, Infinitus Plaza, 199 Des Voeux Road Central, Sheung Wan, Hong Kong. The Company's shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") since 25 April 2014 (the "Listing").

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 36 to the consolidated financial statements.

Winding-up petition and appointment of the joint and several provisional liquidators for restructuring purpose

On 20 September 2019, the Company received a petition (the "Petition") from Su Dajie (the "Petitioner"), a holder of the 2% bond and 2.5% bond in the principal amount of approximately HK\$3,000,000 and HK\$3,006,000 issued by the Company on 12 April 2018 and 13 April 2018 (collectively, the "Bonds") respectively, in the matter of the Companies (Winding Up and Miscellaneous Provisions) Ordinance (Chapter 32, Laws of Hong Kong) filed in the High Court of The Hong Kong Special Administrative Region (the "High Court") under Companies Winding-up Proceedings No. 283 of 2019, alleged that the outstanding indebtedness owed by the Company to him up to 11 March 2019 was approximately HK\$2,890,000. The winding up petition was heard before the High Court on 20 November 2019. In connection with the Petition, the Company has engaged professional parties to work out a restructuring plan for the Company's indebtedness. Such restructuring plan had been filed to the Supreme-Court of Bermuda (the "Bermuda Court").

於二零一九年九月二十日,本公司收到 蘇大傑(「呈請人」)(持有本公司於二 零一八年四月十二日發行的本金額約為 3,000,000港元的2%債券和本公司於二 零一八年四月十三日發行的本金額約為 3,006,000港元的2.5%債券(以下簡稱「本 債券」))就香港法例第32章公司(清盤及 雜項條文)條例向香港特別行政區高等法 院(「高等法院」)提交的呈請(「呈請」), 根據二零一九年第283號公司清盤程序, 聲稱截至二零一九年三月十一日,本公司 欠其未償債務為約2,890,000港元。清盤 呈請已於二零一九年十一月二十日於高 等法院進行聆訊。就呈請而言,本公司已 聘請專業人士編製有關本公司債務的財 務重組計劃。有關重組計劃已提交百慕達 最高法院(「百慕逹法院」)。

To facilitate the Company's financial restructuring, on 10 October 2019, a winding up petition together with an application for the appointment (the "JPL Application") of Tang Chung Wah and Kan Lap Kee of Shinewing Specialist Advisory Services Limited and Edward Alexander Niles Whittaker of R&H Services Limited respectively was appointed as joint and several provisional liquidators of the Company (together "JPLs") on a light touch approach for restructuring purpose was presented and filed with the Bermuda Court by the Company's Bermuda Counsel, Conyers Dill & Pearman at the request of the Company.

Under the JPL Application, the Company sought an order from the Bermuda Court so that the board of directors of the Company should under the monitoring of the JPLs, continue to manage the Company's affairs in all respects and exercise the powers conferred upon it by the Company's Memorandum of Association and Bye-laws, provided always that, the JPLs should have the power to seek such directions from the Bermuda Court as the JPLs are advised are appropriate to maximize the prospects of the financial restructuring being successful and to provide a moratorium to avoid a disorderly insolvency liquidation of the Company and its subsidiaries by any of the creditors who have threatened to commence liquidation proceedings.

On 5 March 2020, upon the joint application of the Petitioner and the Company by way of the consent summons, an order was made by the High Court that the Petition be dismissed.

On 11 November 2020, as part of the Company's debt restructuring scheme, the Company, together with JPLs, has formulated a restructuring transaction involving the issue of shares. On 18 May 2022, pursuant to the order dated 20 April 2022 made by the High Court, the High Court has directed that a meeting of creditors be convened for the purpose of considering and, if thought fit, approving (with or without modification) a creditors scheme of arrangement (the "Scheme") proposed to be made between the Company and the creditors of the Company in respect of claims against the Company which arose on or before the effective date of the Scheme.

Pursuant to the resolution to approve the Scheme was duly passed on 8 June 2022 and the Scheme has been sanctioned by the Hong Kong Court on 28 June 2022, the Scheme has become effective on 5 September 2022. The completion of issue of Scheme Shares under specific mandate (the "Completion") took place on 4 January 2023. An aggregate of 3,262,705,241 Scheme Shares were allotted and issued to the Scheme Creditors at the issue price of HK\$0.317 per Scheme Share for settlement of the all Admitted Claims of the Scheme Creditors totalling approximately HK\$1,034.3 million.

Upon Completion, all the Admitted Claims owing by the Company to the Scheme Creditors, including all amount owing by the Company under the Bonds (including the Notes), were discharged and released in full.

On 25 January 2024, the Hong Kong Court had made an order in modifying the Scheme (i) the identity of the scheme administrators be changed from Mr. Tang Chung Wah (Alan) and Mr. Kan Lap Kee (Terry) of SHINEWING Specialist Advisory Services Limited to Mr. Lai Wing Lun and Mr. Osman Mohammed Arab of Acclime Advisory Services Limited (the "New Scheme Administrators"); and (ii) the New Scheme Administrators will continue to complete all the outstanding procedures of the Scheme of arrangements as mentioned in the Scheme documents.

Details of the above are set out in the Company's announcements and circulars dated 11 November 2020, 11 April 2022, 18 May 2022, 9 June 2022, 28 June 2022, 21 July 2022, 5 September 2022, 4 January 2023 and 25 January 2024 respectively.

2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs") issued by International Accounting Standards Board (the "IASB"). IFRSs comprise International Financial Reporting Standards ("IFRS"); International Accounting Standards ("IAS"); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange and with the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). Material accounting policies adopted by the Group are disclosed below.

The IASB has issued certain new and revised IFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 4 provides information on any changes in accounting policies resulting from initial amendments to IFRS to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

3. GOING CONCERN BASIS

The Group incurred a loss of approximately RMB816,320,000 for the year ended 31 December 2023, the Group had net current liabilities and capital deficiency of approximately RMB339,788,000 and RMB146,126,000 respectively as at 31 December 2023. In addition, as disclosed in note 25 to the consolidated financial statements, as at 31 December 2023, the Group's bank borrowings of approximately RMB200,371,000 are subject to renewal or to be fully repaid within the next twelve months, of which approximately RMB162,864,000 were overdue. Furthermore, The Group recorded net operating cash outflow of approximately RMB120,283,000 for the year ended 31 December 2023 with the Group's total bank and cash balance remaining at a low level of RMB17.377.000 as of 31 December 2023. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern. Therefore, the Group may be unable to realise its assets and discharge its liabilities in the normal course of business.

截至二零二三年十二月三十一日止年度, 本集團產生虧損約人民幣816.320.000元, 而於二零二三年十二月三十一日,本集團 有流動負債淨額及資本虧絀分別約人民 幣339,788,000元及人民幣146,126,000 元。此外, 誠如合併財務報表附註25所披 露,於二零二三年十二月三十一日,本集 團約人民幣200,371,000元的銀行借款須 重續或於未來十二個月內悉數償付,其中 約人民幣162,864,000元已逾期。另外,本 集團於截至二零二三年十二月三十一日 止年度錄得經營現金流出淨額約人民幣 120,283,000元,且截至二零二三年十二 月三十一日,本集團的銀行及現金結餘總 額維持在人民幣17,377,000元的低位。此 等狀況表示存在重大不確定因素,可能對 本集團按持續經營基準經營的能力構成 重大疑慮。因此,本集團可能無法於正常 業務過程中變現資產及償還債務。

Having carefully considered the liquidity and working capital requirements for the next twelve months, the directors of the Company are of the opinion that it is appropriate to prepare the consolidated financial statements on going concern basis. Certain plans and measures have been or will be taken by director of the Company to mitigate the Group's liquidity pressure and to improve its cashflows which include, but are not limited to, the following:

- (a) The Group will negotiate with certain financial institutions, including the existing major lenders, for options of restructuring of the Group's existing borrowings or obtaining new financing;
- (b) The Group will continue its ongoing efforts to convince the lenders of the defaulted borrowing not to take any actions against the Group for immediate payment of the principals and interest of these borrowings;
- (c) Obtain external source of funding from potential investors by issuance of new shares; and
- (d) The directors of the Company have been taking various cost control measures to tighten the costs of operations and capital expenditure and implementing various strategies to enhance the Group's revenue.

The directors of the Company are of the opinion that, considering the abovementioned plans and measures, the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within twelve months from 31 December 2023. Accordingly, they are satisfied that it is appropriate to prepare the consolidated financial statements on a going concern basis.

Notwithstanding the above, material uncertainties exist as to whether the Group will be able to achieve its plans and measures as described above. Whether the Group will be able to continue as a going concern would depend upon the following:

- successfully secure new financing from the financial institutions to fund its operations and financial obligations as and when they fall due as well as restructuring of the existing borrowings by extending the payment schedule;
- (b) successful negotiations with the lenders of the defaulted borrowing that they will not take any actions against the Group to exercise their rights to demand immediate payment of the principals and interests of these borrowings;
- (c) successful obtain external source of funding from potential investors by issuance of new shares; and
- (d) the Group's ability to generate operating cash flows to meet the Group's ongoing funding needs as well as successfully control operations costs and capital expenditure, and implementing various strategies to enhance the Group's revenue.

Should the Group be unable to continue as a going concern, adjustments would have to be made to the consolidated financial statements, to write down the value of assets to their recoverable amounts, to provide for further liabilities which might arise and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effect of these adjustments has not been reflected in the consolidated financial statements.

5. MATERIAL ACCOUNTING POLICY INFORMATION

These consolidated financial statements have been prepared under the historical cost convention.

The preparation of financial statements in conformity with IFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 6.

The material accounting policies applied in the preparation of these consolidated financial statements are set out below.

(a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill and any accumulated foreign currency translation reserve relating to that subsidiary.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment loss.

(b) Associates

Associates are entities over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of an entity but is not control or joint control over those policies. The existence and effect of potential voting rights that are currently exercisable or convertible, including potential voting rights held by other entities, are considered when assessing whether the Group has significant influence. In assessing whether a potential voting right contributes to significant influence, the holder's intention and financial ability to exercise or convert that right is not considered.

Investment in an associate is accounted for in the consolidated financial statements by the equity method and is initially recognised at cost. Identifiable assets and liabilities of the associate in an acquisition are measured at their fair values at the acquisition date. The excess of the cost of the investment over the Group's share of the net fair value of the associate's identifiable assets and liabilities is recorded as goodwill. The goodwill is included in the carrying amount of the investment and is tested for impairment together with the investment at the end of each reporting period when there is objective evidence that the investment is impaired. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss.

The Group assesses whether there is an objective evidence that the interest in an associate may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with IAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill, that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with IAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group's share of an associate's post-acquisition profits or losses and other comprehensive income is recognised in consolidated statement of profit or loss and other comprehensive income. When the Group's share of losses in an associate equals or exceeds its interest in the associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the associate. If the associate subsequently reports profits, the Group resumes recognising its share of those profits only after its share of the profits equals the share of losses not recognised.

Unrealised profits on transactions between the Group and its associates are eliminated to the extent of the Group's interests in the associates. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the Group.

(c) Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Renminbi ("RMB"), which is the Company's functional and presentation currency.

(ii) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the company initially recognises such non-monetary assets or liabilities.

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

Property, plant and equipment, including buildings held for use in the production or supply of goods or services, or for administrative purposes (other than properties under construction as described below), are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The useful lives are as follows:

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

(e) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

(i) The Group as a lessee

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated nonlease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets, which for the Group are primarily office and factory. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases held by the Group, which does not have recent third-party financing, and
- makes adjustments specific to the lease, such as term, country, currency and security.

If a readily observable amortising loan rate is available to the individual lessee (through recent financing or market data) which has a similar payment profile to the lease, then the group entities use that rate as a starting point to determine the incremental borrowing rate.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Rental income from operating lease is recognised in profit or loss on a straight line bases over the term of the relevant lease.

Rental income which are derived from the Group's ordinary course of business are presented as revenue.

(f) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average basis. The cost of finished goods and work in progress comprises raw materials, direct labour and an appropriate proportion of all production overhead expenditure. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale. Costs necessary to make the sales include incremental costs directly attributable to the sale and nonincremental costs which the Group must incur to make sale.

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value except for trade receivable arising from contracts with customers which are initially measured in accordance with IFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

(i) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Receivables are stated at amortised cost using the effective interest method less allowance for expected credit losses ("ECL").

(j) Financial liabilities and equity instruments Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under IFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

(k) Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(I) Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

(m) Impairment of financial assets

The Group recognises a loss allowance for ECL on trade and other receivables. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

The Group always recognises lifetime ECL for trade and other receivables. The ECL on these financial assets are estimated using the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

For all other financial instruments, the Group recognises lifetime ECL when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forwardlooking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- (i) The financial instrument has a low risk of default.
- The debtor has a strong capacity to meet its (ii) contractual cash flow obligations in the near term, and
- (iii) Adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

The Group considers a financial asset to have low credit risk when the asset has external credit rating of "investment grade" in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of "performing". Performing means that the counterparty has a strong financial position and there is no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;
- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the counterparty will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date determined based on historical trend, the Group's understanding of the specific future financing needs of the debtors, and other relevant forward-looking information.

For financial assets, the ECL is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

(n) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated cash flow statement. Cash and cash equivalents are assessed for ECL.

(o) Revenue

Revenue is recognised when control over a product is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Sales of manufactured products

Revenue from the sale of manufactured products is recognised at a point in time when control of the goods has transferred, being when the goods have been shipped to the buyer's specific location (delivery). Following delivery, the buyer has full discretion over the manner of distribution and price to sell the goods, has the primary responsibility when on selling the goods and bears the risks of obsolescence and loss in relation to the goods. A receivable is recognised by the Group when the goods are delivered to the buyer as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due.

Provision of digital marketing services

The Group offers diversified digital marketing services including performance-based advertising services, displaybased advertising services and short video exposure services. To fulfill contracts with certain customers, the Group enters into cooperation agreements with third party platforms and places the advertisements of the Group's customers displayed on third party platforms. For above services mentioned, the Group is the principal for fulfilling these marketing service contracts as it has obtained controls over third party platform services through cooperation contracts. The Group is also primarily responsible for fulfilling these marketing services as it is the only party that the Group's customers entered agreements with. As such, the Group recognises revenues from contracts with customers on a gross basis and records charges from third party platforms as cost of revenues

(i) Performance-based advertising services

The Group provides performance-based advertising services which allow advertising customers to place links on the third parties' internet platforms. Performance-based advertising services are primarily presented and delivered in the way of short video with clickable thumbnails together with other recommended short videos or displayed between other short videos at varying frequency. Revenue from performance-based advertising services is recognised when relevant specific performance measures are fulfilled.

(ii) Display-based advertising services

Displayed advertisements appear in the form of opening-page splash advertisements, traditional banner ads and logos, etc. on various interfaces of the platform. The revenue is recognised ratably over the period that the advertising is displayed. Generally, the terms of these display-based advertisements are short term

(iii) Short video exposure services

The Group also provides short video exposure services where the customers pay for exposure of their short video to a targeted number of viewers for a specified period of time on the third parties' internet platforms. The Group has determined that each exposure to a target viewer represents one performance obligation. Revenue from each performance obligation is recognised when the short video or live show is exposed.

(p) Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period. Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) Pension obligations

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to profit or loss represents contributions payable by the Group to the funds.

(iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits, and when the Group recognises restructuring costs and involves the payment of termination benefits.

(q) Borrowing costs

Borrowing costs are recognised in profit or loss in the period in which they are incurred.

(r) Government grants

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Government grants relating to income are deferred and recognised in profit or loss over the period to match them with the costs they are intended to compensate.

Government grants relating to the purchase of assets are recorded as deferred income and recognised in profit or loss on a straight-line basis over the useful lives of the related assets.

(s) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of transaction does not give rise to equal taxable and deductible temporary difference.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis, or to realise the asset and settle the liability simultaneously.

(t) Impairment of non-financial assets

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit ("CGU") to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the cash-generating unit.

Value in use is the present value of the estimated future cash flows of the asset/cash-generating unit. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/cash-generating unit whose impairment is being measured.

Impairment losses for cash-generating units are allocated first against the goodwill of the unit and then pro rata amongst the other assets of the cash-generating unit. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

(u) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

(v) Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

Critical judgements in applying accounting policies

In the process of applying the accounting policies, the directors of the Company have made the following judgements that have the most significant effect on the amounts recognised in the consolidated financial statements (apart from those involving estimations, which are dealt with below).

(b) Significant increase in credit risk

ECL are measured as an allowance equal to 12-month ECL for stage 1 assets, or lifetime ECL for stage 2 or stage 3 assets. An asset moves to stage 2 when its credit risk has increased significantly since initial recognition. IFRS 9 does not define what constitutes a significant increase in credit risk. In assessing whether the credit risk of an asset has significantly increased the Group takes into account qualitative and quantitative reasonable and supportable forward-looking information.

(c) Revenue recognition

Determining whether the Group is acting as a principal or as an agent when a third-party is in the provision of certain services to its customers requires judgement and consideration of all relevant facts and circumstances. In evaluation of the Group's role as a principal or agent, the Group considers factors to determine whether the Group controls the specified goods or services before they transferred to the customer include, but are not limited to the following: (a) who is primarily responsible for fulfilling the contract, (b) who is subject to inventory risk, and (c) who has discretion in establishing prices.

(d) Property, plant and equipment used for generating for rental income

The Group has developed certain criteria in making judgements whether certain properties used for generating rental income are qualified and recognised in property, plant and equipment. Certain properties comprise a portion that is held to earn rental income, and another portion that is held for use in the operation of the Group's business. If portions could be sold separately or leased out separately under a finance lease, the Group accounts for the portions separately. Also the properties are classified as property plant and equipment if only insignificant portion used for generating rental income. Judgement is made in an individual property basis to determine whether the above criteria are so significant that property does not qualify as investment properties.

Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

(a) Impairment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets are stated at costs less accumulated depreciation and impairment. In determining whether an asset is impaired, the Group has to exercise judgement and make estimation, particularly in assessing: (1) whether an event has occurred or any indicators that may affect the asset value; (2) whether the carrying value of an asset can be supported by the recoverable amount; and (3) the appropriate key assumptions to be applied in estimating the recoverable amounts. Changing the assumptions and estimates could materially affect the recoverable amounts.

The carrying amount of property, plant and equipment and right-of-use assets as at 31 December 2023 were approximately RMB178,589,000 and RMB31,677,000 (2022: RMB168,459,000 and RMB16,693,000) respectively.

(b) Impairment losses for trade and other receivables

The management of the Group estimates the amount of impairment loss for ECL on trade receivables and other receivables based on the credit risk of trade receivables and other receivables. The amount of the impairment loss based on ECL model is measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition. Where the future cash flows are less than expected, or being revised downward due to changes in facts and circumstances, a material impairment loss may arise.

As at 31 December 2023, the total carrying amount of trade and other receivables is approximately RMB32,618,000 (net of allowance for ECL of approximately RMB10,054,000) (2022: RMB22,348,000 (net of allowance for ECL of approximately RMB1,798,000)).

The Group is subject to income taxes in several jurisdictions. Significant estimates are required in determining the provision for income taxes. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

During the year, RMB31,000 (2022: RMB662,000) of income tax was credited (2022: charged) to profit or loss based on the estimated profit.

(d) Impairment losses of prepayments

The Group assesses prepayments whether there are indicators of impairment for prepayments at the end of each reporting period. Prepayments are tested for impairment when there are indicators that the carrying amounts may not be recoverable. Impairment exists when the carrying amount of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs to sell and its value-in-use. The calculation of fair value less costs to sell is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value-in-use calculations are undertaken, management estimates the expected future cash flows from the asset or cash-generating unit and chooses a suitable discount rate in order to calculate the present value of those cash flows.

The carrying amount of prepayments as at 31 December 2023 were approximately RMB1,179,000 (net of allowance for doubtful debts of approximately RMB86,574,000) (2022: RMB12,868,000 (net of allowance for doubtful debts of approximately RMB84,855,000)).

The Group's activities expose it to a variety of financial risks: foreign currency risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Foreign currency risk

The Group has certain exposure to foreign currency risk as some of its business transactions, assets and liabilities are denominated in the currencies other than functional currencies of the Group entities.

The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group monitors its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

The following table demonstrates the sensitivity at the end of the reporting period to a reasonably possible change in the exchange rate of HK\$, with all other variables held constant, of the Group's loss after tax due to changes in the value of monetary assets and liabilities.

Credit risk is the risk that a counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. The Group is exposed to credit risk from its operating activities of trade and other receivables and bank balances. The Group's exposure to credit risk arising from bank balances is limited because the counterparties are banks and financial institutions with high credit-rating assigned by international credit-rating agencies, for which the Group considers to have low credit risk.

The Group has no concentration of credit risk.

Customer credit risk is managed by each business unit subject to the Group's established policy, procedures and control relating to customer credit risk management. Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 90 days from the date of billing. Debtors with balances that are more than 30 days past due are requested to settle all outstanding balances before any further credit is granted. Normally, the Group does not obtain collateral from customers.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECL. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

The Group's exposure to cash flow interest-rate risk arises from its bank deposits and bank borrowings. The bank deposits and bank borrowings bear interests at variable rates that vary with the then prevailing market condition.

Ltd, a public company established in the People's Republic of China (the "PRC") whose shares are listed on the National Equities Exchange and Quotations in the PRC (stock code: 832674) (collectively, the "Leader Elastic Group"). The principal activities of Leader Elastic and its subsidiaries are sales of elastic webbing used for bras and underwear in the PRC. Its revenue and results are separate into one new reportable segment, being sales of elastic webbings.

The Group have also developed a new businesses of providing digital marketing services during the year.

The Group's reportable segments are strategic business units that offer different products. The directors of Company, being the chief operating decision maker, managed the operating segments separately because each business requires different resources, technology and marketing strategies.

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern and to maximise the return to the shareholders through the optimisation of the debt and equity balance. The capital structure of the Group comprises all components of shareholders' equity.

The Group reviews the capital structure frequently by considering the cost of capital and the risks associated with each class of capital. The Group will balance its overall capital structure through the payment of dividends, new share issues and share buy-backs as well as the issue of new debts, redemption of existing debts or selling assets to reduce debts. No change was made in the objectives, policies or processes for managing capital during the years ended 31 December 2023 and 2022.

The only externally imposed capital requirement for the Group is that in order to maintain its listing on the Stock Exchange, it has to have a public float of at least 25% of the shares. Leader Elastic owns approximately 84.14% issued share capital of Zhuhai Sundust Apparel Co. Ltd, a public company established in the PRC whose shares are listed on the National Equities Exchange and Quotations in the PRC (stock code: 832674). The principal activity of Leader Elastic and its subsidiaries is investment holding and sales of elastic webbing used for bras, underwear in the PRC. The consideration for the acquisition was HK\$21,000,000 (equivalent to approximately RMB18,546,000).

The acquisition was in line with the Company's business strategy to expand the Company's business in the production and the sales of elastic webbing used for bras and underwear, and strengthen the products, revenue sources and cash flow position of the Group in future.

39. EVENTS AFTER THE REPORTING PERIOD

Reference is made to the announcement of the Group dated 4 January 2024 in relation to memorandum of understanding (the "MOU") in respect of a possible acquisition (the "Possible Acquisition"). Pursuant to the MOU, the Group intends to acquire and obtain from a seller, and the seller intends to sell and transfer to the Company, approximately 20-28% of the entire issued share capital of a target company, China Tian YF Holdings Group Limited (the "Target Company") An initial deposit of HK\$2,000,000 had been paid to the seller after the date of the MOU and will be applied towards the payment of the consideration for the shares of the Target Company subject to due execution of the definitive transaction documents. The Possible Acquisition is subject to, among other things, the negotiation and execution of the definitive transaction documents. The Group therefore may or may not proceed with the Possible Acquisition.

40. APPROVAL OF CONSOLIDATED FINANCIAL STATEMENTS

The consolidated financial statements are approved and authorised for issue by the Board of Directors on 28 March 2024.
