CORPORATE PROFILE 企業資料

Chu Kong Petroleum and Natural Gas Steel Pipe Holdings Limited (the "Company", together with its subsidiaries hereinafter referred to as the "Group") is the largest manufacturer and exporter of longitudinal welded steel pipes and is engaged in property development and investment in the People's Republic of China (the "PRC"). The Company has been listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (Stock Code: 1938) since February 2010. The Group's steel pipes are mainly used for energy transmission including oil and gas transmission pipelines, deep sea pipelines, city gas networks, and petrochemicals, mining, infrastructure construction, offshore engineering, steel structures and water utilities industries.

The Group's production bases and offices are located in Panyu, Zhuhai, Lianyungang, Nanjing, Hong Kong, Yunfu and Indonesia, with five production lines for longitudinal submerged arc-welded ("LSAW"), two production lines for spiral submerged arc-welded ("SSAW") and other production lines with a combined annual production capacity of 1,800,000 tonnes as at 31 December 2023.

The Group is an industry pioneer, particularly strong in research and development, holding 120 patents (including 41 invention patents) and 14 international quality certificates and having a long standing international and nationwide track record. Furthermore, the Group is the first and only steel pipe manufacturer in the PRC to manufacture and successfully develop deep sea welded steel pipes for use at a water depth of 3,500m and a qualified supplier of Petrobras and Petronas. The Group is a welded steel pipe manufacturer in the PRC that has received various honours and awards, including "Gold Cup Prize for Actual Quality of Metallurgical Products", "Superior Quality Award for Actual Quality of Metallurgical Products", "National Key New Products", "Provincerecognised Enterprise Technology Centre" and "High and New Technology Enterprise", hosted a "Academician Workstation" and is the main drafter of the national standard for longitudinal welded steel pipes in the PRC.

珠江石油天然氣鋼管控股有限公司(「本公司」,連同其 附屬公司於下文統稱為(「本集團」))是於中華人民共和 國(「中國」)最大的直縫焊管製造商及出口商並從事物業 開發及投資。本公司由二零一零年二月起於香港聯合交 易所有限公司(「聯交所」)主板上市(股份代號:1938)。 本集團鋼管產品主要用於能源運輸,包括油氣傳輸管 線、深海管道、城市燃氣網絡,以及石化產品、採礦、 基建工程、海洋工程、鋼結構及水務行業。

本集團的生產基地及辦事處位於番禺、珠海、連雲港、 南京、香港、雲浮及印度尼西亞,共設有五條直縫埋弧 焊管(「LSAW」)生產線、兩條螺旋埋弧焊管(「SSAW」) 生產線及其他生產線,於二零二三年十二月三十一日的 年產能合共為1,800,000噸。

本集團為行業先驅,憑藉強大研發實力,擁有一百二十 項專利(包括四十一項發明專利)及十四項國際質量認 證,以悠久往績享譽海外及全國。另外,本集團是中國 第一家及唯一製造及成功研發用於3,500米水深深海焊 管的焊管製造商。本集團亦為巴西石油及馬油的合資格 供應商。本集團是中國焊管製造商,獲得「中國冶金產 品實物質量金盃獎」、「中國冶金產品實物質量特優質量 獎」、「國家重點新產品」、「省級認定企業技術中心」及 「高新技術企業」等各項榮譽,設有「院士工作站」,也是 中國直縫焊管國家標準的主要起草單位。

Dear Shareholders,

On behalf of the Board, I would like to present to you the audited consolidated annual results of the Group for the year ended 31 December 2023.

致各位股東:

本人謹代表董事會,向 閣下提呈本集團截至二零二三 年十二月三十一日止年度之經審核綜合全年業績。

In 2023, while the COVID-19 pandemic no longer constituted a public health emergency of international concern, the geopolitical conflicts and the tightening of monetary policy in the U.S. has led to bank failures, aggravating financial instability, global inflation woes and multiple challenges and uncertainties for the global economy. The global economic growth further slowed down in 2023, with the global and Chinese economies growing at 3% and 5.2% respectively. Notwithstanding the above, the Group recorded sales of approximately RMB2,651 million (2022: RMB2,362 million), representing an increase of approximately 12.2% over 2022. The Group recorded a profit of approximately RMB183.8 million (2022: RMB163 million). Earnings per share attributable to ordinary equity holders was approximately RMB0.18 (2022: RMB0.16). The Board did not recommend the payment of final dividend for the year ended 31 December 2023.

The Group delivered a total of 553,000 tonnes of steel pipes during the year and received orders for a total of 601,000 tonnes of steel pipes, including the East African Crude Oil Pipeline Project, the Huai'an Gas Storage Branch Line Section of the Jiangsu Coastal Gas Pipeline, the Nigeria AKK Project, the Terminal Engineering of Guangxi Liquefied Natural Gas (LNG) Phase III Expansion Project and the Shell Offshore Platform Project and other projects. Among them, the East African Crude Oil Pipeline Project was the largest single order in the Group's history during the year, with a total procurement of 260,000 tonnes of steel pipes and a total sales amount of US\$370 million (approximately RMB2,600 million). The East African Crude Oil Pipeline Project, which involves the construction of a pipeline with a total length of 1,540 kilometers that transports oil from Ugandan oil fields to Tanzanian ports, is the world's longest heated crude oil transmission pipeline project. It is anticipated that the construction of the pipeline will greatly promote the economic development of the East African region.

於二零二三年,儘管新冠疫情已不再構成國際關注的突 發公共衛生事件,但地緣政治衝突,美國貨幣政策收緊 導致銀行倒閉,加劇金融的不穩定,環球陷入通脹困 境,全球經濟面臨多重挑戰及不確定性。二零二三年全 球經濟增長進一步放緩,全球經濟及中國經濟增長分別 為3%及5.2%。儘管如此,本集團錄得銷售約人民幣 2,651,000,000元,(二零二二年:人民幣2,362,000,000 元),較二零二二年增加約12.2%。本集團錄得溢利約 為人民幣183,800,000元(二零二二年:人民幣 163,000,000元)。普通股權持有人應佔每股盈利約人民 幣0.18元(二零二二年:人民幣0.16元)。董事會不建議 派發截至二零二三年十二月三十一日止年度之末期股 息。

本集團年內共交付553,000噸的鋼管,並接獲共601,000 噸的鋼管訂單,其中包括東非原油管道項目(East African Crude Oil Pipeline)、江蘇沿海輸氣管道淮安儲 氣庫支線段、奈及利亞AKK項目、廣西液化天然氣 (LNG)三期擴建專案碼頭工程、殼牌海洋平台專案等。 其中東非原油管道項目是本集團年內接獲歷史上銷售規 模最大的單筆訂單,鋼管總採購量26萬噸,銷售總金額 達3.7億美元(約人民幣26億元),東非原油管道專案全 長1,540公里,其包括興建一條將石油從烏干達油田輸 送到坦桑尼亞港口的管道,是全球最長加熱原油輸送管 道項目,預計興建管道將極大推動非洲東部區域經濟發 展。

The Group successfully delivered all the LSAW steel pipes required for the Ras Laffan Petrochemicals refinery project during the year. This project involves the construction of an ethane cracker in Ras Laffan, Qatar with an annual capacity of up to 2.1 million tonnes of ethylene. We have delivered 2,230 tonnes of LSAW steel pipes, with diameter of 610mm and wall thickness of 11.7mm and 9.5mm, in this project. External double epoxy anti-corrosion technology was adopted to protect the pipelines from corrosion. It is reported that this project will be the largest ethylene project in the Middle East and one of the largest ethylene projects in the world. The Board believes that the successful delivery of this project demonstrates the high recognition of the Group by large energy companies, and helps to establish "Chu Kong Steel Pipe" as a world-class steel pipe brand.

In terms of research and development technology, the Group overcame the difficulties in manufacturing equipment and technology for spiral arc-welded pipes with ultra-large wall thickness during the year, broke through the century-long limit in the history of spiral steel pipe manufacturing, and produced the world's first large-diameter ultra-thick-walled spiral steel pipe with a diameter of 3,000mm and a wall thickness of 30mm, which is a major breakthrough in the global supply specification of spiral steel pipes products with ultra-large wall thickness, and signified that the technological standard of China's manufacturing of spiral steel pipes had moved up to a new level. The strength grade of the trialproduced large wall thickness spiral arc-welded pipe is Q355C, the length of the steel pipe reaches 45m, and the weight of the steel pipe reaches 90 tonnes. The product will be used in the construction of a 19.64 kilometer passageway (being the Third East Passageway Project), which crosses the eastern sea area in the east of Guanyinshan, Xiamen and terminates at the Xiamen Xiang'an International Airport.

本集團於年內順利交付Ras Laffan Petrochemicals煉化 廠項目所需的全部直縫埋弧焊管。此項目包含修建位於 卡達拉斯拉凡(Ras Laffan),年產高達210萬噸乙烯的乙 烷裂解裝置。我們於該項目已交付2,230噸管徑為 610mm,壁厚分別為11.7mm和9.5mm的直縫埋弧焊 管。採用外雙環氧防腐技術以保護管道免受腐蝕。據悉 這項目將成為中東地區最大的乙烯專案,也是世界上最 大的乙烯項目之一。董事會相信此次項目的順利交付體 現了大型能源公司對本集團的高度認可,將助力「珠江 鋼管」打造成為世界一流的鋼管品牌。

研發技術方面,本集團年內克服超大壁厚螺旋焊管製造 裝備及工藝技術難題,突破了螺旋鋼管製造史上的百年 極限,製造出全球首根直徑為3,000mm、壁厚為30mm 的大口徑超厚壁螺旋鋼管,其為全球螺旋鋼管超大壁厚 產品供應規格的一個重大突破,標誌著中國製造螺旋鋼 管的技術水準邁上了一個新台階。本次試製的大壁厚螺 旋焊管強度等級為Q355C,鋼管長度達45m,鋼管重量 達90噸,產品將用於修建在廈門觀音山向東跨越東部海 域,終點為廈門翔安國際機場的19.64公里的通道,第 三東通道專案工程。

In December 2023, the Group was invited by the financial programme centre of China Media Group to launch a large-scale convergence media campaign entitled "Specialized and New -Manufacturing Power (專精特新•製造強國)", in which the Group was reported as a provincial Specialized and New "Little Giant" enterprise, showcasing the characteristics, highlights and achievements of the development of specialized and new enterprises in China. As an outstanding representative of the provincial Specialized and New "Little Giant" enterprises, the Group explained how we utilise deep sea steel pipe to support the new limit of marine energy transportation for 3,500-meter ultra-deep submarine pipelines. The impact-resistant experiment conducted by using a huge drop hammer perfectly demonstrated the Group's superior technology in strength and toughness, chemical composition design, metallurgy technology, rolling technology and heat treatment technologies of deep sea steel pipe. We have also employed these technologies to produce samples of welded steel pipes for 3,500-meter ultra-deep submarine pipelines which meet the technical requirements of resistance to compression and collapse, fatigue, and large deformation, which is currently the leading level in the world.

PROSPECT

The global economy will continue to recover in 2024. In the face of worrying geopolitical tension and climate change, the volatility of bulk commodity prices is likely to rise, posing a significant risk to the strategy of reducing inflation, and the world's economic development is fraught with uncertainties, which will continue to inhibit the growth of demand and thus limit the pace of global recovery. However, China's efforts to promote the development of the natural gas industry remain unchanged. The "14th Five-Year Plan Modern Energy System Plan" published by the National Development and Reform Commission and the National Energy Administration of the People's Republic of China proposes that the total length of national oil and gas pipeline network should reach the target of 210,000 kilometers by 2025, which will accelerate the construction of oil and gas pipeline network facilities. In addition, for the implementation of the "dual-carbon" policy and the reduction of carbon emission, natural gas is an important clean energy source. However, the current length of natural gas pipelines still falls short of the target set out in the Medium and Long-Term Oil and Gas Pipeline Network Plan (《中長期油氣管網規劃》), and there will still be a demand for pipeline construction in the future. Therefore, the Group will continue to benefit from the demand for pipelines.

本集團於二零二三年十二月獲中央廣播電視總台財經節 目中心推出「專精特新・製造強國」大型融媒體活動邀 請,報導本集團為省專精特新「小巨人」企業,展現中國 專精特新企業發展的特色、亮點和成就。本集團作為省 專精特新「小巨人」企業傑出代表,闡述我們如何在 3,500米超深海底利用深海鋼管撐起海洋能源輸送新極 限!通過巨大的落錘展開的的抗衝擊實驗,完美展示出 本集團在深海鋼管的強度和韌性、化學成分設計、冶金 工藝、軋製工藝和熱處理工藝方面的高超技術。我們亦 應用該等技術製出3,500米超深海底管道焊接鋼管樣品, 符合抗壓潰、抗疲勞、抗大變形的技術要求。這項技術 目前在全球處於領先水準。

展望

二零二四年全球經濟將繼續復蘇,面對地緣政治緊張局 勢和與氣候變化,大宗商品價格的波動可能會上升,對 降低通脹的策略構成了重大風險,世界經濟發展充滿不 確定性,將繼續抑制需求增長從而限制全球復蘇的步 伐。儘管如此,中國推動天然氣產業發展未變,國家發 展改革委、國家能源局印發《「十四五」現代能源體系規 劃》提出到二零二五年,全國油氣管網規模總長度達到 21萬公里左右的目標,將會加快油氣管網設施建設。另 外,為了落實「雙碳」政策以及減少二氧化碳排放,天然 氣是重要清潔能源,但現時天然氣管道長度仍然跟《中 長期油氣管網規劃》的目標有差距,所以未來仍對建設 管道有需求。因此,本集團將會仍然受惠於管道需求。

BUSINESS REVIEW

The Group mainly (i) manufactures and sells longitudinal welded steel pipes, as well as provides manufacturing service for processing raw materials into steel pipes; and (ii) engages in property development and investment.

Steel pipe business

Our welded steel pipe products can be broadly categorised into LSAW steel pipes, SSAW steel pipes and ERW steel pipes. We are the largest LSAW steel pipe manufacturer and exporter in the PRC, and are capable of producing LSAW steel pipes that meet the X100 standard. We are also accredited with 14 international quality certifications such as Det Norske Veritas and American Petroleum Institute. In addition, we are the first and the only PRC manufacturer that has successfully produced and developed deep sea welded pipes for use at 3,500m under water. Our products are widely used in major oil and gas pipeline projects (both onshore and offshore) and infrastructure projects domestically and internationally.

Our Group is capable of manufacturing subsea pipes and drilling platforms structure pipes for offshore projects and is being classified as a member of the Offshore Engineering Equipment Industry* (海洋工程裝備製造業).

Order Status

In 2023, the Group received new orders of approximately 601,000 tonnes of welded steel pipes. The Group has received some sizeable overseas orders, such as orders from steel pipes for the East African Crude Oil Pipeline project, Nigeria Ajakuta-Kaduna-Kano (AKK) natural gas pipeline project and Shell offshore platform project. The Group delivered approximately 553,000 tonnes of welded steel pipes during 2023.

業務回顧

本集團主要(i)製造及銷售直縫焊接鋼管,以及提供將原 材料加工為鋼管的製造服務;及(ii)從事物業開發與投 資。

鋼管業務

本集團的焊接鋼管產品大致可分為直縫埋弧焊管、螺旋 埋弧焊管及電阻焊管。我們是中國最大直縫埋弧焊管製 造商及出口商,可生產符合X100標準的直縫埋弧焊管, 而我們已取得挪威船級社及美國石油協會等十四項國際 質量認證。此外,我們為中國首名和唯一能成功生產及 研發出3,500米深海焊管的製造商。我們的產品在國內 外被廣泛用於大型石油及天然氣管道項目(岸上和海上) 及基建項目。

由於本集團可製造海上工程使用的海底管及海上鑽井平 台結構管,故此本集團被劃入海洋工程裝備製造業企業 之一。

訂單狀況

於二零二三年,本集團接獲的新訂單數量約為601,000 噸焊接鋼管。本集團已接獲若干大型海外訂單,如東非 原油管道項目、奈及利亞Ajakuta-Kaduna-Kano (AKK) 天然氣管道項目及殼牌海上平台項目等鋼管訂單。本集 團已於二零二三年交付約553,000噸焊接鋼管。

LSAW Steel Pipes

The Group is one of the largest LSAW steel pipe manufacturers and exporters in the PRC. Sales and manufacturing of LSAW steel pipe was the major source of revenue of the Group and accounted for approximately 69.2% of our total steel pipe revenue for the year ended 31 December 2023. For the year ended 31 December 2023, revenue from the sales and manufacturing service of LSAW steel pipes amounted to approximately RMB1,496 million and RMB158 million, respectively, where sales of LSAW steel pipes were higher than that for the year ended 31 December 2022 was due to increase in delivery of LSAW steel pipes to overseas customers.

SSAW Steel Pipes

Our SSAW steel pipes are produced in our plant in Lianyungang using the pre-welding and precision welding SSAW technique, which is the most advanced technique among all SSAW technologies. Revenue from the sales and manufacturing service of SSAW steel pipes amounted to approximately RMB612 million and RMB25 million respectively. The total revenue from SSAW steel pipes accounted for approximately 26.6% of the total steel pipe revenue for the year ended 31 December 2023 which were significantly higher than that for the year ended 31 December 2022. The increase was mainly attributable to the increase in sales of SSAW steel pipes to one major customer in Middle East.

直縫埋弧焊管

本集團是中國最大的直縫埋弧焊管製造商及出口商之 一。直縫埋弧焊管銷售及製造服務為本集團主要收入來 源,截至二零二三年十二月三十一日止年度佔本集團總 鋼管收入約69.2%。截至二零二三年十二月三十一日止 年度,直縫埋弧焊管的銷售及製造服務收入分別約為人 民幣1,496,000,000元及人民幣158,000,000元,當中直 縫埋弧焊管的銷售較截至二零二二年十二月三十一日止 年度增加,由於向海外客戶交付的直縫埋弧焊管數量增 加。

螺旋埋弧焊管

我們於連雲港廠房生產的螺旋埋弧焊管採用預精焊螺旋 埋弧焊管技術製造,該項技術屬所有螺旋埋弧焊管工藝 中最先進的工藝。螺旋埋弧焊管的銷售及製造服務分別 錄得收入約人民幣612,000,000元及人民幣25,000,000 元。螺旋埋弧焊管的總收入佔截至二零二三年十二月三 十一日止年度總鋼管收入約26.6%,較截至二零二二年 十二月三十一日止年度大幅增加。該增長主要由於向一 位位於中東客戶的螺旋埋弧焊管銷售增加所致。

Property development

Apart from the steel pipe manufacturing business, the Group also engaged in property development and investment. Following the conversion of a land in Panyu, PRC in 2013, the Group grasped the opportunity of asset appreciation to convert the land use right of the Panyu production plant from industrial use to commercial use. The property project in relation to Golden Dragon City Fortune Plaza (金龍城財富廣場) ("GDC"), is a large scale integrated commercial complex of offices, shops, apartments and villas. The land area of the converted land accounted for approximately 25% of the total land area of our factory in Panyu. The total permitted construction area of the land (including underground construction area) is approximately 550,000 m².

Below are the details of GDC:

- Usage: Large scale integrated commercial complex of offices, shops, apartments and villas

The Group recorded most of the sales of the first phase of GDC in 2018 and recognised the sale of the second phase of GDC in 2022. The third phase of GDC was sold to Guangzhou City Panyu District Land Development Centre* (廣州市番禺區土地開發中心) in 2019.

The steel pipe business will remain as the Group's core business.

物業開發

除鋼管製造業務外,本集團亦從事物業開發與投資。於 二零一三年中國番禺土地改變用途後,本集團適時利用 資產增值機會,將番禺生產廠房的土地用途由工業轉為 商業用途。有關金龍城財富廣場(「金龍城」)的物業項目 為集寫字樓、商舖、公寓及別墅為一體的大型綜合商業 體。已改土地佔番禺廠區土地的總面積約四分之一。該 土地的總許可建築面積(包括地下建築面積)約為 550,000平方米。

FINANCIAL REVIEW

Revenue and gross profit

Revenue of the Group mainly comprises (i) sales of steel pipe, and (ii) sales of property.

Our revenue increased from RMB2,362 million for the year ended 31 December 2022 to approximately RMB2,651 million in 2023. Such increase was mainly due to increase in overseas sales of steel pipes in 2023. The Group has received a sizable order from the East African Crude Oil Pipeline project during the year. Steel pipes sales in 2023 increased as compared to that of 2022.

The revenue generated from the sales of steel pipes accounted for approximately 89.2% of our total steel pipe revenue in 2023 as compared with approximately 80.9% in 2022. Steel pipe manufacturing services accounted for approximately 7.6% of our total steel pipe revenue in 2023 as compared with approximately 14.7% in 2022. The revenue classified as "Others" mainly represented the trading of steel plates, sales of steel fittings and sales of scrap materials which accounted for approximately 3.2% of our total steel pipe revenue in 2023 as compared with approximately 4.4% in 2022.

Gross profit of steel pipe sales for 2023 was approximately RMB513.4 million as compared with approximately RMB413.9 million in 2022, representing an increase of approximately 24.0% or RMB99.5 million. Gross profit margin for 2023 was approximately 21.5% which was similar to that of 22.9% in 2022.

Overseas Sales for 2023 was approximately RMB1,370.5 million as compared with approximately RMB660.7 million in 2022, representing an increase of approximately 107.4%. Our overseas sales accounted for approximately 57.3% of our total steel pipe revenue in 2023, as compared with approximately 36.5% in 2022.

Sales by Geographical Areas — Steel Pipes

二零二三年的鋼管銷售毛利約為人民幣513,400,000 元,較二零二二年約人民幣413,900,000元增加約24.0% 或人民幣99,500,000元。二零二三年的毛利率約為 21.5%,與二零二二年的22.9%大致相當。

二零二三年的海外銷售約為人民幣1,370,500,000元, 較二零二二年約人民幣660,700,000元,增加約 107.4%。於二零二三年,本集團的海外銷售額佔總鋼 管收入約57.3%,而於二零二二年則約佔36.5%。

Revenue generated from the property development and investment segment mainly comprises sales of property of GDC-Phase II and rental income from shops in Phase I of GDC. Revenue under property development and investment was approximately RMB260.0 million in 2023 as compared with approximately RMB551.9 million in 2022, representing a decrease of approximately 52.9% or RMB291.9 million. Decrease in revenue was due to recognition of sales of Phase II in 2023 decreased. Most of the units under Phase I of GDC had been sold in 2018 and 2019.

Cost of sales primarily represents the costs we incurred directly for the Group's property development activities. The principal component of cost of sales is cost of properties sold, which includes the direct costs of construction and the costs of obtaining land use rights. Cost of sales was approximately RMB219.2 million in 2023 as compared with approximately RMB495.2 million in 2022, representing a decrease of 55.7% or RMB276.0 million. Decrease in cost of sales was due to less properties sold out so as the allocation of cost of Phase II of GDC.

Gross profit of property sales was approximately RMB40.8 million in 2023 as compared with approximately RMB56.7 million in 2022, representing a decrease of 28.0% or RMB15.9 million. Decrease in gross profit was due to decrease in sales of Phase II of GDC.

All revenue under property development and investment was domestic in nature.

銷售成本主要指我們就本集團之物業開發活動直接產生的成本。銷售成本的主要組成部分為已售物業成本,當中包括直接建築成本及取得土地使用權成本。於二零二三年,銷售成本約為人民幣219,200,000元,與於二零 二二年的約人民幣495,200,000元相比,減少55.7%或 人民幣276,000,000元。銷售成本減少乃由於金龍城第 二期的分配成本導致的已售物業減少。

於二零二三年,物業銷售毛利約為人民幣40,800,000 元,與於二零二二年的約人民幣56,700,000元相比,減 少28.0%或人民幣15,900,000元。毛利減少乃由於金龍 城第二期的銷售額減少。

所有物業開發與投資收入均為國內產生。



CHANGE IN FAIR VALUES OF INVESTMENT PROPERTIES

The Group has adopted the accounting policy of measuring investment properties by using fair values. Accordingly, gains or losses arising from the changes in the fair values of investment properties are reflected as profit or loss for 2023. The investment properties as at 31 December 2023 were the shops of Phase I of GDC. The Group has engaged RHL Appraisal Limited, an independent valuer, to value the investment properties as at 31 December 2023. According to the valuation report as at 31 December 2023 issued by RHL Appraisal Limited, the market value of the investment properties as at 31 December 2023 was RMB360.0 million. Loss in fair values of the investment properties in 2023 was approximately RMB2 million (2022: loss of RMB8 million).

OTHER INCOME AND GAINS

Other income and gains in 2023 mainly represented bank interest income and subsidy income from government. Other income and gains decreased by approximately 93.3% or RMB222.8 million from approximately RMB238.7 million in 2022 to approximately RMB16.0 million in 2023. Decrease in other income and gains was mainly due to the decrease in subsidy income from government.

SELLING AND DISTRIBUTION EXPENSES

Selling and distribution expenses increased by approximately 19.0% or RMB10.4 million from approximately RMB55.1 million in 2022 to approximately RMB65.5 million in 2023. Increase in selling and distribution expenses was mainly due to increase in overseas sales that led to the increase in sales commission.

ADMINISTRATIVE EXPENSES

Administrative expenses increased by approximately 9.9% or RMB24.2 million from approximately RMB245.8 million in 2022 to approximately RMB270.0 million in 2023. The increase in administrative expenses was mainly due to increase in research and development expenses.

投資物業公平值變動

本集團已採納會計政策,以公平值計量投資物業。因此,投資物業公平值變動產生之盈虧,已於二零二三年 反映為損益。於二零二三年十二月三十一日的投資物業 為金龍城第一期的商舖。本集團已委聘獨立估值師永利 行評值顧問有限公司,為於二零二三年十二月三十一日 的投資物業進行估值。根據永利行評值顧問有限公司於 二零二三年十二月三十一日出具的估值報告,投資物業 於二零二三年十二月三十一日出具的估值報告,投資物業 於二零二三年十二月三十一日的市值為人民幣 360,000,000元。於二零二三年,投資物業的公平值虧 損約為人民幣2,000,000元(二零二二年:虧損人民幣 8,000,000元)。

其他收入及收益

二零二三年的其他收入及收益主要指銀行利息收入及政府補貼收入。其他收入及收益由二零二二年約人民幣 238,700,000元,減少約93.3%或人民幣222,800,000元 至二零二三年約人民幣16,000,000元。其他收入及收益 減少主要由於政府補貼收入減少。

銷售及分銷開支

銷售及分銷開支由二零二二年約人民幣55,100,000元, 增加約19.0%或人民幣10,400,000元,至二零二三年約 人民幣65,500,000元。銷售及分銷開支增加主要由於海 外銷售增加導致銷售佣金增加。

行政費用

行政費用由二零二二年約人民幣245,800,000元增加約 9.9%或人民幣24,200,000元,至二零二三年約人民幣 270,000,000元。行政費用增加主要由於研發費用增加。

FINANCE COSTS

The finance costs for 2023 was approximately RMB94.5 million as compared with that of 2022 of approximately RMB44.6 million, representing an increase of RMB49.9 million or 111.8%. The effective interest rate in 2023 was approximately 5.2% (2022: 2.5%). Increase in finance costs was due to the fact that interest in relation to property sector can no longer be capitalized and has to be charged to finance costs during the year.

OTHER EXPENSES

Other expenses decreased by approximately 10.4% or RMB21.9 million from approximately RMB209.8 million in 2022 to approximately RMB187.9 million in 2023. The decrease was mainly due to the combined effect of (i) land resumption cost in 2022 but nil in 2023; and (ii) increase in impairment of trade and other receivables in 2023 as compared to 2022.

EXCHANGE GAIN, NET

The Group recorded exchange gain of approximately RMB15.1 million in 2023 as compared with exchange gain of approximately RMB16.4 million in 2022. The exchange gain was mainly due to appreciation of USD against RMB in collection of USD trade receivables.

INCOME TAX CREDIT

The Group recorded income tax credit of RMB144.7 million in 2023 as compared with income tax credit of RMB0.6 million in 2022.

PROFIT FOR THE YEAR

As a result of the reasons discussed above, the Group recorded a profit of approximately RMB183.8 million in 2023 (2022: profit of RMB163.0 million).

融資成本

二零二三年的融資成本約為人民幣94,500,000元,較於 二零二二年的約人民幣44,600,000元相比,增加人民幣 49,900,000元或111.8%。二零二三年的實際利率約為 5.2%(二零二二年:2.5%)。融資成本增加乃由於本年 度與物業分部有關的利息不再資本化,而是計入財務成 本。

其他費用

其他費用由二零二二年約人民幣209,800,000元,減少 約10.4%或人民幣21,900,000元,至二零二三年約人民 幣187,900,000元。該減少主要由於(i)二零二二年的土 地收儲成本,但二零二三年為零;及(ii)貿易應收賬款及 其他應收款項減值較二零二二年增加的綜合影響所致。

匯兑收益淨額

本集團於二零二三年錄得匯兑收益約人民幣15,100,000 元, 而於二零二二年則錄得匯兑收益約人民幣 16,400,000元。匯兑收益乃主要由於收美元應收賬款時 美元兑人民幣升值所致。

所得税抵免

本集團於二零二三年錄得所得税抵免人民幣144,700,000 元,而於二零二二年則錄得所得税抵免人民幣600,000 元。

年內溢利

由於上文所述原因,本集團於二零二三年錄得溢利約人 民幣183,800,000元(二零二二年:溢利人民幣 163,000,000元)。

NET CASH FLOWS FROM OPERATING ACTIVITIES

The Group's net cash inflows from operating activities of approximately RMB154.1 million in 2022 increased to approximately RMB431.1 million in 2023. The increase in net cash inflows from operating activities were primarily due to the combined effect of (i) decrease in profit before tax; (ii) increase in inventories, trade and bills payables and contract liabilities; and (iii) decrease in completed properties held for sale, trade and bills receivables, prepayments, other receivables and other assets, pledged and restricted bank balances, and other payables and accruals.

NET CASH FLOWS (USED IN)/FROM INVESTING ACTIVITIES

The Group's net cash flows from investing activities changed from inflow of approximately RMB38.2 million in 2022 to outflow of approximately RMB8.7 million in 2023. The decrease in net cash flows were mainly due to the combined effects of (i) purchase of items of property, plant and equipment in 2023; (ii) proceeds from disposal of investment in a joint venture; and (iii) receipt of government grants.

經營活動所得現金流量淨額

本集團的經營活動現金流量由二零二二年淨流入約人民 幣154,100,000元增加至二零二三年約人民幣 431,100,000元。經營活動所得現金流入淨額增加主要 由於綜合以下影響所致:(i)除税前溢利減少:(ii)存貨、 貿易應付賬款及應付票據及合約負債增加:及(iii)落成 待售物業、貿易應收賬款及應收票據、預付款項、其他 應收款項及其他資產、已抵押及受限制銀行結餘及其他 應付款項及應計費用減少。

投資活動(所用)/所得現金流量淨額

本集團的投資活動所得現金流量淨額由二零二二年流入 約人民幣38,200,000元變更至二零二三年流出約人民幣 8,700,000元。現金流量淨額減少主要由於綜合以下影 響所致:(i)二零二三年購置物業、廠房及設備;(ii)出售 於一間合營公司投資之所得款項;及(iii)收取政府補貼。

NET CASH FLOWS USED IN FINANCING ACTIVITIES

The Group's net cash flows used in financing activities increased from approximately RMB149.1 million in 2022 to approximately RMB366.0 million in 2023. The increase was mainly resulted from the combined effect of (i) the increase in borrowing of new interestbearing loans and other borrowings of approximately RMB658.3 million; and (ii) decrease in an amount due to a director, the repayment of bank loans, other borrowings, bonds and principal portion of payment of lease and payment of interest of approximately RMB1,024.3 million.

EXCHANGE RISK EXPOSURE

The Group mainly operates in the PRC and most of its operating transactions are settled in Renminbi except for export sales and overseas borrowings which are mostly denominated in US dollar and HK dollar. Most of the Group's assets and liabilities are denominated in Renminbi. Although the Group may be exposed to foreign currency exchange risks, the Board does not expect that future currency fluctuations would materially impact the Group's operations. The Group did not adopt formal hedging policies nor instruments of foreign currency for managing the exchange risk exposure during the year ended 31 December 2023.

CAPITAL EXPENDITURE

For the year ended 31 December 2023, the Group invested approximately RMB96.3 million for the upgrading of property, plant and equipment and right-of-use assets. These capital expenditures were fully financed by internal resources.

FINANCIAL GUARANTEE

As at 31 December 2023, the Group guaranteed RMB27.4 million (2021: RMB36.9 million) to certain purchasers of the Group's properties for mortgage facilities.

融資活動所用現金流量淨額

本集團的融資活動所用現金流量淨額由二零二二年約人 民幣149,100,000元增加至二零二三年約人民幣 366,000,000元。該增加主要由於綜合以下影響所致: (i)新借計息貸款及其他借款增加約人民幣658,300,000 元;及(ii)應付董事款項減少、償還銀行貸款、其他借 款、債券及租賃付款之本金部分及支付利息約人民幣 1,024,300,000元。

外匯風險

本集團主要於中國經營,其大部分營運交易乃以人民幣 結算,惟出口銷售及海外借貸大部分以美元及港元計 值,而本集團大部分資產及負債乃以人民幣計值。儘管 本集團可能面對外匯風險,董事會預料日後匯率波動不 會對本集團營運構成重大影響。截至二零二三年十二月 三十一日止年度,本集團並無就管理外匯風險採用正式 對沖政策或外幣工具。

資本開支

於截至二零二三年十二月三十一日止年度,本集團投資約人民幣96,300,000元更新物業、廠房及設備以及使用權資產。該等資本開支全部以內部資源支付。

財務擔保

於二零二三年十二月三十一日,本集團就按揭融資向本 集團物業之若干買家作出為數人民幣27,400,000元(二 零二一年:人民幣36,900,000元)之擔保。

PLEDGE OF ASSETS

The Group pledged the following assets with an aggregate net book value to secure bank loans granted to the Group as at 31 December 2023:

- certain property, plant and equipment of approximately RMB696.4 million (2022: RMB598.1 million);
- (ii) certain leasehold land of approximately RMB481.6 million (2022: RMB489.4 million); and
- (iii) completed properties held for sale of approximately RMB1,003.0 million (2022: RMB913.7 million).

CAPITAL STRUCTURE, LIQUIDITY AND FINANCIAL RESOURCES

The Group's gearing ratio is calculated based on the sum of bank loans, other borrowings and fixed rate bonds and notes divided by total assets. The gearing ratio of the Group as at 31 December 2023 and 2022 were approximately 28.5% and 27.1%, respectively. There was no major change in gearing ratio in 2023 as compared with that of 2022.

On 27 April 2020, the Company entered into a subscription agreement with an investment fund, pursuant to which the Company agreed to issue, and the investment fund agreed to subscribe for HK\$140,000,000 12% bonds due in April 2022 (the "Bonds"). The Company and the noteholder mutually agreed to extend the maturity date to 22 December 2023. Mr Chen Chang, an executive Director and the controlling shareholder of the Company, undertakes and covenants that for so long as any of the Bonds remain outstanding, he shall remain as (i) the single largest direct or indirect shareholder of the Company; and (ii) the chairman of the Board and executive Director (the "Specific Performance Obligations"). Any breach of the Specific Performance Obligations may constitute an event of default under the Bonds and the bondholder is entitled to redeem the Bonds immediately upon the occurrence of the breach in accordance with the terms and conditions of the Bonds. Subsequent to 31 December 2023 and up to the date of this report, the Company will continue to actively negotiate with the investor for the extension of the Bonds.

資產抵押

於二零二三年十二月三十一日,本集團抵押以下總賬面 淨值資產作為本集團獲授的銀行貸款的抵押:

資本架構、流動資金及財務資源

本集團的資產負債比率乃按銀行貸款、其他借貸及定息 債券及票據的總和除以資產總值計算。本集團於二零二 三年及二零二二年十二月三十一日的資產負債比率分別 約為28.5%及27.1%。於二零二三年的資產負債比率較 二零二二年並無重大變動。

於二零二零年四月二十七日,本公司與投資基金訂立認 購協議,據此,本公司同意發行,而投資基金同意認購 140,000,000港元於二零二二年四月到期的12%債券 (「債券」)。本公司及票據持有者相互協定將到期日延長 至二零二三年十二月二十二日。本公司執行董事兼控股 股東陳昌先生承諾並保證,在債券期內,彼應為(i)本公 司的單一最大直接或間接股東;及(ii)董事會主席兼執行 董事(「特定履約義務」)。違反特定履約義務可能構成債 券的違約事件,在發生違約時,債券持有人有權根據債 券的條款和條件立即贖回債券。自二零二三年十二月三 十一日起至本報告日期,本公司將繼續積極與投資者就 延長債券進行磋商。

As at 31 December 2023, the Group's total borrowings amounted to approximately RMB1,832.4 million, of which approximately 8% (2022: 46%) were long term borrowings and approximately 92% (2022: 54%) were short term borrowings. The total borrowings included, (i) a loan of RMB791.6 million in relation to the Group's property development business; and (ii) net borrowings under steel pipe business of around RMB1,040.8 million. The Group had to finance its working capital of steel pipe business by short term borrowings as around 90% of the cost of sales was incurred on the procurement of steel plates and steel coils. Once the Group received sales proceeds from its customers, it would then repay the short term borrowings. Taking into account the Group's cash in hand, the Group has sufficient liquidity and is in a strong financial position to repay its short term borrowings.

As at 31 December 2023, (i) approximately 80% (2022: 80%) of the total borrowings were denominated in Renminbi which carried interest rates linked to the benchmark lending rate published by the People's Bank of China; (ii) approximately 16% (2022: 15%) of the total borrowings were denominated in Renminbi which carried fixed interest rate; and (iii) approximately 4% (2022: 5%) of the total borrowings were denominated in US dollar and HK dollar which carried fixed interest rate.

SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES, ASSOCIATES AND JOINT VENTURES

As at the date of this report, the Group had no significant investments, material acquisitions or disposals of subsidiaries, associates and joint ventures during the year.

於二零二三年十二月三十一日,(i)借貸總額約80%(二 零二二年:80%)以人民幣計值,按中國人民銀行公佈 的基準貸款利率計息:(ii)借貸總額約16%(二零二二年: 15%)以人民幣計值,按固定利率計息;及(iii)借貸總額 約4%(二零二二年:5%)以美元及港元計值,按固定利 率計息。

LITIGATION

The Group is involved certain lawsuits brought by third parties alleging that the Group breached and repudiated certain purchase and construction contracts. The claims are subject to the legal arbitration and are expected to be finalized in 2024. As at 31 December 2023, a provision of approximately RMB50.0 million has been provided.

EVENTS AFTER THE REPORTING PERIOD

As at the date of this report, there is no significant event subsequent to 31 December 2023 which would materially affect the Group's operating and financing performance.

EMPLOYEE AND REMUNERATION POLICY

For the year ended 31 December 2023, staff costs (including Directors' remuneration in the form of salaries) were approximately RMB151.4 million (2022: RMB123.7 million).

The Group remunerates its employees based on their performance, experience and prevailing industry practice. The emoluments of the Directors are recommended by the Remuneration Committee and are decided by the Board, having regard to the Group's operating results, individual performance and comparable market statistics. Competitive remuneration package is offered to retain elite employees. Our package includes salaries, medical insurance, discretionary bonuses, on-job training, other benefits as well as mandatory provident funds schemes for employees in Hong Kong and state-managed retirement benefit schemes for employees in the PRC. Pursuant to the Company's share option scheme, options to subscribe for shares in the Company may be granted to eligible employees. No share option was granted under the share option scheme during the year ended 31 December 2023.

訴訟

本集團根據員工的表現、經驗及現時行業慣例釐定員工 的薪酬。董事的酬金乃經薪酬委員會提供推薦建議及由 董事會考慮本集團的營運業績、個人表現及可資比較的 市場統計數據後釐定。本集團提供具競爭力的薪酬待 遇,以留任優秀員工。我們的酬金組合包括薪金、醫療 保險、酌情花紅、在職培訓、其他福利以及有關香港員 工的強制性公積金計劃及有關中國員工的國營退休福利 計劃。根據本公司之購股權計劃,認購本公司股份之購 股權可授予合資格僱員。於截至二零二三年十二月三十 一日止年度,概無根據購股權計劃授出購股權。

PROSPECT

In the face of geopolitical tensions and climate change, the volatility of global oil and gas trade prices poses significant risks to the strategy of reducing inflation. As a result, global economic development is full of uncertainty, which will continue to restrain demand growth and thus limit the pace of global recovery in 2024. The Group expects that the year 2024 will remain a challenging year for the oil and natural gas industry. In the medium and long term, it is expected that the oil and natural gas industry will continue to develop due to the combined effects of the insufficient oil and natural gas pipeline facilities, and China's emphasis on energy security and the promotion of clean energy.

未來展望

面對地緣政治緊張局勢和與氣候變化,全球油氣貿易價 格的波動,對降低通脹的策略構成了重大風險,世界經 濟發展充滿不確定性,二零二四年將繼續抑制需求增長 從而限制全球復蘇的步伐。本集團預計二零二四年對石 油及天然氣行業而言仍將是充滿挑戰的一年,從中長期 來看,石油及天然氣管道的建設不足、中國對能源安全 的重視和推動清潔能源等有望繼續對石油及天然氣行業 構成支撐。

For a long time, oil and natural gas have always been the overriding primary energy in the global energy consumption structure, and China is no exception. In recent years, the output of crude oil and natural gas has continued to increase, especially for clean energy such as natural gas, which has experienced long-term rapid growth in output. Oil and gas pipeline construction industry is an important part of the development of China's energy industry, as well as an important support for national energy security and economic development. With the rapid development of China's economy, the oil and gas pipeline industry has developed rapidly, and the market size has been expanding. The National Energy Administration held the 2023 National Oil and Gas Pipeline Planning, Construction and Protection Work Conference in April 2023 to implement the new deployment and requirements of energy work, continue to promote the construction of oil and gas production, supply, storage and sales system, accelerate the improvement of the "national network", and coordinate the pipeline protection work and major oil and gas pipeline network projects. Meanwhile, it is necessary to take the mid-term evaluation and optimization of the "14th Five-Year Plan" as an opportunity to further strengthen the connection between provincial and enterprise planning and national planning, and effectively ensure the implementation of national strategies and plans.

長期以來,石油及天然氣一直是全球能源消費結構中最 主要的一次能源,在中國也不例外,近年來原油以及天 然氣的產量也在持續提升,尤其是清潔能源,如天然 氣,產量長期快速增長。油氣管道工程建設行業是中國 能源行業發展的重要組成部分,也是國家能源安全和經 濟發展的重要支撐。隨著中國經濟的快速發展,油氣管 道行業發展迅速,市場規模不斷擴大。國家能源局在二 零二三年四月召開二零二三年全國油氣管道規劃建設和 保護工作會議,貫徹落實能源工作的新部署新要求,持 續推進油氣產供儲銷體系建設,加快完善「全國一張 網」,統籌做好管道保護工作和油氣管網重大工程,同 時,要以「十四五規劃」中期評估和優化調整為契機,進 一步加強省級和企業規劃與國家規劃的銜接,切實保障 國家戰略和規劃落地寬施。

At the beginning of 2022, the National Development and Reform Commission and the National Energy Administration issued the "14th Five-Year Plan Modern Energy System Plan", which put forward the goal that by 2025, the scale of domestic oil and gas pipeline network would reach approximately 210,000 kilometers. As of the end of 2022, the total mileage of long-distance oil and gas pipelines in China reached approximately 180,000 kilometers, which was twice the length recorded a decade ago, including 28,000 kilometers of crude oil pipelines, 32,000 kilometers of refined oil pipelines and 120,000 kilometers of natural gas pipelines. According to the demand forecast under the "dual carbon" goal, it is expected that China will add a total of approximately 65,000 kilometers of natural gas pipeline construction by 2035, including 29,500 kilometers of new trunk pipelines and 35,300 kilometers of provincial pipelines, approximately 2,000 kilometers of new crude oil pipelines and 4,000 kilometers of refined oil product pipelines. The "14th Five-Year Plan" will see China's oil and gas pipeline network enter into a new development stage of "national network" with physical interconnection and fair and open services, and it is expected that China will enjoy a stable growth in pipeline transportation in the next 10 to 20 years, of which the construction of pipeline transportation for natural gas pipelines and other ancillary facilities will be the focus of development. Emphasis will also be put on the construction of the Southern Section of China-Russia East Line, the middle section of West-to-East line 3, Westto-East line 4, Sichuan-to-East line 2, Hulin-Changchun natural gas pipeline and other major projects. The Group will be benefit from the construction of oil and natural gas pipelines.

二零二二年初,國家發展改革委、國家能源局印發《[十 四五」現代能源體系規劃》提出到二零二五年,全中國油 氣管網規模達到21萬公里左右的目標。截至二零二二年 底,全中國長輸油氣管網總里程約18萬公里,是十年前 的兩倍。其中包括原油管道2.8萬公里,成品油管道3.2 萬公里,天然氣管道12萬公里。按照「雙碳」目標下的需 求預測,預計到二零三五年中國還將新增天然氣管道建 設總里程約6.5萬公里,其中新增幹線管道2.95萬公里, 省級管道3.53萬公里,新建原油管道約2.000公里,成 品油管道約4.000公里。「十四五規劃」將是中國油氣管 網全面進入物理互聯互通、服務公平開放的「全國一張 網」發展新階段,預計未來10年至20年中國管道運輸還 將處於穩定增長期,其中天然氣管道等配套設施管道運 輸建設將是發展重點,重點建設中俄東線南段、西氣東 輸三線中段、西氣東輸四線、川氣東送二線、虎林 --長春天然氣管道等重大工程,本集團將受惠於石油及天 然氣管道的建設。

At the end of 2019, China Oil & Gas Pipeline Network Corporation ("Pipe China") was formally established, which is principally engaged in the investment, construction and operation of infrastructure such as oil and gas trunk pipeline networks and gas storage and peak shaving, the interconnection of the trunk pipeline network and the connection of social pipelines, as well as the operation and scheduling of the national oil and gas pipeline network, and the construction of an oil and gas pipeline network covering the west-east gas transmission, north-south gas transmission, coastal delivery to inland, east-west synergy, northsouth interoperability in accordance with the national plan, so as to enhance oil and gas transportation capacity and ensure a safe and stable supply of oil and gas energy. Pipe China plans to build a natural gas pipeline network of "5 verticals, 5 horizontals" in the next five years. By 2025, the natural gas pipeline network of Pipe China will form a trunk pipe network pattern of "four major (inlet) channels" and "5 verticals, 5 horizontals". Since its establishment, Pipe China has been constantly strengthening the overall coordination of China's oil and gas pipeline network layout, which has a positive impact on the development of the industry and the Group.

According to the China Natural Gas Development Report (2023), China's oil and gas enterprises increased their investment in exploration and development by approximately RMB370 billion in 2022, representing a year-on-year increase of 19%. Major breakthroughs have been made in natural gas exploration and development in onshore ultra-deep, deepwater, shale gas and coalbed methane. Among them, offshore oil and gas exploration and development has been moving towards deep water, and China's offshore oil and gas resources are relatively abundant. The remaining technically recoverable reserves of offshore oil and natural gas account for approximately 34% and 52% of China's remaining technically recoverable reserves of oil and natural gas. respectively. The ocean will be an important substitute area for the development of oil and gas exploration and production in China. In the future, China's offshore oil and gas exploration and development will expand to deepwater and ultra-deep water areas, and the Group, as a deep sea welded steel pipe manufacturer, will firmly seize the opportunities.

二零一九年底,國家石油天然氣管網集團有限公司(「國 家管網集團」正式成立,集團主要從事油氣幹線管網及 儲氣調峰等基礎設施的投資建設和運營,負責幹線管網 互聯互通和與社會管道聯通,以及全中國油氣管網的運 行調度,構建西氣東輸、北氣南下、沿海內送、東西協 同、南北互通的油氣管網建設,提升油氣運輸能力,確 保油氣能源安全穩定供應。國家管網集團規劃未來五年 將建成「五縱五橫」的天然氣管網,到二零二五年,國家 管網集團的天然氣管網將形成「四大(進口)通道」和「五 縱五橫」的幹線管網格局。國家管網集團成立以來,不 斷加強對中國油氣管網佈局的整體統籌,對產業發展起 到積極影響,也對本集團有正面的影響。

根據《中國天然氣發展報告(二零二三)》, 二零二二年中 國油氣企業加大勘探開發投資約人民幣3,700億元, 佔 同比增長19%, 天然氣勘探開發在陸上超深層、深水、 頁岩氣及煤層氣等取得重大突破。其中海洋油氣勘探開 發不斷向深水進發, 中國海洋油氣資源較為豐富, 海洋 石油及天然氣剩餘技術可採儲量分別約佔中國石油及天 然氣剩餘技術可採儲量的34%和52%。海洋將是中國油 氣勘探開發和生產發展的重要接替區。未來中國海洋油 氣勘探開發將拓展深水、超深水領域, 本集團作為深海 焊管製造商, 定能為本集團帶來機遇。

MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論與分析

In order to achieve the "dual carbon" strategic goal of "achieving peak carbon dioxide emission before 2030 and carbon neutrality before 2060", China indicates that ecology-focused green and low-carbon development will become the leading strategy in the future. In the medium to long term, natural gas will become the focus of fossil energy development, while oil and gas companies will also actively develop and explore clean energy, such as hydrogen, wind power and hydro-power. The construction of a series of natural gas pipeline, wind power and offshore platforms will be accelerated, and the Group will be able to meet the demand for green and low-carbon products with its technical strength and track record.

In the international market, the original global industrial and supply chains have been disrupted and are facing readjustment due to geopolitical conflicts, rising international commodity prices, high inflation and other factors. As such, importers of steel pipes are more inclined to seek for stable suppliers in the PRC. Besides, since the economies of certain developing countries around the world are gradually recovering from the pandemic, the demand for oil and natural gas continues to increase, which enables the Group to further expand its market share of the welded pipe overseas.

The Group believes that it is also our mission to achieve national energy safety and dual carbon goal, which will create business opportunities for the steel pipe manufacturing industry at the same time. Therefore, the Group will firmly seize the opportunities to boost its sales. As our long-term strategic goal is to become a leading global steel pipe manufacturer, the Group will expand our customer bases and market share by participating in more global oil and gas and engineering projects, diversify the use of steel pipes by supplying steel pipes for projects in infrastructure and high-end construction fields, such as bridges, wind power generation, offshore platforms, insulation pipe and water pipes. The Group will also continue to leverage its strengths in the steel pipe industry to secure project orders. 中國為實現「二零三零年前實現碳達峰,二零六零年前 實現碳中和」的「雙碳」戰略目標,標誌著以生態為重點 的綠色低碳發展將成為未來的主導戰略。中長期天然氣 將成為重點發展的化石能源,同時油氣企業也會積極發 展探索清潔能源,如氫氣、風力發電及水力發電等清潔 能源。一系列天然氣管網、風電及海上平台的建設將會 加快,憑藉本集團技術實力及往績記錄將能滿足綠色低 碳產品的需求。

國際市場方面,地緣政治衝突、國際大宗商品價格走 高、高位通脹等因素,令全球原有產業鏈及供應鏈被打 破及重新調整,進口鋼管商更願意尋找穩定中國供應 方;另外,全球部分發展中國家經濟從疫情中慢慢恢 復,對石油和天然氣的需求持續上升,更令本集團進一 步擴大海外焊管市場份額。

本集團認為國家能源安全和雙碳目標也是我們的任務, 也將為鋼管製造行業創造商機,本集團定當把握時機提 升銷售。鑒於我們的長期戰略目標為成為全球領先的鋼 管製造商,本集團將通過參與更多全球油氣工程項目, 拓大客源及市場份額,通過為橋樑、風力發電、海上平 台、保温管、水管等基建及高端建築工程領域的項目提 供鋼管,實現鋼管用途多元化。繼續發揮本集團在鋼管 行業的優勢,爭取項目訂單。

PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding. The principal activities of the subsidiaries of the Company include manufacture and sales of welded steel pipes. The Group is also engaged in property development and investment.

Details of the company's principal subsidiaries as at 31 December 2023 are set out in note 1 to the financial statements.

RESULTS AND DIVIDEND

The Group's profit for the year ended 31 December 2023 and the state of affairs of the Group at that date are set out in the financial statements on pages 117 to 258.

The Directors did not recommend payment of dividend for the year ended 31 December 2023 (2022: Nil).

BUSINESS REVIEW

A fair review of the business of the Group as well as discussion and analysis of the Group's performance during the year under review can be found in the "Chairman's Statement" and "Management Discussion and Analysis" set out on pages 7 to 11 and pages 18 to 36 respectively.

The Group will continue to focus on its steel pipe business by diversifying its product usage and market segment. For property development, the Group will continue to sell units of Phase II GDC and receive rental income from shops of Phase I GDC.

The Group is highly aware of the importance of environment protection and has not noted any material non-compliance with all relevant laws and regulations in relation to its business including health and safety, workplace conditions, employment and the environment. The Group has implemented environmental protection measures to reduce energy consumption, treat sewage before recycling and discharge, and sell wasted steel products to recycling companies. RELATIONS WITH EMPLOYEES, CUSTOMERS AND SUPPLIERS

Employees: The Group remunerates its employees based on their performance, experience and prevailing industry practice. Our package includes salaries, medical insurance, discretionary bonuses, on-job training, other benefits as well as mandatory provident funds schemes for employees in Hong Kong and statemanaged retirement benefit schemes for employees in the PRC. Our current relationship with our employees and the labour unions are good and are based on mutual support and respect.

Customers: We have built strong, long-standing relationships with our major customers, and established a strong customer base. We have obtained numerous patents, awards and recognitions, international certificates and long standing international and nationwide track record to establish our stable customer base. We are an industry pioneer and are the first and only steel pipe manufacturer in the PRC to manufacture and successfully develop deep sea welded steel pipes for the use at a water depth of 3,500m and a qualified supplier of Petrobras and Petronas. We believe that this can enable us to establish and maintain market leadership in the steel pipe industry.

Suppliers: We choose our suppliers of raw materials mainly based on the prices and quality of raw materials offered. We issue purchase orders to our suppliers that set out the quantities, prices and specifications of the products to be purchased, delivery arrangement and credit terms which were determined at arms' length negotiations between the parties based on normal commercial terms. We believe the relationship between us and our major suppliers is good and stable. Most of our procurements were paid in RMB.

Most of our revenue is generated from pipeline or other infrastructure projects that are mainly project-originated and non-recurring in nature. Our revenue will be affected if we cannot successfully obtain biddings from customers.
- The Group does not have any long term contracts with its customers of steel pipe business. If the Group's customers choose not to engage the Group in the future, the Group's steel pipe business operations, financial results and profitability will be affected.
- The Group's revenue of property business is dependent on the policy of PRC government. Any change of PRC policy will affect the property business operations, financial results and profitability.

As at 31 December 2023, the Company's reserves, including the share premium account and contributed surplus and accumulated losses, available for distribution, calculated in accordance with the Companies Law, Cap 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands (the "Companies Law"), amounted to approximately RMB58.5 million. The Board does not recommend the payment of any final dividend for the year ended 31 December 2023. Details of the reserves of the Company as at 31 December 2023 are set out in note 40 to the financial statements.

The reserves of the Group available for distribution depend on the dividend distributable by the Company's subsidiaries. For dividend purpose, the amount which the Company's subsidiaries in the PRC can legally distribute by way of dividend is determined by reference to their distributable profits as reflected in the PRC statutory financial statements which are prepared in accordance with accounting principles generally accepted in the PRC. These distributable profits differ from those that are reflected in the Group's financial statements prepared in accordance with IFRS Accounting Standards.

TAX RELIEF

The Company is not aware of any relief from taxation available to shareholders of the Company (the "Shareholders") by reason of their holding of the Company's shares.

For the year ended 31 December 2023, sales to the Group's five largest customers accounted for 40% of the total revenue of the Group, and sales to the largest customer amounted to 16%. Purchases from the Group's five largest suppliers accounted for 74% of the total cost of sales of the Group, and purchases from the largest supplier amounted to 20%. None of the Directors or any of their associates or any Shareholders (which, to the best knowledge of the Directors, own more than 5% of the number of the Company's issued shares) had any beneficial interest in the Group's five largest customers and five largest suppliers.

The Board is responsible for the leadership and control of the Company, overseeing the Group's businesses, strategic decisions, internal control, risk management systems, monitoring the performance of senior management and determining the policy for corporate governance. The management is responsible for daily operations of the Group under the leadership of the Chairman. The Directors have the responsibility to act objectively in the interests of the Company.

All Directors have carried out their duties in good faith, in compliance with applicable laws and regulations and in the interests of the Company and its shareholders at all times.

The Board has delegated various responsibilities to the Board committees including the Audit Committee, the Nomination Committee and the Remuneration Committee. Further details of these Committees are set out below in section B of this corporate governance report.

董事會致力於維持高水準的企業管治常規及商業道德, 並深信其是維持及提升投資者信心以及為股東帶來最高 回報的根本。

(A) 董事會 *職責及授權*

全體董事於所有時間均已竭誠履行彼等之職責, 遵守了適用法律及法規,符合本公司及其股東之 利益。

董事會已授權董事委員會(包括審核委員會、提名 委員會及薪酬委員會)多項職責。有關該等委員會 的進一步詳情載於本企業管治報告下文B節。

The Directors, including the independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective delivery of the Board functions. The number of independent non-executive Directors constitutes more than one-third of the Board. A list containing the names of the Directors and their roles and functions is published on the websites of the Stock Exchange and the Company at www.pck.com.cn.

The Company has received annual confirmation from each of the independent non-executive Directors (including Mr Chen Ping who has served the Company for more than nine years) of their independence pursuant to Rule 3.13 of the Listing Rules. The Company considers that all of the independent non-executive Directors are independent.

Upon reviewing the directorships and major commitments of each Director, and the attendance rate of each Director at the meetings of the Board and its committees, the Board is satisfied that all Directors have spent sufficient time in performing their responsibilities during 2023.

Board Meetings and Board Practices

The Company has adopted the practice of holding Board meetings regularly for at least four times a year at approximately quarterly intervals. Ad-hoc meetings will also be convened if necessary to discuss the overall strategy as well as financial performance of the Group. Notice of Board meeting is sent to all Directors at least 14 days prior to a regular Board meeting. Reasonable notice will be given to the Directors for ad-hoc Board meetings. Directors may participate either in person or through electronic means of communication. 董事(包括獨立非執行董事)為董事會帶來了廣泛 而有價值的業務經驗、知識及專業精神,以便董 事會確實有效發揮職能。獨立非執行董事人數佔 董事會人數的三分之一以上。一份載有董事姓名 及彼等職務及職能之名單於聯交所網站及本公司 網站www.pck.com.cn發佈。

本公司已按照上市規則第3.13條就各獨立非執行 董事(包括於本公司任職超過九年的陳平先生)接 獲有關彼等獨立性的年度確認書。本公司認為所 有獨立非執行董事均為獨立人士。

經審閱各董事之董事職位及主要承諾,以及各董 事於董事會及其委員會會議之出席率後,董事會 對所有董事於二零二三年均使用足夠時間履行彼 等之職責表示滿意。

董事會會議及董事會常規

本公司已按常規每年最少定期舉行四次董事會會 議,大約每季舉行一次。需要時亦會召開臨時會 議,商討整體策略以及本集團的財務表現。全體 董事於舉行定期董事會會議前最少十四天獲發董 事會會議通告,而臨時董事會會議通告則於合理 時間內事先派發予董事。董事可親身或以電子通 訊方式參加會議。

Agenda and Board papers together with all appropriate, complete and reliable information will be provided to all the Directors at least 3 days before meetings. All the Directors will be provided with sufficient resources to discharge their duties, and, upon reasonable request, the Directors will be able to seek independent professional advice in appropriate circumstances, at the Company's expenses. All Directors will have the opportunity to include matters in the agenda for Board meetings. The company secretary of the Company is responsible for keeping the minutes of Board meetings and meetings of Board committees. All minutes are open for inspection by any Director at reasonable time on reasonable notice.

For the financial year ended 31 December 2023, four Board meetings were held.

The Company's Articles of Association contain provisions requiring Directors to abstain from voting and not to be counted in the quorum at meetings for approving transactions in which such Directors or any of their associates have a material interest. According to current Board practices, any material transaction, which involves a conflict of interests for a substantial shareholder or a Director, will be considered and dealt with by the Board at a duly convened Board meeting.

The Board is of the view that the following mechanisms adopted by the Company are effective in ensuring that independent views and inputs are available to the Board:

- The Board is represented by sufficient number of nonexecutive Directors which meets the requirement of the Listing Rules.
- In assessing suitability of the Director candidates, the Board will consider their profiles, including their character, experience, qualifications and time commitment; the Board will also consider to the Board's overall composition and skill matrix as well as the Company's diversity policy.
- The Board will review each Director's time commitment to the Company's business annually.

本公司組織章程細則載有條文,要求批准董事或 其任何聯繫人士有重大權益之交易時,該董事須 放棄投票及不計入大會法定人數。根據董事會現 有慣例,牽涉主要股東或董事之利益衝突之任何 重大交易,將於正式召開之董事會會議上考慮及 處理。

董事會認為,本公司採用的以下機制可有效確保 董事會獲得獨立的觀點及意見:

- 董事會由足夠人數的非執行董事代表,符
 合上市規則規定。
- 於評估董事候選人的合適性時,董事會將 考慮彼等的個人資料,包括他們的個性、 經驗、資歷及所付出的時間;董事會亦會 考慮董事會的整體組成及技能,以及本公 司的多元化政策。
 - 董事會將每年審閱各董事對本公司業務的 所付出的時間。

- The Board will assess non-executive Directors' independence upon appointment and annually.
- Directors are required to abstain from voting in matters in which he has material interest.
- The Audit Committee, the Nomination Committee and the Remuneration Committee are authorised by the Board to obtain outside legal or other independent professional advice as necessary to assist the respective committee.

The quality of deliberations at meetings of the Board are reviewed during the annual evaluation of the Board's performance.

Chairman and Chief Executive

The Company is aware of the requirement under paragraph C.2.1 of the CG Code that the roles of chairman and chief executive should be separated and should not be performed by the same individual. The Company does not separately have any officer with the title of "chief executive". Mr Chen Chang, the Chairman and founder of the Group, is also responsible for the leadership and effective running of the Board, ensuring that all material issues are decided by the Board in a conducive manner. The Board will meet regularly to consider major matters affecting the operations of the Group. The Board considers that this structure will not impair the balance of power and authority between the Board and the management of the Company. The roles of the respective executive Directors and senior management, who are in charge of different functions complement the role of the chairman and chief executive. The Board is of the view that this structure provides the Group with strong and consistent leadership, facilitates effective and efficient planning and implementation of business decisions and strategies, and ensures the generation of shareholders' benefits.

The Board shall nevertheless review the structure from time to time to ensure appropriate measures are being taken should suitable circumstance arise.

主席及行政總裁

本公司知悉,企業管治守則第C.2.1條規定主席及 行政總裁的職務應予分離,而不應由同一人擔 任。本公司並未獨立設「行政總裁」一職。本集團 主席及創辦人陳昌先生同時負責董事會的領導工 作及實際運作,確保所有重大事宜均由董事會以 可行方式決定。董事會將定期舉行會議考慮影響 本集團營運的重大事項。董事會認為此架構不會 損害董事會及本公司管理層之間權力及權限的平 衡。各位負責不同職能的執行董事及高級管理層 會互補主席及行政總裁的職務。董事會認為此架 構可為本集團提供強大一致的領導,有助於切實 及有效地規劃及執行商業決策及策略及確保帶來 股東利益。

儘管如此,董事會仍將不時檢討此架構,以確保 因應條件變化適時對其作出適當措施。

Appointments, Re-election and Removal of Directors

The Board is responsible for selection and approval of candidates for appointment as Directors. The Company has established a Nomination Committee on 22 March 2012. The Nomination Committee is responsible for reviewing Board composition including the board diversity policy, evaluating the balance of skills, knowledge and experience of the Board and making recommendations on the appointment of Directors.

Each of the executive Directors has signed or renewed his/ her service contract with the Company for a period of three years. All of their appointments are subject to retirement by rotation and re-election in accordance with the Articles of Association of the Company.

Each of the independent non-executive Directors has been appointed or re-appointed for a term of two years, and are subject to retirement by rotation and re-election in accordance with the Articles of Association of the Company.

The Nomination Committee has reviewed the reappointments/appointment of both executive Directors and independent non-executive Directors and recommended to the Board of Directors for decision.

In accordance with the Company's Articles of Association, all Directors shall be subject to retirement by rotation at least once every three years and any new Director appointed to fill a causal vacancy shall submit himself/herself for re-election by shareholders at the first general meeting after appointment. In accordance with the Articles of Association, Ms Chen Zhao Nian will retire and, being eligible, will offer herself for re-election at the forthcoming AGM of the Company.

In accordance to the Company's Articles of Association, a separate resolution will be proposed for the re-election of each of Ms Chen Zhao Nian and Mr Zhan Jian Zhou and at the forthcoming AGM of the Company.

委任、重選及罷免董事

董事會負責遴選及批准候選人獲委任為董事。本 公司於二零一二年三月二十二日成立提名委員 會。提名委員會負責檢討董事會架構(包括董事會 多元化政策)、評估董事會技能、知識及經驗之間 的平衡,並就委任董事作出建議。

各執行董事均已與本公司簽署或重續其服務合 約,為期三年。彼等的委任均須根據本公司組織 章程細則輪席告退並重選連任。

各獨立非執行董事已獲委任或重新委任,為期兩 年,並須根據本公司組織章程細則輪席告退及重 選連任。

提名委員會已檢討執行董事及獨立非執行董事的 續聘/委任,並已就董事決策向董事會提供推薦 建議。

根據本公司組織章程細則,所有董事均須每三年 至少輪席告退一次,且獲委任以填補臨時空缺之 任何新董事須於獲委任後首個股東大會上供股東 重選連任。根據組織章程細則,陳兆年女士將於 本公司應屆股東週年大會上退任,並符合資格且 願意膺選連任。

根據本公司組織章程細則,將就陳兆年女士及詹 建宙先生各自之重選於本公司應屆股東週年大會 上提呈獨立決議案。

Training Induction and Continuing Development of Directors

The Directors have endeavoured to keep abreast of the changes in their responsibilities as a Director and of the business activities and development of the Company.

Each newly appointed Director receives formal, comprehensive and tailored induction on the first occasion of his/her appointment to ensure appropriate understanding of the business and operations of the Company and full awareness of director's responsibilities and obligations under the Listing Rules and relevant statutory requirements.

Directors are continually updated on developments in the statutory and regulatory regime and the business environment to facilitate the discharge of their responsibilities. The Directors have provided to the Company their records of continuous professional development during the year ended 31 December 2023.

During the year ended 31 December 2023, all Directors (being Mr Chen Chang, Ms Chen Zhao Nian, Mr Chen Ping, Mr Au Yeung Kwong Wah and Mr Zhan Jian Zhou) attended seminars and training courses in relation to corporate governance, Listing Rules update or financial markets update arranged by professional firms/institutions. Records of continuing professional development have been maintained by the company secretary. Besides, the company secretary also conducted briefings on corporate governance, directors' duties and responsibilities and provided materials for Listing Rules amendments to all Directors for their reference.

Model Code for Securities Transactions

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 to the Listing Rules. Following a specific enquiry, all the Directors has confirmed that they have complied with the Model Code throughout the year ended 31 December 2023.

When the Company is aware of any restricted period for dealings in the Company's securities, the Company will notify its Directors in advance.

董事的培訓指引及持續發展

董事須努力跟上董事責任及本公司的業務活動及 發展之變動。

每名新委任的董事在首次接受委任時會接獲一份 正式、全面及特為彼而設的指引,以確保彼對本 公司的業務及營運有合適的認識,並且對上市規 則及相關法定規定下董事之責任及義務有充分的 認識。

董事經常獲得有關法定及監管制度及營商環境之 最新資料,以助彼等履行職責。董事已於截至二 零二三年十二月三十一日止年度向本公司提供彼 等持續專業發展之記錄。

截至二零二三年十二月三十一日止年度,所有董 事(即陳昌先生、陳兆年女士、陳平先生、歐陽廣 華先生及詹建宙先生)均已參加由專業公司/機構 籌辦有關企業管治、上市規則更新或金融市場資 料更新的研討會及培訓課程。持續專業發展之記 錄一直由公司秘書存置。此外,公司秘書亦就企 業管治、董事之職務及職責進行簡介,並提供有 關上市規則修訂之材料,供所有董事參考。

證券交易的標準守則

本公司已採納上市規則附錄10所載的上市發行人 董事進行證券交易之標準守則(「標準守則」)。經 作出具體查詢後,全體董事確認彼等在截至二零 二三年十二月三十一日止年度均已遵守標準守則。

當本公司知悉任何本公司證券交易之受限期間 時,其將提前通知其董事。

Non-Competition Undertakings

The independent non-executive Directors have also reviewed the confirmations given by Mr Chen Chang and Bournam, being controlling shareholders of the Company, in respect of each of their compliance with the non-competition undertakings as disclosed in the prospectus of the Company dated 28 January 2010. The independent non-executive Directors are satisfied that the controlling shareholders have fully complied with the terms of the non-competition undertakings and no new competing business was reported by the controlling shareholders throughout the year ended 31 December 2023.

(B) Board Committees

The Board has established three committees, namely the Audit Committee, Nomination Committee and Remuneration Committee, for overseeing particular aspects of the Company's affairs. All Board committees of the Company are established with defined written terms of reference. The terms of reference of the Board committees are posted on the websites of the Company and the Stock Exchange.

The majority of the members of each Board committee are independent non-executive Directors.

Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances at the Company's expense.

Audit Committee

The Audit Committee consists of three independent nonexecutive Directors, namely Mr Chen Ping, Mr Au Yeung Kwong Wah and Mr Zhan Jian Zhou. Mr Au Yeung Kwong Wah is the Chairman of the Audit Committee. The primary duties of the Audit Committee are to review and supervise the financial reporting process and the internal control and risk management procedures and systems of our Group. The Audit Committee has reviewed the Company's audited consolidated financial statements for the year ended 31 December 2023 and the condensed unaudited consolidated interim financial statements for the six months ended 30 June 2023, including the accounting principles and practices adopted by the Company and the Group.

不競爭承諾

獨立非執行董事亦已審閱本公司控股股東陳昌先 生及Bournam就彼等各自已遵守本公司日期為二 零一零年一月二十八日之招股章程所披露的不競 爭承諾作出的確認書。獨立非執行董事信納控股 股東已全面遵守不競爭承諾之條款以及控股股東 於截至二零二三年十二月三十一日止整個年度概 無呈報新競爭業務。

(B) 董事委員會

董事會成立了三個委員會,即審核委員會、提名 委員會及薪酬委員會,以監察本公司各方面事 務。本公司全體董事委員會已設立特定書面職權 範圍。董事委員會之職權範圍刊載於本公司及聯 交所網站。

各董事委員會主要成員均為獨立非執行董事。

董事委員會有足夠資源履行其職責及在合理要求 下可於適當情況尋求獨立專業意見,費用由本公 司承擔。

審核委員會

審核委員會由三名獨立非執行董事(即陳平先生、 歐陽廣華先生及詹建宙先生)組成。歐陽廣華先生 為審核委員會主席。審核委員會的主要職責是審 查及監督本集團的財務申報程序及內部監控及風 險管理程序及制度。審核委員會已審閲本公司截 至二零二三年十二月三十一日止年度的經審核綜 合財務報表及截至二零二三年六月三十日止六個 月的簡明未經審核綜合中期財務報表,包括本公 司及本集團所採納的會計原則及慣例。

The main duties of the Audit Committee include the following:

- To review the financial statements and reports and consider any significant or unusual items raised by the internal auditor or external auditors before submission to the Board;
- To review the relationship with the external auditors by reference to the work performed by the auditors, their fees and terms of engagement, and make recommendations to the Board on the appointment, reappointment and removal of external auditors; and
- To review the adequacy and effectiveness of the Company's financial reporting system, risk management and internal control systems and associated procedures.

The Audit Committee held six meetings during the year ended 31 December 2023, of which two meetings with external auditors' presence, and all members of the Audit Committee attended all meetings. At the meetings, it reviewed the financial reporting and compliance procedures, the report of the internal auditor on the Company's internal control and risk management systems and processes, and the reappointment of the external auditors. No major issue on the internal control system of the Group has been identified.

There was no disagreement between the Audit Committee and the Directors in respect of matters about selection, appointment, resignation or dismissal of an external auditor.

The Company had established a whistleblowing policy and system for employees to raise concerns of possible improprieties where all concerns are addressed to the Audit Committee.

The Company's annual results for the year ended 31 December 2023 and interim results for the six months ended 30 June 2023 have been reviewed by the Audit Committee.

審核委員會之主要職責包括以下各項:

審核委員會於遴選、委聘、辭任或罷免外聘核數 師的事宜上,與董事並無意見分歧。

本公司已設立舉報政策及制度,供僱員提出可能 存在不當情況的事宜,而所有事宜均由審核委員 會處理。

本公司截至二零二三年十二月三十一日止年度之 年度業績及截至二零二三年六月三十日止六個月 之中期業績已由審核委員會審閱。

Nomination Committee

The Company recognises the benefits of a board that is composed of a balance of skills, experience, expertise and diversity of perspectives appropriate to the business development of the Company. The Board has adopted a board diversity policy in 2013. The Board has reviewed its composition and considered a number of aspects, including gender, age, educational background, professional experience, skills, knowledge and length of service in accordance with its board diversity policy. The Board considers that the existing board composition is well diversified and appropriate to the business development of the Company.

The Company established the Nomination Committee on 22 March 2012 in compliance with Appendix 14 to the Listing Rules. The Nomination Committee consists of three members, namely Mr Chen Ping, Mr Zhan Jian Zhou and Mr Chen Chang. Mr Chen Ping is the chairman of the Nomination Committee. The majority of them are independent non-executive Directors.

The primary functions of the Nomination Committee are to review and monitor the structure, size and composition (including the skills, knowledge and experience) of the Board to complement the Company's corporate strategy and make recommendations to the Board on matters relating to the appointment or re-appointment of Directors and succession planning for Directors, assess the independence of independent non-executive Directors, and review the board diversity policy and review the measurable objectives that the Board has set for implementing the board diversity policy, and the progress on achieving the objectives.

During the year and up to the date of this annual report, the Nomination Committee has reviewed the composition of the Board and made recommendations to the Board for the reappointment of Directors and succession planning for the chairman, assessed the independence of independent nonexecutive Directors and reviewed the board diversity policy determined the policy for nomination of directors, nomination procedure process and criteria to select and recommend candidates.

提名委員會

本公司認識到董事會成員組成達到技能、經驗、 專業知識及範疇多元化的平衡大有裨益,適合本 公司業務的發展。董事會已於二零一三年採納董 事會多元化政策。董事會已檢討其成員組成,並 根據董事會多元化政策考慮了多個方面,包括性 別、年齡、教育背景、專業經驗、技能、知識及 服務期限。董事會認為現有董事會成員組成充分 體現了多元化政策,且適合本公司業務發展。

本公司遵照上市規則附錄14的規定,於二零一二 年三月二十二日成立提名委員會。提名委員會由 三位成員組成,即陳平先生、詹建宙先生及陳昌 先生。陳平先生為提名委員會之主席。大部分成 員為獨立非執行董事。

提名委員會之主要職能是檢討及監督董事會之架 構、規模及成員(包括技能、知識及經驗),以輔 助本公司之企業策略及就委任或重新委任董事及 董事之繼任計劃相關之事宜,向董事會提供建 議,評估獨立非執行董事之獨立性,並檢討董事 會多元化政策,及檢討董事會為執行董事會多元 化政策而設立之可衡量目標,以及達到目標之進 程。

於年內及截至本年報日期,提名委員會已審閲董 事會之組成,並就重新委任董事及主席之繼任計 劃向董事會提供建議,其已評估獨立非執行董事 的獨立性,及檢討董事會多元化政策,並制訂董 事提名政策、提名程序及甄選及推薦候選董事的 標準。

The Nomination Committee held three meetings during the year ended 31 December 2023 and all members of the Nomination Committee attended the meetings.

According to the Nomination Policy adopted by the Company, appointments of Board members will be made on a merit basis and candidates will be considered against objective criteria. The selection criteria used in assessing the suitability of a candidate include:

- the candidate's academic background and qualifications (including professional qualifications, skills and knowledge which are relevant to the Company's business and corporate strategy);
- the candidate's relevant experience in the industry;
- the candidate's character and integrity;
- the candidate's willingness and capacity to devote adequate time in discharge of a director's duties;
- whether the candidate can contribute to the Board a diversity of perspectives, including but not limited to gender, age, race, cultural and educational background, professional experience, skills, knowledge and length of service;
- (where the candidate is proposed to be appointed as an independent non-executive Director) whether the candidate is in compliance with the criteria of independence under the Listing Rules; and
- any other factors as may be determined by the Board from time to time.

於截至二零二三年十二月三十一日止年度,提名 委員會已舉行三次會議,而提名委員會所有成員 均有出席該等會議。

根據本公司採納的提名政策,董事會成員的委任 將以用人唯賢的準則,根據客觀標準考慮可擔任 董事會成員的人選。用以評估候選人的甄選準則 包括:

- 候選人的學歷背景及資格(包括與本公司業務及企業策略有關之專業資格、技能及知識);
- 候選人的與行業有關之經驗;
- 候選人的品格及誠信;
- 候選人是否願意及能夠投入足夠時間以履 行董事之職責;
- 候選人是否能為董事會貢獻不同方面之多
 樣性,包括但不限於性別、年齡、種族、文
 化及教育背景、專業經驗、技能、知識及服
 務任期;
- (若候選人被建議委任為獨立非執行董事) 其是否符合上市規則下相關之獨立準則; 及
- 由董事會不時訂定的任何其他條件。

In terms of nomination procedures, any Board member may nominate or invite a candidate for appointment as a Director to be considered by the Nomination Committee. The Nomination Committee will then evaluate the personal profile of the candidate based on the selection criteria set out above, undertake due diligence in respect of such candidate and make recommendation for the Board's consideration and approval. For nomination of independent non-executive Director, the Nomination Committee will also assess the candidate's independence in accordance with the CG Code and the Listing Rules. For re-appointment of retiring Directors, the Nomination Committee will review the candidate's overall contribution and performance (including the candidate's attendance at Board committee meetings, Board meetings and general meetings, his/her level of participation and performance on the Board), and make recommendations to the Board and shareholders for re-election at general meetings.

The Company continuously seeks to enhance the effectiveness of the Board and to maintain a high standard of corporate governance and recognises and embraces the benefits of diversity in the composition of the Board.

In 2013, the Company has adopted a board diversity policy (the "Board Diversity Policy") for compliance with the Code Provision of the Listing Rules concerning the diversity of Board members. The Company recognises and embraces the benefits of diversity in Board members. A truly diverse Board will include and make good use of differences in the skills, regional and industry experience, background, race, gender and other qualities of Directors. These differences will be taken into account in determining the optimum composition of the Board. All Board appointments will be based on merit while taking into account diversity, including gender diversity.

As at the date of this report, the Board comprises five Directors, one of them is female. Three of them are independent non-executive Directors, thereby promoting critical review and control of the management process.

The Nomination Committee will continue to review the Board Diversity Policy from time to time to ensure its continued effectiveness. 就提名程序而言,任何董事會成員可提名或邀請 候選人擔任董事,以供提名委員會審議。提名委 員會將根據上述甄選標準評估候選人的個人資 料,對該候選人進行盡職調查,並提出董事會審 議和批准的建議。就提名獨立非執行董事而言, 提名委員會亦將根據企業管治守則及上市規則評 估候選人的獨立性。就重新委任退任董事而言, 提名委員會將檢討候選人的整體貢獻及表現(包 括候選人出席董事委員會會議,董事會會議及股 東大會,他/她的參與程度及董事會表現),以及 建議董事會及股東於股東大會上重選連任。

本公司不斷尋求提升董事會之成效及維持高水準 的企業管治,且認同及確信董事會組成多元化帶 來的裨益。

於二零一三年,本公司遵守上市規則有關董事會 成員多元化的守則條文,已採納董事會多元化政 策(「董事會多元化政策」)。本公司認同及確信董 事會成員多元化帶來的裨益。一個真正多元化的 董事會應包括並善用董事於技能、地區及行業經 驗、背景、種族、性別及其他素質等方面之分 別。公司在制定董事會成員的最佳組合時,將考 慮上述的分別。所有董事會成員之任命,均以用 人惟才為原則,並考慮多元化(包括性別多元化)。

截至本報告日期,董事會由五名董事組成,其中 一名為女性。其中三名為獨立非執行董事,有助 嚴格檢討及監控管理程序。

提名委員會將繼續不時檢討董事會多元化政策, 已確保其持續有效。

Workforce diversity

As at 31 December 2023, the Group had a total workforce of 875 employees, of which 77% (675 employees) are males, and 23% (200 employees) are females.

While we believe our future employee recruitment should predominantly be merit-based and do not consider it appropriate to set any target gender ratio for our workforce, we recognize and embrace the benefits of having a diverse workforce, and will continue to enhance the diversity of our workforce, subject to availability of suitable candidates.

Remuneration Committee

The Remuneration Committee consists of three members, namely Mr Chen Ping, Mr Zhan Jian Zhou and Mr Chen Chang. Mr Zhan Jian Zhou is the chairman of the Remuneration Committee. The majority of them are independent non-executive Directors.

The primary functions of the Remuneration Committee are to make recommendations to the Board on the remuneration of our Directors and senior management, determine on behalf of the Board specific remuneration packages and conditions of employment for our Directors and senior management and to review and/or approve the matters relating to share schemes under chapter 17 of the Listing Rules. Remuneration will be determined by reference to the duties and level of responsibilities as well as market practice and conditions. None of the Directors themselves approve their own remuneration.

During the year and up to the date of this annual report, the Remuneration Committee has reviewed the Group's remuneration policy, assessed the performance of executive Directors and reviewed the remuneration package of the executive Directors and senior management and recommended to the Board on the remuneration packages of the executive Directors and senior management. No share option has been granted during the year ended 31 December 2023.

For the year ended 31 December 2023, two meetings of the Remuneration Committee were held and all members attended the meetings.

薪酬委員會的主要職能是就董事及高級管理層的 薪酬向董事會提供建議,代表董事會釐定董事及 高級管理層的具體薪酬待遇及聘用條件,以及審 閱及/或批准上市規則第17章所述有關股份計劃 的事宜。有關薪酬將參考其職責及職權範圍,以 及市場慣例及市況釐定。概無董事批准其本身之 薪酬。

於年內及截至本年報日期,薪酬委員會已審閱本 集團的薪酬政策、評估執行董事的表現及審閲執 行董事和高級管理層的薪酬待遇以及就執行董事 及高級管理層之薪酬待遇向董事會提出推薦意 見。截至二零二三年十二月三十一日止年度,概 無授出購股權。

於截至二零二三年十二月三十一日止年度,薪酬 委員會舉行了兩次會議,而所有成員均有出席該 等會議。

Corporate Governance Function

The Board is responsible for performing the corporate governance duties of the Company. Terms of reference adopted by the Board include the duties of the Board on corporate governance functions to develop and review the Group's policies and practices on corporate governance, to review and monitor the training and continuous professional development of the Directors and the senior management and to review the Group's compliance with the CG Code and disclosure in this Corporate Governance Report.

(C) Accountability and Audit Financial Reporting

The Board, supported by the chief financial officer and the finance department of the Group, is responsible for the preparation of the financial statements of the Company and the Group. In the preparation of financial statements, IFRS Accounting Standards have been adopted and the appropriate accounting policies and statutory requirements have been consistently complied with. The Board aims to present a clear and balanced assessment of the Group's performance in the annual and interim reports to the shareholders, and make appropriate disclosure and announcements in a timely manner.

Directors' Responsibility on the Financial Statements

The Directors are responsible for overseeing the preparation of financial statements for the year ended 31 December 2023 with a view to ensuring that such financial statements give a true and fair view of the state of affairs of the Group and of the results and cash flows for that period. The Company's accounts are prepared in accordance with all relevant statutory requirements and suitable accounting standards.

The Directors are responsible for ensuring that appropriate accounting policies are selected and applied consistently; judgements and estimates made are prudent and reasonable; and the financial statements are prepared on a going concern basis.

The statement of the external auditor of the Company about their reporting responsibilities on the financial statements is set out in the Independent Auditor's Report on pages 106 to 116 of this annual report.

Management had provided monthly updates to Directors for giving a balanced and understandable assessment of the Company's performance, position and prospects to enable the Directors to discharge their duties.

(D) Internal Controls and Risk Management

The Board has overall responsibilities for maintaining a sound and effective internal control system of the Group. The Company has an internal audit department to ensure effective internal control system of the Group. The Group's system of internal control includes a defined management structure with limits of authority, and is designed to help the Group achieve its business objectives, safeguard its assets against unauthorised use or disposition, ensure the maintenance of proper accounting records for the provision of reliable financial information for internal use or for publication, and ensure compliance with relevant laws and regulations. The system is designed to provide reasonable, but not absolute, assurance against material misstatement or loss, and to manage rather than eliminate risks of failure in the Group's operational systems and in the achievement of the Group's business objectives.

The internal audit department conducts internal audit throughout the year. The internal audit process includes conducting supervision and examination on financial management and contract management, identifying problems and overseeing the rectification and correction of these problems, and reporting to the Audit Committee and the Board any material issues identified in the internal audit and the rectification and correction thereof for their review.

(D) 內部監控及風險管理

The Board has reviewed the internal audit report on quarterly basis and assessed the effectiveness (according to its magnitude and significance) of the Group's internal control system which covered all material controls, including financial, operational and compliance controls as well as risk management functions during the year ended 31 December 2023. The Board is of the view that risk management and internal control systems are adequate. No major risk was identified which affect operation of the Group.

The Company is in strict compliance with the related requirements of the Listing Rules, the SFO and the Guidelines on Disclosure of Inside Information issued by the Securities and Futures Commission. The Company discloses inside information to the public as soon as reasonably practicable. Before the information is fully disclosed to the public, the Company ensures the information is kept strictly confidential.

(E) Company Secretary

The Board appoints its Company Secretary in accordance with the Company's Articles of Association and in compliance with the requirements of the Listing Rules. Biographical details of the current Company Secretary is set out in the section headed "Profile of Directors and senior management" on page 37 to 48 of this annual report. The Company Secretary has complied with the professional training requirement as set out in the Rule 3.29 of the Listing Rules during the year ended 31 December 2023.

(F) Shareholders' Rights

The Board welcomes shareholders to present their views and shareholders may at any time submit their questions and concerns about the Group. Enquiries may be put to the Board by contacting the Company Secretary through our shareholders' email at ir@pck.com.cn. Shareholder(s) holding not less than one-tenth of Company's paid-up capital may request the Board to convene an extraordinary general meeting. The objects of the meeting must be stated in the related requisition deposited at the Company's registered office and addressing to the Company Secretary at the Company's principal place of business in Hong Kong. Procedures for a shareholder to propose a person for election as a Director

Subject to the applicable laws and the provisions of the Company's Articles of Association, the Company may from time to time in general meeting by ordinary resolution elect any person to be a Director either to fill a casual vacancy or as an additional Director. A shareholder may propose a person for election as a Director by lodging the following documents to the Board or Company Secretary at our Hong Kong office at Unit 605-606, 6/F., Tower III, Enterprise Square, No. 9 Sheung Yuet Road, Kowloon Bay, Kowloon, Hong Kong: 1) a notice in writing of the intention to propose that person (with full name and biographical details as required by Rule 13.51(2) of the Listing Rules) for election as a Director; and 2) a notice in writing by that person of his willingness to be elected as a Director. Such notices shall be lodged at least 7 clear days before the date of the general meeting and the period for lodgement of such notices shall commence no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and shall be at least 7 clear days in length.

To safeguard shareholder interests and rights, a separate resolution is proposed for each substantial separate issue at shareholder meetings, including the election of individual Directors.

All resolutions put forward at shareholder meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and of the Stock Exchange after each shareholder meeting.

(G) Investor Relations and Communication With Shareholders

The Company considers that effective communication with shareholders is essential for enhancing investor relations and investor understanding of the Group's business performance and strategies. The Company also recognises the importance of transparency and timely disclosure of corporate information, which will enable shareholders and investors to make the best investment decisions.

The Company will continue to maintain an open and effective investor communication policy and to update investors on relevant information on the Group's business in a timely manner, subject to relevant regulatory requirements.

Memorandum and Articles of Association

There was no change in the constitutional documents of the Company during the year. The latest version of the Memorandum and Articles of Association of the Company is posted on the Company's website.

2023 Annual General Meeting

The Board is committed to the constructive use of the AGM as a forum to meet shareholders. The chairman of the Board and the chairmen of the Audit Committee and Nomination Committee, members of the Remuneration Committee and the external auditors attended the 2023 AGM. 本公司即將於二零二四年六月二十一日(星期五) 舉行股東週年大會。股東週年大會通告將最少於 股東週年大會前20個完整營業日前寄發予股東。

董事會已檢討股東通訊政策之實施及成效。經考 慮現有溝通及聯繫之多個渠道後,董事會信納股 東通訊政策截至二零二三年十二月三十一日止年 度已具有成效。

本公司將繼續維持開放、有效的投資者溝通政 策,並遵照相關監管規定及時向投資者提供有關 本集團業務的最新資料。

二零二三年股東週年大會

At the 2023 AGM, the Company proposed separate resolutions on the issues considered. Resolutions passed at the 2023 AGM were as follows: (i) received the audited consolidated financial statements for the year ended 31 December 2022 together with the reports of the Directors and auditors of the Company; (ii) re-elected Mr Chen Guo Xiong as executive Director, Mr Chen Ping and Mr Au Yeung Kwong Wah as independent non-executive Directors and authorised the Board to fix the Directors' remuneration: (iii) reappointed CCTH CPA Limited as auditors of the Company and authorised the Directors to fix its remuneration; (iv) approved a general mandate for the Directors to allot and issue of new shares of an amount not exceeding 20 per cent of the issued share capital of the Company as at the date of the 2023 AGM; (v) approved a general mandate for the Directors to repurchase shares of an amount not exceeding 10 per cent of the aggregate nominal amount of the Company's issued share capital as at the date of the 2023 AGM; (vi) extended the general mandate granted to the Directors of the Company to allot, issue, and deal with additional shares in the share capital of the Company by an amount not exceeding the amount of the shares repurchased by the Company; and (vii) approved and adopt the amended and restated articles of association of the Company in substitution for and to the exclusion of the existing articles of association of the Company and to authorise the Directors to do all things necessary to implement the adoption of the new amended and restated articles of association of the Company. All resolutions were passed by way of a poll conducted by the Company's registrar. The poll results of the 2023 AGM were available on the Company's website.

The 2024 annual general meeting ("2024 AGM") of the Company will be held at 1/F., China Building, 29 Queen's Road Central, Hong Kong on Friday, 21 June 2024 at 10:30 a.m.

All Shareholders are encouraged to attend the 2024 AGM and exercise their rights to vote. Shareholders are invited to ask questions relating to the business of the meeting. In order to enhance transparency of the Company and facilitate the shareholders of the Company and investors to make informed investment decisions relating to the Company, the Board adopted a dividend policy on 28 March 2019 ("Dividend Policy").

According to the Dividend Policy, when determining whether to declare any dividend in the future and the amount of dividend to be declared, the Company shall consider a number of factors, including but not limited to:

- the Group's actual and expected financial results;
- the general economic conditions and other internal or external factors that may have an impact on the business or financial performance and position of the Company;
- the Company's business operation strategy, including expected working capital requirements, capital expenditure requirements and future expansion plans;
- the Company's liquidity position;
- retained earnings and distributable profit reserves of the Company;
- the contractual restrictions on the payment of dividends imposed by the Company's lenders and other institutions; and
- any other factors that the Board considers to be applicable from time to time.

The Company does not have any pre-determined dividend distribution proportion or distribution ratio. The declaration, payment and amount of dividends will be subject to the Board's discretion. The Board will review the Dividend Policy on a regular basis.

(J) Anti-corruption and Whistle-blowing Procedures

The Group maintains and effectively implements a comprehensive system of internal control and stringent policies for anti-corruption, and is committed to preventing and monitoring any malpractices or unethical practice.

The Group is in compliance with all applicable anti-bribery and corruption laws including the Prevention of Bribery Ordinance (Chapter 201 of the Laws of Hong Kong) in Hong Kong. The Group has also applied the Corporate Governance Code as the basis in formulating the internal rules and regulations for integrity discipline and clean administration. The Group will adhere to its corporate ethics and uphold its reputation to prevent corruption.

To prevent corruptive practices and raise employees' awareness regarding such matter, the expectations and appropriate procedures of engaging third parties, and standards relating to anti-bribery and anti-corruption are set out in the anti-corruption and bribery policy of the Group.

Employees, who are found breaching the Group's code and policies will be investigated and may be subject to warning, suspension, termination of contract, dismissal and disciplinary discharge.

In addition, a whistleblowing policy has been established to provide employees with guidance and channels for the reporting of fraud, corruption, bribery, criminal offences, conflict of interest, harassment, workplace bullying and other non-compliances with the laws, regulations and internal controls or other forms of misconducts without fear of adverse consequences. 本公司沒有任何預定的股息分配比例或分配比 率。股息之宣派、派付及金額將由董事會酌情決 定。董事會將定期檢討股息政策。

Suspected non-compliance issues may be reported to the chairman of the Audit Committee, the assistant to chairman of the Company, immediate supervisor or the head of department who is also required to notify any concerns to the Audit Committee on a timely basis. According to this policy, the identities of employees who reported in good faith will be kept confidentially and protected by the Group without any form of retaliation, harassment or victimization.

The Board is committed to the long-term sustainability of the environment and communities in which the Group operates and continually enhances investment value to stakeholders through proper and effective internal control systems and ESG risk management measures throughout its operations. The Board maintains oversight of and approves the identification and assessment of ESG issues and confirms that to the best of its knowledge, this report addresses the material topics related to the operations of the Group and fairly presents its ESG performance and impacts.

The Group's management is responsible for monitoring and reviewing the compliance with local laws and regulations with regards to ESG-related issues. The management is also responsible for establishment of sustainability strategies, policies and measures to implement sustainability initiatives, provide sustainability reporting and prepare the ESG report.

This section is prepared in accordance with Appendix 27 Environmental, Social and Governance Reporting Guide (the "ESG Guide") of the Listing Rules. The Board is pleased to present our performance and progress on the environmental and social aspects from 1 January 2023 to 31 December 2023.

This ESG section would separate into two subject areas — (A) environmental and (B) social and each subject area included relevant aspects as follow:

A. ENVIRONMENTAL

The Group is committed to energy saving and environmental protection. The Group is trying to keep the damage to the environmental at a minimal level by reducing pollutants and hazardous wastes during the manufacturing process and ensuring our activities and operations are to be energy, water and resources saving, and to prevent pollution, reduce wastes and minimize the negative impacts on and harmonize with the environment. The Group has set up procedures and systems to comply with the rules and impose control on emissions.

A.1 Emissions

Types of emissions from the Group were mainly carbon dioxide, methane, nitrous oxide etc. emitted during operation of production lines.

Scope 1 greenhouse gas emissions in 2023 were primarily generated from natural gas, diesel oil and gasoline.

Hazardous waste

Hazardous wastes were produced during production, including waste oil, waste sludge, waste mineral oil, paint, paint residue, waste grease, waste grease drum, waste paint drum, waste emulsion drum, waste activated carbon, waste organic solvent, waste developer, and fixer. Total hazardous waste produced in 2023 was approximately 261 tonnes and 0.0005 tonnes of hazardous waste was produced for each tonne of product.

有害廢棄物

生產期間產生的有害廢棄物包括廢油、廢油泥、 廢礦物油、油漆、漆渣、廢油脂、廢油脂桶、廢 漆桶、廢乳化液桶、廢活性碳、廢有機溶劑、廢 顯影液及定影液。於二零二三年產生的總有害廢 棄物為約261噸,每噸產品產生0.0005噸有害廢 棄物。

Non-hazardous waste

Non-hazardous wastes were produced during production including welding slag, iron filings, scrap steel. Total non- hazardous waste produced in 2023 was approximately 2,490 tonnes and 0.005 tonnes of non-hazardous waste was produced for each tonne of product.

Emissions are proportional to the production level. Therefore, total emissions in 2023 increased as compared to 2022. Intensity amount per each tonne of product in 2023 decreased as compared to 2022. Nevertheless, in an aim to reduce emission of greenhouse gas, the Group has implemented the policies as follow:

- The factory in Lianyungang and Zhuhai is designed to let in more natural light and allow for natural ventilation in order to reduce use of electricity;
- Solar photovoltaic power generation equipment are installed on the roof of the factories of Lianyungang and Zhuhai factories in order to facilitate the use of clean energy;
- The light and equipment would be turned off during luncheon rest time.

Treatment of hazardous and non-hazardous wastes

- The Group has set up procedures in the collection, storage, transportation and disposal of polluting wastes to prevent scattering, draining, leakage. Authorization is need for dumping, stacking, discarding or scattering the wastes;
- The Group has identified specific rubbish bins for different types of wastes like scrap steel, industrial wastes, domestic wastes, oil-bearing wastes, and delivered the wastes to units with waste treatment qualification for waste disposal or recycling;
- The Group has strengthened training for employees to enhance their skills and knowledge of handling waste;
- 4. Hazardous wastes are disposed to qualified and designated institutions with special care.

The Group has received no cases of environmental pollution or complaints in 2023.

無害廢棄物

Use of resources like electricity is proportional to the production level. Therefore, electricity usage in 2023 increased as compared to that of 2022. Intensity amount per each tonne of product in 2023 decreased as compared to that of 2022.

Water source

The water source that is fit for purpose of the Company and is the running water supplied by the government which guarantees reliable quality and supply. There has been no suspension of water supply.

Water was consumed mainly for office general use, hydrostatic pressure test and ultrasonic tests.

Measures to enhance water efficiency:

- 1. Reuse water for production;
- Use of water-saving taps and sanitary wares with sensor;
- Increase awareness of employees on water saving by training.

Water consumption efficiency was improved. Total water consumption in 2023 was similar to that of 2022.

Package material

The Group uses packing rope, packing tape and dunnage for packaging final products.

A.3 The Environmental and Natural Resources

In an aim to minimize surplus materials, the Group would estimate the materials needed for production prior to procurement. In addition, the Group puts in place a scrap metal recycling mechanism to sell the wasted steel produced in our production process to recycling companies. 使用電力等資源與生產水平成正比。因此,於二 零二三年的用電量較二零二二年有所增加。於二 零二三年每噸產品數量的密度較二零二二年有所 減少。

水源

本公司適用的水源為政府提供的自來水,質量可 靠,水量充足,未出現無故停水事件。

本公司水消耗主要為辦公室一般用途、水壓試驗 及超聲檢驗。

採取了以下提高用水效益的措施:

- 1. 生產用水循環利用;
- 使用「人用即開,人走即停」的節能水龍頭 及衛生潔具;
- 3. 通過培訓提高僱員節水意識。

用水效益得到了提高。於二零二三年的總用水量 與二零二二年大致相當。

包裝材料

本集團使用包裝繩、包裝膠帶及墊材打包成品。

A.3 環境及天然資源

為減少剩餘材料,本集團將於採購前估算生產所 需的材料。另外,本集團設有廢鐵回收機制,將 在生產過程中產生的廢棄鋼材售予回收商。

A.4 Climate Change

Extreme weather events are becoming more frequent and severe and tackling climate change has become a global consensus. The Group has realized that climate change will affect its business operations. The Group regularly reviews global and local government policies, regulatory updates and market trends to identify potential climate-related risks which may have impact on the Group's business operation.

In accordance to the reporting framework developed by the Task Force on Climate-related Financial Disclosures, there are two major categories of climate-related risks, physical and transition risks. Climate change can pose threats to the Group, such as business disruption, physical damage and rise in operational costs due to severe and extreme weather events. The Group has insurance policies in place to mitigate such risks.

B. SOCIAL

B.1 Employment

The Group has committed in cultivating a good workplace practice free from discrimination and providing equal opportunities for all regardless of age, gender, race, colour, sexual orientation, disability or marital status to increase employee satisfaction.

The Group has also adopted principles in hiring new employees regardless of colour, religion, gender, nationality, race for selection, hiring, training, compensation and promotion.

A.4 氣候變化

極端天氣事件發生概率日趨頻繁及嚴重,同時應 對氣候變化已成為全球共識。本集團意識到氣候 變化將影響其業務運營。本集團定期審閲全球及 地方政府政策、監管更新及市場趨勢,以識別可 能影響本集團業務運營的潛在氣候相關風險。

根據氣候相關財務披露工作組制定的報告框架, 氣候相關風險分為物理及過渡風險兩大類。氣候 變化會給本集團帶來威脅,如嚴重及極端天氣事 件造成的業務中斷、物質損失及運營成本上升。 本集團已制定保險政策以減輕此類風險。

B. 社會 B.1 僱傭

本集團致力營造無歧視的良好工作環境,令員工 不論年齡、性別、種族、膚色、性傾向、殘疾或 婚姻狀況均能獲得平等機會,從而提高員工滿意 度。

本集團在招聘新員工時亦不設虜色、宗教、性 別、國籍、種族等限制,在員工甄選、僱用、培 訓、報酬及晉升方面秉持一視同仁的原則。 The Group has complied with the all the relevant laws and regulations in the PRC and Hong Kong, including but not limited to:

Our employment contract specified the terms, including compensation and dismissal, working hours, rest periods and other benefits and welfare of our staff. The Group's employee handbook distributed to employees also includes information of policies on compensation and dismissal, employment benefits, rights on termination, business conduct and leave benefits.

In relation to 2023, the Group was not aware of any material non-compliance with the relevant labour laws and regulations in to compensation and dismissal, recruitment and promotion, working hours, rest periods, and other benefits and welfare that have a significant impact on the Group. 本集團已遵守所有於中國及香港的相關法律法 規,包括但不限於:

B.2 Health and Safety

The Group has complied with the laws and regulations and adopted the Health Safety and Environmental ("HSE") management policy, in an effort to prevent pollution, ensure health and safety of our employees, and promote sustainable development. Our target is to achieve zero accidents, zero injuries and zero losses in order to meet the international HSE management standard.

The Group's employees reside in the neighbourhood areas. Within our plant zone, there are gardening landscape, fish ponds and recreational facilities, which offer a comfortable environment and a sports ground for our employees.

Occupational Safety

We have adopted the HSE risk identification, risk assessment and control procedures to manage our occupational safety risk. The Group's management is responsible for organising periodic risk identification and evaluation exercises, and is responsible for sorting, aggregation and distribution of relevant information, which includes the identification of risk factors for occupational safety and health, risk assessment on operating conditions, possibility of accidents, the formulation of operational control procedures, contingency plans, safety level standards, as well as training and education issues.

The Group has kept records and documents relating to risk management, including the "Control procedures of the new, rebuilding and extension projects", "Risk sources identification and risk evaluation form" and "List of major risks" for staff reference.

The Group always finds great importance in occupational safety and regularly provides training for staff. In 2023, the Group hosted trainings and rehearsals in productions bases for fire alert, so as to enhance safety awareness and emergency response, and held hazards identification programs and assemblies of risk management activities.

B.2 健康與安全

本集團一直遵守法律法規並採納健康安全環保 (「HSE」)管理政策,防止污染,確保員工的健康 安全,促進持續發展。我們致力追求零事故、零 傷害、零損失,以達到國際HSE的管理水準。

本集團的員工均在鄰近地區居住。廠區內設置園 藝、魚池及康樂設施供員工觀賞及運動。

職業安全

公司使用HSE的風險辨識、風險評估控制程式管 理職業安全風險。本集團的管理層負責定期組織 風險辨識和評估活動,並負責相關資料的整理、 匯總和分發。當中內容包括:職業安全健康風險 因素的辨識:作業條件風險評估法;發生事故的 可能性;制定運行控制程式;應變方法;安全等 級標準;培訓及教育等事項。

本集團備有風險管理的相關記錄及文件,包括《新 改擴建項目控制程式》、《風險源辨識和風險評估 表》及《重大風險清單》,供員工參考。

本集團一直十分重視職業安全並定時為員工提供 培訓。於二零二三年,本集團在各生產基地進行 消防培訓及演練,以加強安全意識及應對突發事 件能力,並舉辦崗位危害因素辨識與風險管控活 動的匯報大會。

B.3 Development and Training Staff Development and Training

Through meetings, trainings and notifications on notice board, the Group promotes its safety philosophy and amiable working environment among various departments and teams. We offer our employees access to learning and understanding about the Group, so that each employee and contractors of the Group or visitors can recognize their responsibilities and obligations in the aspect of improving the environment and enhancing occupational health and safety performance. We make great efforts on improving the environment and occupational safety.

Our adherence to the HSE management policy is a testimony of the greatest commitment of the Group towards environment and occupational health and safety. This policy is available for review by employees at any time. In the year, the Group further improved site management standards, achieved the goal of dedicated management, and further promoted the 6S management model in the Company. Project meetings were kicked off in the production sites of Zhuhai and Lianyungang.

B.3 發展及培訓

員工發展與培訓

本集團通過會議、培訓、板報宣傳等方式,將本 集團的安全理念、良好工作環境的訊息傳達到各 部門及各自班組,組織員工學習、了解本集團, 使本集團的每個員工、承包商或到訪人員均認識 到自己在改善環境和加強職業健康安全表現方面 的職責和應盡的義務,努力改善環境和職業安全。

本集團以HSE管理方針,對環境及職業健康安全 作出最高的承諾。該方針是公開性文件,任何員 工均可隨時閱讀。年內,本集團進一步提高現場 管理水準,達到精細化管理的目標,進一步加強 企業6S管理模式的應用推廣。專案大會亦在珠海 及連雲港生產基地舉行。

The Group endeavours to enhance the skills of each employee in various aspects by providing staff trainings, which include the "Weekly Star" and "Weekly Talk". A wide array of training courses are provided for employees to strengthen their work-related knowledge and skills. Also, the Group hosted an "advanced employee's election", whereby each of the employees obtaining a certificate of honorary was offered an outdoor training opportunity. To enable excellent employees to take up management positions and to bolster our team's management capabilities, the Company also organised the "team leader for production and management training" courses during the year.

The Group has set up a labour union to further promote spiritual positive energy with various social activities.

To reinforce the employees' sense of belonging to the Group, a wide range of sport events are provided by the Group for its employees every year, including basketball and table tennis contests and a game of tug-of-war, etc. In addition, we have provided activities that are of educational significance and served to enhance the work performance of our employees, including the "Business Oral English", "Training and Assembly for Fire", "Sales Training", "Joint Training and Team Building Program for Financial Department", and "Annual Sales Meeting", etc. The Zhuhai Company of the Group also held the third quarter award ceremony of "Set an example around you and consolidate the strength of the Company". The Company honored the advanced teams and individuals emerging from various functions with great ceremony, and called on all employees to learn from such advanced teams and individuals. The Zhuhai Company also organized a warm spring trip for the 8th March Women's Day.

We encourage our employees to take an active part in local community activities, including the "Green Enterprise Cup" Table Tennis and Badminton Tournament of Panyu District Youth Entrepreneur Association and the private enterprises working concern group activities. Various events were held, including the second "We Are Family • PCK" friendly wall donation, the hike of female employees for the 8th March International Women's Day, the Lantern Festival Fair jointly held by the Lianyungang base of Chu Kong Steel Pipe and the Community Workstation of the Neighborhood Center of Xuwei New Area, and the employee-oriented "1st May Caring Show" organized by the Artistic Association of Zhuhai Trade Union.

本集團已設有工會,透過各項社區活動傳遞精神 文化正能量。

為提高員工對本集團的歸屬感,本集團每年會為 員工組織各類運動,包括籃球比賽、乒乓球賽、 拔河比賽等;另有其他具教育義意及提升員工對 工作表現的相關活動,包括「商務英語口語培訓課 程」、「消防培訓及演練」、「銷售系統培訓」、「集 團財務部聯合會議」及「銷售年會」等。本集團的 珠海公司亦舉辦了第三季度「樹立身邊先進凝聚 公司力量」,先進表彰大會上,公司隆重表彰了各 條戰線上湧現出來的先進團隊及個人,號召全體 員工向受表彰的先進團隊和先進個人學習。珠海 公司亦安排了三八婦女節暖春之旅。

B.4 Labour Standards

The Group has complied with the Labour Law of the People's Republic of China (《中華人民共和國勞動法》), Labour Contract Law of People's Republic of China (《中華人民共和國勞動合同法》), the Law of the PRC on Prohibition of Using Child Labour* (《禁止使用童工規定》) and other relevant laws. The Group has specified staff recruitment procedures which avoid the recruitment of child labour and ensure the fulfilment of entry requirements by recruited staff through examining their identification card and certificate. The Company is required to enter into written labour contracts with employees upon their entry. There is no forced labour within the Group. The Group has not employed any staff aged under 16.

Staff Code

The staff code of the Group is prepared based on the PRC labour law and is in line with the national standards of the PRC. The Group has also been providing its staff with guidance in accordance with the national legislation.

B.5 Supply Chain Management

The Group has maintained proven track records of high production efficiency and timely delivery. We have established deep and cordial relationships with our suppliers. The Group keeps a list of qualified suppliers, whose appraisal is based on their track record of compliance with international standards and the Group's past cooperation relationship with them. The Group also consider factors such as compliance with environmental requirements in our supplier vendor assessment, selection and evaluation process.

For the year ended 31 December 2023, the Group has 1,673 suppliers which are located in the PRC.

B.4 勞工準則

員工守則

B.5 供應鏈管理

本集團一直保持高生產效能並及時付運的往績, 與各供應商保持良好合作關係。本集團內部亦備 有一份合資格供應商的名單,考核過程以該供應 商符合國際標準的往績及本集團過往與其合作關 係作參考。本集團在評估、選擇及評價供應商的 過程中,亦考慮遵守環境要求等因素。

截至二零二三年十二月三十一日止年度,本集團 有1,673家供應商位於中國。

The Group has adopt the following procedures to select and evaluates suppliers:

- Evaluating their product quality and company background including but not limited to the environment, health and safety awareness;
- 2. Comparing historical level and test results of products;
- 3. Evaluating the standards of their products;
- Evaluating their production capacity, delivery time and stability, reputation, cost and services;
- Inspecting the sample of purchased products fulfilling the requirements;
- 6. Checking the products fulfilling the specific requirements under the laws and regulations or supply contracts.

B.6 Product Responsibility *Product quality*

With its state-of-art technology, equipment, management and well-established reputation, the Group is dedicated to the provision of high-quality products and services that satisfy customers' needs. Our product quality has met a number of international standards. We are also the only domestic welded steel pipe manufacturer being granted five honors, namely the "Superior Quality Award for Actual Quality of Metallurgical Products", "Gold Cup Prize for Actual Quality of Metallurgical Products", "High and New Technology Enterprise", "Province-recognised Enterprise Technology Center", and "National Key New Products" and hosts a "Academician Workstation". We are the main drafter of the national standard for longitudinal welded steel pipes in China. Meanwhile, with the setting up of the "Post-doctoral Research Station" and "Academician Workstation", the Company strives to further enhance its product quality and extend the application of its products.

B.6 產品責任 產品質量

本集團以先進技術、設備、管理和良好的信譽保 證提供高品質的產品和服務,深受客戶滿意。產 品品質符合不同的國際標準,亦是中國目前唯一 一家同時擁有「中國冶金產品實物質量特優獎」、 「中國冶金產品實物質量金杯獎」、「高新技術企 業」、「省級認定企業技術中心」和「國家重點新產 品」五項榮譽於一身的焊管製造商及設有「院士工 作站」,是國家直縫焊管標準的主要起草單位。同 時,本公司設有「博士後科研工作站」和「院士工 作站」,不斷提升產品的品質和拓展產品的適用 領域。

Quality assurance process

The Group strictly upholds the ISO9001 quality management system. With the use of advanced testing equipment, and the conduct of on-line and off-line testing as well as mechanical and chemical properties testing, we inspect the products at each production process stage in accordance with the highest product quality requirements through a myriad of tests, such as steel ultrasonic testing, ultrasonic welding detection, weld X-ray inspection system, hydrostatic testing and flattening test. Upon obtaining post-test data, we will make a rigorous analysis on product quality, so as to ensure that each product meets customer requirements. We have built a testing center in compliance with the national standards and the center has been recognised by China National Accreditation Service for Conformity Assessment (CNAS). The Group's testing center is equipped with a wide variety of laboratory equipment, including universal materials testing machine, low temperature impact material testing machine, drop weight tear test (DWTT) machine, hydrogen induced cracking (HIC) testing, sulfide stress corrosion cracking (SSC), crack tip opening displacement (CTOD) test, computer-controlled chemical composition vacuum direct reading spectrometer and microscope. Achieving six standards, our measuring chamber has passed through the ISO10012: 2003 AAA measurement management system certification. This proves that our measuring instruments are of high qualification and effectiveness. The Group's testing centre has passed the "National safety quality standardisation" and obtained the "TUV SUD Metal Materials Laboratory Accreditation Certificate". Our products, an unfailing symbol of quality, are blessed with unparalleled reputation in the international market under the "PCK" brand.

In 2023, return of products sold or delivered due to safety and health reasons was zero. The Group would repair the products to customers if there are problems.

質量檢定過程

本集團嚴格執行ISO9001品質管理體系,採用先 進檢測設備,通過線上和離線檢測以及機械和化 學性能測試等方法,嚴格按最高產品質量要求檢 驗每個生產過程的產品品質,通過鋼板超聲波檢 測、焊縫超聲波檢測、焊縫X光檢測系統、水壓試 驗和壓扁試驗等檢測。在取得檢測資料後,還會 對產品品質作嚴格的分析,確保每件產品均符合 客戶的要求。公司擁有達到國家標準的檢測中 心,獲中國合格評定國家認可委員會(CNAS)認 可。本集團檢測中心配備包括萬能材料試驗機、 低溫衝擊材料試驗機、落錘撕裂試驗(DWTT)機、 氫致開裂(HIC)檢測、硫化物應力腐蝕開裂(SSC) 檢測、裂紋尖端張開位移(CTOD)試驗、電腦控制 化學成份真空直讀光譜儀和金相顯微鏡等實驗設 備。公司計量室通過ISO10012:2003測量管理體 系AAA認證,具備六項建標,可保證計量器具合 格有效。本集團的檢測中心已通過《國家級安全標 準化企業達標評審》、《TUV南德頒金屬材料實驗 室認可證書》。產品質素極具保證,以「PCK」品牌 在國際市場上享有極高的知名度。

於二零二三年,因安全及健康原因而退回已售出 或交付產品的情況為零。若產品出現問題,本集 團會為客戶維修產品。

The Group put emphasis on product quality and customer satisfaction. The Group will handle any product complaints immediately. Our staff will identify, evaluate and record every product complaint and reply and address the issues as soon as possible. In 2023, the Group did not receive any product complaints.

Intellectual property rights

The Group is an industry pioneer, particularly strong in research and development, holding 120 patents (including 41 invention patents). The Group treasures its intellectual property rights. To protect our proprietary rights, the Group rely on the applicable patent and trademark laws, laws relating to protection of other intellectual property rights, and impose confidentiality obligations on our employees. The Group also protects our know-how by requiring our employees, in particular, the technical and mechanical personnel, to enter into confidentiality and non-competition undertakings with the Group. In addition, in order to improve the Company's intellectual property protection system, strengthen the company's core competitiveness, promote technological innovation, promote technological progress, encourage employees to invent and create, and increase employees' enthusiasm for applying for independent intellectual property rights, the Group rewards employees for independent research and development on intellectual property rights.

Consumer data protection

The Group respects the values and rights of the customers' information assets, and in the process of providing our customers with products, we strictly comply with the customers' information security management systems and standards. The Group has classified the business-related information as highly confidential and requires employees not to disclose confidential information to third parties to ensure that the data will not be leaked. The Group has also formulated the rules and regulations in relation to data protection in the employee handbook for employees to perform their duties.

本集團注重產品質量及客戶滿意度。本集團將立 即處理任何產品投訴。我們的員工將識別、評估 及記錄所有產品投訴,並盡快回覆並解決問題。 於二零二三年,本集團並未收到任何產品投訴。

知識產權

本集團作為行業先驅者,於研發方面尤為強勁, 擁有120項專利(包括41項發明專利)。本集團尤 為重視其知識產權。本集團依據適用的專利及商 標法律,有關保護其他知識產權之法律並要求我 們的僱員履行保密責任以保護我們的知識產權。 本集團亦要求我們的僱員,尤其是技術及機械人 員,與本集團訂立保密及競業禁止承諾書,以保 護我們的專有技術。此外,為完善本公司知識產 權保護體系,增強公司的核心競爭力,促進技術 創新,推動技術升級,鼓勵僱員發明創造,並提 高僱員申請自主知識產權的積極性,本集團會對 僱員自主研發知識產權進行獎勵。

消費者數據保護

本集團尊重客戶信息資產的價值和權益,在向客 戶提供產品的過程中,嚴格遵守客戶的信息安全 管理制度和規範。本集團將業務往來相關的資料 列為高度機密,要求僱員不得對第三方透露機密 資料,確保數據不會外洩。本集團亦於員工手冊 中制定有關數據保護的規則及規例,以供僱員履 行其職責。

B.7 Anti-corruption

The operation of various departments of the Group is in compliance with legal regulations and legislations. We have established a whistle blowing policy, which enables our employees to express their views to the management anonymously. The Group conducts stringent management on procurement and tender process. Various approval on contract review and tender process is adopted, reviewed and monitored. In addition, the Group has formulated the "Good Professional Conduct" policy on conflict of interests, which are included in the employee handbook for employees to perform their duties with the highest level of integrity and professional attitude. All employees are not allowed to engage in any activities that conflict with the interests of the Group. Employees must report any activities and situations that may lead to conflict of interest to the Group. Relevant activities can only be carried out with the consent of the Group. Employees failing to report potential conflicts of interests may be subject to disciplinary actions. In 2023, the Group did not encounter any corruption procedures or cases.

B.8 Community Investment

Contribution to the Community

The Group has been playing an active role in charitable activities in Panyu, Guangdong Province, China and other regions in which we operate. With the organisation of a couple of educational, sports, cultural and charitable activities, we promoted the exuberance of Guangzhou City, thus enhancing foreign interest in Guangzhou and fostering urban development. These activities included:

- Sponsoring Panyu District "PCK Cup" 1st, 2nd and 3rd Table Tennis Contest
- Sponsoring Zhujiang "PCK Cup" 1st and 2nd World Go Team Championships
- Sponsoring "Golden Dragon City Cup" 1st and 2nd Dragon Boats Championships
- Sponsoring the 9th Table Tennis Competition of "Mayor's Cup" of Guangzhou

B.7 反貪污

We have audited the consolidated financial statements of Chu Kong Petroleum and Natural Gas Steel Pipe Holdings Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") set out on pages 117 to 258, which comprise the consolidated statement of financial position as at 31 December 2023, and the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with IFRS Accounting Standards as issued by the International Accounting Standards Board (the "IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

As set out in note 2.1 to the consolidated financial statements, the directors of the Company have implemented a number of plans and measures to improve the Group's liquidity and consider that the Group will have sufficient funds to meet its financial obligations for at least the next twelve months from the date of approval of these consolidated financial statements. Our opinion is not modified in respect of this matter.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

1. CORPORATE AND GROUP INFORMATION

Chu Kong Petroleum and Natural Gas Steel Pipe Holdings Limited (the "Company") was incorporated in the Cayman Islands on 9 January 2008 as an exempted company with limited liability under the Companies Law, Cap.22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of the Company's registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands.

The Company and its subsidiaries (together, the "Group") are involved in the following principal activities:

2.1 Basis of preparation

The consolidated financial statements of the Group have been prepared in accordance with IFRS Accounting Standards (which include all International Accounting Standards ("IASs"), International Financial Reporting Standards ("IFRSs") and interpretations) issued by the International Accounting Standards Board ("IASB"), and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties which have been measured at fair value. These financial statements are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Group for the year ended 31 December 2023. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

As at 31 December 2023, the Group maintained cash and cash equivalents of approximately RMB32,191,000 (2022: RMB16,128,000) and recorded net current liabilities of approximately RMB845,744,000 (2022: net current assets of approximately RMB76,834,000). In view of these circumstances, the directors of the Company have considered the future liquidity and performance of the Group and its available sources of finance in assessing whether the Group will have sufficient financial resources to continue as a going concern.

In order to improve the Group's liquidity and cash flows to sustain the Group as a going concern, the Group implemented or is in the process of implementing the following measures:

(1) Active negotiation with banks to obtain adequate bank borrowings to finance the Group's operations

As at 31 December 2023, the Group have obtained sufficient unutilised general facility granted by financial institutions, and the Group are expected to have sufficient financial support to pay off debts in the next 12 months, so the consolidated financial statements are prepared on the basis of going concern.

Subsequent to 31 December 2023 and up to the date of this report, the renewal of the loan amounted to RMB790,000,000 is under negotiation and the Group expects that the renewal of the loan could be renewed with related bank for five years. The Group continues to actively negotiate with the banks for the renewal of the Group's borrowings when they fall due or obtain additional sources of finance to meet the Group's working capital and financial requirements in the near future. The directors of the Company have evaluated all the relevant facts available to them and are of the opinion that they have a good track record and relationship with the banks and considered that the Group would be able to renew the Group's loans upon expiry.

(2) Improvement of the Group's operating cash flows

The Group is taking measures to tighten cost control over various production costs and expenses with an aim to attain profitable and positive cash flow operations. The eventual outcome of the above measures is inherently uncertain and cannot be estimated with reasonable certainty.

The directors of the Company have prepared a cash flow forecast for the Group which covers a period of eighteen months from the end of the reporting period. Taking into account the positive cash flows from the Group's steel pipes business and the continued sale of the Group's existing real estate projects, the directors considered that the Group will have sufficient working capital to finance its operations and meet its financial obligations as and when they fall due. Accordingly, the consolidated financial statements of the Group have been prepared on a going concern basis.

Should the going concern assumption be inappropriate, adjustments may have to be made to reflect the situation that assets may need to be realised at amounts other than those which are currently recorded in the consolidated statement of financial position. In addition, the Group may have to provide for any further liabilities that might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in the consolidated financial statements.

In June 2022 the Hong Kong SAR Government (the "Government") gazette the Hong Kong Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 (the "Amendment Ordinance"), which will come into effect from 1 May 2025 (the "Transition Date"). Once the Amendment Ordinance takes effect, an employer can no longer use any of the accrued benefits derived from its mandatory contributions to mandatory provident fund ("MPF") scheme to reduce the long service payment ("LSP") in respect of an employee's service from the Transition Date (the abolition of the "offsetting mechanism"). In addition, the LSP in respect of the service before the Transition Date will be calculated based on the employee's monthly salary immediately before the Transition Date and the years of service up to that date.

In July 2023, the HKICPA published "Accounting implications of the abolition of the MPF-LSP offsetting mechanism in Hong Kong" that provides accounting guidance relating to the offsetting mechanism and the abolition of the mechanism. In particular, the guidance indicates that entities may account for the accrued benefits derived from mandatory MPF contributions that are expected to be used to reduce the LSP payable to an employee as deemed contributions by that employee towards the LSP.

However, applying this approach, upon the enactment of the Amendment Ordinance in June 2022, it is no longer permissible to apply the practical expedient in paragraph 93(b) of HKAS 19 that previously allowed such deemed contributions to be recognised as reduction of service cost (negative service cost) in the period the contributions were made; instead these deemed contributions should be attributed to periods of service in the same manner as the gross LSP benefit.

To better reflect the substance of the abolition of the offsetting mechanism, the Group has changed its accounting policy in connection with its LSP liability and has applied the above HKICPA guidance retrospectively. The cessation of applying the practical expedient in paragraph 93(b) of HKAS 19 in conjunction with the enactment of the Amendment Ordinance resulted in a catch-up profit or loss adjustment in June 2022 for the service cost up to that date and consequential impacts on current service cost, interest expense and remeasurement effects from changes in actuarial assumptions for the rest of 2022 with the corresponding adjustment to the comparative carrying amount of the LSP liability. This change in accounting policy did not have any impact on the opening balance of equity at 1 January 2022, and the cash flows and earnings per share amounts for the year ended 31 December 2022. Further information about those IFRS Accounting Standards that are expected to be applicable to the Group is as follows:

Amendments to IFRS 10 and IAS 28 (2011) address an inconsistency between the requirements in IFRS 10 and in IAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to IFRS 10 and IAS 28 (2011) was removed by the IASB in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IFRS 16 specify the requirements that a seller-lessee uses in measuring the lease liability arising in a sale and leaseback transaction to ensure the seller-lessee does not recognise any amount of the gain or loss that relates to the right of use it retains. Amendments to IAS 1 Non-current Liabilities with Covenants clarify how to treat liabilities that are subject to covenants to be complied with, at a date subsequent to the reporting period. The 2022 Amendments improve the information an entity provides when its right to defer settlement of a liability for at least twelve months is subject to compliance with covenants. The 2022 Amendments clarify that only covenants with which an entity must comply on or before the reporting date will affect a liability's classification as current or noncurrent. A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investment in a joint venture is stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

The Group's share of the post-acquisition results and other comprehensive income of a joint venture is included in the consolidated statement of profit or loss and consolidated statement of comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its joint venture are eliminated to the extent of the Group's investment in the joint venture, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of the joint venture is included as part of the Group's investment in a joint venture.

In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

The Group measures its investment properties at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises, unless the asset is carried at a revalued amount, in which case the reversal of the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

Construction in progress represents buildings, plant and machinery under construction, which are stated at cost less any impairment losses, and are not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Investment properties

Investment properties are interests in land and buildings (including the leasehold property held as right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss in the year of the retirement or disposal.

Non-current assets and disposal groups held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amounts will be recovered principally through a sales transaction rather than through continuing use. For this to be the case, the asset or disposal group must be available for immediate sale in its present condition subject only to terms that are usual and customary for the sale of such assets or disposal groups and its sale must be highly probable. All assets and liabilities of a subsidiary classified as a disposal group are reclassified as held for sale regardless of whether the Group retains a non-controlling interest in its former subsidiary after the sale.

Non-current assets and disposal groups (other than investment properties and financial assets) classified as held for sale are measured at the lower of their carrying amounts and fair values less costs to sell. The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. It also applies the recognition exemption for leases of low-value assets that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Net realisable value is determined by the directors based on the prevailing market prices on an individual property basis less costs to be incurred in selling the property.

If an item of completed property held for sale becomes owner-managed, it is transferred to property, plant and equipment at the carrying amount.

For a transfer from an item of completed property held for sale to investment property that will be carried at fair value as its use has changed as evidenced by the commencement of an operating lease, any difference between the fair value of the property at that date and its previous carrying amount shall be recognised in the statement of profit or loss.

Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

For debt investments at fair value through other comprehensive income, the Group applies the low credit risk simplification. At each reporting date, the Group evaluates whether the debt investments are considered to have low credit risk using all reasonable and supportable information that is available without undue cost or effort. In making that evaluation, the Group reassesses the external credit ratings of the debt investments. The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade and bills receivables and contract assets which apply the simplified approach as detailed below.

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs.
- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs.
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs.

For trade and bills receivables that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

Financial liabilities

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings or payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Derivative financial instruments

Initial recognition and subsequent measurement

Derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently remeasured at fair value. Derivatives are carried as assets when the fair value is positive and as liabilities when the fair value is negative.

Any gains or losses arising from changes in fair value of derivatives are taken directly to the statement of profit or loss, except for the effective portion of cash flow hedges, which is recognised in other comprehensive income and later reclassified to profit or loss when the hedged item affects profit or loss.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

Income tax

Income tax comprises current and deferred income tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

Sale of goods

Manufacturing services

Revenue from the provision of manufacturing services is recognised over time, using an input method to measure progress towards complete satisfaction of the service, because the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced. Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

Pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in central pension schemes operated by the local municipal government. These subsidiaries are required to contribute certain percentages of their payroll costs to the central pension schemes. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension schemes.

Other benefits

The Group contributes on a monthly basis to defined contribution housing, medical and other benefit plans organised by the PRC government. The PRC government undertakes to assume the benefit obligations of all existing and retired employees under these plans. Contributions to these plans by the Group are expensed as incurred. The Group has no further obligations for benefits for their qualified employees under these plans. 2. 會計政策(續)

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Foreign currencies

These financial statements are presented in RMB. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgement

In the process of applying the Group's accounting policies, management has made the following judgement, apart from those involving estimations, which have the most significant effect on the amounts recognised in the consolidated financial statements:

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Estimation of fair value of investment properties

In the absence of current prices in an active market for similar properties, the Group considers information from a variety of sources, including:

- (a) current prices in an active market for properties of a different nature, condition or location, adjusted to reflect those differences;
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the date of the transactions that occurred at those prices; and
- (c) discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing lease and other contracts and (when possible) by external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs to sell and its value in use. The calculation of the fair value less costs to sell is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

In determining the useful lives and residual values of items of property, plant and equipment, the Group has to consider various factors, such as technical or commercial obsolescence arising from changes or improvements in production, or from a change in the market demand for the product or service output of the asset, expected usage of the asset, expected physical wear and tear, the care and maintenance of the asset, and legal or similar limits on the use of the asset. The estimation of the useful life of the asset is based on the experience of the Group with similar assets that are used in a similar way. Additional depreciation is made if the estimated useful lives and/or the residual values of items of property, plant and equipment are different from the previous estimation. Useful lives and residual values are reviewed at each financial year end date based on changes in circumstances.

Deferred tax assets

Deferred tax assets are recognised for all unused tax losses to the extent that it is probable that future taxable profits will be available against which the unused tax losses can be utilised, based on all available evidence. Recognition primarily involves significant management's judgements regarding the future performance of a particular legal entity or tax group in which the deferred tax asset has been recognised. A variety of other factors are also evaluated in considering whether there is convincing evidence that it is probable that some portions or all of the deferred tax assets will ultimately be realised, such as the existence of taxable temporary differences, tax planning strategies and the periods in which estimated tax losses can be utilised. The carrying amounts of the deferred tax assets and related financial models and budgets are reviewed at the end of the reporting period and to the extent that there is insufficient convincing evidence that sufficient taxable profits will be available within the utilisation periods to allow the utilisation of the carryforward of tax losses, and that the asset balance will be reduced and charged to profit or loss.

Estimation uncertainty (Continued) Write-down of inventories to net realisable value

A write-down of inventories to net realisable value is made based on the estimated net realisable value of inventories. The assessment of the write-down involves management's judgement and estimates. Where the actual outcome or expectation in future is different from the original estimate, such differences will have an impact on the carrying amount of inventories and the write-down/write-back of inventories in the period in which such estimate has been changed. Further details are given in note 18 to the financial statements.

Provision for expected credit losses on trade receivables

The Group applies the provision matrix method in the assessment of the ECLs on trade receivables at each reporting period. This method studies the probability of default to arrive at the ECLs of trade receivables.

The provision matrix method is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of customers' actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 19 to the financial statements.

撥備矩陣法最初基於本集團的過往觀察得出的違約率而釐定。本集團將通過就前瞻性資料對歷史 信貸虧損經驗作出調整,調校有關矩陣。例如, 倘預測經濟狀況(如國內生產總值)將在未來一年 惡化,這可能導致製造業違約數量增加,故對歷 史違約率作出調整。於各報告日期,會對過往觀 察所得違約率進行更新,並對前瞻性估計的變動 作出分析。

Development costs of properties are recorded as properties under development during the construction stage and will be transferred to completed properties held for sale upon completion. Apportionment of these costs will be recognised in the consolidated statement of profit or loss upon the recognition of the sale of the properties. Before the final settlement of the development costs and other costs relating to the sale of the properties, these costs are accrued by the Group based on management's best estimate.

When developing properties, the Group may divide the development projects into phases. Specific costs directly related to the development of a phase are recorded as the cost of such phase. Costs that are common to different phases are allocated to individual phases based on the estimated saleable area of the entire project.

Where the final settlement of costs and the related cost allocation is different from the initial estimates, any increase or decrease in the development costs and other costs would affect the profit or loss in future years.

Estimation uncertainty (Continued) Revenue from the provision of manufacturing services

Revenue in respect of manufacturing services is recognised over time using input method to measure progress towards complete satisfaction of the service. In addition, revenue and profit recognition is dependent on estimating the proportion of the actual costs incurred relative to the estimated total costs for satisfaction of the manufacturing services. Based on the Group's recent experience and the nature of the activity undertaken by the Group, the Group makes estimates of the point at which it considers the work is sufficiently advanced such that the costs to complete and revenue can be reliably estimated. Based on the latest information available in respect of the market environment, the Group prepares budgets for contracts individually and the budget, which is used in the Group's financial reporting, is reviewed regularly. Onerous contracts are provided for when identified. Material adjustments to the budgeted costs may occur in future if there is a significant change in the market environment.

PRC land appreciation tax

The Group is subject to land appreciation tax in Mainland China. The provision for land appreciation tax is based on management's best estimates according to its understanding of the requirements set forth in the relevant PRC tax laws and regulations. The actual land appreciation tax liabilities are subject to the determination by the tax authorities upon the completion of the property development projects. The Group has not finalised its land appreciation tax calculations and payments with the tax authorities for certain property development projects.

The final outcome could be different from the amounts that were initially recorded, and any differences will impact the land appreciation tax expenses and the related provision in the period in which the differences are realised.

For management purposes, the Group is organised into business units based on their products and services and has two reportable and operating segments, as follows:

- (a) the steel pipes segment engages in the manufacture and sale of welded steel pipes and the provision of related manufacturing services; and
- (b) the property development and investment segment engages in development of properties for sale and property investment for its rental income potential.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/loss, which is a measure of adjusted profit/loss before tax. The adjusted profit/loss before tax is measured consistently with the Group's profit/loss before tax except that head office and corporate expenses are excluded from such measurement.

Segment assets exclude unallocated head office and corporate assets as these assets are managed on a group basis.

Segment liabilities exclude unallocated head office and corporate liabilities as these liabilities are managed on a group basis.

There were no intersegment sales during the years ended 31 December 2023 and 2022.

For sale of steel pipes, revenue is recognised when control of the goods has transferred, being when the goods have been shipped to the customer's specific location (delivery). Transportation and handling activities that occur before customer obtain control are considered as fulfilment activities. Following the delivery, the customer has full discretion over the manner of distribution and price to sell the goods, has the primary responsibility when on selling the goods and bears the risks of obsolescence and loss in relation to the goods. Payment is generally due 30 days to 90 days from the invoice date, except for new customers, where payment in advance is normally required.

Payment is generally due within 50 days from the date of delivery or customer acceptance of the product processed.

The Group generally offers one-year warranties for its product. The Group recognised retention money as contract assets as the Group's entitlement to the consideration was conditional on satisfactory completion of the warranty period. The retention money will be recognised as trade receivables at the end of warranty period.

The Group does not recognise the warranty service as a separate performance obligation in a single contract as the warranty service is assurance type, and the Group's obligation to repair or replace faulty products under the warranty terms is recognised as a provision, if any.

Since most of the sales contracts of the Group are for periods of one year or less. The transaction price allocated to these unsatisfied contracts is not disclosed.

Lessonstart and Lucknow, which were incorporated in the British Virgin Islands, are not subject to CIT. Crown Central, CKSPG and View Sharp International Limited, which were incorporated in Hong Kong, were subject to profits tax at the rate of 16.5% on the estimated assessable profits arising in Hong Kong during the year, except for one subsidiary of the Group which is a qualifying entity under the two-tiered profits tax rates regime. The first HK\$2,000,000 (2022: HK\$2,000,000) of assessable profits of this subsidiary are taxed at 8.25% (2022: 8.25%) and the remaining assessable profits are taxed at 16.5% (2022: 16.5%).

According to the PRC corporate income tax law and its relevant regulations issued in 2019 and renewed policy issued in 2023, entities that qualified as Small and Micro Enterprises are entitled to a preferential income tax rate of 5% for taxable income less than RMB3,000,000 (2022: 2.5% for taxable income less than RMB1,000,000 or 5% for taxable income ranged between RMB1,000,000 to RMB3,000,000). The Group estimated and made provision for LAT according to the requirements set forth in the relevant PRC tax laws and regulations. The actual LAT liabilities are subject to the determination by the tax authorities upon completion of the property development projects and the LAT determined by the tax authorities might be different from the basis on which the provision for LAT is calculated.

Impairment testing of property, plant and equipment

When any indicators of impairment are identified, property, plant and equipment are reviewed for impairment based on each CGU. The CGU is an individual plant or operating entity. The carrying values of these individual plants or entities were compared to the recoverable amounts of the CGUs, which were based predominantly on value in use. Value in use calculations use pre-tax cash flow projections based on financial budgets approved by management covering a 5-year period. Cash flows beyond the 5-year period are extrapolated using the same cash flow projections of the fifth year. Other key assumptions applied in the impairment tests include the expected product price, demand for the products, product cost, finance costs and other related expenses, with the consideration of the possible significant decrease in finance costs following the measures adopted by management.

The Group applied the provision matrix method in the assessment of the ECLs on trade receivables at each reporting period. This method studies the probability of default to arrive at the ECLs of trade receivables. The process involves a review of, among others, the Group's historical sales recordings and trade receivables, in order to determine the default rate of the debtors.

The Group have considered and conducted, among other things, the following key steps:

- Define a period of sales and bad debts relating to those sales;
- Collect the historical data of trade receivables;
- · Calculate the historical default loss percentage; and
- Calculate the ECL using the default rate determined aforementioned.

The provision matrix method involves the definition of an appropriate period of time to analyse the proportion of receivables written off as bad debts. Based on the best estimation of the management, over 3 years unpaid trade receivables as at each reporting date have been defined in this exercise.

As at 31 December 2022, the Group had trade receivables of approximately RMB54,240,000 and RMB179,943,000 due from a debtor (the "Debtor") and state-owned enterprises respectively (the "Specific Debtors"). Based on management's experience and best estimation, as a business partner, there was a high likelihood that the amount payables held by a subsidiary due to the Debtor could provide coverage against the potential financial losses embedding in trade receivables due from the Debtor. Meanwhile, as the state-owned enterprises were normally with lower credit risk, it was assumed by the management that their default probability was insignificant. Therefore, the trade receivables from the Specific Debtors had been deducted from ECLs. As at 31 December 2023, all the trade receivables of the Group have been reasonably investigated and assessed for ECLs regardless of Specific Debtors after management considered the economic situation. Based on management's experience and best estimation, the amount payables held by the subsidiary due to the Debtor have a relatively high likelihood to loss. Therefore, impairment loss of 100% on the trade receivables from the Debtor have been recognised.

The Derecognised Bills had a maturity of one to nine months at the end of the reporting period. In accordance with the Law of Negotiable Instruments in the PRC, the holders of the Derecognised Bills have a right of recourse against the Group if the PRC banks default (the "Continuing Involvement"). In the opinion of the directors of the Company, the Group has transferred substantially all risks and rewards relating to the Derecognised Bills. Accordingly, it has derecognised the full carrying amounts of the Derecognised Bills and the associated trade payables. The maximum exposure to loss from the Group's Continuing Involvement in the Derecognised Bills and the undiscounted cash flows to repurchase these Derecognised Bills was equal to their carrying amounts. In the opinion of the directors of the Company, the fair values of the Group's Continuing Involvement in the Derecognised Bills were not significant.

On 28 April 2017, the Company issued bonds with a principal amount of US\$3.000.000 to an individual investor (the "2017 Bonds A"). The bonds should be repayable in full by 28 April 2020 but the expiry date could be extended to 30 June 2022 and further extended to 31 March 2023 and 30 September 2023 by the Company and the investor. The bonds bear interest at a fixed coupon interest rate of 7% per annum, payable semiannually in arrears commencing on 28 October 2017. The bonds are unsecured. The Group's guarantee period starts from the date of grant of the relevant mortgage loans and ends upon the issuance of real estate ownership certificates to the purchasers, which will generally be available within one to two years after the purchasers take possession of the relevant properties.

The fair value of the guarantees is not significant and the directors of the Company consider that in the event of default on payments, the net realisable value of the related properties can cover the repayment of the outstanding mortgage principals together with the accrued interest and penalties, and therefore, no provision has been made in the financial statements for the guarantees.

The Group's principal financial instruments include bank and other borrowings, fixed rate bonds and notes, cash and short term deposits. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group also has various other financial assets and liabilities such as trade receivables and trade payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. Generally, the Group introduces prudent strategies on its risk management. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below:

(a) Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's bank loans and government loans with floating interest rates. The Group is also exposed to fair value interest rate risk in relation to fixed-rate bank and other borrowings.

The Group regularly reviews and monitors the mix of fixed and floating interest rate borrowings in order to manage its interest rate risk. Interest-bearing loans, cash and short term deposits are stated at amortised cost and not revalued on a periodic basis. Floating rate interest income and expenses are credited/charged to the statement of profit or loss as earned/incurred.

If there was a general increase/decrease in the interest rate of bank and other borrowings with floating interest rates by one percentage point, with all other variables held constant, the consolidated operating results would have decreased/increased by approximately RMB12,559,000 (2022: RMB11,700,000), and there would have been no impact on other components of the consolidated equity, except for accumulated losses, of the Group.

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant. For transactions that are not denominated in the functional currency of the relevant operating unit, the Group does not offer credit terms without the specific approval of the Head of Credit Control.

Maximum exposure and year-end staging

There are no significant concentrations of credit risk within the Group as the customer bases of the Group's trade receivables are widely dispersed in different sectors and industries.

(d) Liquidity risk

The Group's objective is to ensure continuity of sufficient funding and flexibility by utilising a variety of bank and other borrowings with debt maturities spreading over a range of periods, thereby ensuring that the Group's outstanding borrowing obligation is not exposed to excessive repayment risk in any one year. Due to the capital intensive nature of the Group's businesses, the Group ensures that it maintains sufficient cash and credit lines to meet its liquidity requirements.

The liquidity of the Group is primarily dependent on its ability to maintain adequate cash inflows from operations to meet its debt obligations as they fall due, and its ability to obtain external financing to meet its committed future capital expenditure. With regard to its future capital commitments and other financing requirements, the Group has already obtained banking facilities with several banks of up to an amount of approximately RMB2,365,190,000 as at 31 December 2023, of which an amount of approximately RMB1,523,534,000 has been utilised.

The Group monitors capital using a gearing ratio, which is total debts divided by total assets. Total debts include interest-bearing bank and other borrowings and fixed rate bonds and notes. The gearing ratio as at 31 December 2023 was 28.5% (2022: 27.1%).
