#### **1.INTRODUCTION**

The purpose of this circular is to provide you with information in respect of the (i) the proposed general mandates for the issue and repurchase of shares to be granted to the Directors and (ii) other information required under the GEM Listing Rules, to enable you to make an informed decision on whether to vote for or against the resolutions to be proposed at the AGM.

## 2. PROPOSED GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the last annual general meeting of the Company held on 16 June 2022, general mandates were given by the Company to the Directors (a) to allot, issue and deal with Shares not exceeding 20% of the aggregate nominal amount of the share capital of the Company in issue as at the date of the passing of the resolution; (b) to repurchase the Shares on the Stock Exchange with an aggregate nominal value not exceeding 10% of the aggregate nominal value of the share capital of the Company in issue as at the date of passing of the resolution; and (c) to the effect that the aggregate nominal value of the Shares which may be allotted and issued under the issue mandate may be extended by an addition of an amount representing the aggregate nominal value of Shares repurchased under the repurchase mandate. Such general mandates will lapse at the conclusion of the AGM.

At the AGM, the following resolutions, among other matters, will be proposed:

(a) to grant the Issue Mandate to the Directors to exercise the powers of the Company to allot, issue and deal with the Shares up to a maximum of 20% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of such resolution;

#### (一) 緒言

(二) 建議授予發行授權、回購授權和擴額授權

於本公司在二零二二年六月十六日舉行之上屆股 東周年大會上,本公司授予董事一般授權以(a)配 發、發行及處理不超過於決議案通過當日本公司 已發行股本面值總額 20%之股份;(b)在聯交所 購回面值總額不超過於決議案通過當日本公司已 發行股本面值總額 10%之股份;及(c)透過增加 相當於購回授權項下購回股份之面值總額之金額, 將可能根據發行授權配發及發行之股份之面值總 額擴大。該等一般授權將在股東周年大會結束時 失效。

下列決議案(其中包括)將在股東周年大會上提 呈:

(a)授予董事發行授權以行使本公司之權力,配發、發行及處理最多為通過有關決議案當日本公司已發行股本面值總額 20%之股份;

(b)to grant the Repurchase Mandate to the Directors to enable them to repurchase the Shares up to a maximum of 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of such resolution; and

(c) to grant the Extension Mandate to the Directors to increase the total number of Shares which may be allotted and issued under the Issue Mandate by an additional number representing such number of Shares repurchased under the Repurchase Mandate.

As at the Latest Practicable Date, the issued share capital of the Company comprised 995,351,660 Shares. Subject to the passing of the resolutions approving the Issue Mandate and the Repurchase Mandate at the AGM and assuming that there is no change in the issued share capital of the Company between the Latest Practicable Date and the date of the AGM, the maximum number of Shares which may be issued pursuant to the Issue Mandate will be 199,070,332 Shares (representing 20% of the total number of Shares in issue as at the date of passing of the relevant resolution) and the maximum number of Shares which may be repurchased pursuant to the Repurchase Mandate will be 99,535,166 Shares (representing 10% of the total number of Shares in issue as at the date of passing of the relevant resolution).

Each of the Issue Mandate, the Repurchase Mandate and the Extension Mandate will expire at the earliest of: (a) the conclusion of the next annual general meeting of the Company following the AGM; (b) the date by which the next annual general meeting is required by any applicable law of the Cayman Islands or the Articles of Association to be held; or (c) when the mandates are revoked or varied by ordinary resolution(s) of the Shareholders in a general meeting of the Company prior to the next annual general meeting of the Company following the AGM.

Under the GEM Listing Rules, the Company is required to give to the Shareholders all information which is reasonably necessary to enable the Shareholders to make an informed decision as to whether to vote for or against the resolution in respect of the Repurchase Mandate at the AGM. The chairman of the AGM will therefore demand a poll for all the resolutions put to the vote at the AGM.

This appendix serves as an explanatory statement, as required by the GEM Listing Rules, to provide requisite information to enable Shareholders to make an informed decision as to whether to vote for or against the resolution to approve the grant of the Repurchase Mandate.

## 1. GEM LISTING RULES RELATING TO THE REPURCHASE OF SHARES

The GEM Listing Rules permit companies whose primary listing is on GEM to repurchase their shares on GEM or any other stock exchange on which the securities of the Company are listed and such exchange is recognized by the Securities and Futures Commission of Hong Kong and GEM subject to certain restrictions. Among such restrictions, the GEM Listing Rules provide that the shares of such companies must be fully paid up and all repurchase of shares by such companies must be approved in advance by an ordinary resolution of shareholders, either by way of a general repurchase mandate or by specific approval of a particular transaction.

#### 2. SHARE CAPITAL
