



CORPORATE PROFILE 公司簡介

Central China Management Company Limited (hereinafter referred to as "CCMGT" or the "Company", together with its subsidiaries, the "Group", stock code: 9982.HK) was incorporated in the Cayman Islands on 22 October 2020 as an exempt company with limited liability, the shares of which were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 31 May 2021.

中原建業有限公司(下稱「CCMGT」或「本公司」,連同其附屬公司統稱「本集團」,股票編號:9982.HK)於2020年10月22日在開曼群島註冊成立為獲豁免有限公司,並於2021年5月31日在香港聯合交易所有限公司(「聯交所」)主板上市。

The project management business of the Group is primarily carried out by Henan Zhongyuan Central China City Development Limited ("Zhongyuan Jianye") and Zhongyuan Central China (Hainan) Management Services Co., Ltd. ("Zhongyuan Jianye (Hainan)"), the Company's wholly-owned subsidiaries. After years of development, CCMGT has possessed independent capital, construction and management capabilities, and embarked on a path of independent, national, large-scale and professional development, especially in the business model, operation logic, engineering construction and partner resource management.

本集團房地產代建業務主要由本公司全資子公司河南中原建業城市發展有限公司(「中原建業」)及中原建業(海南)管理服務有限公司(「中原建業(海南)」)負責開展。經過多年發展,中原建業已具備獨立的資金、建設、管理等能力,尤其在業務模式、運營邏輯、工程建設、合作方資源管理等層面已走出一條自主化、全國化、規模化、專業化的發展路徑。

As of 31 December 2024, CCMGT signed contracts on project management projects in 136 counties and above-county-level cities in 8 provinces, municipalities and autonomous regions, and cooperated with 237 partners on 449 projects. Its cumulative GFA under management stood at approximately 55.61 million sq.m., with the repeat cooperation rate of 62%. It served more than 500,000 property owners. CCMGT has a well-established marketing and management team. With its mature development capability and brand superiority, it has been able to bring higher premiums to its partners, with average selling prices 10% higher than those of its competitors.

截至2024年12月31日,中原建業代建項目遍佈全國8個省份及自治區,136個縣及縣級以上城市,擁有合作夥伴237位,合作項目449個,累計在管建築面積約5,561萬平方米,重複合作率達62%,服務業主超50萬。中原建業積累了成熟的營銷、管理團隊,並通過成熟的開發能力、品牌優勢,為合作夥伴項目帶來較高的溢價能力,平均售價較競品高出10%。

Currently, CCMGT has four business segments, namely commercial project management, government project management, capital project management and management consulting. Traditional commercial project management is its core business, with extensive cooperation resources, high business proportion and strong profit realization. With business development, the Company has begun to focus on the government project management business, which involves the traditional government project management model, the joint venture platform model, and the equity trading model. At present, the Company has forged strategic partnerships with 30 government platform companies and 8 state-owned enterprises in Henan, including Zhoukou Chengtou, Finance Bureau of Shangcai County, and Henan Airport Group. The corresponding projects are intended to be followed up on.

目前中原建業已形成商業代建、政府代建、資本代建、管理諮詢四大業務結構。傳統商業代建是中原建業的核心業務,合作資源廣、業務佔比高、利潤實現強:隨著業務的發展,公司已開始重點推進政府代建業務,業務類型涉及傳統政府代建模式、合資平台模式、股權交易模式三大類模式。公司目前已與周口城投、鄲城城投、伊川城投、南陽高新城投、上蔡縣財政局、河南省機場集團等省內30家政府平台公司、8家國企達成戰略合作,且有意向項目跟進。

The CCMGT City Partner Council was established in December 2022. With like-minded city partners gathering together, the Council promotes cooperation among member companies, and ultimately strives to push forward urbanization and all-round social progress in Central China. In the course of operation, the Council utilizes credit and financing tools to help member companies in terms of projects and funding and integrate resources, and at the same time creates quality products and provides quality services for customers. Eventually, CCMGT sees rapid growth and takes root in Greater Central China.

Relying on years of experience, CCMGT officially released in September 2023 a brand-new project management trust system called CCMGT C Platform. CCMGT C Platform is a revolutionary exploration and attempt by CCMGT on the basis of its increased brand premium and management capability. It built an institutional partnership platform, a financial linking platform, a digital management efficiency enhancement platform, a supply chain empowerment platform, and a think-tank sharing platform. Meanwhile, it introduced innovative cooperation models in area development, capital project management, government project management, and project revitalization to establish cooperation advantages, create value through cooperation, and jointly win the trust of property owners, governments, capital markets, partners, clients, and industry players.

依托多年發展經驗,中原建業於2023年9月正式對外發佈全新的代建信賴體系一中原建業代建 C平台。中原建業代建C平台是中原建業在品牌溢價能力、管理紅利能力不斷疊加的基礎上,進行的一次革新化的探索和嘗試,鏈接並打造制度合夥平台、金融鏈接平台、數字化管理增效平台、供應鏈賦能平台、智庫分享平台,在片區開發、資本代建、政府代建、紓困項目盤活等方面創新合作模式,形成平台合作優勢,以合作創造價值,共同贏取業主、政府、資本市場、合作方、客戶以及行業的信賴。

CCMGT, which values the communication and exchange with partners, upholds the work standards of "ensuring that every project is a success, every partner is satisfied, and cooperation is sustainable" in the process of project management and sets forth the goal of "each project is profitable, and each risk is eliminated" to provide partners with more quality services. Once CCMGT enters a city, it creates a new image for the city via every product it builds for that city; creates a new lifestyle for local people; improves the construction level of the city together with local developers; pays more tax to local governments; becomes a good propagandist of the city by fitting into them.



CHAIRMAN'S STATEMENT 主席報告



Dear Shareholders,

On behalf of the board of directors (the "Board") of the Company, I am pleased to present a review of the Group's results for the year ended 31 December 2024 (the "Year") and the outlook for the future.

EXTERNAL ENVIRONMENT AND INDUSTRY BACKGROUND

In 2024, the global economy showed some resilience amidst multiple challenges. Despite geopolitical tensions, volatile energy prices and supply chain bottlenecks, policy fine-tuning and technological innovation in major economies have provided new impetus to economic growth. Under the combined effect of policy regulation, economic transition, demographic change and technological innovation, the real estate industry will enter a new development stage with both challenges and opportunities.

外部環境及行業背景

2024年,全球經濟在多重挑戰中展現出一定的韌性。儘管地緣政治緊張局勢、能源價格波動以及供應鏈瓶頸等問題依然存在,但主要經濟體的政策調整和技術創新為經濟增長提供了新的動力。在政策調控、經濟轉型、人口結構變化以及技術創新的共同作用下,房地產行業將進入一個新的發展階段,既面臨挑戰,也蘊含機遇。

CHAIRMAN'S STATEMENT 主席報告

China's economy maintained medium-to-high speed growth, and the focus of real estate policies shifted from strict regulation in the past to support for reasonable housing demand, especially for rigid demand and improvement. The Chinese government has further optimized the policies of purchase and loan restrictions, lowered the threshold for home purchase, and at the same time increased its support for indemnificatory housing and rental housing, so as to promote the stable and sound development of the real estate market. However, the decline in income growth and weak consumer confidence constrained the growth in domestic demand. The real estate market remained in a deep correction trajectory, putting greater short-term downward pressure on all fronts.

Preliminary statistics show that the planned GFA of newly contracted projects of project management companies in 2024 was estimated to be 165 million sq.m., which remained high. The market concentration of the leading companies lingered above 50%. In 2024, more than 100 companies entered the realm of project management, further intensifying competition. From the point of view of various project management companies, leading players developed steadily and those in the middle part were on the rise.

REVIEW OF RESULTS FOR 2024

CCMGT has always adhered to the Greater Central China business development strategy and stepped up presence in Central China. In enterprises. The successful implementation of the innovative city partnership model allowed CCMGT to link resources, which pushed forward the urbanization process in Greater Central China.

2024, the Company further increased the proportion of government project management and continually optimized its business structure to expand its business territory by signing strategic cooperation agreements with government platform companies and state-owned

It inked strategic cooperation agreements with 30 platform companies and 8 state-owned enterprises. In 2024, the Company's contracted sales on behalf of its partners amounted to approximately RMB13.4 billion, representing a year-on-year decrease of 54.6%, and contracted sales GFA was approximately 2.17 million sq.m. Its opening inventory sales were RMB8.74 billion in 2024, with a sales rate of 48.5%. Compared to an average level of 40% in third- and fourth-tier cities, the Company's inventory digestion rate was 8.5% higher than that of its peers.

The Company improved the operation management effectiveness and built iconic projects in Greater Central China, setting a new industry benchmark in the face of adversity. CCMGT regards product realization as its core competitiveness and adheres to its core values. In 2024, it delivered 6.2 million sq.m. of approximately 47,000 apartments, with an early delivery rate of 39% and an average of 95 days ahead of schedule for a single batch. With high quality and efficient deliverables, the Company spared no effort to fulfil its promises to property owners and the society.

OUTLOOK FOR 2025

Looking forward to 2025, benefiting from the loose policy, the real estate industry will show a more accelerated stabilization in 2025, the industry competition will get increasingly fierce, residential products will further return to the residential attributes, the project management industry will enter a new stage of high-quality development, and the "products and quality" will become the core of the market competition.

In the future, CCMGT will continually deepen the improvement in management quality and efficiency, strengthen its leading position in the industry, bring growth momentum via product innovation, turn a "good product" into a new value driver, comprehensively improve design innovation, product display, cost control, scenario creation, sales target, partner satisfaction and more, and adhere to the concept of "quality is the best marketing", so as to accelerate the product sales of cooperative projects and capital withdrawal. In the meantime, efforts will be made to improve the management efficiency, adapt to the new development trends of the industry, optimize the cost structure, broaden sources of income, enhance cost savings, and rely on management effectiveness to create more "good products" for the society.

In the face of the challenges and opportunities that coexist in the project management industry, CCMGT will continually regard high-quality development as its core strategy, deepen the Greater Central China Strategy, take "Rejuvenation, Reconstruction, and Symbiosis" as the driving force, strengthen the product power enhancement and product innovation, and construct a risk prevention and control mechanism, so as to lay the foundation of brand reputation with project reputation. Moreover, the Company will strengthen the industrial synergy, meet the diversified needs of its partners with innovative cooperation models, enhance the service capabilities, and establish deeper cooperation with partners, governments, platforms, and the capital market, in an effort to achieve greater strategic goals, become a trustworthy project management service provider, and create greater value for shareholders.

2025年展望

OPERATION REVIEW

I. Business Overview

Over the past year, CCMGT responded positively to the complex and volatile market conditions and maintained its leading position in China's real estate project management services sector with its strong resilience and excellent management capabilities.

During the Year, the Company signed a total of 449 project contracts, with a contracted gross floor area ("GFA") of 55,610,000 square metres ("sq.m."). Contracted sales amounted to RMB13,404 million, and sales GFA was 2,174,200 sq.m.. Benefiting from business collaboration and resource integration, it acquired land plots, sold out properties and delivered them within the year. It fully demonstrates the Company's efficient operation capability and excellent project management. These achievements not only embody its continuous influence and competitiveness in the market, but also lay a solid foundation for its sustainable development in the future.

營運回顧

一、業務概覽

過去的一年裡,中原建業積極應對複雜多變的市場環境,以強大的韌性和卓越的管理能力,保持了中國房地產代建服務領域的領先地位。

年內,本公司累計簽約項目達到449個,累計簽約面積5,561萬平方米,實現合約銷售134.04億元,銷售面積217.42萬平方米。通過業務協同及資源整合,在地市項目開稅中實現了當年拿地、當年清盤、當年交付的高效運行。充分展現了公司高效的運營能力和卓越的項目管理水平。這些成績的取得,不僅彰顯了中原建業在市場中的持續影響力和競爭力,更為公司未來持續發展奠定了堅實基礎。

II. Macro Environment

In 2024, due to the chaotic external environment and growing internal challenges, it was more difficult for the economy to maintain stable growth. The global economic recovery was weak, protectionist barriers were high, geopolitical conflicts and international trade frictions occurred frequently, effective domestic demand remained insufficient, and the country was in the throes of a transition from old to new growth drivers. The economy slowed down in the second and third quarters, and at one point faced the unfavorable situation of high downward pressure, which increased the difficulty to achieve the expected targets. In the face of the complex situation, the PRC central government strengthened macro-control in the fourth guarter and made extra efforts to introduce an incremental policy package to drive a significant economic upturn and effectively boost social confidence, which not only facilitated the realization of the annual target, but also laid a good foundation for the development in 2025.

二、宏觀形勢

2024年外部環境變亂交織,內部困難挑戰增多,經濟穩定運行難度上升。世界經濟復甦乏力,保護主義壁壘高築,地緣政治衝突和國際貿易摩擦頻發,國內有效需求不度較調察經歷新舊動能轉換陣痛,二、三季內不度面臨經濟下行壓力,便面臨經濟下行壓力,面內不利局面,實現預期目標難度陡增。面內推出增量政策,打出強有力的會信心對,推動經濟運行明顯回升,社會信效提振,既促進了全年目標實現,也為2025年發展奠定了良好基礎。

In 2024, the services sector was relatively sluggish, and the real estate and construction sectors turned around weakly. The pickup in external demand supported the relative stabilization of aggregate demand, but prices remained low amid insufficient domestic demand. Domestic demand growth was constrained by a fall in income growth and weak consumer confidence. The real estate market remained in a deep correction trajectory, putting greater short-term downward pressure on all fronts. The endogenous contraction in social financing has yet to be reversed.

Despite continued efforts on the policy front, with governments at all levels releasing a series of policy combinations for the property market, such as lowering down payment ratios, removing the lower limit on housing loan interest rates, and establishing a real estate financing coordination mechanism, the year-on-year contraction in real estate investments, sales, and project starts has yet to be fundamentally reversed.

2024年,服務業相對疲軟,房地產業、建築業復甦乏力。外需回暖支撐了總需求的相對穩定,但內需不足的情況下,物價持續低位運行。居民收入增速回落,消費者信心偏弱制約內需增長。房地產市場持續深度調整,給各方面造成較大的短期下行壓力。社會融資等內生性緊縮態勢尚未扭轉。

儘管政策端持續發力,各級政府推出了一系列樓市政策組合拳,如降低首付比例、取消房貸利率下限、建立房地產融資協調機制等,但房地產投資、銷售業績及項目開工率同比縮減的趨勢仍未根本扭轉。

III. Project Management Market

In 2024, the area of the properties involved in contracts in the project management industry totaled 220 million sq.m., representing a year-on-year increase of 27%. The magnitude of increase fell 26% year-on-year, returning to a stable level. More than a hundred companies set foot in the project management industry which saw a slowdown, competition intensification and enterprise differentiation following gradual "saturation".

From the perspective of project management companies, the leading real estate developers still developed steadily, but their market shares were gradually eroded by medium-sized project management companies and new entrants, resulting in increasingly fierce competition in the industry. In the meantime, the contract-signing threshold for the top 10 companies in the project management industry was raised to 8 million sq.m.. As a result of the growth in government project management and intensified market competition, the profitability of project management companies and the proportion of fees charged went down. As to more than 40% of the newly signed projects in 2024, the project management fee rate was merely 1%–2%, the lowest level in recent years.

三、 代建市場

2024年代建行業累計簽約2.2億平方米,同 比增長27%,同比增速下降26%,增速回歸 平穩;已有超百家企業涉足代建領域,代建 行業在企業逐步「飽和」之後,也迎來增速 放緩、競爭加劇、企業分化的新階段。

從各陣營代建企業來看,頭部房企仍發展穩健,但市場份額逐漸被中型代建企業和新入局企業分食,行業競爭也愈發白熱化。同時,代建前十位企業的簽約門檻已提升至800萬平方米。受政府代建增長及市場競爭加劇等影響,代建企業盈利水平和收費比例不斷下降;2024年新簽項目超四成代建費率僅在1%—2%之間,為近年最低水平。

In 2024, CCMGT proactively addressed market challenges and won a number of honors through solid and stable operations and refined management. In March, it won six honors, namely 2024 China Outstanding Project Management Operation Real Estate Companies, 2024 China Outstanding Government Project Management Operation Companies, Top 30 Chinese Real Estate Enterprises in terms of Comprehensive Strength in Project Management in 2023 (ranked sixth), Top 6 Chinese Project Management Enterprises in terms of Comprehensive Strength in 2024, the 2024 Excellent Commercial Project Management Enterprise and the 2024 Excellent Urban Renewal Project Management Enterprise, for its good service ability, innovative business models, and rising brand influence. In April, CCMGT ranked 5th in the Excellence Index — 2024 Superior Performance of Real Estate and came 4th in the Excellence Index - 2024 Superior Performance of Housing Management in Government Project Management for its outstanding operation and service capabilities. In May, the Company ranked fourth among the Outstanding Listed Chinese Real Estate Companies in Project Management Operation in 2024. In August, CCMGT was named the 2024 Top 5 Brand of China Project Management Companies by virtue of its outstanding product power. In September, the Company was awarded three honors, namely 2024 Leading Brand of China Real Estate Project Management Companies, 2024 Leading Brand of China Real Estate Government Project Management Companies, 2024 Leading Brand of China Real Estate Residential Building Development — Green Project Management.

IV. Greater Central China Strategy

CCMGT has always adhered to the Greater Central China strategy and stepped up its presence in the region, committed to building high-quality real estate projects in Central China. By entering into strategic cooperation agreements with government platform companies and state-owned enterprises, the Company further increased the proportion of government project management and continually expanded its business territory. The successful implementation of the city partnership model deepened cooperation among member companies, thus jointly advancing urbanization. CCMGT provided a full range of integrated services for real estate development and operation, including branding, management, service and operation, which has further enhanced its brand influence in Central China.

四、大中原戰略

V. Project Development During the Year

During the Year, 31 new project management projects were signed with an additional contracted GFA of 2,517,200 sq.m., representing a year-on-year decrease of 64.8%. Among them, 26 new projects were in Henan province, with a newly contracted GFA of 2,113,000 sq.m.. There were 5 contracts signed for provinces other than Henan with a newly contracted GFA of 404,200 sq.m. The contracted sales for projects under the Group's management amounted to RMB13,402 million, representing a year-on-year decrease of 54.6%. The contracted sales GFA stood at 2,174,243 sq.m., a year-on-year decrease of 53.3%. As at 31 December 2024, the Group had 248 projects under management with a GFA of 29,869,665 sq.m., of which 215 projects with a GFA of 26,280,672 sq.m. were in Henan and 33 projects with a GFA of 3,588,993 sq.m. were in provinces other than Henan.

CCMGT will continuously deepen its Greater Central China Strategy, pay close attention to the market dynamics, and flexibly adjust its strategies to ensure the smooth implementation of various plans and strategies.

Looking into the future, CCMGT will carry out the core strategies of innovation and expansion, strength rebuilding, teamwork and quality delivery, and construct an all-round, multi-level cooperation ecosystem with partners, governments, platforms and the capital market, with a view to bringing together the strengths of all parties in an effort to realize the Company's strategic goals and create greater value for its shareholders:

1. Use innovative expansion models and stimulate diversified cooperation

In order to satisfy customer demands and promote diversified cooperation, CCMGT intends to select pilot cities in Henan as innovation-driven development zones. It will adopt innovative models in the principles of project management service fee allocation, development team formation, project management and so forth, and increase internal and external development incentives to achieve rapid project implementation. The three innovative models it will initially use are internal and external co-innovation, internal partnership, and external partnership.

六、 未來業務計劃及策略

受益於政策環境優化與市場需求逐漸穩定,代建行業正迎來從規模擴張向高質量發展的轉型期,中原建業將繼續深化大中原戰略,密切關注市場動態,靈活調整策略,確保各項計劃和策略的順利實施。

展望未來,中原建業將以創新拓展、優勢重構、團隊協同和品質交付為核心策略,與合作方、政府、平台、資本市場等構建全方位、多層次的合作生態體系,匯聚各方力量,努力實現公司戰略目標,為股東創造更大價值:

1、 創新拓展模式激發多元合作

為匹配客戶訴求、促進多元合作,中原建業擬在省內選取試點城市作為創新發展特區。在項目管理服務費分配原則、拓展團隊組建、項目管理服方面採用創新模式,加大內外部的拓展激勵,以實現項目快速落地,初步展激勵,以實現項目快速落地,初步形成內外共創、內部合夥人、外部合夥人三種創新模式。

2. Strengthen panoramic management and fine control to re-establish its advantageous leading position

In the future, CCMGT will continuously strengthen panoramic management and fine control to re-establish its advantageous leading position. On the one hand, the Company will market "good products" to drive up sales, build up its strengths in design innovation, product presentation, cost control, scenario creation, sales target and partner service satisfaction, put into practise the concept of "products are the best marketing behavior" and achieve rapid sales and capital recovery. At the same time, it will strengthen internal management, promote multiple competences in a single role, optimize cost paths, and open up new sources of income and cut down on expenses, in order to meet the needs of industry development and business breakthroughs. On the other hand, CCMGT will rely on its accumulated costcontrol capabilities and its strengths in various market segments to create benchmark products. Efforts will be made to continuously expand the advantages of the bidding and procurement committee, coordinate the supply chain, integrate cost reduction measures throughout the whole process, open up the product system, and establish the whole-process control standards based on the product system, aiming to cut costs, improve quality and increase efficiency, and lead the high-quality development of the project management industry.

3. Optimize team performance and pass on the corporate spirit

CCMGT will optimize staffing to meet business needs, implement a management model of reducing redundancy and increasing efficiency, and enhance decision-making and execution efficiency to ensure that the team focuses on key business areas to drive growth. At the same time, the Company will enhance expense control, refine the cost structure, construct an incentive mechanism linking expenses to performance, and promote lean management. Additionally, it will further strengthen cultural leadership, carry forward the heroism, and stimulate endogenous motivation, ensure the efficient and effective implementation of the Group's decisions and deployments, and promote common progress of teams, so as to achieve long-term development of the Company.

2、 全景管理與精細管控重構優勢領先

著眼未來,中原建業將持續強化全景 管理與精細管控,重構優勢領先地位。 一方面,以「好產品|驅動銷售業績, 構建設計創新、產品呈現、成本管控、 場景營造、銷售達標及合作方服務滿 意等優勢,踐行「產品就是最好的營 銷」理念,實現快速銷售去化與資金 回籠。同時,強化內部管理,推廣一 職多能,優化成本路徑,廣開源、強 節流以配適行業發展與業務突破需 求。另一方面,依靠自身積累的成本 控制能力及在各級市場的優勢,打造 標桿產品。持續擴大招採委員會優勢, 統籌供應鏈,整合全流程降本措施, 打通大產品體系,依產品體系制定全 流程管控標準,實現降本提質增效, 持續引領代建行業高質量發展。

3、 團隊效能優化與傳承精神並舉

圍繞業務需求優化人員配置,推行減 冗增效管理模式,提升決策與執行效 率,確保團隊在關鍵業務上集中發力, 推動業績增長。同時,強化費用管控, 優化成本結構,建立費用與業績掛外, 優的激勵機制,推動精益管理。此英 調,傳承文化引領,傳承決 精神,激發內生動力,確保集團決 部署高效落地,促進團隊協同共進, 實現公司長遠發展。

4. Control risks and improve quality to build a bright future

Continuous actions will be taken to strengthen the process control and resolve front-end risks. CCMGT will gradually dissolve risks while developing steadily, achieve both high-quality development and high-level security, revitalize stock assets with the use of real estate financing coordination mechanism, and inject new vitality into projects. It will conduct precise classification and implement hierarchical treatment strategies for risky projects, and hold regular meetings to ensure that issues are resolved in a timely manner. At the level of capital control, strict control will be carried out for projects with capital shortage and delay to ensure that funds are earmarked for specific purposes, which will provide a solid guarantee for the smooth progress of projects. With focus on deliverability, CCMGT will connect all business lines and set up a multi-dimensional and threedimensional evaluation system from multiple perspectives. While maintaining stability, the Company will gradually seek transformation and upgrading to make "Good Houses" and strive to offer a higher quality living experience.

4、 風險管控與品質提升共築未來

持續強化過程管控,前置風險化解, 堅持在穩步發展中逐步化解風險,實 現高質量發展和高水平安全的良性 互動,利用房地產融資協調機制,盤 活存量資產,換發項目新生;針對風 險項目,實施精準分類與分級處理策 略,定期召開專題會議,確保問題得 到及時解決。資金管控層面,針對資 金緊張、工期滯後項目,實施嚴格監 控,確保項目資金專款專用,為項目 的平穩推進提供堅實保障。以交付力 為核心,串聯全業務線條,融合多元 視角,構建多維度、立體化的評估體 系。在保持穩定的基礎上,逐步推動 向「好房子」標準的轉型升級,致力 於提供更高品質的居住體驗。

VII. OUTLOOK

In the face of challenges and opportunities in the project management industry, CCMGT will firmly embark on the path of high-quality development. Continuing to deepen its Greater Central China strategy, CCMGT, driven by "Rejuvenation, Reconstruction, and Symbiosis", will strengthen brand building, solidify product quality, and enhance the risk prevention and control mechanism to ensure that each project will become the cornerstone of reputation. Synchronously, efforts will be made to innovate the service model, so as to strengthen the collaboration between the upstream and downstream of the industry chain to meet the diversified needs of partners. In the future, CCMGT will continually expand its business boundaries and strive to become a trustworthy project management service provider via the innovation in key factors such as business models, management methods, and operational approaches.

七、前景展望

FINANCIAL ANALYSIS

For the Year, the Group achieved:

Revenue

The Group generated revenue and received management service fees from the provision of project management services. Principal factors affecting revenue include the business size, number of projects under management and total contracted GFA, milestones and progress of projects under management as well as the sale strategies. During the Year, revenue amounted to RMB252.0 million, representing a decrease of 46.2% from RMB468.4 million in 2023. The decline in revenue was due to lower service fees charged by the Company as a result of the continued downturn of the domestic real estate market and the fact that the increase in new project development was not as significant as the decrease in completed projects. Below is the Group's revenue divided by whether projects under management are based in Henan Province:

Other Income

Other income is primarily interest income on financial assets measured at amortised cost and government grants. During the Year, other income amounted to RMB20.9 million, representing a decrease of RMB53.0 million or 71.8% as compared with that of RMB73.9 million in 2023. This was mainly due to a decrease in interest income on advances to third parties during the Year.

其他收入

其他收入主要為按攤銷成本計量的金融資產的利息收入及政府補助。於本年度內,其他收入為人民幣20.9百萬元,較2023年的人民幣73.9百萬元減少人民幣53.0百萬元,減少71.8%,主要因為本年度第三方墊款利息收入減少。

Personnel Cost

Personnel cost is the Group's largest cost item, which primarily comprises base salary and bonus, social insurance and other benefits as well as equity-settled share-based payments by Central China Real Estate Limited (previously the holding company of the Group) and the Company paid to the Group's employees. Such cost does not include salary, bonus, social insurance and housing funds, and other benefits and fees paid to the Group's employees who are seconded to relevant project companies in connection with real property development projects managed by us, which are borne by respective project owners and paid by the project owners to the seconded personnel directly. During the Year, personnel cost amounted to RMB101.5 million, representing a decrease of 9.6% from RMB112.2 million in 2023. The decrease was primarily due to our strict control over personnel cost and expenses during the Year.

Other Operating Expenses

The Group's other operating expenses mainly comprise corporate overhead and business entertainment, office and travelling expenses. During the Year, other operating expenses amounted to RMB47.2 million, representing a decrease of RMB11.4 million or 19.4% from RMB58.6 million in 2023, which was mainly due to the Company's strict control of various operating expenses.

Income Tax

During the Year, income tax amounted to RMB20.5 million, representing a decrease of 55.3% from RMB46.0 million in 2023. The effective income tax rate was 21.9%, which was 3.3 percentage points higher than the effective tax rate of 18.6% for 2023, mainly due to changes in the income structure of the Company with different tax rates.

Profit for the Year

During the Year, net profit amounted to RMB73.2 million, representing a decrease of 63.6% from RMB201.2 million in 2023, which was mainly due to the decrease in revenue.

人員成本

人員成本為本集團最大的成本項目,主要包括基本薪金及獎金、社會保險及其他福利以及建業地產股份有限公司(本集團前控股公司)及本公司向本集團的僱員支付的以權益結算的股份を可款。該等成本不包括已付因我們在管的房地產開發項目而派駐予相關項目公司僱員的薪金、獎金、社會保險及住房公積金和其他福利及費用,與該籍有人直接向派駐人員支付。於本年度內,人民幣101.5百萬元,較2023年的人民幣12.2百萬元下降9.6%。下降的主要原因是本年度內本集團嚴控人員成本費用。

其他經營開支

其他經營開支主要包括公司開銷、業務招待費、辦公及差旅開支。於本年度內,其他經營開支為人民幣47.2百萬元,較2023年58.6百萬元降低11.4百萬元,下降19.4%,主要是公司嚴控各項經營開支。

所得税

於本年度內,所得税為人民幣20.5百萬元,較2023年的人民幣46.0百萬元下降55.3%。所得税有效税率為21.9%,較2023年有效税率18.6%,增加3.3個百分點,主要由於不同税率公司收入結構變化所致。

年度溢利

於本年度內,淨利潤為人民幣73.2百萬元,較 2023年的人民幣201.2百萬元下降63.6%。主要 是由於收入下降。

Trade and Other Receivables

As of 31 December 2024, trade and other receivables amounted to RMB469.9 million, representing a decrease of 58.1% from RMB1,121.5 million as of 31 December 2023. This was mainly attributable to repayment from advances to third party.

Contract Assets

Contract assets amounted to RMB98.4 million as of 31 December 2024, representing a decrease of 21.5% from RMB125.3 million as of 31 December 2023, mainly due to lower revenue recognised.

Trade and Other Payables

Trade and other payables amounted to RMB222.5 million as of 31 December 2024, representing a decrease of 25.9% from RMB300.4 million as of 31 December 2023. It was primarily because the 2023 interim dividend of RMB124.9 million has been paid during the year of 2024.

Contract Liabilities

Contract liabilities amounted to RMB222.3 million as of 31 December 2024, representing a decrease of 28.3% from RMB309.9 million as of 31 December 2023. Contract liabilities represent the payments received before the related project management service is provided. The decrease during the Year was primarily due to a decrease in payments received.

貿易及其他應收款項

於2024年12月31日,貿易及其他應收款項為人民幣469.9百萬元,較2023年12月31日的人民幣1,121.5百萬元降低58.1%。主要是由於第三方墊款收回。

合約資產

於2024年12月31日,合約資產為人民幣98.4百萬元,較2023年12月31日的人民幣125.3百萬元下降21.5%。主要是由於收入確認減少。

貿易及其他應付款項

於2024年12月31日,貿易及其他應付款項為人民幣222.5百萬元,較2023年12月31日的人民幣300.4百萬元降低25.9%。主要由於2023年半年度中期股息人民幣124.9百萬元在2024年度內支付。

合約負債

於2024年12月31日·合約負債為人民幣222.3百萬元·較2023年12月31日的人民幣309.9百萬元減少28.3%。合約負債反映了於提供相關項目管理服務前的已收付款,本年度內減少主要是由於已收付款減少。

Use of Proceeds from the Listing

The ordinary shares of the Company ("Shares") were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 31 May 2021 (the "Listing"), with a total of 328,172,000 Shares issued pursuant thereto. After deducting the underwriting fees and relevant expenses, net proceeds from the Listing amounted to approximately HK\$915.8 million (equivalent to RMB751.4 million). Subscription of New Shares

On 18 November 2022 (after trading hours), the Company (as issuer) entered into twelve subscription agreements with twelve high net worth independent subscribers in respect of the subscription of an aggregate of 343,140,000 Subscription Shares at the subscription price and net subscription price of HK\$0.80 per Subscription Share (the "Subscriptions"). On the date of the subscription agreements, the closing price per Share was HK\$0.62. The aggregate nominal value of the subscription Shares under the Subscriptions was HK\$3,431,400. The Subscriptions have been completed on 3 May 2023.

The Directors are of the view that the Subscriptions will benefit the Group's long term development by providing a good opportunity to raise additional funds to strengthen the financial position and to broaden the Company's shareholder base and capital base to facilitate the future growth and development of its business as well as to increase the trading liquidity of the Shares. In particular, the Directors believe the Subscriptions represent a desirable opportunity for the Company to scale up the Group's government project management business and capital project management business, while allowing the Group to preserve its existing internal cash resources.

Financial Resources Management and Capital Structure

The Group has adopted comprehensive treasury policies and internal control measures to review and monitor its financial resources.

As of 31 December 2024, cash and cash equivalents amounted to RMB2,484.0 million (31 December 2023: RMB1,835.8 million). The Group maintained at net cash position as of 31 December 2024 without any borrowings.

The gearing ratio is calculated as total borrowings divided by total equity, i.e. the sum of long-term and short-term interest bearing bank loans and other loans as of the corresponding date divided by the total equity as of the same date. As of 31 December 2024, the gearing ratio was nil (31 December 2023: Nil).

Debt

During the Year, the Group had no significant borrowings.

Foreign Exchange Risk

The Group conducts substantially all of its business in China and in RMB. Therefore, the Group is exposed to minimum foreign exchange risks. However, the depreciation or appreciation of RMB and HK\$ against foreign currencies may have impact on the Group's results. Currently, the Group does not hedge foreign exchange risks, but will continue to closely monitor its exposure to foreign exchange risks. The management will consider hedging foreign exchange risks when the Group becomes materially affected by such risks.

Contingent Liabilities and Capital Commitment

As at 31 December 2024, the Group did not have any significant contingent liabilities and capital commitment.

Pledge of Assets

During the Year, the Group did not have any pledged assets.

Material Acquisitions and Disposals

During the Year, the Group did not have any material acquisitions or disposals of subsidiaries, associates or joint ventures.

茲提述本公司日期為2024年3月26日、2024年3月28日、2024年4月26日、2024年6月14日、2024年6月20日、2024年6月27日、2024年7月29日、2024年8月30日、2024年9月13日、2024年9月27日、2024年10月10日、2024年10月15日、2024年10月18日、2024年10月18日、2025年1月9日、2025年1月15日及2025年1月27日的公告(「該等公告」)。由於延遲刊發本公司截至2023年12月31日止年度的年度業績、本公司股份已自2024年4月2日上午九時正起暫停於聯交所買賣。於2024年6月24日及2024年10月15日、本公司接獲聯交所載列復牌指引的函件、有關詳情載於本公司日期為2024年6月27日及2024年10月18日的公告。

本公司已於2025年1月9日刊發截至2023年12月31日止年度的年度業績及截至2024年6月30日止 六個月的中期業績。本公司已於2025年2月12日 刊發截至2023年12月31日止年度的年度報告及 截至2024年6月30日止六個月的中期報告。本公司股份於本年報日期仍然暫停買賣。本公司將尋求盡快恢復本公司股份買賣。

報告期後事項

除上述者外,於2024年12月31日之後及直至本年報日期,概無發生影響本集團的重要事項。

僱員及薪酬政策

截至2024年12月31日,本集團共有669名全職僱員,包括432名派駐至相關項目公司以進行本集團在管的房地產開發項目的僱員。

The management of the Company, who understands the importance of realising the personal value of employees, has established a transparent evaluation system for all employees seeking career development in various business units. A performance-based compensation structure was set up to reward employees for their performance. The Company also adjusted compensation from time to time in accordance with its development strategies and market standards. Efforts have been made to promote the healthy competition within the Company, maximise the potential of employees, continuously optimise the current compensation incentive system to retain and attract excellent talents.

In addition to internal trainings, third-party training institutions were also invited to provide online and offline trainings for the Group's employees. Through these measures, team members can get access to the latest information on industry trends and market development. so a stable talent pool full of cohesion and vitality will support the Company's long-term and sustainable development.

CORPORATE GOVERNANCE REPORT 企業管治報告

CORPORATE GOVERNANCE PRACTICES

The Group is committed to achieving high corporate governance standards to safeguard the interests of its stakeholders. The Company has applied the principles in the Corporate Governance Code ("CG Code") in Appendix C1 of the Listing Rules by conducting its business by reference to the principles of the CG Code and emphasising such principles in the Company's governance framework. To the best knowledge of the Directors, except for the deviation from the code provision F.2.2 of the CG Code, the Company has complied with all applicable code provisions under the CG Code during the Year.

Under code provision F.2.2 of the CG Code, the chairman of the board should attend the annual general meeting. The chairman of the board should also invite the chairmen of the audit, remuneration, nomination and any other committees (as appropriate) to attend. In their absence, the chairman should invite another member of the committee or failing this their duly appointed delegate, to attend. An issuer's management should ensure the external auditor attend the annual general meeting to answer questions about the conduct of the audit, the preparation and content of the auditors' report, the accounting policies and auditor independence. Due to business arrangements, Mr. Wu Po Sum (being the chairman of the Board and the nomination committee of the Company and a non-executive Director) and Mr. Zhu Baoguo (being the then chairman of the remuneration committee of the Company and an independent nonexecutive Director, and subsequently resigned with effect from 10 October 2024) were not present at the annual general meeting held on 28 June 2024 ("2024 AGM"). However, Mr. Hu Bing (being an executive Director), Mr. Liu Dianchen (being the chairman of the audit committee of the Company and an independent non-executive Director) and Mr. Xu Ying (being a member of the audit committee, remuneration committee and nomination committee of the Company and an independent non-executive Director) were present at the 2024 AGM to maintain an ongoing dialogue and communicate with the shareholders of the Company and encourage their participation. Due to the delays in the publication of the annual results and annual report of the Company for the year ended 31 December 2023, the resolutions in relation to the approval of (i) consolidated financial statements, directors' reports and auditors' report for the year ended 31 December 2023; and (ii) re-appointment of auditors were not voted on at the 2024 AGM. Accordingly, the then auditors of the Company did not attend the 2024 AGM. The Company will arrange its auditors to attend the forthcoming annual general meeting to answer questions (if any) from its shareholders.

企業管治常規

為保障利益相關者權益,本集團致力達致高水平的企業管治標準。本公司已透過參照《企業管治守則》原則開展業務及於本公司治理框架中強調該等原則,應用上市規則附錄C1所載的企業管治守則(「《企業管治守則》」)的原則。就董事所深知,除偏離《企業管治守則》守則條文第F.2.2條外,本公司於本年度已遵守《企業管治守則》所載的所有適用守則條文。

根據《企業管治守則》之守則條文第F.2.2條,董 事會主席應出席股東週年大會。董事會主席亦應 邀請審核、薪酬、提名及任何其他委員會(如適 用)的主席出席。倘彼等缺席,主席應邀請委員 會的另一名成員出席,否則應邀請彼等正式指定 的代表出席。發行人管理層應確保外聘核數師出 席股東週年大會,以回答有關審核的進行情況、 核數師報告的編製及內容、會計政策及核數師獨 立性的問題。由於業務安排,胡葆森先生(本公 司董事會及提名委員會主席兼非執行董事)及朱 保國先生(本公司薪酬委員會當時主席兼獨立非 執行董事,其後於2024年10月10日辭任)並無出 席於2024年6月28日舉行的股東週年大會(「2024 年股東週年大會」)。然而,胡冰先生(執行董 事)、劉殿臣先生(本公司審核委員會主席兼獨 立非執行董事)及徐穎先生(本公司審核委員會、 薪酬委員會及提名委員會成員兼獨立非執行董事) 均出席2024年股東週年大會,以與本公司股東保 持持續對話及溝通,並鼓勵股東參與其中。由於 本公司截至2023年12月31日止年度的年度業績 及年報延遲刊發,有關批准(i)截至2023年12月 31日止年度的綜合財務報表、董事會報告及核數 師報告;及(ii)於2024股東週年大會上並無就續 聘核數師進行表決。因此,本公司當時的核數師 並無出席2024股東週年大會。本公司將安排其核 數師出席應屆股東週年大會,以回答股東提問(如 有)。

CULTURE AND VALUE

The Company takes win-win cooperation as its guiding ideology and "jointly builds industry and develops together" as its vision and goal.

The Group strives to maintain high standards of business ethics and corporate governance across the Company. The Group has a whistleblowing policy in place to support employees and other contacts, such as customers or suppliers, to anonymously raise their concerns with the Audit Committee about any possible irregularities. At the same time, the Group formulated a clear anti-corruption policy to support anti-corruption laws and regulations, and promoted a culture of integrity internally.

In order to create long-term sustainable growth for shareholders and deliver long-term values to all stakeholders, the board will continue to monitor and evaluate the culture of the Company by:

- Reviewing the company's decisions and actions to assess whether they are consistent with the desired culture;
- · Undertaking staff and stakeholders engagements; and
- Making reference to complaints received, disclosures by whistleblowers, staff turnover rate and code of conduct/ regulatory breaches for potential areas of concerns.

MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS OF LISTED ISSUERS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") in Appendix C3 to the Listing Rules as the code of conduct for the Directors in their dealings in the Company's securities. Having made specific enquires with each Director, the Company confirmed that, save as disclosed below, all the Directors had complied with the required standard as set out in the Model Code for the Year.

Reference is made to the announcement of the Company dated 28 March 2024. The Board was informed at the close of business of 28 March 2024 by Mr. Wu Po Sum ("Mr. Wu"), chairman and non-executive director of the Company, that 395,560,000 Shares (which were placed in securities trading accounts with margin facilities) held by Joy Bright Investments Limited (a company wholly-owned by Mr. Wu), representing approximately 10.2% of the then total issued share capital of the Company, were sold on the market as collateral pursuant to the terms and conditions applicable to such margin

文化及價值

本集團致力於在本公司上下維持高水準的商業 道德及企業管治。本集團制定了舉報政策,支持 僱員及其他往來者(如客戶或供應商)以不具名 方式向審核委員會提出其對任何可能違規行為 的關注。同時,本集團制定了清晰的反貪污政策 支持反貪污法律及規例,並在內部推崇廉潔文化。

為給股東創造長期可持續的增長及為所有利益 相關者帶來長期價值,董事會將繼續監控及評估 本公司的文化,措施如下:

- 審視公司的決定及行動,以評估與理想文化是否貫徹一致:
- 推動員工及利益相關者參與;及

上市發行人董事進行證券交易的標準 守則

本公司已採納上市規則附錄**C3**《上市發行人董事進行證券交易的標準守則》(「**標準守則**」)作為其董事進行本公司證券交易的操守準則。經向各董事作出具體查詢後,本公司確認,除下文所披露者外,所有董事於本年度一直遵守標準守則所載的規定標準。

茲提述本公司日期為2024年3月28日的公告。於2024年3月28日營業結束時,董事會獲本公司主席兼非執行董事胡葆森先生(「胡先生」)告知,恩輝投資有限公司(一間由胡先生全資擁有的公司)持有的395,560,000股股份(存放於證券交易賬戶,設有保證金融資),佔本公司當時已發行股本總數約10.2%,已於2024年3月27日及28日根據適用於該等保證金融資的條款及條件在市場上作為抵押品出售(「出售事項」),以償付結

facilities on 27 and 28 March 2024 (the "Disposal") to settle the outstanding balances owing to the relevant securities firm. Pursuant to paragraph A.3 of Appendix C3 to the Listing Rules, the Directors were prohibited from dealing in any securities of the Company on any day on which its financial results are published and during the period of 60 days immediately preceding the publication date of the annual results (the "Black-out Period"). The Disposal fell within the Black-out Period. As disclosed in the announcement of the Company dated 26 March 2024, there would be a delay in publication of the Company's annual results for the year ended 31 December 2023. therefore the Disposal fell within the Black-out Period and constituted a dealing of shares by Mr. Wu. Mr. Wu was however in a passive position in relation to the Disposal. The Directors (except Mr. Wu) considered the Disposal and were satisfied that the Disposal during the Black-out Period was made under exceptional circumstances under paragraph C.14 of Appendix C3 to the Listing Rules.

欠相關證券公司之尚未償還結餘。根據上市規則附錄C3第A.3段,董事被禁止於本公司財務業績刊發之任何日子及於緊接全年業績刊發日期前60日期間內(「禁售期」)買賣任何本公司證券。出售事項乃於禁售期內進行。誠如本公司日期為2024年3月26日的公告所披露,本公司截至2023年12月31日止年度的全年業績延遲刊發,故出售事項乃於禁售期內進行,並構成一項由胡先生進行的股份交易。然而,胡先生乃處於被動的情況下作出該出售事項。董事(胡先生除外)已考慮出售事項,並信納禁售期內進行出售事項乃根據上市規則附錄C3第C.14段項下之特殊情況作出。

Under the articles of association (the "Articles of Association") of the Company, the Board is empowered to appoint any person as a Director to fill the casual vacancy on or as an additional Director.

During the Year, in compliance with Rules 3.10 and 3.10A of the Listing Rules, the Company has appointed three independent non-executive Directors (representing one-third of the Board), one of whom possesses the appropriate professional qualifications in accounting and financial management. Each of the three independent non-executive Directors has confirmed his independence of the Company and the Company considers each of them to be independent in accordance with the guidelines of assessing independence as set out in Rule 3.13 of the Listing Rules. Each of the three independent non-executive Directors has signed a letter of appointment with the Company for a specific term of three years.

Following the resignation of Mr. Zhu Baoguo, an independent non-executive Director, with effect from 10 October 2024, the Company had two independent non-executive Directors only, and was therefore not in compliance with, among others, the requirements of Rule 3.10(1) of the Listing Rules. Following the appointment of Ms. Yan Yingchun as an independent non-executive Director with effect from 27 December 2024, the Company has recompiled with Rule 3.10(1) of the Listing Rules. For details, please refer to the announcements of the Company dated 10 October 2024 and 27 December 2024 respectively.

Pursuant to Article 83(3) of the Articles of Association, any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election. Pursuant to Article 84 of the Articles of Association, at every annual general meeting of the Company, one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. A retiring Director shall be eligible for re-election and shall continue to act as a Director throughout the meeting at which he retires. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of directors to retire by rotation) any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment. In accordance with Articles 83(3) of the Articles of Association, Ms. Yan Yingchun retired from office and offered herself for re-election at the 2025 annual general meeting of the Company ("2025 AGM"). In accordance with Articles 84(1) and 84(2) of the Articles of Association, Mr. Wu Po Sum and Mr. Xu Ying retired from their offices, and being eligible, offered themselves for re-election at the 2025 AGM.

All Directors have given sufficient time and attention to the affairs of the Group and in particular, the independent non-executive Directors have provided the Board with their diversified expertise and professional advices. The Board is of the view that there is a balanced composition of executive, non-executive and independent non-executive Directors in the Board and the independent non-executive Directors are able to provide sufficient checks and balances to safeguard the interests of the Group and its Shareholders. The participation of the independent non-executive Directors in the Board and committee meetings also provides independent judgment on the issues relating to strategy, policy, performance, accountability, conflict of interest and standards of conduct.

Independent professional advice can be sought to discharge their duties at the Group's expense upon their request. No such advice was sought during 2024. The Company has subscribed appropriate and sufficient insurance coverage on Directors' liabilities in respect of legal actions taken against Directors arising out of corporate activities.

RESPONSIBILITY OF THE BOARD

The Board is in charge of leadership and control of the Group and is responsible for maximising the Group's financial performance and making decisions in the best interests of the Group and its Shareholders. Under the leadership of Mr. Wu Po Sum, the chairman of the Board (the "Chairman"), the Board is also responsible for formulating and overseeing the business strategies and policies of the Group, approving and monitoring annual budgets and business plans, reviewing operational and financial performance, and reviewing and monitoring the Group's financial control and risk management systems. The Board has delegated the daily operation and day-to-day management of the Group as well as the implementation of the Board's policies and strategies to the executive Directors and management of the Group.

CHANGES OF INFORMATION IN RESPECT OF DIRECTORS

There is no information required to be disclosed pursuant to Rule 13.51B(1) of the Listing Rules.

BOARD MEETINGS AND GENERAL MEETING

The Board holds meetings regularly and meets at other times as and when required to review financial, internal and compliance controls, risk management, company strategy and operating performance of the Group. In addition, the Board holds general meeting to maintain an on-going dialogue with the Shareholders.

For the Year, the Board held 4 regular meetings, 3 additional meetings, 2 remuneration committee meetings, 2 nomination committee meetings and 6 audit committee meetings, and the Company held 1 general meeting.

During the intervals between Board meetings, the senior management of the Company provides the Directors with information on a timely basis regarding all major developments or changes in the Group's businesses.

When the Directors or committee members are unable to attend a meeting, they are advised of the matters to be discussed and given an opportunity to make their views known to the chairman prior to the meeting.

CHAIRMAN AND EXECUTIVE OFFICERS

Under code provision C.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. As at 31 December 2024 and up to the date of this Report, the position of chairman is held by Mr. Wu Po Sum and the position of chief executive officer (the "CEO") is held by Mr. Wang Jun. The CEO is mainly responsible for the overall daily operation and management of the Group as well as its strategic development. The roles of the chairman and the CEO are clearly defined and segregated to ensure independence and proper checks and balances. The chairman focuses on formulating the overall development and strategic planning of the Group. The CEO are mainly responsible for the overall daily operation and management of the Group as well as its strategic development.

ACCOUNTABILITY AND AUDIT

The Directors acknowledge their responsibility to present a balanced, clear and understandable assessment of the Group's performance, position and prospects in the consolidated financial statements of the annual and interim reports in accordance with statutory requirements and applicable accounting standards. Pursuant to code provision D.1.1 of the CG Code, management should provide sufficient explanation and information to the Board to enable the Board to make an informal assessment of the financial and other information put before the Board for approval. The Directors confirm that, to the best of their knowledge, information and belief, having made all reasonable enquiries, they are not aware of any material uncertainties relating to events or conditions that might cast significant doubt upon the Company's ability to continue as a going concern.

In preparing the consolidated financial statements for the Year, the Directors have selected appropriate accounting policies and applied them consistently, and have made judgments and estimates that are prudent and reasonable.

Risk Management and Internal Control

The Board is responsible for maintaining sound and effective risk management and internal control systems and reviewing their effectiveness to protect the assets of the Group and the interests of shareholders. The Group is aware of the responsibilities of the Board and the management in risk management and internal control systems:

- The Board is responsible for assessing and determining the nature and extent of risks which the Group is willing to take in achieving its strategic objectives and ensuring that the Group establishes and maintains appropriate and effective risk management and internal control systems; overseeing management in the design, implementation and monitoring of risk management and internal control systems, and conducting a review annually.
- The management is responsible for the design, implementation and monitoring of risk management and internal control systems, and should provide a confirmation to the Board on the effectiveness of these systems.

The risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

風險管理及內部監控

董事會負責維持穩健及有效之風險管理及內部 監控系統並檢討其成效,以保障本集團之資產及 股東之利益。本集團知悉董事會及管理層於風險 管理及內部監控系統中的責任:

- 董事會負責評估及釐定達成本集團策略目標時所願接納的風險性質及程度,並確保本集團設立及維護合適及有效的風險管理及內部監控系統;監督管理層對風險管理及內部監控系統的設計、實施及監察,並且每年進行審核。
- 管理層負責對風險管理及內部監控系統的 設計、實施及監察,並應向董事會確認風險 管理及內部監控系統是否有效。

該等風險管理及內部監控系統旨在管理而非消除未能達成業務目標的風險,並僅能對不會有重大失實陳述或損失作出合理而非絕對的保證。

RISK MANAGEMENT

In previous years, the Group has established a risk management framework at the group level, clarified risk management process, promoted the internal risk management culture, which has been increasing year by year in accordance with the Group's strategy. Based on the work done in previous years, the Group continued to improve the risk management system structure through the following efforts and has guided the implementation of risk assessment and continuous risk monitoring activities:




Figure 1: Risk management organizational structure

Restatement and continued implementation of risk management organizational structure: The Group has restated a risk management organizational structure covering the decision-making level (the Board and the Audit Committee), the executive level (Group headquarters and subsidiaries at all levels) and the supervisory level (the Group's Audit and Supervision Department) (see Figure 1: risk management organizational structure), and split risk management responsibilities to clarify risk management responsibilities and risk information reporting routes at all levels;

風險管理

本集團已在以往年度在集團層面搭建了風險管理框架,明確風險管理流程,促進內部風險管理文化的提升,並根據本集團戰略逐年持續提升。本集團在過往年度的工作基礎上,通過以下工作持續完善風險管理體系架構,指引風險評估工作的開展以及持續的風險監控活動:

• 重申了風險管理組織架構並持續宣貫:本 集團重申了貫穿於包括決策層面(董事會 及審核委員會),執行層面(集團總部及下 屬各級公司)和監督層面(集團審計監察部) 的風險管理組織架構(參見圖一:風險管理 組織架構),並進行風險管理職責劃分,明 確各層面的風險管理責任和風險信息報告 路線:

- Renewal of risk assessment standards: During the Year, based on changes of internal and external environments, and according to its business nature and operating characteristics, strategic objectives, and management's risk appetite, the Group renewed applicable risk assessment standards covering strategic, financial, operational, people, compliance, security, reputation and other dimensions, and used jointly confirmed assessment methods and assessment standards to assess the risks that were most likely to affect the achievement of corporate objectives.
- 更新風險評估標準:本年度基於內外部環境的變動,根據本集團的業務性質和經營特點、戰略目標,以及管理層風險偏好,更新適用於本集團的風險評估標準,包括戰略、財務、運營、人員、合規、安全、聲譽等維度,並運用共同確認的評估方法與評估標準,對最有可能影響企業目標達成的風險進行評估。




Figure 2: Risk management process 圖二: 風險管理流程

- Clarification and standardization of risk management process: The Group established a risk management process involving risk identification, risk assessment, risk response, risk monitoring, reporting and improvement (see Figure 2: risk management process), and formed a closed loop to continuously monitor and manage risks. Specifically, driven by its business objectives, the Group identified the risk factors that affected its achievement of the business objectives, and evaluated the possibility and potential impact of each specific risk; sorted out and recorded the existing specific risk response measures; and continuously oversaw and assessed changes in risks and adjusted responses in a timely manner.
- 明確及規範風險管理工作流程:建立了包括風險識別、風險評估、風險應對、風險態控、匯報與改進為主要步驟的風險管理流程(參見圖二:風險管理流程),並形成閉環,對風險進行持續監控及管理。具體包括以公司經營目標為主導,識別影響其達成該經營目標的風險因素,並評估每個具體風險發生可能性及潛在影響;梳理和記錄現有的風險具體應對措施;以及持續監督和評估風險的變化,並及時調整應對措施。

The main features of the Group's risk management system are as follows:

本集團風險管理體系的主要特點如下:

- Closed-loop risk management process: The risk management process adopts a combination of top-down and bottom-up approaches. Through a series of work processes including risk identification, risk assessment, risk response, risk monitoring, reporting and improvement, the Group aims to understands the major risks faced by the Group and continuously monitors and manages the risks through a closed-loop risk management process.
- Risk database with a clear hierarchy and focuses: Based
 on five risk categories, namely strategy, market, operation,
 finance and law, and taking into account the principles of
 comprehensiveness, importance, synergy and standardization,
 the Group has established a risk database at different levels.
- 閉環式風險管理程序: 風險管理程序採取 自上而下與自下而上相結合的方式, 通過 風險識別、風險評估、風險應對、風險監控、 匯報與改進等一系列工作流程, 全面瞭解 本集團所面臨的主要風險, 並通過閉環式 的風險管理程序對風險進行持續監控及管 理。
- 層級清晰、重點突出的風險數據庫:從戰略、市場、運營、財務、法律5個風險類別出發,考慮全面性、重要性、協同性及規範性原則,建立集團層面分層級的風險數據庫。

- Risk assessment criteria that fit for the Group: The Group
 has established appropriate risk assessment criteria based on
 the nature of its industry and business objectives, and the
 management's risk appetite.
- Continuous improvement and optimization mechanism: The Group clarified the frequency of risk assessment (at least once a year) and requirements for reporting and communication, and continuously improved risk management process and optimized risk management and control measures through regular assessment, implementation and follow-up of risk response measures, communication and reporting.
- On the basis of the establishment of the above risk management system, the management, with the assistance of an external advisory body, conducted the identification, assessment and analysis of material risks in the principal businesses of the Group (including the consideration of risks related to the environmental, social and governance). A comprehensive review of the risk management system was completed. The top ten risks facing the Group in 2024 were newly assessed and the corresponding measures were sorted out. It also clarified the main responsible department for risks, next-step countermeasures and improvement directions, and reported the assessment results to the Audit Committee.

在上述風險管理體系搭建的基礎上,管理層通過外部諮詢機構的協助,開展了本集團主要業務範圍內重大風險識別、評估及分析工作(包括考慮了環境、社會及管治領域有關風險在內),並對風險管理體系進行了一次全面的檢討,對本集團2024年面臨的前十大風險進行了更新評估及應對措施的梳理,明確了風險主責部門和下一步應對措施及改善方向,並向審核委員會就評估結果進行了匯報。

INTERNAL CONTROL

The Group established its applicable internal control system with reference to the internal control framework of the Committee of Sponsoring Organizations of the Treadway Commission (COSO). The control system includes a mature organizational structure that clearly defines the rights and responsibilities of various departments to protect the assets of the Group and the interests of shareholders.

As an important part of risk management, the internal control system of the Group was formed on the basis of various risks facing the Group. As the first line of defense, the management of the Group headquarters, the management of its subsidiaries and the management of its various departments designed and implemented a series of policies and procedures for the processes related to finance, operation and compliance, and monitored the implementation and effect of relevant policies and procedures.

內部監控

本集團參照 COSO (Committee of Sponsoring Organizations of the Treadway Commission) 內部控制管理框架,建立適用於本集團的內部監控系統。監控系統包括一個成熟的組織架構,清楚界定各部門之權力責任,以保障本集團之資產及股東之利益。

本集團內部監控系統作為風險管理的重要組成部分,以本集團面臨的各項風險為基礎而形成。本集團總部管理層、下屬公司管理層以及其各部門管理層,作為第一道防線針對與財務、運營、合規相關的流程,設計、實施了一系列的政策及程序,並監察有關政策及程序的執行情況及效果。

The Group has constantly improved the Anti-Fraud and Whistleblowing System and supports rational whistleblowing. The office of the Board is responsible for managing the hotline and e-mail for reporting fraud cases, and receiving real-name or anonymous reports from employees and external third parties (e.g. customers or suppliers). The Group will protect complainants and whistleblowers in the process of cooperating with investigations, in a bid to prohibit any illegal discrimination or retaliation. In the meantime, the Group attaches importance to employees' integrity, requiring all employees to declare conflicts of interest and sign the Integrity Initiative when they join the Group, in a bid to strengthen employees' anti-corruption awareness from the beginning of their job. In addition, it set up a column of integrity on the official website of the Company, and continuously promoted the culture of integrity internally through various channels, such as the WeChat official accounts and the internal office platform.

本集團持續完善《反舞弊與舉報制度》,支持理性舉報並由董事會辦公室負責管理舞弊案件的舉報電話熱線、電子郵箱,接收來自僱員及其他往來者(如客戶或供應商)的實名、匿名舉報人,協助調查過程中,本集團全程保護投訴、舉報人,禁止任何非法歧視或報復行為的發生。同時,本集團重視員工廉潔行為管理,要求所有員工入,本集團重視員工廉潔行為管理,要求所有員工入,職業起點強化員工反貪腐意識,並在本公司官方網站設置廉潔宣傳專欄,通過微信公眾號、內部辦公平台等多個渠道在內部持續推崇廉潔文化。

The Company has established an internal audit function. The Group has established the Audit and Supervision Department as the third line of defense. Through internal audit and follow-up review of the improvement of internal control defects found in the audit process, it communicates with the relevant management to supervise the timely implementation of internal control improvement measures, and provides independent and objective advice to the Board on the effectiveness of the Group's risk management and internal control systems. The Audit and Supervision Department has unrestricted access to the documents and records, information systems and staff required to perform audit procedures, and reports the audit results to the Audit Committee.

INSIDE INFORMATION

The Group is aware of its responsibilities under the Securities and Futures Ordinance and the Listing Rules. In terms of procedures for handling and disseminating inside information and internal controls, the Group has formulated the Guidelines on the Management and Disclosure of Inside Information and has publicized its disclosure policy to directors, senior management and relevant employees who may have access to sensitive information, requiring them to follow relevant procedures for handling confidential resources and/or inside information, regulatory information disclosure and inquiry reply in accordance with the guidelines.

內幕消息

REVIEW OF RISK MANAGEMENT AND INTERNAL CONTROL SYSTEMS

During the Year, the Board conducted a comprehensive review of the Group's risk management and internal control systems through the Audit Committee, including the risk assessment and the review of internal control over key business processes in 2024. The review, which is conducted annually, covers the fiscal year 2024 and the Group's principal businesses. The review covers all material controls, including financial, operational and compliance controls, and takes into account changes in the nature and severity of material risks and the Group's ability to respond to changes in its businesses and external environment. The Board considers that the Group has complied with the risk management and internal control provisions set out in the CG Code and that the risk management and internal control systems are effective and adequate.

The Audit Committee has reviewed the resources, staff qualifications and experience of accounting, internal audit and financial reporting functions and those relating to environmental, social and governance performance and reporting, as well as the training courses received by the staff and the associated budgets, and considered them to be adequate.

There was a delay in publication of the Company's annual results for the year ended 31 December 2023 and the interim results for the six months ended 30 June 2024 due to the changes of auditors and the trading of Shares on the Stock Exchange has been suspended since 9:00 a.m. on 2 April 2024. The reasons for the changes of auditors were set out in the announcements of the Company dated 26 March 2024, 28 March 2024 and 27 September 2024. It was noted that the delay in providing information to the auditors (some of which was beyond the Company's control and required co-operation of external parties and some of which was caused by the excessive turnover in personnel of the Company and its business partners) had indirectly caused the changes in auditors. Whilst the Company is of the view that the foundational elements for effective risk management and internal control are in place, it is believed that improvements can be made.

風險管理及內部監控系統檢討

於本年度,董事會透過審核委員會對本集團風險管理及內部監控系統進行了一次全面檢討,工作包括2024年風險評估及關鍵業務流程的內部控制檢討。年度檢討覆蓋2024年會計年度,範圍蓋本集團主要業務,對所有重要的監控方面,包括財務監控、運作監控及合規監控,並考慮了重大風險的性質及嚴重程度的轉變,以及本集團應對其業務及外部環境轉變的能力。董事會認為本集團已遵守《企業管治守則》內訂明之風險管理及內部監控係文,並認為風險管理及內部監控系統是有效及足夠的。

審核委員會已檢討會計、內部審核及財務匯報職 能以及環境、社會及管治表現及報告有關方面的 資源、員工資歷及經驗,以及員工所接受的培訓 課程及有關預算,並認為是足夠的。

由於更換核數師,本公司截至2023年12月31日止年度的全年業績及截至2024年6月30日止六個月的中期業績延遲刊發,股份已於2024年4月2日上午九時正起暫停於聯交所買賣。更換核數師的原因載於本公司日期為2024年3月26日、2024年3月28日及2024年9月27日的公告。謹請注意,延遲向核數師提供資料(部分資料超出本公司控制範圍,需要外界合作,部分則由本公司及其業務夥伴的人員流動率過高所致)間接導致核數師的更換。雖然本公司認為有效風險管理及內部監控的基本要素已到位,但相信仍可作出改進。

As a general measure, the management of the Company will continue to maintain close communication with its auditors and the Audit Committee, by conducting periodic assessments and providing timely responses at important stages to identify and resolve any issues that may potentially affect timely publication of future financial results. The Company has also adopted the following internal control measures and improvements to prevent re-occurrence of a delay in results publication:

DIVIDEND POLICY

Pursuant to the dividend policy of the Company ("Dividend Policy"), the Company intends to declare and distribute approximately 50% of the Group's net profit for a given year as dividends to the Shareholders. Any future determination to declare and pay any dividends would require the approval of the Board and will be at their discretion. In addition, any final dividend for a financial year will be subject to shareholders' approval and the relevant laws. The Board will review the Dividend Policy from time to time in light of the following factors in determining whether dividends are to be declared and paid:

- result of operations;
- cash flows;
- financial condition:
- Shareholders' interests;
- general business conditions and strategies;
- capital requirements and surplus;
- the payment by the Group's subsidiaries of cash dividends to the Group; and
- other factors the Board may deem relevant.

The payment of the dividend by the Company is also subject to any restrictions under the Companies Law of the Cayman Islands and the Articles of Association of the Company.

Any final dividend declared by the Company must be approved by an ordinary resolution of the Shareholders at an annual general meeting of the Company and must not exceed the amount recommended by the Board. The Dividend Policy will continue to be reviewed from time to time and there can be no assurance that a dividend will be proposed or declared in any specific period. The Dividend Policy is available on the Company's website.

本公司宣派股息亦須遵守開曼群島公司法及本 公司組織章程細則之任何限制。

本公司宣派的任何末期股息必須經股東於本公司股東週年大會以普通決議案予以批准,且不得超過董事會所建議之金額。股息政策將持續不時作出審閱,且概不能保證將在任何既定期間建議或宣派股息。股息政策可於本公司網站上閱覽。

BOARD INDEPENDENCE

The Board has established mechanisms to ensure independent views are available to the Board. The summary of the mechanisms is set out below:

(i) Composition

The Board ensures the appointment of at least three independent non-executive Directors and at least one-third of its members being Independent Non-executive Directors (or such higher threshold as may be required by the Listing Rules from time to time), with at least one independent non-executive Director possessing appropriate professional qualifications, or accounting or related financial management expertise. Further, Independent non-executive Directors will be appointed to Board committees as required under the Listing Rules and as far as practicable to ensure independent views are available.

(ii) Independence Assessment

The Nomination Committee strictly adheres to the nomination policy of the Company ("Nomination Policy") with regard to the nomination and appointment of independent non-executive Directors, and is mandated to assess annually the independence of independent non-executive Directors to ensure that they can continually exercise independent judgement.

(iii) Board Decision Making

Directors (including independent non-executive Directors) are entitled to seek further information from the management on the matters to be discussed at Board meetings and, where necessary, independent advice from external professional advisers at the Company's expense. A Director (including independent non-executive Directors) who has a material interest in a contract, transaction or arrangement shall not vote or be counted in the quorum on any Board resolution approving the same.

董事會獨立性

董事會已建立機制以確保董事會可獲得獨立意 見。機制概要載列如下:

(i) 組成

董事會確保委任至少三名獨立非執行董事 及至少三分之一成員為獨立非執行董事(或 上市規則可能不時規定的較高限額),且至 少一名獨立非執行董事須具備適當專業資 格或會計或相關財務管理專業知識。此外, 獨立非執行董事將根據上市規則的規定獲 委任加入董事委員會,並在切實可行的情 況下確保可獲得獨立意見。

(ii) 獨立性評估

提名委員會嚴格遵守有關本公司提名及委任獨立非執行董事的提名政策(「**提名政策**」),並獲授權每年評估獨立非執行董事的獨立性,以確保彼等可持續行使獨立判斷。

(iii) 董事會決策

董事(包括獨立非執行董事)有權就將於董 事會會議上討論的事項向管理層尋求進一 步資料,並於必要時向外部專業顧問尋求 獨立意見,費用由本公司承擔。於合約、交 易或安排中擁有重大權益的董事(包括獨 立非執行董事)不得就批准該等合約、交易 或安排的任何董事會決議案投票或計入法 定人數。

BOARD COMMITTEES AND CORPORATE GOVERNANCE FUNCTIONS

The Board has established three committees, namely the audit committee (the "Audit Committee"), the remuneration committee (the "Remuneration Committee") and the nomination committee (the "Nomination Committee") to oversee the relevant aspects of the Company's affairs. The three Board committees are provided with sufficient resources to discharge their duties.

During the Year, as part of its corporate governance function, the Board has performed the corporate governance duties including:

- a) reviewed the Company's policies and practices on corporate governance;
- reviewed and monitored the training and continuous professional development of Directors and senior management;
- c) reviewed and monitored the Company's policies and practices in compliance with legal and regulatory requirements;
- d) reviewed and monitored the code of conduct and compliance manual (if any) applicable to employees and Directors; and
- e) reviewed the Company's compliance with the code and disclosure in the Corporate Governance Report.

AUDIT COMMITTEE

In compliance with Rule 3.21 of the Listing Rules, the Audit Committee was established on 12 May 2021. As at 31 December 2024, the Audit Committee comprises three independent non-executive Directors, being Mr. Liu Dianchen (the chairman of the Audit Committee), Mr. Xu Ying and Ms. Yan Yingchun. None of them is a member of the former or existing auditors of the Company. The Board is of the view that the members of the Audit Committee have sufficient accounting and financial management expertise and experience to discharge their duties. However, the Audit Committee is also authorised to obtain external legal or other independent professional advice if it considers necessary.

董事委員會及企業管治職能

董事會轄下設三個委員會,即審核委員會(「審核委員會」)、薪酬委員會(「薪酬委員會」)及提名委員會(「提名委員會」),以監督本公司相關方面的事務。三個董事委員會可獲充分資源以履行彼等之職責。

審核委員會

為遵守上市規則第3.21條,審核委員會於2021年5月12日成立。於2024年12月31日,審核委員會由三名獨立非執行董事劉殿臣先生(審核委員會主席)、徐穎先生及閆穎春女士組成。彼等概無擔任本公司前任或現任的核數師。董事會認為,審核委員會的成員有足夠的會計及財務管理的專業知識及經驗,可履行彼等之職責。然而,審核委員會亦獲授權,可於其認為必要時從外部取得法律或其他獨立專業意見。

During the Year, following the resignation of Mr. Zhu Baoguo, an independent non-executive Director, with effect from 10 October 2024, the Company had two members of Audit Committee only, and was therefore not in compliance with, among others, the requirements of Rule 3.21 of the Listing Rules. Following the appointment of Ms. Yan Yingchun as an independent non-executive Director with effect from 27 December 2024, the Company has recompiled with Rule 3.21 of the Listing Rules. For details, please refer to the announcements of the Company dated 10 October 2024 and 27 December 2024 respectively.

The Audit Committee is governed by its terms of reference in accordance with the CG Code, which are available at both the Company's website and the Hong Kong Stock Exchange's website. The principal functions of the Audit Committee include:

The Audit Committee has reviewed the risk management and internal control systems of the Group as well as considered and identified risks of the Group subsequent to 31 December 2024 and will continuously monitor the systems on a regular basis.

For the Year, the external independent auditors' remuneration to the Group's auditor of annual audit services provided to the Group amounted to approximately RMB1,600,000.

NOMINATION COMMITTEE

The Nomination Committee was established on 12 May 2021 with written terms of reference as suggested under the CG Code. As at 31 December 2024, the Nomination Committee comprises one non-executive Director, namely Mr. Wu Po Sum (the chairman of the Nomination Committee), and two independent non-executive Directors, namely Mr. Xu Ying and Ms. Yan Yingchun.

The Nomination Committee is governed by its terms of reference, which are available at both the Company's website and the Hong Kong Stock Exchange's website. The primary duties of the Nomination Committee include: (i) reviewing the structure, size and composition (including skills, knowledge and experience) of the Board at least once a year, and making recommendations to the Board regarding any proposed changes to the Board for conforming to the strategy of the Company; (ii) identifying and nominating qualified individuals to act as Directors and making recommendations to the Board regarding such matters; (iii) assessing the independence of the independent non-executive Directors; (iv) making recommendations to the Board regarding the appointment or reappointment of Directors and succession planning for Directors, in particular the Chairman and the Executive Officers; and (v) reviewing the board diversity policy of the Company ("Board **Diversity Policy**"), and the implementation of the progress targets set by such policy.

The chairman of the Nomination Committee shall attend the annual general meeting of the Company to answer questions raised by the Shareholders on Directors' nomination and other nomination policy matters.

The Company has adopted the Nomination Policy which sets out the following procedures for nomination of Directors:

- The proposed candidates will be asked to submit the necessary personal information in a prescribed form by the Nomination Committee.
- The Nomination Committee shall convene a meeting upon request by any member of the Nomination Committee, and invite nominations of candidates from Board members (if any), for consideration by the Committee. The Committee may also nominate candidates for its consideration.

- any other relevant factors as may be determined by the Nomination Committee or the Board from time to time as appropriate.

The Company has adopted the Board Diversity Policy with effect on 12 May 2021 which sets out its approach to achieve and maintain diversity on the Board in order to enhance the effectiveness of the Board. With a view to achieving sustainable and balanced development, the Company is committed to increasing diversity in the Board in order to bring in innovation, fresh and broad business perspectives and enhance the decision-making process of the Board. The Board is of the view that having diversity will help the Company better understand and meet the needs of the customers and maintain its competitive advantages in the project management service industry. The Board Diversity Policy is available on the Company's website.

The Company recognizes the benefits of Board diversity and endeavours to ensure that the Board has the appropriate and balanced skill levels, experience and perspectives to support the execution of its business strategies. The Company seeks to achieve Board diversity through the consideration of a number of factors, including professional qualifications and experience, cultural and educational background, race and ethnicity, gender, age and length of service. The Company will also take into consideration factors based on its own business model and specific needs from time to time in determining the optimum composition of the Board.

本公司深明董事會多元化之裨益,並致力確保董事會擁有合適及均衡的技能水平、經驗及觀點,以支持執行業務策略。本公司考慮眾多因素以達致董事會成員多元化,包括專業資格及經驗、文化及教育背景、種族及族裔、性別、年齡及服務任期。本公司於釐定董事會成員之最佳組合時,亦按自身業務模式及不時的特定需求考慮各項因素。

As at 31 December 2024, the Board comprises seven members including one female Director and six male Directors with a balanced mix of knowledge and skills, including various aspects of the real estate industry (such as project management and property development), as well as overall business management, investment and accounting. The Company has three independent non-executive Directors who have different industry backgrounds, including accounting, property development and investment. Furthermore, the Board has a relatively wide range of ages, ranging from 41 to 74 years old.

於2024年12月31日,董事會由七名成員組成,包括一名女性董事及六名男性董事,具有均衡之知識及技能,包括房地產行業(例如項目管理及物業開發)及整體業務管理、投資及會計等各領域。本公司有三名獨立非執行董事,彼等具備不同的行業背景,包括會計、物業開發及投資。此外,董事會年齡分佈相對較廣,介乎41至74歲。

With regards to gender diversity on the Board, the Group recognizes the particular importance of gender diversity. As at 31 December 2024, the Board comprised seven Directors, including one female Director. The senior management also comprised two male members. The Group has taken and will continue to take steps to promote and enhance gender diversity at all levels of the Company. The Board shall take opportunities when selecting and making recommendations on suitable candidates for Board appointments with the aim to increase the proportion of female members over time. The Group will also ensure that there is gender diversity when recruiting staff at mid to senior level so that it will have a pipeline of female senior management and potential successors to the Board going forward. It is the Group's objective to maintain an appropriate balance of gender diversity with reference to the stakeholders' expectation and international and local recommended best practices.

As recommended by the Nomination Committee, the Board has set measurable objectives (in terms of gender, skills and experience) to implement the Board Diversity Policy and review such objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives. The Nomination Committee has reviewed the Board Diversity Policy, as appropriate, to ensure its continued effectiveness from time to time.

In accordance with the requirements under the CG Code, the Company has set an initial target of appointing at least one director of a different gender in the Board and has achieved such target. Taking into account the Group's business model and specific needs and also the above (including the presence of one female Director), the Group considers that the composition of the Board satisfies the

- considering the nomination of Directors to be re-elected as Directors at the annual general meeting in accordance with the Nomination Policy and Board Diversity Policy; and
- 7. discussing and considering the Board composition during the Year and Board succession plan.

As at 31 December 2024, the full-time employees of the Group (including senior management) comprise about 70.0% male and 30.0% female. Whilst it is relatively more challenging for the Group to achieve equal gender ratio across all business units of the Group due to the characteristics and job nature of different business units, it is the Group's goal to achieve a balanced gender ratio in the overall workforce (including senior management).

REMUNERATION COMMITTEE

The Remuneration Committee was established on 12 May 2021 and revised on 30 December 2022 with written terms of reference as suggested under the CG Code. As at 31 December 2024, the Remuneration Committee comprises three members, including two independent non-executive Directors, namely Ms. Yan Yingchun (the chairman of the Remuneration Committee) and Mr. Xu Ying and one non-executive Director, namely Mr. Wu Po Sum (the chairman of the Company).

The Remuneration Committee is governed by its terms of reference, which are available at both the Company's website and the Hong Kong Stock Exchange's website. The primary duties of the Remuneration Committee include (but not limited to) (i) making recommendations to the Board on the Company's policies and structures for all remuneration of the Directors and senior management and on the establishment of a formal and transparent procedure for developing policy on such remuneration; (ii) reviewing and approving remuneration proposal by reference to corporate objectives set by the Directors from time to time; (iii) to make recommendations to the Board on the remuneration packages of individual executive Directors and senior management; (iv) to make recommendations to the Board on the remuneration of non-executive Directors; and (v) to review and/or approve matters relating to share schemes under Chapter 17 of the Listing Rules.

The amount of the Directors' remuneration is determined on the basis of the relevant executive Directors' experience, responsibility, workload and the time devoted to the Group. The entire Directors' remuneration is reviewed by the Remuneration Committee from time to time.

The Remuneration Committee may also consult the Chairman on proposals relating to the remuneration of other executive Directors and has access to professional advice if necessary.

The Remuneration Committee held 2 meetings during the Year. The work performed by the Remuneration Committee for the Year included:

- review of the remuneration policy and structure for all Directors and senior management and to assess their performance;
- made recommendations to the Board on the remuneration packages of the newly appointed independent non-executive Directors; and

Each general meeting, other than an annual general meeting, shall be called an extraordinary general meeting.

Procedures for Shareholders to Convene an Extraordinary General Meeting and Put Forward Proposals thereat

The following procedures for the Shareholders to convene an extraordinary general meeting are prepared in accordance with Article 58 of the Articles of Association of the Company:

- One or more member(s) holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company, on a one vote per share basis, shall have the right, by written requisition to the Board or the Company Secretary, to require an extraordinary general meeting to be called by the Board for the transaction of any business or resolution specified in such requisition.
- 2) The requisition must state the objects of the meeting, and must be signed by the Shareholder(s) concerned and may consist of several documents in like form, each signed by one or more of those Shareholders.
- The requisition shall be made in writing to the Board or the Company Secretary via mail to the Company's principal place of business in Hong Kong at Units 1602–1605, 16/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong.
- 4) The extraordinary general meeting shall be held within two months after the deposit of the requisition.
- 5) If the Board fails to proceed to convene the extraordinary general meeting within twenty-one (21) days of the deposit of such requisition, the requisitionist(s) himself or themselves may convene a physical meeting at only one location which will be the Principal Meeting Place, and all reasonable expenses incurred by him/her/them as a result of the failure of the Board shall be reimbursed to him/her/them by the Company.

- 2) a notice in writing signed by the Person of his/her willingness to be elected as a Director. Such notices shall be lodged at least seven (7) days prior to the date of the general meeting and the period for lodgment of such notices shall commence no earlier than the day after the despatch of the notice of the general meeting appointed for such election and shall be at least seven (7) days in length.

Procedures for Raising Enquiries

Memorandum of Association and Articles of Association

During the year ended 31 December 2023, the Company amended the Articles of Association for the purpose of, among other things: (i) reflect and align with the latest regulatory requirement in relation to the expanded paperless listing regime and the electronic dissemination of corporate communications by listed issuers and the relevant amendments made to the Listing Rules which took effect from 31 December 2023; and (ii) align with other relevant requirements of the Listing Rules and company law of the Cayman Islands and incorporate certain corresponding and housekeeping amendments. Such amendments were set out in the circular of the Company dated 5 June 2024. The amendments to the Articles of Association and the adoption the amended articles of association of the Company were approved by the shareholders of the Company at the annual general meeting held on 28 June 2024.

The Company's Memorandum of Association and Articles of Association are available on both the websites of the Company and the Stock Exchange. Save as disclosed above, there had been no changes in the constitutional documents of the Company for the Year.

Corporate Communication and Investor Relations

The Company has adopted the Shareholders Communication Policy, which is available on the Company's website. The Company is committed to enhancing long-term shareholder value through communications with the Shareholders, both individual and institutional, as well as potential investors. The Board shall maintain an on-going dialogue with the Shareholders and potential investors. Effective and timely dissemination of the Company's information to the Shareholders and potential investors shall be ensured at all times.

BOARD OF DIRECTORS

The Board of Directors is the primary decision-making body of the Company, setting fundamental business strategies and policies for the management and operation of the Group's business and monitoring their implementation. As at 31 December 2024, the Board of Directors comprises seven Directors, consisting of three executive Directors, one non-executive Director and three independent non-executive Directors. The Directors are elected to serve initial terms of three years, which are renewable upon reelection and/or re-appointment.

CHAIRMAN AND NON-EXECUTIVE DIRECTOR

Mr. Wu Po Sum (胡葆森先生) (formerly known as Hua Jianming 滑建明), aged 74, is the Chairman of the Board, a non-executive Director and Controlling Shareholder of the Company. Mr. Wu is the chairman of the nomination committee and a member of the remuneration committee of the Company. He was appointed as a Director on October 22, 2020 and was redesignated as a non-executive Director and appointed as the Chairman of the Board on November 6, 2020. Mr. Wu is responsible for formulating the overall development and strategic planning of the Group. Mr. Wu is one of the Group's controlling shareholders. Mr. Wu is the father of Ms. Wu Wallis, a non-executive Director of the Company. Mr. Wu is also a director of various of the Group's subsidiaries, namely Start Ahead Investment Limited, Central China Management (Hong Kong) Limited and Henan Start Ahead Commercial Management Co., Ltd.* (河南前啟商業管理有限公司) ("Henan Head Start").

Mr. Wu is the founder of Central China Real Estate Limited (建業地產股份有限公司*) (stock code: 832) ("CCRE") and its subsidiaries (the "CCRE Group") and has nearly 31 years of experience in real estate development and investment. He entered the People's Republic of China (the "PRC") real estate market in May 1992, when he laid the foundation for the CCRE Group and established the "Jianye (建業)" brand name. He has always been the chairman and an executive director of CCRE and a director of CCRE and various subsidiaries of the CCRE Group, and is responsible for formulating development strategies, making decisions on investment projects and determining development directions of the CCRE Group (including the Group).

董事會

董事會為本公司的主要決策機構,為管理及營運本集團的業務而制定基本業務策略及政策,並監督其實施。於2024年12月31日,董事會由七名董事組成,包括三名執行董事、一名非執行董事及三名獨立非執行董事。董事經選舉選出,初始任期三年,並可連選連任及/或重新委任。

主席兼非執行董事

胡葆森先生(曾用名滑建明),74歲,為本公司董事會主席、非執行董事兼控股股東。胡先生為本公司提名委員會主席及薪酬委員會成員。彼於2020年10月22日獲委任為董事,並於2020年11月6日任命為非執行董事及董事會主席。胡先生負責制定本集團整體發展及策略規劃。胡先生為本集團的控股股東之一。胡先生為本公司非執行董事李樺女士的父親。胡先生亦為本集團附屬公司前啟投資有限公司、中原建業(香港)有限公司及河南前啟商業管理有限公司(「河南前啟」)之董事。

胡先生乃建業地產股份有限公司*(股份代號: 832)(「建業地產」)及其附屬公司(「建業地產集團」)的創始人及於房地產開發及投資方面擁有近31年的經驗。彼於1992年5月涉足中華人民共和國(「中國」)房地產市場,為建業地產集團打下根基,並創立「建業」品牌。彼一直擔任建業地產主席兼執行董事,並同時擔任建業地產及建業地產集團多個附屬公司的董事,及負責制定發展策略、決策投資項目並釐定建業地產集團(包括本集團)的發展方向。

In 2017, Mr. Wu was invited to the selection of Golden Sunlight Public Welfare Awards of Henan Daily (河南日報社金陽光公益獎) and was awarded the "Meritorious Person of the First (2017) Central China Social Responsibility (首屆(2017)中原社會責任•功勛人物)" prize. Besides, the Benyuan Humanity Education Foundation in Henan (河南省本源人文基金會) sponsored by him was awarded the "Outstanding Nonprofit Organization of First (2017) Central China Social Responsibility (首屆(2017) 中原社會責任•優秀公益組織)".

Mr. Wu received various awards in 2018. He was appointed as the "Deputy Director of the Advisory Committee of Industry and Commerce Association of Henan Province (河南省工商聯諮詢委員會副主任)", received the "Outstanding Contribution Entrepreneur of Henan (河南卓越貢獻企業家)" award at the "40 Years of Reform and Opening up of Henan (河南省紀念改革開放40年)" event organized by Henan Daily, and was awarded the highest accolade of a leading entrepreneur in the real estate industry in Henan at the "40 Years of Reform and Opening up, Development of Central China (改革開放四十年中原城市大發展)" by Henan Province Real Estate Business Chamber of Commerce. Mr. Wu also received the "Golden Camel Award" granted by the Society of Entrepreneurs and Ecology Foundation for his significant contribution in promoting projects concerning environmental protection.

Mr. Wu was an executive director and the chairman of the board of DIT Group Limited (築友智造科技集團有限公司) (a company listed on the Stock Exchange, stock code: 726) from November 2019 to August 2020. The principal business of DIT Group Limited includes research and development, design, manufacture and sales of assembled building prefabricated units. Mr. Wu has also been a director of CURA Investment Management (Shanghai) Co., Ltd. AWARD OF SHARES AND POOL OF AWARDED SHARES

The total number of Shares which may be issued in respect of all awards under the Share Award Scheme and other share schemes of the Company would be no more than 362,580,212 Shares, representing no more than 10% of the total number of Shares in issue as at the date of adoption of the Share Award Scheme or the relevant date of approval of the refreshment of the scheme mandate limit.

Both as at 1 January 2024 and 31 December 2024, the number of awards in the form of new Shares available for future grant under the scheme mandate limit of the Share Award Scheme was 297,080,212 Shares (being the abovementioned scheme mandate limit of 362,580,212 Shares less the 65,500,000 awarded Shares in the form of new Shares granted as set out in the announcement of the Company dated 30 May 2023 and the circular of the Company dated 20 July 2023).

As at 31 December 2024 and as at 11 April 2025, being the latest practicable date prior to the issue of this annual report, the total number of Shares available for issue under the Share Award Scheme was 297,080,212, representing approximately 7.69% and 7.69% of the issued Shares (excluding treasury shares) as at 31 December 2024 and 11 April 2025 respectively.

MAXIMUM ENTITLEMENT OF EACH PARTICIPANT

Where any grant of awards to a selected participant would result in the Shares issued and to be issued in respect of all options and awards granted to such selected participant (excluding any options and awards lapsed in accordance with the terms of any relevant scheme) in the 12-month period up to and including the date of such grant representing in aggregate over 1% of the Shares, such grant must be separately approved by the Shareholders (which excludes any Shareholders that are required to abstain from voting under the Listing Rules, such as the relevant selected participant and his/her close associates (or associates if such selected participant is a connected person)) in general meeting, with such selected participant and his/her close associates (or associates if the selected participant is a connected person) abstaining from voting.

The respective awarded Shares shall vest on the selected participant in accordance with the applicable vesting schedule as set out in the letter of grant when all the vesting conditions set out therein have been satisfied and/or waived (all of which shall be determined by the Board or the Remuneration Committee in its absolute discretion). The Board or the Remuneration Committee may direct and procure the trustee to release from the trust the awarded Shares to the selected participants by transferring the number of awarded Shares to the selected participants in such manner as determined by the Board or the Remuneration Committee from time to time.

The Board may at its discretion specify any conditions (including performance targets (if any)) which must be satisfied before the awarded Shares may be vested in the award letter. Such performance targets may include financial targets and management targets which shall be determined based on the (i) individual performance, (ii) performance of the Group and/or (iii) performance of business groups, business units, business lines, functional departments, projects and/or geographical area managed by the selected participants.

Subject to the Listing Rules, the Board or the committee of the Board or person(s) to which the Board delegated its authority may from time to time while the Share Award Scheme is in force and subject to all applicable laws, determine such vesting criteria and conditions or periods for the award to be vested. The vesting date in respect of any award shall be not less than 12 months from its date of grant, provided that for employees, the vesting date may be less than 12 months from the date of grant (including on the date of grant) in and only in the following circumstances where:

- grants of "make whole" awards to new joiner employee participants to replace share awards such employee participants forfeited when leaving their previous employers;
- (b) grants to an employee participant whose employment is terminated due to death or disability or occurrence of any out of control event. In those circumstances, the vesting of awards may accelerate;
- grants of awards with performance-based vesting conditions, in lieu of time-based vesting criteria;

獎勵股份的歸屬及績效目標

ACCEPTANCE OF AWARD AND PURCHASE PRICE OF AWARDED SHARES

Subject to the above vesting period requirements, the Board has the authority to determine, among other things, the amount payable on acceptance of the award and the relevant payment terms. In general, no amount is payable on acceptance of grant of award under the Share Award Scheme.

The purchase price of the awarded Shares (being the price payable by a grantee to purchase Shares under the Share Award Scheme, if any) shall be such price which shall be determined by the Board, the committee of the Board, or person(s) to which the Board has delegated its authority from time to time based on considerations such as the prevailing closing price of the Shares (being the average closing market price for the five preceding business days on which the Shares are traded on the Stock Exchange), the purpose of the award and the characteristics and profile of the selected participant. Such room for discretion provides the Board with flexibility to stipulate, if necessary, a purchase price for awarded Shares, while balancing the purpose of the award and the interests of Shareholders.

獎勵股份的購買價(即承授人購買股份獎勵計劃 項下股份應付的價格,如有)將由董事會、董事 會委員會,或董事會已授權人士不時根據股份的 現行收市價(即股份於聯交所買賣的前五個營業 日的平均收市價)、獎勵的目的以及選定參與者 的特徵及概況等考慮因素釐定。這種酌情權為董 事會提供了靈活性,在必要時規定獎勵股份的購 買價,同時平衡獎勵的目的和股東的利益。

REMAINING LIFE

Subject to early termination, the Share Award Scheme shall be valid and effective for a term of 10 years commencing from the date of its adoption, being 7 August 2023, until 6 August 2033.

MOVEMENTS OF AWARDED SHARES

On 29 May 2023, the Board resolved to award an aggregate of 65,500,000 awarded Shares (the "2023 Awarded Shares") at nil consideration to a total of 15 employee participants, which includes 2 Directors and the chief executive officer of the Company ("Chief Executive Officer"), pursuant to the Share Award Scheme.

The grant of the 2023 Awarded Shares were made conditional on the Shareholders approving the adoption of the Share Award Scheme (and for the Directors, approval of independent Shareholders for such grant to them), which was obtained via the ordinary resolution passed at the extraordinary general meeting of the Company held on 7 August 2023. The 2023 Awarded Shares were issued to the trustee on 8 September 2023.

The closing price of the Shares, immediately before the Board resolved to grant of the 2023 Awarded Shares (i.e. 25 May 2023) and before the date of Shareholders' approval of such grant (i.e. 4 August 2023) was HK\$0.35 and HK\$0.39, respectively. According to the accounting standard and policy adopted by the Company, the date of grant is considered to be the date of Shareholders' approval (i.e. 7 August 2023). The aggregate fair value of the 2023 Awarded Shares as at 7 August 2023 amounted to approximately HK\$25.2 million. The fair value of awarded shares on the grant date is determined by reference to the closing price of the underlying ordinary shares on the date of grant, taking into account the terms and conditions upon which the awarded shares were granted, in accordance with Hong Kong Financial Reporting Standards 2, Share-based payment.

剩餘期限

除非提前終止,否則股份獎勵計劃將自採納日期 起十年(即2023年8月7日至2033年8月6日)內有 效及生效。

獎勵股份變動

於2023年5月29日,董事會議決根據股份獎勵計劃無償向合共15名僱員參與者(包括2名董事及本公司首席執行官(「首席執行官」))獎勵合共65,500,000股獎勵股份(「2023年獎勵股份」)。

授出2023年獎勵股份的前提是股東批准採納股份獎勵計劃(而就董事而言,則須經獨立股東批准向彼等授出有關股份),有關批准乃透過本公司於2023年8月7日舉行的股東特別大會上通過的普通決議案取得。2023年獎勵股份已於2023年9月8日發行予受託人。

緊接董事會議決授出2023年獎勵股份前(即2023年5月25日)及於股東批准有關授出日期前(即2023年8月4日),股份的收市價分別為0.35港元及0.39港元。根據本公司採納的會計準則及政策,授出日期被視為股東批准日(即2023年8月7日)。2023年獎勵股份於2023年8月7日的公允價值總額約為25.2百萬港元。根據香港財務報告準則第2號以股份為基礎的付款,獎勵股份於授出日期的公允價值乃參考相關普通股於授出日期的收市價釐定,並考慮授出獎勵股份的條款及條件。

The 2023 Awarded Shares are subject to the satisfaction of the vesting criteria and conditions as set out in the table below. These also include performance targets. The Company has established an appraisal mechanism to evaluate the performance of each Selected Participant. Each Selected Participant will be continually assessed throughout his/her employment. The performance targets of the Awarded Shares are individualized based on the job nature and job positions of each Selected Participant and the projected market and business conditions. The performance targets of the Awarded Shares include (among others) the Company achieving satisfactory revenue, gross profit, net profit, gross floor area under management or other internal performance metrics during the vesting period of the awarded Shares. Shortly prior to each vesting date, the Board will determine whether the relevant grantee has met his/her performance targets for the relevant one-year period prior to the vesting date. In assessing whether such performance targets have been satisfactorily met, the Board and Remuneration Committee will focus on the growth and reputation of the Group, its industry ranking, as well as benchmarking of such key performance metrics against comparable companies in the same industry and/or with a listing on the Stock Exchange or a comparable and recognized stock exchange.

The Company has subscribed appropriate directors' and officers' liabilities insurance coverage for the Directors and officers of the Group which remains in force.

Trademark Licensing Agreement

On May 13, 2021, a trademark licensing agreement (the "Trademark Licensing Agreement") was entered into between CCRE and our Company, pursuant to which CCRE agreed to grant to the Group the right to use certain trademarks of the CCRE Group registered in the PRC and Hong Kong (the "Licensed Trademarks") for the Group's business operations and investment activities, as well as the right to sub-lease the Licensed Trademarks to third parties solely for the purpose of business operation of the Group. The Trademark Licensing Agreement has a term of ten years commencing from the Listing, unless otherwise terminated by both parties. Neither CCRE nor the Group has the right to unilaterally terminate the Trademark Licensing Agreement. Pursuant to the Trademark Licensing Agreement, the licensing fee payable by the Group to CCRE from Listing onwards will be: (1) for the first three years: RMB15 million per year; (2) for the fourth to sixth year: RMB20 million per year; and (3) for the seventh to tenth year: RMB25 million per year. Such licensing fee will be calculated on a pro-rated basis for less than an entire calendar year.

As at the dates of the above agreement and up to the date of this report, Mr. Wu Po Sum is the controlling shareholder of the Company, and indirectly owned more than 30% equity interests in CCRE. Therefore, the abovementioned transactions also constitute the continuing connected transactions of the Company. Details of the above agreement are set out in the prospectus of the Company dated 18 May 2021.

Pursuant to Rule 14A.55 of the Listing Rules, the independent nonexecutive Directors of the Company have reviewed the abovementioned continuing connected transactions and confirmed that such continuing connected transactions have been entered into:

- a) in the ordinary and usual course of business of the Group;
- either on normal commercial terms or, if there were not sufficient comparable transactions to judge whether they were on normal commercial terms, on terms no less favorable to the Group than terms available to or from (as appropriate) independent third parties; and
- c) in accordance with the relevant agreements governing them on terms that are fair and reasonable and in the interests of the Company's shareholders as a whole.

The Company's auditor was engaged to report on the Group's continuing connected transactions for the Year in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. The auditor has issued its unqualified letter containing its findings and conclusions in respect of the continuing connected transactions in accordance with Rule 14A.56 of the Listing Rules.

Project management service fee income is recognised on a straight-line basis over the estimated service period. The service period typically ranges from three years to five years.

We identified revenue recognition as a key audit matter because revenue is one of the key performance indicators of the Group and is significant to the consolidated financial statements, both of which give rise to an inherent risk of manipulation of the timing of revenue recognition.

Central China Management Company Limited ("the Company") was incorporated in the Cayman Islands on 22 October 2020, as an exempted company with limited liability under the Companies Act, Cap. 22 (Act 3 of 1961, as consolidated and revised) of the Cayman Islands (the "Companies Act"). Its principal place of business is at Units 1602–1605, 16/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong and has its registered office at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1–1111, Cayman Islands. The shares of the Company were listed on the Main Board of the Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 31 May 2021 (the "Listing Date"). The Company and its subsidiaries (together, the "Group") are principally engaged in the provision of project management services in Henan and other provinces in the People's Republic of China (the "PRC").

(a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (HKFRSs), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (HKASs) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (HKICPA), and the disclosure requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). Material accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain amendments to HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 1(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting period reflected in these consolidated financial statements.

(b) Basis of preparation and functional and presentation currency

The consolidated financial statements for the year ended 31 December 2024 comprise the Company and its subsidiaries (together referred to as "the Group") and the Group's interest in an associate. The consolidated financial statements are presented in Renminbi ("RMB") rounded to the nearest thousand except as otherwise indicated, while the Company's functional currency is the Hong Kong dollar ("HK\$").

The measurement basis used in the preparation of the financial statements is the historical cost basis except that the following assets and liabilities are stated at their fair value as explained in the accounting policies set out below:

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so it can continue to provide returns for equity shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade and other receivables and contract assets. The Group's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks and financial institutions with sound credit rating for which the Group considers to have low credit risk.

The Group does not provide any other guarantees which would expose the Group to credit risk. The maximum exposure to credit risk is represented by the carrying amount of each financial asset in the statement of financial position after deducting any impairment allowance. There is no significant concentration of credit risk within the Group.

(i) Trade receivables and contract assets

There is no significant concentration of credit risk within the Group. The trade receivables are due upon the date of the billing. The Group measures loss allowances for trade receivables and contract assets, including bills receivable and trade-related amount due from related parties, at an amount equal to lifetime ECLs, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

The application of HKFRS 18 is not expected to have significant impact on the financial positions or performance of the Group but may affect the presentations and disclosures of the Group's consolidated financial statements. The Group is in the process of making a detailed assessment of the impact of HKFRS18. Except for the HKFRS 18, so far it has concluded that the adoption of them is unlikely to have a significant impact on the consolidated financial statements.
